Free Will Baptists Around the World Where Our Missionaries Serve—Part 1

Panama

Stan and Brenda Bunch live in Chitre, Panama, in the province of Herrera and serve in the area of Parita. The mission church which they started in Parita has purchased land but has been unable to get clearance to build a place of worship. God has blessed the work with several people coming to know Christ in spite of opposition. Stan oversees

outreach in the region, including giving counsel and support to the Las Tablas church.

Steve and Judy Lytle reside in the area of El Dorado, a suburb of Panama City, and have worked faithfully to develop the Betania Free Will



Baptist Church which is currently being led by Daniel, a Panamanian preacher. Now Steve is developing the Bible institute program. He recently began extension training courses, taking them throughout the provinces where Free Will Baptists have works.

Brazil

Tom and Nancy Hughes have the northernmost Free Will Baptist work in Brazil, laboring in the city of Uberlandia in the state of Minas Gerais. The Hughes have started a second church in the city and have already built a nice facility for services and Sunday school classes. The mission church continues to grow through Bible teaching and conversions.

Jim and Karen Cowart
moved to Uberlandia in May of
1993. The First FWB Church in
Uberlandia was being
maintained by lay preachers
until the Jim Cowarts were
called by the church to assume
the pastorate. Jim and Karen
had been working in the state of
São Paulo. They had planned to
open a new work in the city of

FALKLAND ISLANDS (U.K.) Limeira when it became evident they were needed at Uberlandia. Latest reports indicate the church is experiencing renewed enthusiasm since the Cowarts began their ministry there.

Norman and Laura McFall moved to the metropolitan area of Belo Horizonte in the state of Minas Gerais in April of 1989 and Dave and Pat Franks joined them in January of 1990. They began having Bible studies in their homes and later were able to see a building erected through the help of Master's Men from the U.S. God has given gradual growth as the Franks have continued to work while the McFalls went on furlough. This thriving area of over 400,000 people has very little other gospel witness.

In 1974, when Earnie and Jean Deeds went to the city of Conselheiro Lafaiete, south of Belo Horizonte. Free Will Baptists had only one other ministry within 300 miles. The Bobby Aycocks had started a work in the neighboring town of Barbacena. Now a beautiful church building graces Lafaiete and a stable group of believers carries on an effective program of evangelism and Bible training.

Bobby and Sue Aycock

moved to Barbacena, Minas Gerais, in 1971 and started witnessing and winning people to Christ. A vibrant church was established and soon built a sanctuary and Sunday school classrooms. Although the Aycocks left the work to labor in the U.S. for approximately eight years, the church has continued. In 1991 they returned to Barbacena after the church experienced some discouragement due to inadequate leadership. The church is now reaching out to neighboring towns in an effort to start satellite churches.

Traveling southwest some 440 miles from Barbacena and Lafaiete, a person will encounter Ribeirão Preto in the northern part of the state of São Paulo. Bobby and Geneva Poole moved there in 1961 and have continued to minister there ever since. At least four FWB works have been started in the city through the Pooles' efforts. While Bobby and Geneva are developing a new church in the Alto da Boa Vista area of town, their youngest son, John, pastors the First FWB Church in Ribeirão. The central Bible institute is also

Araras. Jim and Shirley maintain an effective ministry at the First FWB Church and are involved in a new ministry of the church to reach orphans and homeless children. A number of these children have accepted Christ as their Savior, and the church has gained a good standing with the city as a result of this special ministry.

Curt and Mary Holland, the newest missionaries on the field, are laboring about 40 miles south of Araras in the city of Campinas, São Paulo. They have been studying the Portuguese language and are helping in the First FWB Church in Campinas (the first church started in Brazil by Free Will Baptists). The Hollands are praying for guidance concerning their location and ministry following language study.

Although **Ken and Marvis Eagleton** were in Brazil for some 32 years, they are currently in the States working with the development of the TEAM ministry among high school students. They have labored in the areas of Campinas, Araras, Monte Alto, and Jaboticabal

At Jaboticabal, the Free Will Baptist camp has proven to be a blessing for outreach and spiritual growth, often doubling as facilities to house the Bible institute. Until recently **Jim and Vicki Sturgill** lived at the camp and worked in Jaboticabal

and Araraquara. They are currently on furlough but when they return, they plan to join the church-planting team in Belo Horizonte, a city of 3.5 million population.

Dave Jr. and Becky Franks joined the Uruguay team in August of 1992. They have been studying Spanish in Montevideo and recently assumed the pastoral role for the Malvin Alto congregation in a Montevideo suburb.

Susan Bumpus hopes to go to Uruguay in 1994 and plans to work in the Montevideo area. She will be teaching music at The Sower Bible Institute and developing children's ministries.

Ron and Linda Callaway are busy seeking to establish a new church in Móstoles, a suburb of Madrid. where approximately four million people reside. Móstoles has proven to be one of the most difficult areas to penetrate with the gospel. Although some inroads have been made, the work has progressed slowly. Ron and all of the other missionaries are teaching in the Logos Bible Seminary which is being developed to train national leaders.

Lynn Midgett also works in the church-planting effort at Móstoles, ministering to children and youth. A special youth outreach ministry has been started in the church facilities. Approximately 50 young people attended a ping pong tournament there recently and many of those heard the gospel for the first time.

Dwain and Debbie Crosby have moved to the area of Majadahonda between Madrid and Villalba. This area of more than half a million people has the fastest growing population in that entire province. The Crosbys hope to establish a church in this very needy area

following furlough.

Jeff and Susan Turnbough went to Spain in 1982. Early in their first term they moved to Villalba, an area of nearly one million people. They successfully launched the only Bible-believing work to date between Madrid and Segovia. Today they have a good group of Christians who are developing leadership skills. The congregation has outgrown its facilities and has purchased property but has faced difficulty in getting clearance to build a church. Financing for construction of the church has been difficult to arrange, but the group hopes to be able to begin construction in 1994.

Steve and Linda Reeves have been laboring in the area of Villalba with the Turnboughs and assumed responsibility for the ministry while Jeff and Susan were home for furlough. Steve has also been involved in teaching in the Bible institute program as well as working with children and youth. The Reeves plan to continue working in the Villalba area following furlough.

France

Steve and Becky Riggs have been working with the mission church at Nantes.

France, since August of 1989. Steve assumed the leadership role when John and Pansy Murray left the field. Steve has also assisted in an outreach ministry to university students. The Riggs have been in the United States since May of 1992 fulfilling their deputational ministry and hope to return to Nantes in July.

Allan and LaRue Crowson are in charge of the Nantes FWB mission church while the Riggs are on furlough. Allan is busy developing and teaching a Bible institute curriculum aimed at training national leaders. He also writes and translates materials into French for publication.

Charolette Tallent also labors in Nantes. Working with the mission church, she is particularly involved in counseling and leads the university outreach program aimed at approximately 30,000 students. She has successfully channeled a number of students into the church and some have been saved and baptized.



pefore I met Christ, whenever I faced problems my heart cried, "Somebody, please help!" But no matter how much I searched and pleaded. I could find no savior. So I concluded that unless I could somehow become a stronger, more self-sufficient person, I would be completely overcome by pain and despair. From childhood I remember thinking what I wanted more than anything was the emotional strength to overcome my suffering and pain.

For some reason—maybe our poverty, maybe my very brief encounter with a Christian Sunday school, or maybe my interest in Western stories—I had a curiosity about Christianity from childhood. But my curiosity stemmed from thinking that having faith was the coward's way of escape when he couldn't face life's difficulties. I rejected the whole idea, feeling I wanted to work hard at solving my own problems.

My earliest memories of home are of my drunken grandmother.

My earliest memories of home are of my drunken grandmother. My father was very ill with tuberculosis, and we all lived together in the shadow of poverty and illness. My grandmother coped with my father's condition by drinking—so much so that she became a completely different person. She always compared me to my younger brother, whom she favored. She showed me no affection, only hatred. We were very poor and seldom had

anything but rice to eat. If we had a little fish, my grandmother ate it herself instead of feeding it to the children. She would go from house to house in her drunken fits of rage, and I was deeply ashamed to be from such a home. I hated to go to school and feared the thought of my classmates coming to my home.

As I grew to junior high age, I realized my meek and soft-hearted parents, who couldn't stand up to my grandmother, were also to be pitied. And I realized above all, my grandmother was to be pitied because she was loved by literally no one. I came to see her as a lonely, pitiful old lady. Both the giver and receiver of suffering are truly equal

tragedies.

I remember thinking the human life is only grief and suffering. I felt no love for my family, and I knew no way out of life's sorrow. When I remember my childhood, I recall nothing but a deep sadness which felt like someone had put a lead weight in the depths of my heart. Gradually, like a small sea animal crawls into its shell. I withdrew into my own sorrow. By high school age, I had dropped out of school and developed such emotional problems that I lost large amounts of hair and had patches of baldness. I was caught in a vicious cycle: I hated my home, yet I was afraid to venture out into the world.

I became an adult and got married. At 21 years of age, I learned I was pregnant. But we were very poor and my husband was upset. He did not want the baby. So I decided to have an abortion. I am now 42, so that

was more than 20 years ago. But until I met Christ, I could not forgive myself for this horrible act. Though I never voiced it, deep in my heart I blamed my husband for the guilt I felt. Our relationship became stormy as a result, and I'm sure my husband suffered the consequences of the abortion as much as I.

In giving my life over to Christ last August, I discovered Him as my true Helper and Savior.

In August of 1992, after a prolonged struggle with lung cancer, my husband passed away. Though not a Christian, he had no special regard for Buddhism and the exorbitant fee the priests charge for funerals. So he requested his funeral to be held in a Christian church. We didn't have a relationship with any Christian church, so I looked for one in the phone book and called the Ai No Sato Free Will Baptist Church.

At the funeral, a verse at the front of the sanctuary caught my eye and afterward I could not get it out of my head. It was Galatians 5:1, "Stand fast therefore in the liberty wherewith Christ hath made us free." At that time of special grief, I felt I could not go on living. I had such a weight of sin and pain. More than anything, I wanted to be free! I decided if Christ could truly make me free. I wanted to become a Christian. "For the preaching of the cross is to them that perish foolishness; but unto us which are saved it is the power of

God" (1 Cor. 1:18).

I began attending Sunday morning worship and weekday Bible study and learned about the cross. For the first time, I understood my lifelong desire to be emotionally self-sufficient was a goal born of pride. I had been unable to see just how weak I really was. I was convicted for my failure to seek God's help and my great sin of unbelief.

In giving my life over to Christ last August, I discovered Him as my true Helper and Savior, the only one who can really solve all my problems. I received assurance of salvation in Christ and accepted His love. "Herein is love, not that we loved God, but that he loved us, and sent his Son to be the propitiation for our sins" (1 John 4:10). "Hereby perceive we the love of God, because he laid down his life for us" (1 John 3:16).

In all my human relationships, I've never experienced a love that even begins to compare to the perfect love I now know in Christ. In Him, I know I've finally found a home.

Mrs. Amano was baptized and became a member of the Ai No Sato Free Will Baptist Church on December 13, 1992. This is her testimony as she gave it on the day of her baptism. She is currently taking an active role in the Sunday school and women's group, and her countenance truly radiates the joy of the Lord.

A local church can be a blessing to a missionary during furlough! Many of the specifics depend on the size and location of the church, but the possibilities are great. It is thrilling to see how many congregations, both large and small, urban and rural, are becoming aware of the needs of missionaries on furlough and are striving to meet those needs.

The missionary always seeks to spend as little money as possible stateside so he will not deplete his missionary account. At the same time he wants to minister to his stateside supporters.

One of the major ways to aid a missionary is to provide a house for him. A good example would be Donelson Free Will Baptist Church in Nashville or Fellowship FWB in Kingsport, Tenn. Sometimes it may be a parsonage that is not being used, or it could be a house that the church would buy for that particular purpose.

Another way to help is to pay the missionary's utilities. This will save the missionary's account many dollars a month.

It is essential that the missionary stay in contact with his supporters by mail. If the church has a bulk mailing permit, the congregation can offer to send out the prayer letters for him.

With missionary families, the husband is on the road much of the time. Sometimes repairs around the house are left undone because the husband isn't home for several weeks at a time. Individuals in the church could provide maintenance to help in this case.

The local church could also provide car maintenance for the missionary, and possibly even provide a second car for the missionary wife if it is needed. Or members might simply offer to take the family somewhere when actually providing a second car isn't feasible.

A church, or several churches, can purchase equipment that the missionary will need to take back to the field for his next term of service. This might include such things as tools, literature, a computer, a camera, projector, etc.

Making the missionary and his family feel at home in the local church is very important. The family needs a church

Helping Furloughing Missionaries!



Invite the missionary's children to participate in the activities for the children and youth, i.e., youth meetings, recreational activities, etc.

The ladies of the church can invite the missionary wife to meals, social events and church functions.

Most missionaries enjoy reading and listening to Christian music. Find out what their musical tastes are, whether classical, Southern Gospel, or contemporary, and give them cassette tapes of Christian music. Buy Christian novels by Janette Oke, Bodie Thoene, Frank Peretti, and others. Purchase commentaries and/or study books for the missionary. Subscribe to some Christian magazines for them, or maybe Reader's Digest.

Find out more about the field where they work and any special prayer requests they may have. Pray for them!
Someone once said, "Most Christians know the importance of prayer, but missionaries

survive by it."

Let other churches in your area know that the missionary is home so they, too, can minister to the family's needs. Maybe the missionary has a special project to raise money for a certain need. Local churches can band together and promote this project.

Get to know the missionaries in your area. If they live in another area, write to them. Tell them about yourself and your family, and ask about their family, as well as about their work.

Things to Remember

Missionaries are human! They are real people, just like other church members. They have all the same needs as the rest of us: physical, mental, financial and spiritual.

The local church can be used by God to meet those needs. We must be sensitive to the Holy Spirit as He leads us to minister to the missionary.

When a missionary arrives at the airport to begin furlough, he and his whole family are in the middle of a tremendous adjustment from one culture to another. The adjustment will take time as they gain strength, both spiritual and physical, to meet the task ahead. The local church must demonstrate concern, patience, and a willingness to serve.

The family needs a church home where each person is not thought of as "the missionary."

For simplification, we have referred to the missionary as "he." But we realize our Free Will Baptist missionaries consist of single women, man and wife teams, and families. They are all missionaries, and we can be used by the Lord to meet their needs.

Things not to do:

Do not give the missionary items which serve no useful purpose.

Do not have endless large meals. Work out menus in such a way that the missionary can be fed sensibly.

Do not ask the missionary to

give out more than he is emotionally, spiritually, or physically able. He needs to be replenished himself so he can take in, as well as give out.

Do not project an air of being better in your pursuits than he is in his. After all, we are all servants of Christ.

In entertaining, check with the missionary as to the type of recreation he is comfortable with. Certain places or events may be in conflict with his personal convictions.

In exchange of ideas, do not argue about the politics of the mission board or the politics of the country where the missionary serves.

Do not be a burden to your missionary.

Do not transfer any bitterness you may have in your personal life or ministry to the missionary or his family.

We are all servants of Christ. We are all in this together. The missionary wants no special favors or special treatment. What he does need is spiritual encouragement and edification to build him up in his service for the Lord.

The ideal situation in a ministry to missionaries is for one or more churches to assume the entire support of a missionary couple or a single missionary. This relieves the missionary of the burden of extensive traveling. Furloughs will, then, be true furloughs. Quality home life for the missionary can be maintained. Recuperation can really take place. Each can be refreshed and rejuvenated. When the time comes to go back to the field. he and his family will be ready.

Dr. Eagleton Cites Rise in Measles Vaccinations

Côte d'Ivoire—"During the months of March and April several cases of measles were reported in our area," writes Dr. Kenneth Eagleton from Doropo in Côte d'Ivoire. "We saw several cases in the clinic and even hospitalized four patients. One baby died from respiratory complications from measles."

In 1986, prior to the availability of the measles vaccine in the area, the doctor saw over 300 cases of measles. "We started promoting vaccination and many came to get their children vaccinated," says Kenneth. "In the years since then, measles has been rare. In April we gave 651 doses of vaccine, up from 233 doses a year ago."

Franks Jr. Assumes Malvin Alto Post

Uruguay—Dave Jr. and Becky Franks finished Spanish language study in May and have assumed leadership responsibility for the Malvin Alto work in a suburb of Montevideo, Uruguay.

Walter and Marcia Ellison have been in charge of the work since the young national leader became dis-

couraged.

Côte d'Ivoire—Alice Smith reported leading a young woman to Christ on May 18. Alice says , "Marie's parents claimed to be Christians; however, they chose to 'give' her to Moslem relatives when she was a little girl."

Miss Smith requested prayer for the young lady who has been taught the Moslem religion and forced to bow to Allah.

"She wept as she told me her tragic story," Alice continued. "She is determined to serve Christ in spite of expected opposition. Please intercede to God on her behalf."

McCullough to Fill in at St. Nazaire in July

France—Although Tom and Patty McCullough are in the United States for extended medical furlough, Tom is scheduled to spend the month of July in France filling in while the Jerry Gibbs family is in the United States for vacation.

Jerry and Barbara Gibbs were scheduled for regular furlough this summer but have extended their term due to the medical needs of Patty McCullough who is undergoing treatment for cancer.

400 Attend "Easter Conference" at Bouna

Côte d'Ivoire—Nearly 400 people from the Free Will Baptist works in the northern sector of Côte d'Ivoire met at Bouna in April for their annual "Easter Conference." The meeting involved three days of fellowship and edification.

Statistics indicated over 1,500 believers are included in the Free Will Baptist works of the area. According to missionary Clint Morgan, church attendance has nearly doubled in the last ten years.

Ellisons Host Seniors, Give Gospel Witness

Uruguay—On Friday, May 14, Walter and Marcia Ellison hosted a group of high school seniors from the Uruguayan American School in Montevideo. Some 28 people were on hand, including seven out of the nine seniors. Other guests included the faculty and Pastor Gerardo and his wife, Alba, from the Central church in Montevideo.

Marta Laino, an actress whom Dennis and Trena Owen led to the Lord, and Teresa Puglia, a poet and musician, were featured in the program. "It was a cultural event with several Christians from our work present," writes Marcia.

Brazil—Tom and Nancy Hughes in Brazil expressed praise over four people who were converted at the Second church in Uberlandia, Brazil, as a result of a volleyball program. Joaquim, the brick mason who built the First Free Will Baptist Church in Uberlandia, was largely responsible.

Tom writes, "Joaquim . . . never felt qualified to accept a position of leadership in the church. He longed to serve the Lord in a greater way, but there seemed to be no opportunities for him. 
