## COMMITTEE REPORTS

## General Business Committee

#### RESOLUTIONS:

- 1. That a committee of not less than three, no more than five, be appointed by the moderator at this session to raise money for the purpose of building an orphanage in Alabama. That the first man appointed be treasurer and that he bank all funds. This board will make appeals to the Association during the year for funds. The treasurer's name is to be printed in the minutes with his address.
- 2. That this State Association send delegates to the National Association at the First Free Will Baptist Church, Columbus, Mississippi, on Monday through Thursday after the second Sunday in July, 1942. The fee is \$10.00. One delegate is to be appointed from each association represented in the State Association.
- 3. That this body support our national work. Rev. Winford Davis, Monett, Missouri, is treasurer of foreign missions. We have several missionaries on the field to be supported. Rev. F. S. VanHoose, Paintsville, Kentucky, is the treasurer of unified program. Money sent to him is divided as follows:

  40 per cent for Christian Education; 30 per cent for Foreign Missions; 20 per cent for Home Missions; 10 per cent for Superannuation. Rev. J. R. Davidson, 808 W. 27th Street, Bryan, Texas is treasurer of National Educational Board. Money sent to him is used to pay on the new Bible college purchased in Nashville, Tennessee, and for holding Christian Worker's Institutes..
- 4. We urge all our preachers and workers who can to attend the Christian Worker's Institute at Jakin, Georgia, in May, 1942. Write to A. D. Ivey, Jakin, Georgia, for date and cost.
  - 5. We urge our people to subscribe to the Free Will Bap-

tist published at Ayden, North Carolina, \$1.50 per year, and to the Free Will Baptist Gem, Monett, Missouri, for 75c per year.

6. That a committee be appointed to write a Constitution and By-Laws for this body.
