

GENERAL BOARD MEETING WEDNESDAY AFTERNOON, NOVEMBER 9, 2011

The General Board met on Wednesday afternoon, November 9, 2011. The moderator, Rev. Jerry Smith, called the meeting to order and opened the meeting with Scripture reading from Ephesians, and remarks about the battle we are in. Bro. Smith led in prayer.

The clerk, Bro. Rodney Yerby, called the roll of the General Board members.
