

GENERAL BOARD MEETING WEDNESDAY AFTERNOON, NOVEMBER 9, 2016

The General Board met on November 9, 2016 at First Free Will Baptist Church of Dothan. The Moderator, Rev. Steve Trail, asked the clerk to call the roll. Bro. Trail read a passage from Ephesians, beginning in chapter 3, verse 14, and made some comments. Bro. Trail led in prayer.

The following items of business were dealt with:

The moderator asked the board members to review the minutes printed on pages 4 and 5 of the 2016 Digest of Reports. There were no additions or corrections, and the minutes stood as printed.

Rev. Mickey Crane gave the Mid-South Bible Conference report. The financial report is on page 15 of the *2016 Digest of Reports*. There was a motion and second to receive the report. The motion carried.

Rev. Roger Lucas gave the Mission Board report, which is on page 22 of the 2016 Digest of Reports. April 2017 is the target date for Bay City to become self-supporting, which will be 10 years after the start of the work. Danny Williams gave the financial report (pages 22-23 of the 2016 Digest of Reports for the Mission Board (the Executive Office handles finances for the Mission Board and Mid-South Bible Conference Board). There was a motion and second to receive the report. The motion carried.

Rodney Yerby introduced Mandy Mitchell, Executive Director of Alabama Free Will Baptist Children's Home, to give the Children's Home report. Budget and financial statement are on pages 19-21 of the 2016 Digest of Reports. There was a motion and second to receive the report and adopt the budget. The motion carried.

Carolyn Michael gave the Alabama Women Active for Christ report, which is on page 16 of the 2016 Digest of Reports. There was a motion and second to receive the report. The motion carried.

Rev. Rick Taylor presented the Nominating Committee report, on page 17 of the 2016 Digest of Reports. There was a motion and second to receive the report.

There was a motion and second to adjourn. The motion carried. Bro. Trail asked Bro. Taylor to dismiss in prayer.

PROCEEDINGS

THE NINETY-SEVENTH SESSION of the

ALABAMA STATE ASSOCIATION OF FREE WILL BAPTISTS WEDNESDAY EVENING, NOVEMBER 9, 2016

The Alabama State Association of Free Will Baptists convened at First Free Will Baptist Church of Dothan on Wednesday evening, November 9, 2016.

Steve Messer opened the service and invited the congregation to sing "What a Day That Will Be" and "The King is Coming."

The moderator, Rev. Steve Trail, asked Rev. Tim Riggs to come to the platform and lead the congregation in prayer.

The Clerk, Bro. Rodney Yerby called the Ninety-Seventh Annual Session of the Alabama State Association of Free Will Baptists to order, and introduced the officers: Rev. Steve Trail, Moderator; Rev. Jason Miller, Assistant Moderator; and Rev. Jeff Lunsford, Assistant Clerk.

Bro. Messer led the congregation in singing "When We All Get to Heaven."

Bro. Trail introduced the evening's speaker, Rev. Rob Morgan, from Nashville, TN, and summarized his biography.

The host church choir sang "Here in Your Presence," including a solo by Bro. Trail.

Bro. Morgan preached on "The Strength You Need." His text was Nehemiah 8:1-9. Bro. Morgan closed the message with prayer.

There was an invitational hymn, "Take Time to be Holy."

Bro. Trail announced that the Thursday morning session would start at 8:30 AM, and invited attendees to breakfast in the ministry center, starting at 8:00 AM.

Bro. Danny Williams made some announcements: Rev. John Warren, pastor of Cedrom Grove Free Will Baptist Church, passed away November 7th; the State Association is giving every pastor a copy of the book *Mastering Life Before It's Too Late*, by Rob Morgan, paid for out of proceeds from the golf tournament.

Bro. Trail thanked the members of the Dothan church for the tremendous job they were doing hosting the meeting.

It was announced that tickets were available for the Women Active for Christ Missions Banquet. Bro. Trail called on Rev. Tommy Franks to dismiss the session in prayer.

The estimated total attendance for the Wednesday evening service was 184.

STATE ASSOCIATION MEETING THURSDAY MORNING, NOVEMBER 10, 2016

The Moderator, Rev. Steve Trail, opened the morning session.

Bro. Steve Messer noted that November 10th was the birthday of the United State Marine Corps, and discussed passing on wisdom and tradition. He led the congregation in singing "Standing on the Promises."

Bro. Trail preached the Moderator's Message from Luke 23:39-43, "The Scandal of the Cross." Bro. Trail closed the message with prayer.

Bro. Ken Michael presented the Credentials Committee report. Bro. Michael made a motion to receive the report. There was a second. The motion carried. Bro. Trail asked the standing delegates to stand, and then asked the elected delegates to stand. There was a motion and second to seat the elected delegates. The motion carried.

Bro. Trail called on the Clerk, Bro. Rodney Yerby, to read a partial report from the General Board. There was a motion and second to receive the partial report of the General Board. The motion carried.

Bro. Trail called on Executive Director of State Ministries Bro. Danny Williams to present the Executive Director's report.

During his report, Bro. Williams asked Rev. Mark Riggs to discuss partnerships with Cuba and with the Enviame Seminary. Bro. Riggs introduced the president of the Cuban pastor's association and member of the Executive Committee Juriam Remirez, who reported on the work in Cuba; Leonel Sotero, Vice President and Missions Director, who invited Alabama Free Will Baptists to celebrate the 75th anniversary of Cuban Free Will Baptists in February 2017; Ariel Alfaro, Dean of the Cedars of Lebanon Seminary and head of the Theological Department; Samuel Ramos, pastor of one of the larger churches in Cuba, representing the Convention in Cuba to Free Will Baptist International Missions.

Bro. Riggs reported on the partnership with Mexico, which is thriving. The 7th church building that Alabama Free Will Baptists have been a part of was dedicated in March.

There was a motion and second to receive the report and adopt the Executive Fund, Executive Office budgets, and the cooperative giving percentages. The motion carried.

Bro. Trail asked Rev. Keith Burden, Executive Secretary of the National Association of Free Will Baptists, to give a report from the Executive Office of the National Association. Bro. Burden recognized Danny Williams as a new member of the National Association Executive Committee, and thanked Rodney Yerby for working as the national convention photographer. He noted that the national convention will be in Alabama in 2022, and the 2017 convention would be July 16-19 in Louisville, KY.

Bro. Trail pointed out that the State Association has asked churches to voluntarily give \$100 per year for six years to fund Alabama's part of the cost of hosting the national convention.

Rev. Doug Little gave a report from the Free Will Baptist Foundation on investments and estate planning. He recognized Mike Wootton and Kris Wootton from Cornerstone Estate Planning.

After a break, Bro. Trail introduced Matthew Turnbough, missionary to Spain, who reported via Skype.

Bro. Messer led the congregation in singing "He Lives" and "Because He Lives."

Bro. Trail called for ushers. After an offertory prayer, an offering of \$114 was collected while the pianist played "Peace, Peace, Wonderful Peace."

Bro. Trail introduced the morning speaker, Rev. Tim Campbell, from Walnut Ridge, Arkansas. Bro. Campbell was formerly Arkansas Free Will Baptist State Director.

Sis. Merle Jordan sang special music, "Keep On."

Bro. Campbell preached from Jeremiah 20:1-8 on the topic "It's Not About Me."

After the message, Bro. Trail asked the congregation to stand, gave an altar call, and led in prayer. Bro. Trail dismissed the session in prayer.

THURSDAY AFTERNOON, NOVEMBER 10, 2016

Bro. Trail called the session to order, and asked Dr. Joe Godfrey to give the ALCAP report.

Bro. Trail asked Sis. Carolyn Michael to give the Alabama Women Active for Christ (AWAC) report. Sis. Michael pointed out the AWAC report in *The Digest of Reports*. The report was received as information.

Rev. Riley Young gave the State Board of Christian Education report. He announced that state competition would be April 29th at Sulphur Springs Free Will Baptist Church, and pointed out the Board's reports in *The Digest of Reports*. He expressed the Board's thankfulness to the Association for increasing the Board's percentage from cooperative giving. The report was received as information.

Alabama Free Will Baptist Children's Home Board of Directors Chairman Bro. Rodney Yerby introduced Director of the Children's Home Mandy Mitchell who gave the Children's Home report. There was a motion and second to receive the report and adopt the Children's Home budget. The motion carried.

Rev. Roger Lucas presented the State Missions Report. Bro. Lucas reported on Bay City mission work and the Eastside revitalization project. Bro. Williams gave the Missions Board financial report and proposed budget, on pages 22-24 of *The Digest of Reports*. There was a motion and second to receive the report and adopt the Missions Board budget. The motion carried.

Bro. Williams introduced the afternoon breakout sessions. Bro. Trail provided directions to each of the breakout session locations, and dismissed the congregation.

THURSDAY EVENING, NOVEMBER 10, 2016

The evening session was opened with Bro. Steve Messer playing "At Calvary" on the trumpet. He made some remarks about the author of the hymn, then led the congregation in singing "At Calvary" and "Glory to His Name."

Moderator Rev. Steve Trail introduced missionaries to Uruguay Jaimie and Tammy Lancaster, who reported to the Association via Skype.

Bro. Trail called for the ushers to receive the evening offering, and asked Rev. David Crowe to pray the offertory prayer. An offering of \$178 was received while the organist played "His Eye is on the Sparrow."

Bro. Trail introduced the evening's speaker, Rev. Tim Campbell. Prior to the message there was special music by Hannah Siemens, "By Faith."

Bro. Campbell preached from Rev. 3:14-22, "He that hath an ear, let him hear what the Spirit sayeth to the churches."

Bro. Trail conducted an invitation, and Bro. Messer led the congregation in singing "Have Thine Own Way Lord."

Bro. Trail asked Rev. Jason Miller to dismiss the session in prayer.

FRIDAY MORNING, NOVEMBER 11, 2016

Assistant Moderator Rev. Jason Miller opened the morning session with Scripture reading from Deut. 7:9, "God is faithful and He keeps his promises," and led in prayer.

Rev. Mickey Crane presented the Mid-South Bible Conference report. The report was received as information.

Rev. Bobby Ned Peters gave the Resolutions Committee report. Bro. Trail read a report from the Executive Committee regarding the resolution from the North Alabama District Association received in 2015. There was a motion and second to receive the Resolutions Committee report. Bro. Trail asked the congregation to stand for a moment of silence to honor veterans, and then asked Rev. Bobby Ned Peters to lead in prayer.

Bro. Waymon Fields gave the Auditing Committee Report.

Clerk Bro. Rodney Yerby gave the final General Board report. There was a motion and second to receive the report.

Bro. Trail pointed out the ACTS 1:8 budget on page 30 of *The Digest of Reports*. There was a motion and second to approve the ACTS 1:8 budget. The motion carried.

Bro. Trail pointed out the Nominating Committee report on page 17 of *The Digest of Reports."* He asked if there were any other nominations beside those in the report. There was a motion and second that nominations cease and the nominees in the report be elected by acclamation. The motion carried.

Bro. Trail called for reports from the National Association departments.

Rev. Sam McVay gave a report from Free Will Baptist International Missions.

Bro. David Womack gave a report from Randall House Publications.

Rev. David Williford gave a report from Welch College.

Rev. Chris Compton gave a report from the Free Will Baptist Board of Retirement.

Rev. Jim McComas gave a report from Free Will Baptist North American Ministries.

Bro. Mike Wootton gave a report from Cornerstone Estate Planning.

Bro. Trail called for new business. There was none.

Bro. Williams made several announcements: he reminded churches that the State Association has asked for \$100 per church per year for 6 years, \$600 total for hosting the National Association; he asked people to continue to pray and give to ACTS 1:8 to finish the year; he announced Bro. Leonel Sotero was available for services; he announced a trip to Cuba February 21-27, 2017.

The session was dismissed in prayer by Rev. David Crowe.

After a break, Bro. Trail called attendees back, and introduced Bro. Steve Messer to lead in worship. Worship started with a video tribute to veterans. Bro. Messer led the congregation in singing "The Star Spangled Banner," and then led pledges to the U.S. flag, the Christian flag, and the Bible. There was a moment of silence for veterans who died in service of our country, while Bro. Messer played "Taps." Bro. Trail asked veterans to stand and be recognized.

Bro. Messer led the congregation in singing "Faith of Our Fathers."

Bro. Trail introduced the morning speaker, Rev. Rob Morgan. Prior to the message, Sis. Karen Williams sang "I Have Been Blessed."

Bro. Morgan preached on the topic "We Need to be Strong," reading from Nehemiah 8 and Luke 10. He closed the message in prayer.

Bro. Trail led an invitational hymn, "To Be Like Jesus."

The meeting was closed with altar prayer for the nation, the denomination and churches.


