

PROCEEDINGS

The second Session of the North Carolina Albemarle Conference of the original Free Will Baptist Church convened with Fairmont Park Church in the city of Norfolk, Virginia, October 9 and 10, 1946.

Worship services consisting of Scripture, Hymn, and prayer were conducted by Joseph Ange.

The Address of Welcome was delivered by Joseph Ange and Rev. L. E. Ambrose made the response.

Rev. W. A. Hales, Moderator of the Conference, made many favorable remarks concerning the work of the Conference. He recommended that all churches in the conference support the program of the Free Will Baptist as it is set forth by the North Carolina State Association. The moderator also emphasized the need of spiritual unity in all sessions of the Conference.

A business session was declared in order and the minutes of the last Conference were read, corrected and approved.

Rev. M. L. Johnson of Lucama, N. C., led in prayer.

Rev. W. A. Hales introduced Tommy Steele, Evangelist, who led in prayer.

Rev. W. A. Hales introduced the speaker of the hour, Rev. A. L. Reynolds, who preached an inspiring message on the subject "God's Promises," using as a text II Peter 3:9, and other passages.

The congregation sung the hymn "In the Sweet Bye and Bye," after which we were dismissed with prayer by Rev. M. L. Johnson.

Lunch was served picnic style on the church lawn.

Worship services consisting of Hymn, Scripture, prayer and remarks were conducted by Rev. J. A. Alexander.

Business session re-assumed.

Re-calling of the list of churches.

Rev. L. B. Manning, chairman of the State Mission Board made a talk on missions urging that all churches and auxiliaries send their offerings for missions to Rev. J. W. Alford, Columbia, N. C., who is treasurer of the State Mission Board.

Rev. J. W. Alford made a brief report on the work of the Mission Board in North Carolina.

Rev. M. L. Johnson made a report on Superannuation and stressed the need of making offerings to retired and needy ministers in the month of October. He explained that 25% of all funds for this cause goes to Rev. Joe Fort who is national treasurer and is used to help pay retirement insurance to Ministers of our denomination. The other 75% is kept within the state and is used as a pension to all retired ministers in the state.

A solo by Mrs. Ruth Whipple, formerly of Elizabeth City, entitled "Some Day He'll Make It Plain To Me," was enjoyed by all.

Joseph Ange of the Fairmont Park church presented several of the young people of the church who made testimonies thanking the Lord for saving their souls from sin. Special music was given by the choir and a duet, "Have You Counted the Cost" was sung by two members of the church choir. Songs sung by the choir included "No Tears in Heaven," and "Anchored on the Rock."

A. L. Reynolds led in prayer.

Rev. W. A. Hales reviewed the crowded condition of the Norfolk church and urged every one to help the church build much needed Sunday School rooms. An offering was taken for this cause and \$88.55 was finally received.
