# Proceedings

The third annual session of the North Carolina Albemarle Conference of the original Free Will Baptist Church convened with Mt. Tabor Church near Creswell, N. C., October 8 and 9, 1947.

At 9:30 o'clock A. M., a worship service consisting of hymn, Scripture and prayer was conducted by Rev. R. P. Harris.

The Welcome Address was given by Mr. Isaac Furlough of the local church and Rev. J. W. Alford of Columbia gave the response.

The moderator, Rev. W. A. Hales, took charge of the meeting and made a few well-placed remarks concerning our work. He called attention to several phases of our work and urged us to use good judgment in all our deliberations. "Since this is the Lord's business, let us seek to honor Him in all that we do," stated Brother Hales.

A business session of the conference was called and the minutes of the last meeting were read and approved.

All delegates and preachers were given seats in the conference and all visiting delegates and preachers were recognized and given the privilege to speak. They were invited to sit with us during this session of the conference.

Rev. O. M. Hilburn, being a member of the Piedmont Association in good standing presented his letter asking for membership in this conference.

On motion Rev. O. M. Hilburn was received into the full fellowship of the conference.

On motion the report of the Executive Committee be adopted. See report.

Rev. H. Edgar Harden presented himself expressing a desire to become a member of the conference. On motion Rev. Harden was received into full fellowship of the conference.

Business session called off.

Rev. Herman Wooten, host Pastor, took charge and led the congregation in several selections. Rev. W. B. Nobles led in prayer and Rev. M. C. Roscholer of Norfolk, Va., brought the introductory message using as a text Hebrews 6:1-3. He brought to our hearts an appealing message on the subject of "On to Perfection."

The pastor, Rev. Wooten, then led the congregation in another hymn while an offering for the Orphanage amounting to \$22.64 was received. Dismissed for lunch with prayer. A delicious mid-day meal was served by the good ladies of the church and community.

### WEDNESDAY AFTERNOON

Worship services consisting of hymn, Scripture and prayer was conducted by Rev. W. M. Oliver.

Business session re-assumed.

On motion Rev. W. E. Richardson be excommunicated for departing our faith.

On motion Rev. W. M. Oliver be received as a licensed minister.

At the suggestion of our Moderator, business was suspended and Rev. M. L. Johnson, President of the State Convention, also Secretary-Treasurer of the State Superannuation Board, was introduced and given the privilege to speak concerning the work of the State Convention and that of the Superannuation Board.

On motion the report of the Credentials Committee be adopted which means that the First Free Will Baptist Church of Portsmouth, Virginia, becomes a member of our Conference.

On examination and consideration of certain papers and charges growing out of a dispute in the Elizabeth City Church involving Revs. W. A. Hales, R. P. Harris, R. C. Alexander, O. M. Hilburn, the Union Meeting and the Albemarle Conference, our Moderator, Rev. W. A. Hales, ruled all such matters out of order and recommended that all papers be destroyed immediately by the clerk of the Conference.

On motion the ruling of the Moderator be sustained.

On motion business be called off for the day.

The right hand of Christian felowship was extended to all new preachers coming into the conference, i. e. Rev. O. M. Hilburn, Rev. H. Edgar Harden, and Rev. W. M. Oliver.

Rev. Herman Wooten, host pastor, gave a hearty welcome to all delegates, preachers and visitors and invited them to spend the night in the community.

Adjournment with a hymn and prayer at 3:45 P. M.

### WEDNESDAY EVENING

Worship Services consisting of several spirited songs, prayer and Scripture reading was led by Rev. Herman Wooten. Rev. R. H. Mason led in prayer and Rev. A. L. Reynolds sang a solo entitled, "The Hem of His Garment," accompanied by Rev. R. P. Harris at the piano.

The Sound Side church then gave a Missionary Program consisting of Mission Hymns, readings, and talks. This was an inspiring program. Rev. J. W. Alford, Pastor of the Sound Side Church brought the Missionary Sermon with the same impressive and heart-stirring originality as becomes him in making gospel addresses.

An offering for missions amounting to \$17.18 was received at the close of the service.

## THURSDAY MORNING

The morning services opened at 9:00 with a Worship Service consisting of hymn, Scripture and prayer conducted by Rev. R. C. Ambrose.

Business session.

Minutes of yesterday's session were read and approved.

On motion the report of the Educational Board be adopted. See report.

On motion the clerk make copies of the report and mail one to each preacher, and church clerk within our conference.

On motion the report of the Mission Board be adopted. See report.

On motion the report of the Ordaining Council be adopted. See Report.

At this time Mr. Oscar Webster, President of the State League Convention, was given the privilege to speak in the interest of young people and their work in the state. He informed us that Miss Alethia Etheridge had been appointed League Field Worker and was ready to help organize Leagues anywhere within the state.

On motion the report of the Field Secretary be adopted.

Ordination Service—Rev. W. M. Oliver was duly ordained into the Gospel Ministry with Rev. W. A. Hales delivering the charge, Rev. R. P. Harris presenting the Bible and Rev. A. L. Reynolds offering the prayer.

The Conference sermon was delivered at the regular time by Rev. R. C. Alexander on the subject of "Evangelism." The "Go Ye" of the Gospel was emphasized and preached with fervor and power. Called off for lunch.

## THURSDAY AFTERNOON

Worship Services consisting of Hymn, Scripture and Prayer was conducted by Brother R. L. Spencer.

Rev. J. A. Evans, Superintendent of the Orphanage, gave us a very encouraging message concerning the Orphanage and its program for the year ahead.

Brother R. L. Spencer, recently elected to the Orphanage Board, made a few well-placed and timely remarks concerning the work of the Albemarle Conference for the Orphan Home.

On motion the report of the Sunday School Board be adopted.

On motion the report of the Resolution Committee be adopted.

On motion we accept the invitation to convene with Free Union Church in Beaufort County next year on Wednesday and Thursday before the second Sunday in October.

On motion we accept the report of the Finance Committee.

On motion we adopt the Treasurer's report.

Next on the program was a Round Table discussion for the good of the conference conducted by Rev. A. L. Reynolds.

On motion we extend a rising vote of thanks to this church and community for the very fine way they have entertained us during the sitting of this conference.

On motion we represent by letter to all other conferences in the state where no delegate was appointed. On motion we adjourn until the next session in October, 1948.

#### REPORT OF COMMITTEE ON EDUCATION

We, your committee on Education beg leave to make the following report:

1. Realizing the need for well trained and more efficient leadership, we recommend and urge this conference to support the F. W. B. College to its utmost capacity.

2. Realizing the important place of the laity of the Church, we urge every member of the laity to take advantage of every opportunity of learning more about the operations of a Church and a Church Conference in order that they may lend more assistance to the operation thereof, to the end that they may be operated more efficiently.

3. We urge substantial support for our Orphanage at Middlesex, making it possible for the unfortunate children to have equal educational opportunities with the more fortunate children.

4. We recommend to the Ordaining Council that they make and maintain a high standard of educational requirements for prospective Ministers. We make this observation: that in a day of enlightenment and cultural advantages the demand is great for Ministers who can present the Word of God in its simplicity and its power, and can present it in an intelligent manner.

5. It has been observed in this and other Conferences, Conventions and Associations that dissentions and disputes arise between individuals and groups of individuals and is very noticeable in the Ministerial ranks. These dissentions arise because of policies that are sometimes unsound and words and acts that are sometimes unchristian.

Inasmuch as the laymembers are the sheep of a flock and the Pastor the Shepherd of the flock, We urge every minister in our Church to use extreme caution, sound policies, good judgment, and set such examples before their flocks that the Church as a whole may be exalted to a higher level; that it may be cleansed of its impurities and selfishness and may be made fit to become the Bride of the Lord, Jesus Christ.

Whereas, a division was caused in the Cape Fear Conference in this state, many of the churches going away and into this said Holiness movement, and

Whereas, these who went away persist in calling themselves "Free Will Baptists," and even call their conference by the name of "Cape Fear Conference" to the confusion of our loyal people and the general public as well.

Whereas, these so-called "Free Will Baptists" are not a part of the original Free Will Baptists, nor can they even become members of the State Convention because of their doctrine and practices, therefore be it

Resolved:

1st. That we declare to the world at large our adherence to the doctrines, practices and ideals of the Original Free Will Baptist church.

2nd. That the Albemarle Conference this day place itself on record as condemning the attitude of these who went away for persisting in calling themselves by the name "Free Will Baptists," which is misleading and confusing to the world at large.

3rd. That we pledge our whole-hearted support to the Original Cape Fear Conference, and the North Carolina State Convention of the Original Free Will Baptists in any lawful effort they may make to have some distinction made in the name of these two different bodies, so as to save us and the public at large from the confusion we have experienced in the past. October 9th, 1947.

# CONSTITUTION OF ALBEMARLE CONFERENCE

Article 1. This shall be the Constitution of the Albemarle Conference of the original Free Will Baptist church of North Carolina.

Article 2. The object of the annual Conference shall be to promote Christ's Kingdom among men by means in strict conformity to the Holy Scriptures.

Article 3. This conference shall be composed of the ministers and delegates belonging to the body and from churches within the bounds of this conference district. The number of delegates being decided upon by the conference, shall represent their churches other organizations within the bounds of this conference.

Article 4. The delegates from each church shall bear to the conference a letter certifying their appointment, showing the condition and statistics of the church and giving a statement of all funds raised during the year for denominational or other benevolent purposes.

Article 5. The officers of this body shall be a moderator, a treasurer, corresponding and recording secretary, who shall be elected for a term of two years, and said election to take place one year prior to their entering upon the duties of said office.

Article 6. This conference may at each regular meeting, elect as many boards or standing committees as may be necessary in carrying out its benevolent purposes. These shall keep a record of their proceedings and make a report at each regular meeting of the conference.

Articl 7. Any church desiring to become a member of this body shall present her petition at a regular session of the conference, through delegates appointed for that purpose. If she be received, the moderator shall extend to her delegates the hand of fellowship.

Article 8. The conference may extend to visiting brethren all the privileges of the body, save that of voting.

Article 9. This constitution may be amended at any regular session by vote of four-fifths of the members present of the conference in session.

### BY-LAWS OF THE CONFERENCE

Article 1. A general conference shall be annually held.

Article 2. Every minister and delegate shall duly attend.

Article 3. If any member in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that conference.

Article 4. No member of the general conference shall be at liberty to withdraw without leave of the moderator.

Article 5. The conference shall always adjourn by vote.

Article 6. There shall annually be a committee of finance chosen to settle with the treasurer and report to conference.

Article 7. The officers and standing committees shall be entitled to vote in the annual conference.

Article 8. No minister or delegate shall, during the sitting of the general conference, be at liberty to fill any place, as to preaching or hearing at the stage, only as liberty shall be granted by the conference.

Article 9. Conference shall always open and adjourn by prayer and praise of God.

Article 10. The minutes of the conference shall be signed by the moderator and the clerk.
