



Proceedings

The ninth annual session of the Albemarle Conference of the Original Free Will Baptists of North Carolina convened with the Trinity Free Will Baptist Church in Beaufort County on October 7 and 8, 1953.

The devotions were conducted by Brother A. B. Chandler, pastor of the local church.

The welcome address was made by Brother C. S. Hyman of the local church, and the response was given by Brother R. C. Alexander.

The retiring moderator, Rev. A. B. Chandler, turned the session over to the incoming moderator, Rev. J. A. Alexander. The moderator made his address.

The minutes of the last session were read and approved. Brother A. M. Reynolds made a motion and Brother A. B. Chandler seconded it, that the record be changed to read, that the Board of Trustees was appointed for the Albemarle Conference and not for the Washington Church. A motion was made by Brother A. B. Chandler and carried that the minutes be approved before the Conference adjourned.

On motion the roll of the ministers was called and the following answered to the call: R. C. Alexander, T. F. Davenport, L. E. Ambrose, R. C. Ambrose, J. A. Alexander, A. B. Chandler, and C. W. Overton.

Licensed ministers present were W. A. Woolard and W. M. Tweedy.

The visiting ministers were recognized as follows: Ralph Osborn, C. H. Overman, S. A. Smith, D. W. Alexander, J. W. Alford, Roland Creech, W. B. Raper, Herman Wooten, and T. C. Smith.

Brother J. Albert Harris was present and asked to become a member of the Albemarle Conference. Brother A. B. Chandler made a motion and was carried that the Conference accept Brother Harris as a member.

Brother Walter Reynolds brought his letter of recommendation from the Cape Fear Conference to become a member of the Albemarle Conference. Brother A. B. Chandler made a motion to accept Brother Reynolds as a member and it was carried.

Brother S. A. Smith, Superintendent of the Orphanage, made a verbal report and all churches were urged to meet their quota on the Girls' Dormitory. There was a motion made by Brother Chandler to accept this report as information and it was carried.

At this time an offering was taken for the Orphanage in the amount of \$66.19.

The moderator appointed the following named brethren as the Finance Committee: David Furlough, Alton Reynolds, and W. A. Willoughby.

On motion the roll of churches was called (see table).

Brother L. A. Ambrose presented the Plymouth Church to the Conference for membership. Brother A. B. Chandler made a motion that the Plymouth Church be accepted as a member of the Conference; the motion was carried.

At this time the congregation was lead in a song, "I Am Thine O Lord," by Brother J. Albert Harris.

Brother Walter Reynolds brought the introductory sermon, after which we recessed for lunch.

WEDNESDAY AFTERNOON

A very delicious lunch was served by the ladies of the local church, after which we reassembled for the afternoon session.

Brother T. F. Davenport was in charge of the devotions consisting of Scripture reading, song, and prayer.

Brother Tom West gave the Conference a report of the Plymouth Church. The church has 26 members on roll and has on a building program. He appealed to the people to help in any way they can for the success of this program.

Brother W. B. Raper brought greetings from the State Convention and a verbal report of the same. He urged each church to report to the State Convention and send their pastors to the National Association. Brother Chandler made a motion to accept this as information.

A motion was made by Brother Chandler that the Ladies Auxiliary send their minutes to clerk by November 15, and it was carried.

The clerk, H. P. Swain, rendered his resignation at this time, and a motion was made and carried that it be accepted. Brother J. Albert Harris and Brother Walter Reynolds were nominated. Brother Harris was duly elected as clerk.

Rev. David Hansley was recognized by the moderator at this time and he discussed Christian Education. He reported that 14 students registered at the Mount Allen Junior College during the year 1953. The Board of Directors have purchased a site for the Junior College at Mount Olive, North Carolina. The initial cost is \$25,000, and have paid \$4,000 down on the property. Brother Chandler made a motion that we receive the report as information and that we pledge our prayers and support to this plan for a school.

A motion was made by Brother Chandler that the body authorize the Mission Board to appoint a treasurer to handle the money sent in to the Conference for Missions Funds; the motion was carried.

Sister Roper resigned from the Mission Board and Brother L. A. Ambrose was duly elected to fill her place.

THURSDAY-10:00 A. M.

The Conference was opened at the appointed hour with Brother L. A. Ambrose leading the devotions.

The moderator declared the Conference ready for business.

Brother Walter Reynolds was appointed to replace W. T. Reynolds on the Resolutions Committee by the moderator.

Brother C. H. Overman was presented by Brother Chandler for membership to the Albemarle Conference. His letter was rendered from the Western Conference.

The discussion was brought up about Brother J. Albert Harris serving as clerk

and his living out of the state. Brother Walter Reynolds made a motion to table this matter; the motion was carried.

A motion was made by Brother Chandler that the Albemarle Conference go on record as pledging our loyal support and legions to the Plymouth Church; motion was carried.

REPORT OF STANDING COMMITTEES

Executive Board

The Executive Board reported that a Free Will Baptist Church has been organized in Plymouth, North Carolina, and that the necessary officers have been appointed. Brother Herman Wooten is the pastor. This report was adopted.

Ordaining Council

The Ordaining Council reported their meeting in Elizabeth City, North Carolina, to examine Rev. Willie Tweedy for ordination. Finding him eligible, they proceeded to ordain him at the Gethsemane Church. Rev. W. T. Reynolds served in the place of Brother A. B. Chandler.

CONSTITUTION OF ALBEMARLE CONFERENCE

Article 1—This shall be the Constitution of the Albemarle Conference of the Original Free Will Baptist Church of North Carolina.

Article 2—The object of the annual Conference shall be to promote Christ's Kingdom among men by means in strict conformity to the Holy Scriptures.

Article 3a—This Conference shall be composed of the ministers and delegates belonging to the body and from churches within the bounds of this Conference district. The number of delegates being decided upon by the Conference, shall represent their churches and other organizations within the bounds of this Conference.

Article 3b—This Conference shall hold its Annual Sessions on Wednesday and Thursday before the second Sunday in October of each year.

Article 4—The delegates from each church shall bear to the Conference a letter certifying their appointment, showing the condition and statistics of the church and giving a statement of all funds raised during the year for denominational or other benevolent purposes.

Article 5—The officers of this body shall be a moderator, an assistant moderator, treasurer, corresponding and recording secretary, and a field secretary, who shall be elected for a term of two years, and said election to take place one year prior to their entering upon duties of said office.

Article 6—This Conference may at each regular meeting, elect as many boards or standing committees as may be necessary in carrying out its benevolent purposes. These shall keep a record of their proceedings and make a report at each regular meeting of the Conference.

Article 7—Any church desiring to become a member of this body shall present her petition at a regular session of the Conference, through delegates appointed for that purpose. If she be received, the moderator shall extend to her delegates the hand of fellowship.

Article 8-The Conference may extend to visiting brethren all the privileges of the body, save that of voting.

Article 9—This constitution may be amended at any regular session of the Conference by vote of four-fifths of the members present.

Article 10—No minister shall be ordained by the Ordaining Council of this Conference unless he has been licensed by his church for a period of one year, has retained his membership in the same church, and has come before the Ordaining Council by recommendation of the church by which he was licensed.

BY-LAWS OF THE CONFERENCE

Article 1-A general Conference shall be annually held.

Article 2-Every minister and delegate shall duly attend.

Article 3—If any member in the judgment of the Conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that Conference.

Article 4-No member of the general Conference shall be at liberty to withdraw without leave of the moderator. Article 5-The Conference shall always adjourn by vote.

Article 6—There shall annually be a committee of finance chosen to settle with the treasurer and report to Conference.

Article 7—The officers and standing committees shall be entitled to vote in the annual Conference.

Article 8—No minister or delegate shall, during the sitting of the general Conference, be at liberty to fill any place, as to preaching or hearing at the stage, only as liberty shall be granted by the Conference.

Article 9—Conference shall always open and adjourn by prayer and praise to God.

Article 10—The minutes of the Conference shall be signed by the moderator and the clerk.
