## Proceedings

The eleventh annual session of the Albemarle Conference of the Original Free Will Baptists of North Carolina convened with the First Free Will Baptist Church, Portsmouth, Virginia, on October 5 and 6, 1955.

#### WEDNESDAY MORNING, 9:30 A. M.

The ministers and pastors of the Albemarle Conference met in an organizational meeting at which time Rev. Walter Reynolds was elected president of the group. The plans of the ministerial conference included a semi-annual meeting in April of 1956, at the Belhaven Free Will Baptist Church.

#### WEDNESDAY MORNING, 10:30 A. M.

The devotions were conducted by Rev. L. E. Ambrose.

The welcome address was given by Mr. F. O. Whitehurst, a member of the local church; the response was given by Mr. Winfred Brickhouse.

In the absence of the moderator, who was ill in the hospital, Rev. Walter Reynolds was elected to serve in his place.

By motion Revs. P. C. Wiggs and Ralph Osborne were received as members of the Albemarle Conference pending their letters from the Central Conference.

On motion that Revs. P. C. Wiggs and Ralph Osborne be granted all the rights and privileges of a member in good standing during this session of the Albemarle Conference. Motion carried.

We were then led in congregational singing by the moderator of the conference.

The introductory sermon was delivered by the Rev. T. O. Terry.

We were dismissed with prayer for lunch.

#### WEDNESDAY AFTERNOON, 1:00 P. M.

After a very delicious lunch, which was served by the ladies of the local church, we reassembled for the afternoon session.

The afternoon devotions were led by the Rev. Ralph Osborne.

The president of the State Convention, Rev. D. W. Alexander, brought greetings from the convention. He also presented some important matters for adoption by the conference.

The first matter was the revision of the North Carolina Treatise. By motion the revised North Carolina Treatise was adopted.

The second item was a resolution which was passed by the State Convention asking that the church fiscal year be changed from what it is now to begin on September 1, and go through August 31. By motion this was adopted.

The third item was the uniform examination for ministers. By motion this item was adopted.

Mr. L. A. Dunn, business manager of the Free Will Baptist Press, Ayden, North Carolina, brought greetings from the press.

A suggestion from Rev. D. W. Alexander relative to raising the standards of the ministry was referred to the board of ordination.

The report of the Albemarle Union was given. (See reports.)

The report of the League Union was given. (See reports.)

Rev. Walter Reynolds gave a report of the State Convention. This report was received as information.

# Report of Standing Boards and Committees

The board of education made no report.

On motion we include the report of the board of ordination in the minutes as soon as Rev. J. A. Alexander is able to make it. Motion carried. (See reports.)

The board of missions made its report to the conference. (See reports.)

On motion that someone be elected to serve in Rev. R. C. Alxander's place as assistant moderator since his health has caused him to retire from active ministry. Motion carried. The nominating committee gave its report. (See reports.)

The convention sermon was preached by Rev. P. C. Wiggs.

Rev. James A. Evans, representing the boundary line committee of the state mission board, presented the proposed boundary lines for the Albemarle Conference.

By motion the boundary lines, as outlined by the boundary line committee, was adopted.

The following resolution was presented from the floor of the conference:

Be it resolved that the Albemarle Conference go on record as asking the state executive committee to approve a resolution asking each conference or association in the State Convention to refuse to admit any church to become a member of their conference or association that is within the boundary of another conference or association; except in the forming of a new conference or association within the boundary of an established conference or association.

This resolution was adopted.

The treasurer gave his report. (See reports.)

By motion that part of the executive committee's report that had to do with the constitutional change was taken off the table.

On motion that this recommended constitutional change be adopted and become a part of the constitution. Motion carried.

On motion that the conference pay the moderator \$15.00 at each annual session of the conference for his services. Motion carried.

By motion the responsibility of placing the 1956 session of the Albemarle Conference was left to the executive committee.

# Constitution of Albemarle Conference

### ARTICLE I

#### Section 1-Name

This organization shall be known as the Albemarle Conference of the Original Free Will Baptists of North Carolina.

#### Section 2-Purpose

The general purpose of this conference shall be to promote the great cause of Christ among men by means in strict conformity to the Holy Scriptures.

#### ARTICLE II

#### Section 1-Composition

This conference shall be composed of the ordained and licensed ministers who are members of churches that belong to the conference, all general officers of the conference, the members of standing boards or committees, the president or moderator of each subordinate general organization and the churches that hold their membership with the conference, together with those that may subsequently be admitted.

#### Section 2-Representation

Every church affiliated with the Albemarle Conference shall represent in its annual session with two delegates, and each subordinate general organization shall represent with one delegate. A report from each church and subordinate organization shall be rendered at the annual session of the conference.

#### ARTICLE III

#### Officers

The officers of this conference shall be a moderator, an assistant moderator, a secretary, an assistant secretary and a treasurer, each of whom shall be elected for a term of two years. The term of office for all officers shall begin at the close of the annual session at which they are elected.

Temporary officers, representatives or messengers may be elected at the option of the conference for whatever purpose deemed essential.

#### ARTICLE IV

#### **Standing Boards and Committees**

It shall be the method of this conference to simplify its work by the assignment of specific work to representative units of authority which shall hereafter be known as standing boards and committees.

A board of trustees, a board of education and a board of ordination consisting of three (3) members each shall be elected. The term of office for members of these boards shall be three years but shall be so adjusted as to terminate the office of one member annually.

A board of missions, consisting of five members, shall be elected. The term of office for members of this board shall be five years, but shall be adjusted as to terminate the office of one member annually.

#### Section 1

Standing boards shall have authority to write their own bylaws and administer their respective programs of work, but each shall remain subject to the authority and approval of the conference.

### Section 2

The executive committee shall be composed of the general officers of the conference and the moderator or president of each subordinate general organization.

#### Section 3

Temporary committees shall be appointed at the option of the conference for whatever purpose deemed necessary.

### ARTICLE V

#### Finance

Each church shall contribute to the conference program according to its membership.

Conference funds shall be used for the work and general expense of the conference. The use of all funds to be approved by the conference.

#### ARTICLE VI

#### Admission of Churches

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Free Will Baptists and desires to help promote the program and work of the Albemarle Conference may submit its petition for membership through an official delegation at any annual session of the conference. If the petition for membership be approved, the moderator shall extend the hand of fellowship to the delegates and declare them duly seated.

#### ARTICLE VII

#### Fraternal Delegations and Visitors

Fraternal delegations and visitors shall be extended all the privileges of the conference except that of voting, serving on committees or holding elective of-fices.

#### ARTICLE VIII

#### Meetings

The Albemarle Conference shall meet in annual session on Wednesday and Thursday before the second Sunday in October of each year. The host church shall be selected by vote of the conference in annual session or by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

#### BYLAWS

#### Section 1

The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Albemarle Conference; to appoint temporary committees, delegates and representatives; to serve as exofficio member of all standing boards and subordinate general organizations; to sign official documents that require the signature of the moderator.

#### Section 2

The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and assist the moderator when called upon.

#### Section 3

The secretary shall record the proceedings of all sessions of the Albemarle Conference and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require his signature.

#### Section 4

The duties of the assistant secretary shall be the duties of the recording secretary when that officer is not present and to assist the secretary when called upon.

#### Section 5

The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

#### Section 6

The executive committee shall have power to act in the behalf of and for the Albemarle Conference from one regular session to another. It shall organize at will and discharge the administrative duties assigned to it. It shall plan the programs of the conference. The executive committee shall meet not less than two times between the annual sessions of the conference.

#### Section 7

The board of trustees shall hold title to all property belonging to this conference. It shall have power to convey such property when authorized by the conference.

#### Section 8

The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: obituary, temperance, resolutions, nominating and finance.

#### Section 9

All reports, resolutions and recommendations shall be considered properly presented to the conference in written form only.
