REPORT OF I'HE BOARD OF ORDINATION AND MINISTERIAL CHARACTER COMMITTEE TO THE ALBEMARLE CONFERENCE IN SESSION OCTOBER 5, 1961

We report as follows:

The board has held three official meetings during the year and has taken care of the following business of the conference:

The board met at the Plymouth Church on January 27, 1961. Brother

Winiford Brickhouse came before us for examination for ordination. He was given full examination resulting that he did not pass written examination for ordination.

Motion passed that the board recommend further preparation and study for Brother Brickhouse and that we further recommend that a copy of our recommendation be forwarded to Brother Brickhouse and to the Sound Side Free Will Baptist Church of which he is a member.

Brother Richard Ambrose came before us with recommendation from Mount Tabor Church that he be reinstated as a licensed minister. Motion was passed after considerable discussion with the applicant that he not be licensed at this time due to his unstable background as a former Free Will Baptist minister; however, we give him privilege to come back before us for re-examination at a later date after he has proven himself stable in the faith.

Motion passed to adjourn.

The board met at the Plymouth Church April 5, 1961. Business was transacted as follows:

Motion passed to give Brother M. E. Cox examination for qualifications for ordination pending ordination with approval by the executive board, ordination board and or the conference.

Motion passed that the board of ordination will not consider any request for approval for license for a minister unless he has been a member of the church requesting license for at least one year prior recommendation from said church.

Motion passed that Brother M. E. Cox be licensed for another year beginning April 17, 1961 to April 17, 1962.

Motion passed to adjourn.

Ordination board met July 25, 1961, at Simp's Cafe near Sound Bridge in Washington County. Several applicants came before us with recommendation for license by their churches. They were examined according to customary practice and procedure, after which motions were passed as follows:

Motion passed to recommend Brother Neil Hearn for license for one year by Malachi's Chapel Free Will Baptist Church.

Motion passed that we recommend Brother James Noah Webster for full-time Christian work. Brother Webster stated that he felt called to the ministry but due to age and in order to be sure of his calling, taking into consideration the seriousness of the call, he did not desire to commit himself to the ministry at this time. The board asked Brother Webster to come back before us at any time for further commitment and examination for the ministry.

Motion passed that pending letter of confirmation from the Plymouth Church that we recommend Brother Wayne West to be licensed to the ministry for one year by the Plymouth Church.

Motion to adjourn.

A motion was carried to accept report of the executive committee.

The executive committee met at Union Chapel Church, R. F. D., Plymouth, North Carolina, December 2, 1960. Present were: Rev. Charlie Overton, Rev. Johnny Eason, Rev. Allen Bryan, Mr. Isaac Furlough, and Mr. Oscar Webster.

Rev. Allen Bryan read the Scripture and Rev. Johnny Eason prayed.

The matter of the National Association meeting annually or every two years was taken up. Motion carried to support action to meet annually.

Motion carried to attend special session of the Executive Committee of the North Carolina State Convention of Original Free Will Baptists to be held in Ayden, January 3, 1961.

Oscar Webster, Willard Early, and Harry Swain were named as delegates to the National Association.

A motion was carried to accept Mizpah Free Will Baptist Church into the Albemarle Conference subject to approval of conference. The action was taken at the request of Mizpah Church and on permission of the Central Conference.

The executive committee met at Plymouth Church May 23, 1961, with their pastor, the Rev. Owen Ganey, in its regular quarterly meeting. The meeting was called to order by the pastor who also presided over the meeting. Reports were given by the different officers.

The main issue of business was a motion made and passed that Brother Ganey turn in his resignation as pastor to become effective in 90 days; this he agreed to do. Respectfully submitted,

2. Whereas communism is making great strides to encompass the world with its atheistic teachings and influences, and

Whereas it seeks to infiltrate every American institution whether political, social, educational, economical, religious, secular, and/or any other with its hellish lies and un-American activities, and

Whereas Free Will Baptists are not immune to the possibility of such infiltration, be it therefore resolved that (1) The Albemarle Conference go on record as standing openly against any and all communistic practices or tendencies in our beloved country, denomination and local churches, and

(2) Be it further resolved that we stand solid in opposition to the employment of any individual who is or ever has been associated with any communistic organization, by any of our institutions,

(3) Be it also resolved that a copy of this resolution be sent to our periodicals for publication

3. Whereas there is much unrest in the state of North Carolina regarding the matter of church government, and

Whereas there is a difference of interpretation regarding the North Carolina treatise on the extent of the authority the conference has over the local church, and

Whereas the National Association of Free Will Baptists has reaffirmed its historic stand on congregational church government, and

Whereas so many boards, committees, and churches are expressing themselves in these matters,

Therefore be it resolved (1) That we reaffirm our historic position on congregational church government.

(2) That we adopt our statement of reaffirmation passed by the National Association when in session in Norfolk, Va., in July of 1961.

(3) That we reaffirm our loyalty to and co-operation with the National Association of Free Will Baptist.

(4) That a copy of this resolution be sent to our periodicals for publication.

## Rev. Johnny Eason

4. In as much as each church petitioning the Albemarle Conference of Original Free Will Baptists and upon being duly received into same becomes a part of said conference.

And in as much as each church in good standing with the conference becomes a vital part, through its duly elected delegates, in the operation of the conference. Also recognizing that each church in its operation, management and affairs, however, independent, becomes an asset or liability to the operation, prestige and respectfulness of the conference as a whole. We also recognize that the conference is made up of duly elected delegates, officers and ministers of said churches in good and regular standing in the conference.

And in as much as each minister, petitioning said conference and being duly received as such is under the watch care of and is a part of said conference. Recognizing that each minister in good standing with the conference becomes a vital part in the operation of the conference. Also, that each minister embraced, received into fellowship or endorsed by the conference becomes an asset or liability to the operation, prestige, fundamental operation and respectfulness of all the churches and the conference, as it relates to Free Will Baptists.

And in as much as it is general and publicized information that two of our church have taken action or through church officials have persuaded their duly elected pastor to resign or terminate his service before his term expired, the cause being by reason of certain defamitory rumors which tend to discredit the integrity and Christian character of their pastor.

And in as much as said charges are of such serious nature until they could wreck a minister's future career and also because they are of such serious nature until complications arising from same has caused unrest and uncertainty in the operation of said churches and also in the relationship and standing of one of our brother ministers who is in good standing in the conference.

Therefore be it resolved: (1) That the Albemarle Conference through its executive and ordination boards proceed with a thorough, impartial and unprejudiced investigation, with the facts at hand, as to the reliability or defamatory nature of said rumored charges.

(2) That the executive and ordination boards determine to the best of their ability, after carefully and prayerfully being engaged, whether the former pastor of the two churches involved was persuaded or asked to terminate his services with them without the true facts at hand or in any way which would be an unwarranted liability to the ministerial profession as it relates to their former pastor.

(3) That when the true facts are known; if known, and conclusions reached, after thorough investigation, that the executive board and ordination board be empowered to deal with the case and make final distribution of same.

(4) That in case of the innocence of said parties and churches, that the executive and ordination boards make a formal statement in as much as they feel it necessary to protect the innocence of persons and churches involved.

(5) That under God and in the spirit of tolerance and Christian respect we request each member of the above mentioned boards to feel it his duty to labor for the common cause of Christ in clearing up this serious matter which could have far and lasting effects upon the Free Will Baptists churches of this area and the denomination at large.

## Constitution of Albemarle Conference

## ARTICLE I

Section 1—Name

This organization shall be known as the Albemarle Conference of the Original Free Will Baptists of North Carolina.

#### Section 2—Purpose

The general purpose of this conference shall be to promote the great cause of Christ among men by means in conformity to the Holy Scriptures.

## ARTICLE II

## Section 1—Composition

This conference shall be composed of the ordained and licensed ministers who are members of churches that belong to the conference, all general officers of the conference, the members of standing boards or committees, the president or moderator of each subordinate general organization and the churches that hold their membership with the conference, together with those that may subsequently be admitted.

#### Section 2—Representation

Every church affiliated with the Albemarle Conference shall represent in its annual session with two delegates, and each subordinate general organization shall represent with one delegate. A report from each church and subordinate organization shall be rendered at the annual session of the conference.

## ARTICLE III

## Officers

The officers of this conference shall be a moderator, an assistant moderator, a secretary, an assistant secretary and a treasurer, each of whom shall be elected for a term of two years. The term of office for all officers shall begin at the close of the annual session at which they are elected.

Temporary officers, representatives or messengers may be elected at the option of the conference for whatever purpose deemed essential.

## ARTICLE IV

## STANDING BOARDS AND COMMITTEES

It shall be the method of this conference to simplify its work by the assignment of specific work to representative units of authority which shall hereafter be known as standing boards and committees.

A board of trustees, a board of education and a board of ordination consisting of three (3) members each shall be elected. The term of office for members of these boards shall be three years but shall be as adjusted as to terminate the office of one member annually.

A board of missions, consisting of five members shall be elected. The

term of office for member of this board shall be five years, but shall be adjusted to terminate the office of one member annually.

## Section 1

Standing boards shall have authority to write their own bylaws and administer their respective programs of work, but each shall remain subject to the authority and approval of the conference.

#### Section 2

The executive committee shall be composed of the general officers of the conference and the moderator or president of each subordinate general organization.

## Section 3

Temporary committees shall be appointed at the option of the conference for whatever deemed necessary.

## ARTICLE V

#### FINANCE

Each church shall contribute to the conference program according to its membership.

Conference funds shall be used for the work and general expense of the conference. The use of all funds to be approved by the conference.

## ARTICLE VI

#### Admission of Churches

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Free Will Baptists and desires to help promote the program and work of the Albemarle Conference may submit its petition for membership through an official delegation at any annual session of the conference. If the petition for membership be approved, the moderator shall extend the hand of fellowship to the delegates and declare them duly seated.

## ARTICLE VII

## FRATERNAL DELEGATIONS AND VISITORS

Fraternal delegations and visitors shall be extended all the privileges of the conference except that of voting, serving on committees or holding elective offices.

## ARTICLE VIII

## MEETINGS

The Albemarle Conference shall meet in annual session on Thursday before the second Sunday in October of each year. The host church shall be selected by vote of the conference in annual session or by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

#### BYLAWS

#### Section 1

The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Albemarle Conference; to appoint temporary committees, delegates and representatives; to serve as exofficio member of all standing boards and subordinate general organizations, to sign official documents that require the signature of the moderator.

## Section 2

The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and assist the moderator when called upon.

#### SECTION 3

The secretary shall record the proceedings of all sessions of the Albemarle Conference and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require his signature.

### Section 4

The duties of the assistant secretary shall be the duties of the recording secretary when that officer is not present and to assist the secretary when called upon.

#### Section 5

The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

#### Section 6

The executive committee shall have power to act in the behalf of and for the Albemarle Conference from one regular session to another. It shall organize at will and discharge the administrative duties assigned to it. It shall plan the programs of the conference. The executive committee shall meet as often as necessary for the good of the conference.

#### Section 7

The board of trustees shall hold title to all property belonging to this conference. It shall have power to convey such property when authorized by the conference.

#### Section 8

The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: obituary, temperance, resolutions, nominating and finance.

#### Section 9

All reports, resolutions and recommendations shall be considered properly presented to the conference in written form only,

#### Section 10

No minister, officer or delegate shall be at liberty to retire from the building during a session of the conference without the consent of the moderator.

## Section 11

If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his rights during the remaining part of that session of the conference.

## Section 12

This constitution and bylaws may be altered or amended by a twothird favorable vote of the members present in a regular session. All amendments shall be on the table not less than three hours prior to adoption and shall, during that time, be read at least one time.

A REMINDER: Every 20 sessions of the conference minutes shall be bound together into a book for the permanent records of the conference.
