

PROCEEDINGS

The twenty-sixth annual session of the Albemarle Conference of Original Free Will Baptists of North Carolina convened with the Virginia Beach Church, 210 South Witchduck Road, Virginia Beach, Virginia, October 8, 1970.

THURSDAY MORNING, 9:30 A. M.

Devotions were conducted by Rev. Charlie Overton, followed with the song, "Have Thine Own Way, Lord," by the congregation. Brother Overton read for his Scripture Amos 3:1-3. Prayer was offered by Rev. Robert Norville.

The welcome was given by Rev. Fred A. Rivenbark, pastor of the host church.

The response to the welcome was given by Mr. Isaac Furlough.

The conference was opened for business by the secretary, Mr. Oscar Webster.

A motion was made and carried to adopt the printed program as the order of business.

The list of churches was called with thirteen (13) churches reporting

by letter of delegate.

The moderator, Rev. Robert May, stated that Rev. John Owens, pastor of St. Paul Church, was seriously ill and in the hospital. He urged that we all pray for Brother Owens.

The list of ministers was called with five (5) present.

The five visiting ministers were recognized at this time, they were: Revs. Walter Reynolds and Larry Barbour, Cape Fear Conference; Revs. Robert Norville and Edward Miles, Central Conference; and Rev. Joseph Ingram, Western Conference.

The report of the Board of Ordination was given by Rev. Charlie Overton. A motion was made and carried to adopt the report. (See report.)

The report of the Executive Committee was given by Mr. Oscar Webster, conference secretary. A motion was made and carried to adopt the report. (See report.)

A motion was made and carried to enroll Rev. Larry Barbour with our list of ministers pending a letter of transfer from his present conference. (A letter of transfer has been received for Brother Barbour.)

An offering was taken for the general fund of the conference. The of-

fertory prayer was by Rev. Joseph Ingram.

Rev. Edward Miles, superintendent of the Free Will Baptist Children's Home, gave a report of the ministry of the Home. A motion was made and

carried to receive the report as information. (See report.)

The business of the conference was called off for the worship service.

A solo was sung by Mrs. Peggy Brickhouse, "I Ask the Lord." The conference sermon was delivered by Rev. Walter Reynolds. Brother Reynolds read for a Scripture text Amos 6:1-8. His subject was, "At Ease in

Zion."

The benediction was prayed by Rev. Fred A. Rivenbark.

THURSDAY AFTERNOON, 1:00 P.M.

The afternoon devotions were conducted by Mrs. Laura C. Webster. The congregation sang "Amazing Grace." Sister Webster used for a Scripture lesson Psalm 23, closing the devotions with prayer.

REPORT OF STATE MISSION BOARD

We bring you greetings from your State Mission Board to the people and churches of the Albemarle Conference.

It is with our most heartfelt gratitude that we make this report to you. Through your generous giving we have seen the best year of support in our history. Our total income for the year was \$79,105.80. Also, at the Mission Rally at the State Convention, a total of \$7,925.84 was given. Because of your concern for the lost and willingness to share the gospel, we have been able to accomplish a great deal for our Lord.

The Free Will Baptist Bible Institute now is in its second year of operation. It is still on a part-time schedule, but is fulfilling a great need in our church mission program. It now is property of Free Will Baptists. You made this possible through your offerings last January. Involved in the institute, we now have seven native Mexican pastors that are full time in the work of Christ in Mexico. Rev. J. E. Timmons is serving our church and Christ in a great way. Also, this past September, the Mission Board purchased a 12-passenger van bus and it is now in operation there in the Texas-Mexico work.

Rev. and Mrs. Joe Barrow are laboring in Biriiri, Rhodesia. Joe is teaching there in the school, but in December plans are for them to move to Chiredzi, Rhodesia. Here, Joe will be in full-time evangelism. Joe and Faye received a blessing from God on the fifth of August in the birth of their second child. The name of the child is Sharon Frances Barrow. Please continue to pray for and support the Barrows.

Rev. and Mrs. Harold Jones went to the Philippines during this past year, and are doing a great work for God in this location. Harold has now assumed a greater responsibility in that one of the General Baptist missionaries is at home on leave, and another one of the General Baptist missionaries is at home for an operation on his back. This only leaves Harold and one other missionary at the Bible College, along with the native workers. I am sure the load is heavy, but God has a man there in Harold Jones capable of carrying this load. Sandra is teaching Bible in the public schools in Davao City. Please pray for these workers also. Your support is needed to keep them on the field.

We ask that you continue to pray that God will call laborers for the field of labor that He has for Free Will Baptists. There are so many opportunities and yet so few that are willing to share in the labor. I do hope that each of you will encourage your church to share in the gospel of Christ to others by supporting your North Carolina Free Will Baptist Board with

your prayers and your financial support.

REPORT OF MOUNT OLIVE COLLEGE

Mount Olive College has entered a new era of development and educational services to both its students and the Free Will Baptist Church. We appreciate the prayers and financial support of our friends who have made this growth possible and we are pleased to share with you a brief summary of our programs and services.

I. NEW PROGRAMS

1. Individualized Instruction. Through a program of written and oral instruction which permits a student to proceed according to his own rate of learning we are seeking to improve the effectiveness of teaching on our campus. Our ultimate goal is to produce graduates who are educationally successful and to eliminate academic failure at Mount Olive College.

2. Cooperative Education. Mount Olive has become the "flagship" college in North Carolina for a program which provides for students alternating work and study experiences. "Coop" permits a student to examine his employment goals in the context of a work experience while still enrolled as a student and at the same time affords him an opportunity to largely finance

his education through his own earnings.

3. Nursing Education. Mount Olive now offers the first two years of study leading toward a Bachelor of Science degree in Nursing.

4. Music. Students who wish to major in music may now take their

first two years at Mount Olive.

5. Church-College Scholarships. Under this program the College will give a student a scholarship equal to one half the cost of tuition if his home church will give the other half. Other financial assistance is also available for qualified students who apply early.

II. OTHER INFORMATION

CHURCH-COLLEGE SCHOLARSHIPS FOR FREE WILL BAPTIST STUDENTS

ATTENDING MOUNT OLIVE COLLEGE

In order to make it possible for more Free Will Baptist students to attend Mount Olive College, the Board of Trustees has inaugurated a special scholarship program which may cover the full amount of *tuition* a student must pay each academic year. The program is on a voluntary basis for those

churches which wish to participate.

To qualify, a student must present at the time of his registration, or the church must send in advance, a check signed by the treasurer with the specification that the check is for a scholarship for the student named. The College will then provide an equal amount, up to \$125 per semester, as a scholarship. Since there are two semesters in an academic year, one beginning in September and another in February, a student may receive up to \$250 from his church and another \$250 from the College for a total of \$500 under this program.

Gifts sent to the College for this purpose will not be listed toward meeting the "Challenge" assigned that church for the College, but will be

recorded as "Restricted Income for Church-College Scholarships."

It is understood that the College may use its own funds or any funds administered by it in matching the scholarship from the church; and further, that if the student qualifies for a scholarship already provided by the College, that scholarship shall be considered as fulfilling the College's matching responsibility. In addition, it is understood that the College retains the right to determine the student's academic eligibility for admission and/or continuation in college quite apart from the matching scholarship.

It is the hope of the College that this program will encourage and help

make it possible for more Free Will Baptist students to attend Mount Olive College, which is the only institution of higher education sponsored by the Free Will Baptists of North Carolina.

Constitution of Albemarle Conference

ARTICLE I

SECTION 1-NAME

This organization shall be known as the Albemarle Conference of the Original Free Will Baptists of North Carolina.

Section 2—Purpose

The general purpose of this conference shall be to promote the great cause of Christ among men by means in conformity to the Holy Scriptures.

ARTICLE II

Section 1—Composition

This conference shall be composed of the ordained and licensed ministers who are members of churches that belong to the conference, all general officers of the conference, the members of standing boards or committees, the president or moderator of each surbordinate general organization and the churches that hold their membership with the conference, together with those that may subsequently be admitted.

SECTION 2—REPRESENTATION

Every church affiliated with the Albemarle Conference shall represent in its annual session with two delegates, and each surbordinate general organization shall represent with one delegate. A report from each church and subordinate organization shall be rendered at the annual session of the conference.

ARTICLE III

OFFICERS

The officers of this conference shall be a moderator, an assistant moderator, a secretary, an assistant secretary and a treasurer, each of whom shall be elected for a term of two years. The term of office for all officers shall begin at the close of the annual session at which they are elected.

Temporary officers, representatives or messengers may be elected at the

option of the conference for whatever purpose deemed essential.

ARTICLE IV

STANDING BOARDS AND COMMITTEES

It shall be the method of this conference to simplify its works by the assignment of specific work to representative units of authority which shall

hereafter be known as standing boards and committees.

A board of trustees, a board of education and a board of ordination consisting of three (3) members each shall be elected. The term of office for members of these boards shall be three years but shall be so adjusted as to terminate the office of one member annually.

A board of missions, consisting of five members shall be elected. The term of office for member of this board shall be five years, but shall be ad-

justed to terminate the office of one member annually.

SECTION 1

Standing boards shall have authority to write their own bylaws and

administer their respective programs of works, but each shall remain subject to the authority and approval of the conference.

Section 2

The executive committee shall be composed of the general officers of the conference and the moderator or president of each subordinate general organization.

Section 3

Temporary committees shall be appointed at the option of the conference for whatever deemed necessary.

ARTICLE V

FINANCE

Each church shall contribute to the conference program according to its membership.

Conference funds shall be used for the work and general expense of the conference. The used of all funds to be approved by the conference.

ARTICLE VI

Admission of Churches

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Free Will Baptists and desires to help promote the program and work of the Albemarle Conference may submit its petition for membership through an official delegation at any annual session of the conference. If the petition for membership be approved, the moderator shall extend the hand of fellowship to the delegates and declare them duly seated.

ARTICLE VII

FRATERNAL DELEGATIONS AND VISITORS

Fraternal delegations and visitors shall be extended all the privileges of the conference except that of voting, serving on committees or holding elective offices.

ARTICLE VIII

MEETINGS

The Albemarle Conference shall meet in annual session on Wednesday before the second Sunday in October of each year. The host church shall be selected by vote of the conference in annual session by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

BYLAWS

SECTION 1

The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Albemarle Conference; to appoint temporary committees, delegates and representatives; to serve as ex officio member of all standing boards and subordinate general organizations; and to sign official documents that require the signature of the moderator.

SECTION 2

The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and assist the moderator when called upon.

SECTION 3

The secretary shall record the proceedings of all sessions of the Albemarle Conference and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require his signature.

SECTION 4

The duties of the assistant secretary shall be the duties of the recording secretary when that officer is not present and to assist the secretary when called upon.

SECTION 5

The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

SECTION 6

The executive committee shall have power to act in the behalf of and for the Albemarle Conference from one regular session to another. It shall organize at will and discharge the administrative duties assigned to it. It shall plan the programs of the conference. The executive committee shall meet as often as necessary for the good of the conference.

SECTION 7

The board of trustees shall hold title to all property belonging to this conference. It shall have power to convey such property when authorized by the conference.

SECTION 8

The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: obituary, temperance, resolutions, nominating and finance.

SECTION 9

All reports, resolutions and recommendations shall be considered properly presented to the conference in written form only.

SECTION 10

No minister, officer or delegate shall be at liberty to retire from the building during a session of the conference without the consent of the moderator.

SECTION 11

If any member, in the judgment of the conference, shall show anger in

his discussion on any subject, he shall forfeit his rights during the remaining part of that session of the conference.

SECTION 12

This constitution and bylaws may be altered or amended by a two-third favorable vote of the members present in a regular session. All amendments shall be on the table not less than three hours prior to adoption and shall, during that time, be read at least one time.

A REMINDER: Every 20 sessions of the conference minutes shall be bound together into a book for the permanent records of the conference.
