REPORT OF THE BOARD OF ORDINATION

We, the Board of Ordination, submit the following report:

On November 28, 1970, the board met at the Plymouth Free Will Baptist Church, Plymouth, North Carolina, to question Brother Fred Bates relative to becoming a licensed minister. After questioning Brother Bates and also after a lengthy discussion relative to the ministry, the board recommended that he wait for awhile and that we would let him know when to appear before us at a later date. Since Brother Robert May was not present, we thought best to wait for the complete board to make the decision.

On January 30, 1971, the complete board met with Brother Fred Bates at Saint Paul Church in Elizabeth City, North Carolina, to talk to him and to discuss the possibility of him becoming a licensed minister. After much discussion, the board voted two in favor of Brother Bates's becoming a licensed minister and one against.

On March 10, the board received a letter and certificate of license from Robert E. Smith stating that he was no longer desiring to be connected with the Albemarle Conference. He is affiliated with the National Association and a member of the Fairmount Church.

On May 29, 1971, the board met Johnnie Sexton to discuss and to question him relative to becoming a licensed minister. We recommended that he appear at a later date. Brother John Owens was absent.

On August 28, 1971, Brother Johnnie Sexton appeared before the said board at the Sidney Free Will Baptist Church, Belhaven, North Carolina, to talk to the board about his license to preach. The board recommended that he get the sufficient letter of recommendation from his church and appear before the board at a later date.

On August 28, 1971, Brother Isaac Furlough appeared before the board to discuss with us relative to him preaching at Pine Grove Church. The board suggested that Brother Larry Barbour be called as pastor and Brother Isaac act as lay speaker since Brother Furlough is not a licensed minister.

REPORT OF SUPERANNUATION BOARD

(July 1, 1970—June 30, 1971)

This has been a good year and the Lord has blessed the superannuation program in many ways. We are grateful to God for His blessings and to you for your prayers and support of this work.

Our work is needful. At the present time there are five ministers and twelve ministers' widows receiving over two hundred sixty-nine dollars on an average each month. We have life insurance on sixty of our ministers with an annual premium of over fifty-five hundred dollars; and the board pays two thirds of this premium. This life insurance amounts to more than one hundred ten thousand dollars. There are eighteen ministers' families and fifty-one individual ministers and ministers' wives participating in the group hospital program. The monthly premium is more than eight hundred dollars, paid by those participating. There are seventy-six ministers enrolled in the *Ministerial Retirement System* in the approximate amount of fiftysix hundred dollars. Thus the board is liable for about twenty-eight hundred dollars each year to insure the retirement and death benefits of the retirement program.

We have two primary needs. The *first* is more funds to increase every phase of our superannuation work. We need over sixteen hundred fifty dollars in gifts (not premium payments) each month from our churches to reach the budget of twenty-thousand dollars adopted by the State Convention. Second: there is a need for more and greater participation on the part of our ministers in the Threefold Superannuation Program. There are almost two hundred ministers associated with the State Convention, but only seventy-six have enrolled in all or a part of this program.

YOU CAN HELP:

1. You can and should pray for the work of superannuation and for the members of the Board of Superannuation. You should pray for the ministers of our denomination, and especially for your pastor.

2. You should assist your pastor in preparing for retirement through the superannuation program as recommended by the State Convention, either by paying the total premiums or by paying a percentage of the premiums.

3. You can assist your church and pastor in making regular offerings to this most worthy cause. Be sure that this cause is included in the budget of your church in proportion to meet our needs. To insure the benefits we are offering to our ministers, we need the support of every Free Will Baptist.

4. Remember that October is SUPERANNUATION MONTH. Send your contribution to: North Carolina Board of Superannuation, P. O. Box 474, Avden, North Carolina 28513.

Constitution of Albemarle Conference

ARTICLE I

Sec. 1

SECTION 1-NAME

65.012.1

This organization shall be known as the Albemarle Conference of the Original Free Will Baptists of North Carolina.

SECTION 2-PURPOSE AND DE MAN DE MAN

The general purpose of this conference shall be to promote the great cause of Christ among men by means in conformity to the Holy Scriptures.

ARTICLE II

SECTION 1-COMPOSITION

This conference shall be composed of the ordained and licensed ministers who are members of churches that belong to the conference, all general officers of the conference, the members of standing boards or committees, the president or moderator of each subordinate general organization and the churches that hold their membership with the conference, together with those that may subsequently be admitted.

SECTION 2-REPRESENTATION

Every church affiliated with the Albemarle Conference shall represent in its annual session with two delegates, and each subordinate general organization shall represent with one delegate. A report from each church and subordinate organization shall be rendered at the annual session of the conference.

ARTICLE III

OFFICERS

The officers of this conference shall be a moderator, an assistant moderator, a secretary, an assistant secretary and a treasurer, each of whom shall be elected for a term of two years. The term of office for all officers shall begin at the close of the annual session at which they are elected.

Temporary officers, representatives or messengers may be elected at the option of the conference for whatever purpose deemed essential.

STANDING BOARDS AND COMMITTEES

It shall be the method of this conference to simplify its works by the assignment of specific work to representative units of authority which shall hereafter be known as standing boards and committees.

A board of trustees, a board of education and a board of ordination consisting of three (3) members each shall be elected. The term of office for members of these boards shall be three years but shall be so adjusted as to terminate the office of one member annually.

A board of missions, consisting of five members shall be elected. The

term of office for members of this board shall be five years, but shall be adjusted to terminate the office of one member annually.

Section 1

Standing boards shall have authority to write their own bylaws and administer their respective programs of works, but each shall remain subject to the authority and approval of the conference.

Section 2

The executive committee shall be composed of the general officers of the conference and the moderator or president of each subordinate general organization. He will be descent of the standard term edentified with the grade ender the set of the first of the

SECTION 3

Temporary committees shall be appointed at the option of the conference for whatever deemed necessary.

ARTICLE V

FINANCE

Each church shall contribute to the conference program according to its membership.

Conference funds shall be used for the work and general expense of the conference. The use of all funds to be approved by the conference.

ARTICLE VI

Admission of Churches

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Free Will Baptists and desires to help promote the program and work of the Albemarle Conference may submit its petition for membership through an official delegation at any annual session of the conference. If the petition for membership be approved, the moderator shall extend the hand of fellowship to the delegates and declare them duly seated.

ARTICLE VII

FRATERNAL DELEGATIONS AND VISITORS

Fraternal delegations and visitors shall be extended all the privileges of the conference except that of voting, serving on committees or holding elective offices.

ARTICLE VIII

MEETINGS

The Albemarle Conference shall meet in annual session on Wednesday before the second Sunday in October of each year. The host church shall be selected by vote of the conference in annual session by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Albemarle Conference; to appoint temporary committees, delegates and representatives; to serve as ex officio member of all standing boards and subordinate general organizations; and to sign official documents that require the signature of the moderator. Section 2

Section 3

The secretary shall record the proceedings of all sessions of the Albemarle Conference and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require his signature.

SECTION 4

The duties of the assistant secretary shall be the duties of the recording secretary when that officer is not present and to assist the secretary when called upon. 3. -

SECTION 5

The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

Section 6

The executive committee shall have power to act in the behalf of and for the Albemarle Conference from one regular session to another.² It shall organize at will and discharge the administrative duties assigned to it. It shall plan the programs of the conference. The executive committee shall meet as often as necessary for the good of the conference.

SECTION 7

The board of trustees shall hold title to all property belonging to this conference. It shall have power to convey such property when authorized by the conference.

Section 8

The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: obituary, temperance, resolutions, nominating and finance.

SECTION 9

All reports, resolutions and recommendations shall be considered properly presented to the conference in written form only.

Section 10

No minister, officer or delegate shall be at liberty to retire from the building during a session of the conference without the consent of the moderator.

Section 11

If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his rights during the remaining part of that session of the conference.

Section 12

This constitution and bylaws may be altered or amended by a twothird favorable vote of the members present in a regular session. All amendments shall be on the table not less than three hours prior to adoption and shall, during that time, be read at least one time.

A REMINDER: Every 20 sessions of the conference minutes shall be bound together into a book for the permanent records of the conference.
