PROCEEDINGS

The twenty-eighth annual session of the Albemarle Conference of Original Free Will Baptists convened with the Mount Zion Free Will Baptist Church, Route 2, Roper, North Carolina, October 4, 1972.

WEDNESDAY MORNING, 9:30 A.M.

The devotions were conducted by Rev. Harry Jones. The congregation sang "Showers of Blessings" and Brother Jones read Scripture from Exodus 29:36, 37, 44. He gave a brief talk on the Scripture and closed the devotions with prayer.

The address of welcome was given by Mrs. Mae Oliver. The response to the welcome was given by Rev. John Owens.

The conference was called to order by the secretary, Mr. Oscar Webster.

A motion was made and carried to adopt the printed program as the order of business, with the moderator making any changes he deems necessary.

The list of churches was called with seventeen (17) reporting by delegate or letter.

The list of ministers was called with nine (9) being present.

Visiting ministers were recognized with eleven (11) being present.

By a motion made and carried, Rev. Harry Jones was received into the conference. The conference is in receipt of a letter from his previous conference. The same action was taken in regard to Rev. Robert Rollins.

A motion was made and carried to receive Rev. William L. Littleton into the conference pending his letter of transfer from his present conference. The conference is now in receipt of such a letter.

By motion made and carried a letter of transfer was granted to Rev. Larry Barbour to the Central Conference. Such a letter has been delivered. A like motion was made and carried in regard to Rev. Jimmy Webster to the Eastern Conference. This letter has also been delivered.

Rev. E. E. Edwards, moderator of the Eastern Conference, was recognized as the representative from that conference.

The moderator's address was given by Rev. Robert May.

Temporary committees were appointed by the moderator as follows:

Temperance: Rev. Harry Jones, Mrs. Robana Fowler, and Rev. William L. Littleton.

Nominating: Rev. John Owens, Mr. Billy Dilday, and Mrs. Mary Furlough.

An offering was taken for the general fund of the conference. Prayer was offered by Rev. Robert Langley.

The report of the Executive Committee was given by the secretary. A motion was made and carried to adopt the report. (See report.)

Rev. Joe Ingram, director-treasurer of the North Carolina State Board of Missions, gave a report of the ministry of this board. A motion was made and carried to adopt the report. (See report.)

The report of the Board of Ordination was given by Rev. Charlie Overton. A motion was made and carried to adopt the report. (See report.)

A report of the Church Finance Association was given by Rev. Hubert Burress, secretary-treasurer. A motion was made and carried to adopt the report. (See report.)

A progress report of Mount Olive College was given by Rev. Frank R. Harrison, campus chaplain. A motion was made and carried to receive the report as information. (See report.)

The business of the conference was called off for the morning worship service.

The congregation sang "At the Cross." Special music was rendered by the host church. The conference sermon was delivered by Rev. Charlie Overton. He read for his Scripture, Matthew 27:28. His subject was, "The Cross."

The benediction was prayed by Rev. Harry Jones.

WEDNESDAY AFTERNOON, 1 P.M.

The devotions were conducted by Rev. Robert Rollins. The congregation sang "Leaning on the Everlasting Arms." Brother Rollins read for his Scripture, Isaiah 6:9. Following a few remarks on the Scripture, he closed the devotions with prayer.

A memorial service was conducted by Rev. Earl Minchew. Brother Minchew read a poem entitled, "There Is No Death." He also read from the Psalms, 143:5-12. The Mount Zion Trio sang "Precious Memories," followed with prayer by Brother Minchew.

A report of the Free Will Baptist Children's Home was given by the acting superintendent, Rev. A. Graham Lane. A motion was made and carried to adopt the report. (See report.)

A report of the annual session of the North Carolina State Convention of Original Free Will Baptists held at Black Jack Church, September 13, 14, was given by Mrs. Laura C. Webster. A motion was made and carried to receive this report as information.

A report of the work of the North Carolina Board of Superannuation was given by Rev. Robert May. A motion was made and carried to receive this report as information.

Mr. Isaac Furlough, treasurer of the conference, gave the annual treasurer's report. A motion was made and carried to adopt the report.

A motion was made and carried for the 1973 session of the conference to be held with Union Chapel Church.

A report of the Free Will Baptist Press Foundation was given by Rev.

Robert May. Brother May is a member of the Board of Directors of the Foundation. A motion was made and carried to receive the report as information.

Miss Alice Webster and Mrs. Laura C. Webster were elected as delegates to the 1973 session of the North Carolina State Convention of Original Free Will Baptists to convene with the Tarboro Church.

The Church Finance Association, Inc. is owned and operated by Free Will Baptists of North Carolina. The Association has been serving the needs of our people since 1940.

Constitution of Albemarle Conference

ARTICLE I

SECTION 1—NAME

This organization shall be known as the Albemarle Conference of the Original Free Will Baptists of North Carolina.

SECTION 2—PURPOSE

The general purpose of this conference shall be to promote the great cause of Christ among men by means in conformity to the Holy Scriptures.

ARTICLE II

SECTION 1—COMPOSITION

This conference shall be composed of the ordained and licensed ministers who are members of churches that belong to the conference, all general officers of the conference, the members of standing boards or committees, the president or moderator of each subordinate general organization and the churches that hold their membership with the conference, together with those that may subsequently be admitted.

SECTION 2—REPRESENTATION

Every church affiliated with the Albemarle Conference shall represent in its annual session with two delegates, and each subordinate general organization shall represent with one delegate. A report from each church and subordinate organization shall be rendered at the annual session of the conference.

ARTICLE III

OFFICERS

The officers of this conference shall be a moderator, an assistant moderator, a secretary, an assistant secretary and a treasurer, each of whom shall be elected for a term of two years. The term of office for all officers shall begin at the close of the annual session at which they are elected.

Temporary officers, representatives or messengers may be elected at the option of the conference for whatever purpose deemed essential.

ARTICLE IV

STANDING BOARDS AND COMMITTEES

It shall be the method of this conference to simplify its works by the assignment of specific work to representative units of authority which shall hereafter be known as standing boards and committees.

A board of trustees, a board of education and a board of ordination consisting of three (3) members each shall be elected. The term of office

for members of these boards shall be three years but shall be so adjusted as to terminate the office of one member annually.

A board of missions, consisting of five members shall be elected. The term of office for members of this board shall be for five years, but shall be adjusted to terminate the office of one member annually.

SECTION 1

Standing boards shall have authority to write their own bylaws and administer their respective programs of work, but each shall remain subject to the authority and approval of the conference.

SECTION 2

The executive committee shall be composed of the general officers of the conference and the moderator or president of each subordinate general organization.

SECTION 3

Temporary committees shall be appointed at the option of the conference for whatever deemed necessary.

ARTICLE V

FINANCE

Each church shall contribute to the conference program according to its membership.

Conference funds shall be used for the work and general expense of the conference. The use of all funds to be approved by the conference.

ARTICLE VI

ADMISSION OF CHURCHES

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Free Will Baptists and desires to help promote the program and work of the Albemarle Conference may submit its petition for membership through an official delegation at any annual session of the conference. If the petition for membership be approved, the moderator shall extend the hand of fellowship to the delegates and declare them duly seated.

ARTICLE VII

FRATERNAL DELEGATIONS AND VISITORS

Fraternal delegations and visitors shall be extended all the privileges of the conference except that of voting, serving on committees or holding elective offices.

ARTICLE VIII

MEETINGS

The Albemarle Conference shall meet in annual session on Wednesday before the second Sunday in October of each year. The host church shall be selected by vote of the conference in annual session by the executive

committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

BYLAWS

SECTION 1

The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Albemarle Conference; to appoint temporary committees, delegates and representatives; to serve as ex officio member of all standing boards and subordinate general organizations; and to sign official documents that require the signature of the moderator.

SECTION 2

The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and assist the moderator when called upon.

SECTION 3

The secretary shall record the proceedings of all sessions of the Albemarle Conference and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require his signature.

SECTION 4

The duties of the assistant secretary shall be the duties of the recording secretary when that officer is not present and to assist the secretary when called upon.

SECTION 5

The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

SECTION 6

The executive committee shall have power to act in the behalf of and for the Albemarle Conference from one regular session to another. It shall organize at will and discharge the administrative duties assigned to it. It shall plan the programs of the conference. The executive committee shall meet as often as necessary for the good of the conference.

SECTION 7

The board of trustees shall hold title to all property belonging to this conference. It shall have power to convey such property when authorized by the conference.

SECTION 8

The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: obituary, temperance, resolutions, nominating and finance.

SECTION 9

All reports, resolutions and recommendations shall be considered properly presented to the conference in written form only.

SECTION 10

No minister, officer or delegate shall be at liberty to retire from the building during a session of the conference without the consent of the moderator.

SECTION 11


If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his rights during the remaining part of that session of the conference.

SECTION 12

This constitution and bylaws may be altered or amended by a two-third favorable vote of the members present in a regular session. All amendments shall be on the table not less than three hours prior to adoption and shall, during that time, be read at least one time.

A REMINDER: Every 20 sessions of the conference minutes shall be bound together into a book for the permanent records of the conference.
