PROCEEDINGS

The thirty-first (31) annual session of the Albemarle Conference of Original Free Will Baptists of North Carolina convened with Hickory Chapel Free Will Baptist Church, Route 4, Ahoskie, North Carolina, October 8, 1975.

WEDNESDAY MORNING, 9:30 A. M.

The devotions were conducted by the Rev. Francis Garner. The congregation sang "He Leadeth Me." The Rev. Marvin Waters led in prayer. Brother Garner read Scripture from 1 John 2:4, 5, 6. Prayer and remarks were given by Brother Garner. He also closed with prayer.

The welcome was given by Mrs. Doris Chamblee.

The response was given by the Rev. Marvin Waters.

The conference was called to order by the secretary, Mr. Oscar Webster. A motion was made and carried to adopt the printed program as the order of business, with the moderator having the privilege to make any changes deemed necessary.

Mrs. Doris Chamblee was appointed by the moderator to act as treasurer for today due to the absence of the treasurer, Mr. Billy Wayne Dilday.

The list of churches was called and fifteen (15) reported, either by delegate or letter.

The moderator gave his address. The Rev. Charlie Overton, assistant moderator, was acting in the absence of the moderator, the Rev. Robert May.

The list of ministers was called with eight (8) present.

Visiting ministers were recognized as follows: The Revs. Walter Reynolds, Hubert Burress, Central Conference; the Revs. James Joyner, Jimmy Barfield,

Joe Ingram, Billy Ray Jordan, John Melancon, Western Conference; the Rev. Floyd Burkey, Union Association Ministers' Conference, Greenville, Tennessee. Brothers Melancon and Burkey are now enrolled with the Ablemarle Conference.

The moderator appointed the following temporary committees:

Nominating: Mr. J. T. Keech, Mrs. Beulah Whitson, and Miss Alice Webster.

Resolutions: The Rev. Francis Garner, the Rev. W. L. Brickhouse, and Mr. Hallet Harris.

Temperance: The Rev. Marvin Waters, Mr. Ernest Whitson, and Mrs. Hallet Harris.

This congregation sang "Near the Cross" while an offering was taken for the general fund of the conference.

The secretary gave the Executive Committee's report. A motion was made and carried to adopt the report. (See report.)

Reports of the standing boards were called for. The Rev. John Owens gave the Board of Ordination report. A motion was made and carried to adopt the report. (See report.) The other standing boards had no report.

Announcements of interest to the body were made by several persons.

A report of the Church Finance Association was given by the Rev. Hubert Burress, the secretary-treasurer of the association. A motion was made and carried to receive the report as information.

The treasurer's report was given by Mrs. Doris Chamblee, the acting treasurer. A motion was made and carried to adopt the report. (See report.)

A motion was made and carried to enroll the Rev. Floyd Burkey in the conference, the Board of Ordination being in receipt of his letter of transfer.

A motion was made and carried to receive, the Rev. John Melancon, into the conference, pending his letter of transfer from his present conference.

(Secretary's Note: His letter of transfer from the Western Conference is now in our files.)

A motion was made and carried to grant the Rev. William Littleton a letter of transfer to the Eastern Conference.

A motion was made and carried to grant the Rev. A. B. Chandler a letter of transfer to the Eastern Conference.

A motion was made and carried to grant the Rev. John Owens a letter of transfer to the Eastern Conference.

A letter of report was read from the North Carolina Home Missions Board. A motion was made and carried to receive the report as information.

By motion, Mr. Oscar Webster and Mrs. Laura Webster were elected delegates to the 1976 session of the North Carolina State Convention of Original Free Will Baptists.

By motion, the Revs. Charlie Overton, Marvin Waters, and John Melancon were elected delegates to the General Conference.

A report of Mount Olive College was given by Mr. Harold Herring, Director of Development at the College. The report consisted of printed material and remarks by Brother Herring. A motion was made and carried to receive the report as information.

The business of the conference was called off for the worship service.

The conference sermon was preached by the Rev. John Owens. He read for a Scripture Matthew 19:1-5 and Matthew 17:1-8. The congregation sang "Just As I Am." The benediction was prayed by the Rev. Charlie Overton.

WEDNESDAY AFTERNOON, 1:15 P. M.

The devotions were conducted by Mr. Oscar Webster. He read for a Scripture Acts 3:1-6. Remarks and prayer were given by Brother Webster.

A memorial service was conducted by the Rev. Charlie Overton. Scripture,

remarks, and prayer were by Brother Overton.

The Rev. Walter Reynolds, manager of the Free Will Baptist Press Foundation, gave a report on the business of the press. A motion was made and carried to receive the report as information.

Mr. Sam Weeks, executive director of the Free Will Baptist Children's Home, gave a report on the ministry of the Home. The report consisted of printed material and remarks by Brother Weeks. A motion was made and carried to receive the report as information.

Brother Weeks also gave a report on the Free Will Baptist Retirement Home. He stated that one building had been weathered in.

The Rev. Walter Reynolds, director-treasurer of the North Carolina State Board of Superannuation, gave a report on the work of this board. A motion was made and carried to receive the report as information.
