PROCEEDINGS

The thirty-fourth annual session of the Albemarle Conference of Original Free Will Baptists of North Carolina convened with Free Union Free Will Baptist Church, Route 1, Pinetown, North Carolina, on October 4, 1978.

WEDNESDAY MORNING

The devotions were conducted by Mr. Billy W. Dilday. The congregation sang "Praise Him, Praise Him." Brother Dilday read for a Scripture, 2 Peter 1:1. Prayer was by Brother Dilday.

The welcome was given by Mr. J. T. Keech. The Rev. Marvin Waters gave the response.

The Conference was called to order by the secretary, Oscar Webster.

The list of churches was called. Fifteen (15) reported—by letter and by delegate.

The list of ministers was called and the following reported: L. E. Ambrose, Charlie Overton, Robert May, W. L. Brickhouse, Marvin Waters, Francis Garner, Floyd Burkey, Charles Parrish, Ransom H. McAbee. It was reported that Johnny Sexton was just out of the hospital, and Stanley Buck had a death in his family.

Visiting ministers were recognized with the following present: Frank Harrison, Taylor Hill, Cape Fear Conference; Joe Ingram and Billy Ray Jordan, Western Conference; J. Stewart Humphrey, Hubert Burress, and Walter Reynolds, Central Conference.

The Rev. Robert May, moderator, gave the moderator's address. As always, Brother May's message was fitted to the hour.

The moderator appointed the following temporary committees:

An offering was taken for the General Fund of the Conference.

The congregation sang "'Tis So Sweet to Trust in Jesus."

A motion was made and carried to adopt the printed program as the order of business with the moderator having the privilege to make any changes he might deem necessary.

The Rev. Hubert Burress, Secretary of the Church Finance Association, Inc., gave a report on the work of the Association. He reported that the Association had over \$2,000,000,000 in loans. A motion was made and carried to receive the report as information.

The Rev. Joe Ingram, Director-Treasurer of the North Carolina Foreign Mission Board, gave a report on the ministry of that Board. Printed material was given out. A motion was made and carried to receive the report as information.

The Rev. Frank Harrison, Chaplain, Mount Olive College, gave a report on the progress of the College. Printed material was given out. A motion was made and carried to receive the report as information.

The Rev. Taylor Hill, Director-Treasurer of the North Carolina Home Mission-Church Extension Board, gave a report on the ministry of this Board. Printed material was also given out. A motion was made and carried to receive the report as information.

The Rev. J. Stewart Humphrey, Executive Director of the Free Will Baptist Children's Home and the Free Will Baptist Retirement Home, gave a report on the ministry of the Children's Home and a report on the progress of

the Retirement Home. A motion was made and carried to receive these reports as information.

Reports from the standing boards were called for.

The Executive Committee's report was given by Oscar Webster, secretary. A motion was made and carried to adopt the report. (See reports.)

A report was given by the Rev. Floyd Burkey, a member of the Mission Board, on an action taken by that Board. A motion was made and carried to adopt the report. (See reports.)

The Rev. Charlie Overton, Chairman of the Board of Ordination, gave a report on the actions taken by that Board. A motion was made and carried to adopt the report. (See reports.)

Business was called off for worship.

Special music was given by Free Union church. A group of four (4) sang: "Follow Along" and "How Long Has It Been."

The Conference sermon was preached by the Rev. Francis Garner. Brother Garner read for a Scripture, Philippians 1:12-18, with Verse 18 as his text. His subject was "So What." Brother Garner challenged the Christians present to commit themselves more fully to God's will, emphasizing that we have a glory to be desired and a message to deliver.

The congregation sang "Have Thine Own Way, Lord."

Announcements were made relative to the noon meal.

Prayer was prayed by the Rev. Francis Garner.

AFTERNOON SESSION

The devotions were conducted by the Rev. Ransom H. McAbee. The congregation sang "There Is Power in the Blood." Brother McAbee read for a Scripture 2 Chronicles 7:14 and Romans 12:1, 2. Remarks were by Brother McAbee. We were lead in prayer by the Rev. Walter Reynolds.

The memorial service was conducted by the Rev. Charlie Overton. The congregation sang "In the Sweet By and By." Brother Overton prayed and read one verse of Scripture, Mark 14:9. Remarks were made by Brother Overton. A motion was made and carried to adopt as a part of the minutes the printed portion of the service. (See reports.)

Mrs. Floyd Burkey gave a report on the 1978 session of the North Carolina State Convention of Original Free Will Baptists held at Cumberland County Memorial Auditorium in Fayetteville, North Carolina. A motion was made and carried to receive the report as information.

The Rev. Walter Reynolds, Free Will Baptist Press Foundation Manager, gave a report on the business of the Press. He reported that a new book store had been opened in Kinston, North Carolina.

Brother Reynolds, who is also Director-Treasurer of the North Carolina Superannuation Board, gave a report on the ministry of that Board. A motion was made and carried to receive these reports as information.

The Rev. Marvin Waters shared with us a letter from Mrs. A. B. Chandler, Treasurer of Cragmont Assembly, Inc., on the progress of the new building program there. He also gave out printed material. A motion was made and carried to receive the report as information.

BUSINESS SESSION OF THE CONFERENCE

A motion was made and carried to refund the secretary \$10 that was made to the North Carolina State Convention of Original Free Will Baptists as an offering to the annual session of the Convention.

A motion was made and carried to adopt the amount of \$10 as the annual offering to the Convention.

A motion was made and carried that the Albemarle Conference sponsor the 1979 annual session of the State Convention.

The Treasurer's report was given by Mr. Billy W. Dilday, treasurer. A motion was made and carried to adopt the report. (See reports.)

Report of the Resolutions Committee was given by the Rev. Floyd Burkey. A motion was made and carried to adopt the two (2) resolutions offered by the committee. (See reports.)

Report of the Temperance Committee was given by the Rev. Ransom McAbee. A motion was made and carried to adopt the report. (See reports.)

The report of the Nominating Committee was given by the Rev. Charlie Overton. A motion was made and carried that the year 1978 be used as the base year for the election of the General Officers of the Conference from this year forward.

The persons nominated by the Committee to the offices of Assistant Moderator and Secretary did not choose to be candidates for these offices. The Rev. Robert May was nominated from the floor for the office of Assistant Moderator and the Rev. Marvin R. Waters to the office of Secretary. These two nominees, along with the others named by the Nominating Committee, were presented for election. A motion was made and carried to adopt the Nominating Committee's report as presented. (See reports.)

The moderator appointed Mrs. Floyd Burkey and Mrs. Laura Webster as delegates to the 1979 session of the North Carolina State Convention of Original Free Will Baptists.

The Rev. Ransom H. McAbee was appointed delegate to the General Conference of Original Free Will Baptists.
