

PROCEEDINGS

The thirty-eighth annual session of the Albemarle Conference of Original Free Will Baptists of North Carolina convened with Saint Paul Original Free Will Baptist Church in Elizabeth City, North Carolina, on October 6, 1982.

WEDNESDAY MORNING

The devotions were conducted by the Rev. Royce Reynolds. The congregation sang "Amazing Grace." Brother Reynolds read for a Scripture Romans 12, beginning with Verse 1. Prayer was by Brother Reynolds.

The welcome was given by Sister I. H. Fowler. The response was given by the Rev. L. E. Ambrose.

The Conference was called to order by the Conference secretary, Brother Oscar Webster.

A motion was made and carried to adopt the printed program as the order of business, with the moderator having the privilege to make any changes that he may deem necessary.

The list of churches was called and eleven (11) reported by letter or with delegates. The list of ministers was called with ten (10) being present.

Visiting ministers were recognized with the following present: the Revs. Royce Reynolds and Billy Ray Jordan, Central Conference; Fred Baker and Charles Crisp, Western Conference; Frank Harrison, Cape Fear Conference; and David Charles Hansley, Eastern Conference.

The Rev. Robert May gave the Moderator's address. As always, Brother May's remarks were well prepared and pertinent to the occasion.

The Moderator appointed temporary committees for the day as follows: Nominating: the Revs. Charlie Overton, W. L. Brickhouse, Mr. Billy Dilday; Resolutions: the Rev. Joe Griffith, Miss Alice Webster, Mr. Ervin Foreman; Temperance: the Rev. Steve Hargrove, Mrs. I. H. Fowler, Mrs. Colla Miller.

As the congregation sang "'Tis So Sweet to Trust in Jesus," an offering was taken for the General Fund of the Conference. Prayer for the offering was prayed by the Rev. Joe Griffith.

The report of the Executive Committee was given by the Conference secretary. A motion was made and carried to adopt the report. (See Reports.)

Reports of standing boards were called for:

Board of Trustees—no report

Board of Christian Education—no report

Board of Missions—no report

The report of the Board of Ordination was given by the chairman, the Rev. Charlie Overton. A motion was made and carried to adopt the report. (See Reports.)

A report on the work of the North Carolina Board of Superannuation, prepared by the Rev. Walter Reynolds, director-treasurer, was read by the Rev. Robert May. Printed material was given out.

A report on the Church Finance Association was given by the Rev. Robert May on behalf of the Rev. Walter Reynolds, the Association's president. Printed material was handed out. A motion was made and carried to receive these two reports as information.

A report on the ministry of the North Carolina Board of Foreign Missions was given by the Rev. Fred Baker, our missionary on furlough from the Philippine Islands. Printed material was given out. A motion was made and carried to receive the report as information.

A report on the ministry of the North Carolina Board of Home Missions was given by the Rev. Charles Crisp, director-treasurer of the Board. Printed material was also given out. A motion was made and carried to receive the report as information.

The Rev. Frank Harrison, Chaplain, Mount Olive College, gave a report on the progress of the College. He, too, gave out printed material. A motion was made and carried to adopt the report as information.

The Rev. David Charles Hansley, Executive Director of the Free Will Baptist Press Foundation, gave instructions as to the locations of the Press and Children's Home displays in the church and urged the people to visit them during the lunch hour.

Brother Hansley presented Brother Oscar Webster a Bible ("The New King James Version") from the Press in recognition of his many years of faithful service to the denomination. More than a half-century ago, Brother Webster was elected Superintendent of the Sunday school at his home church at the age of sixteen.

A report of the Free Will Baptist Retirement Home was given by Mr. Charles Watts. Printed material was handed out. Mr. Charles Watts, promotions director of the Free Will Baptist Children's Home, gave a report on the child care ministry of the Home. Mrs. Watts also spoke in behalf of the ministry there. Printed material was handed out. A motion was made and carried to receive these reports as information.

Business was called off for worship service. The Rev. Joe Griffith, pastor of the host church, was in charge of the service. A solo, "Ivory Palaces," was sung by Mr. Bill Pipkin, a member of the host church.

The Convention sermon was preached by the Rev. Joe Griffith. He read for a Scripture Mark 1:1-4. Using for his subject "Preaching the Word," Brother Griffith spoke with power as he declared the need to proclaim the message of Christ. The congregation sang "Just As I Am." Prayer was by Brother Griffith.

The benediction and blessing on the noon meal was prayed by the Rev. Frank Harrison.

WEDNESDAY AFTERNOON

The devotions were conducted by the Rev. L. E. Ambrose. The congregation sang " 'Tis So Sweet to Trust in Jesus." Scripture and prayer were by Brother Ambrose.

A memorial service was conducted by the Rev. Charlie Overton. The congregation sang "Sweet By and By." Prayer was prayed by Brother Overton. He then read Scripture from Mark 14:9. A resolution of respect based on this Scripture was read by Brother Overton. A motion was made and carried to adopt this resolution. (See Reports.)

A report of the activities of the North Carolina State Convention of Original Free Will Baptists of North Carolina was given by the Rev. Steve Hargrove, a member of the Executive Committee of the Convention. A motion was made and carried to receive the report as information.

A report on the services offered by the Free Will Baptist Press Foundation was given by Mrs. Minnie Chandler, credit manager of the Press. A motion was made and carried to receive the report as information.

A brief report on Cragmont Assembly was given by Mrs. Minnie Chandler.

A report on the 1982 session of the North Carolina State Convention of Original Free Will Baptists was given by Mr. Lloyd Jones Jr. A motion was made and carried to receive the report as information.

A report of the work of the Albemarle Union League was given by the President, Mr. Lloyd Jones Jr. Brother Jones submitted a written report also. A motion was made and carried to adopt the report. (See Reports.)

The report of the Resolutions Committee was given by the Rev. Joe Griffith. A motion was made and carried to adopt the report. (See Reports.)

The report of the Temperance Committee was given by the Rev. Steve Hargrove. A motion was made and carried to adopt the report. (See Reports.)

The report of the Nominating Committee was given by the Rev. Charlie Overton. There being no nominations from the floor, those persons named by the committee were by proper motion elected to office. (See Reports.)

Mr. Lloyd Jones Jr., treasurer, gave the treasurer's report. A motion was made and carried to adopt the report. (See Reports.)

The Rev. Buddy Rogers and wife were appointed delegates to the 1983 session of the North Carolina State Convention of Original Free Will Baptists.

A motion was made and carried to pay up to \$50 on the expenses of two delegates to any body to which the Conference officially sends a delegation.

Oscar and Laura Webster were appointed delegates to the 1983 session of the General Conference that will convene with Sandy Plains Church in North Carolina.

Mrs. Minnie Chandler, who with her late husband, the Rev. A. B. Chandler, lived in and pastored churches in the Albemarle Conference, and who has been very active in all phases of the work of the denomination on both the local and state level, and is at present Credit Manager of the Free Will Baptist Press Foundation, Ayden, was recognized at this time for a special report to the Conference.

The Albemarle Conference was organized in 1945. Our history begins with the minutes of the 1945 session. Therefore we had no record of our roots before that date. Mrs. Chandler, as a labor of love, researched the Conference affiliation of the churches that make up the Albemarle Conference. With this information, she compiled, in record form, a history of the conference membership of each of the churches

that make up the Albemarle Conference. We now know the Conference roots of each of our churches.

The Conference is indebted to Mrs. Chandler for the tremendous amount of work that went into making this information available to the Conference. A motion was made and carried to adopt as a part of the Conference record this work by Mrs. Chandler, and to also express to her the affectionate appreciation of the Conference for her contribution. (See Reports.)

There being no positive invitation from any church for the 1983 session of the Conference, the location will be announced by the Executive Committee.

The minutes of the thirty-eighth annual session were read by the secretary. A motion was made and carried to adopt the minutes as read.

A motion was made and carried to adjourn.

The benediction was prayed by the Rev. Buddy Rogers.

REPORTS 1983 SESSION

EXECUTIVE COMMITTEE

The Executive Committee of the Albemarle Conference of Original Free Will Baptists of North Carolina met at Cape Colony Mission, Edenton, North Carolina, October 17, 1981. The purpose of this meeting was to organize Cape Colony Mission into a church.

Members of the Executive Committee present were the Revs. Robert May and Charlie Overton, Mr. Oscar Webster, Mrs. Beulah Whitson, Mr. Lloyd Jones Jr, and the Rev. Joe Griffith.

The Rev. Ronnie Mohn, pastor of Cape Colony Mission, opened the meeting. Prayer was by the Rev. Joe Griffith.

The meeting was then turned over to the Rev. Robert May, moderator of the Conference. Mr. May stated the purpose of the meeting and asked for a motion to organize the church. Such a motion was made by the Conference secretary, Oscar Webster. This motion carried.

The Rev. Charlie Overton was recognized and presented the Bible to the Chairman of the Deacon Board of Cape Colony Mission.

Remarks were made by the Rev. Taylor Hill, director-treasurer of the North Carolina State Home Missions, and Church Extension Board.

The Rev. Ronnie Mohn, called the roll of the charter members (52). Each member was presented a certificate with the name of each charter member listed. Copies of these certificates signed by members of the Executive Committee were given to the members of the Committee.

The prayer of dedication was prayed by Mr. Lloyd Jones Jr. The sermon was preached by the Rev. Dean Kennedy. The communion of the Lord's Supper was held, consisting of taking the bread and wine.

The mission now became Cape Colony Original Free Will Baptist Church of Edenton, North Carolina.
