PROCEEDINGS and and the state of the second second

WEDNESDAY MORNING

The congregation sang "Come Thou Almighty King" to open the fortieth session of the Albemarle Conference. The devotions were conducted by Mrs. Christine Waters of Free Union Church. The welcome was given by Brother Lloyd Jones Jr. The response was given by Brother Ervin Foreman.

The Conference was called to order by the assistant clerk, using the words uttered by alah di salametan 1 Brother Oscar Webster while he was clerk.

Brother May introduced the program of the day.

Motion was made and carried to use the program as the order of business, giving the right of change if the moderator deemed it necessary.

The roll call of ministers showed 13 present, two excused and one absent. Twelve visiting ministers were present plus Mr. Cliff Gray of the Free Will Baptist Press. The roll call of churches showed 13 present, two absent (one was represented by its pastor.)

The moderator appointed the following committees:

The moderator, the Rev. Robert May, addressed the meeting using as Scripture 1 Corinthians 10. Speaking to the church and ministers needing to be empowered by the Holy Spirit, he stated that when motions were made, look beyond the person but at what could happen. Would it benefit the conference and glorify God?

A short business session was called to order.

1. A letter of resignation was received from Mrs. Ercie Waters, secretary for 1983-84. Due to illness, she resigned with regrets. Motion made and carried to accept her resignation.

2. A letter of resignation was received from Brother Robert May. He has served on the Board of Ordination for twenty years. He requested that the resignation become effective today. Motion made and carried to accept his resignation.

The congregation sang, " 'Tis So Sweet to Trust in Jesus'' during which an offering was received. Offertory prayer was given by the Rev. Charlie Overton.

Reports of standing Boards and Committees were called for.

The Board of Ordination report was given by the Rev. Charlie Overton. Motion was made and carried to adopt this report. (See Reports.)

The following committees gave no reports but materials were passed out: Executive Committee, Board of Trustees, Board of Education, Board of Missions.

The Rev. Don Fader gave a report on Superannuation. Motion made and carried to receive the report. (See Reports).

Mr. Clifford Gray represented the Free Will Baptist Press. Motion was made and carried to accept Mr. Gray's report. (See Reports.)

Brother Harold Jones brought greetings and news of the Foreign Missions work and the Board. He also passed out literature on the Missions work. This report was accepted. (See Reports.)

The Rev. Harold Jones passed out literature for the Rev. Walter Reynolds, who could not be with us, on the Church Finance Association. Cragmont literature was passed out also.

The Rev. Bass Mitchell brought greetings from the Sunday School Convention, presenting new programs for a revival in the work. Motion was made and carried to accept the report. (See Reports.)

The Rev. C. H. Overman announced that literature had gone out to all the churches urging that the Field Secretary be included in their budgets. The money is needed to keep a secretary in the field to get the Sunday schools growing again. When they grow, so grow the churches.

The Rev. Charles Crisp brought greetings from the Home Missions Board. We have seen over 500 people saved in the past year and there is new work in progress. Motion made and carried to accept the report as information. (See Reports.)

The Treasurer's Report was given by the treasurer, Mr. Lloyd Jones. It was moved and passed to accept it. (See Reports.)

Brother Lloyd Jones announced that there were no League Conventions held last year due to lack of interest. Motion made and carried to receive the report as information.

Brother Walter Sutton brought greetings from and a report on the Retirement Homes. Motion made and carried to accept the report as information. (See Reports.)

Several announcements were made concerning the District work.

Brother Charles Crisp announced that a Seminar and Evangelism Conference will be held April 19 and 20, 1985. (See Reports.)

Brother Joe Griffith announced that the Sunday School banquet will be held November 16, 1984, at the Sound View Restaurant, at 7 p.m.

The Rev. Charlie Overton preached the morning sermon. His topic was "The Three Crosses," or "The Darkest Day" (Mark 15:27), after which we were dismissed with prayer.

Lunch was served in the yard.

WEDNESDAY AFTERNOON

After the singing of a congregational hymn, devotions were conducted by the Rev. Bobby Brown. Using 1 Corinthians 12:1, he made timely remarks and views on the Scripture and concluded with prayer.

The Memorial Service was conducted by the Rev. Frank Thigpen. (See Reports.)

The report of the State Convention was given by Brother Gary Bailey. Motion was made and carried to accept the report as information. (See Reports.)

The report of Mount Olive College was given by Brother Frank Harrison. Motion made and carried to accept the report as information. (See Reports.)

The report of the Children's Home was given by Brother Bobby Taylor. Motion was made and carried to accept the report. (See Reports.)

The report of Cragmont was given by the Rev. John Williams. Motion made and carried to accept the report as information. (See Reports.)

The business session opened.

Motion made by the Rev. Bobby Brown for the Executive Board to meet with Piney Grove Church in the near future and investigate the status of the church and its intentions. Motion carried.

A motion was made and carried to continue ordaining ministers as we have in the past in the Albemarle Conference.

Brother Joe Griffith made a motion that we give the \$1,000 that we received from the sale of Cape Colony to the Home Missions Board. Motion carried. (See Reports.)

Report of Temporary Committees.

Resolutions, Temperance, and Nominating all made reports. Motion made and carried to adopt these reports.

A rising vote of thanks was given the Rev. Robert May who served on the Ordaining Council for twenty years and to Mrs. Ercie Waters for their services to the Conference. Their resignations became effective today.

We have an invitation from Mount Tabor Church to meet with them in 1985. Motion made and carried to meet with Mount Tabor Church in October, 1985.

Mr. and Mrs. Johnnie Sexton will represent the Conference as delegates to the North Carolina State Convention at Mount Olive, NC in 1985.

The delegate to the General Conference at Pine Level, NC, will be appointed later.

The minutes of today's meeting were read. Motion made and carried to accept them as read. A motion was made to adjourn. Motion carried. The Rev. C. H. Overman pronounced the benediction.

REPORTS

1984 Session

BOARD OF ORDINATION

On December 3, 1983, the Board met at Mount Zion Church, Roper, to examine Ramond Lagcher for license to preach. The only member present was Brother Overton so no decision was made. The Rev. Aubrey Williamson met the Board at Mount Zion Church to clear his credentials, coming into the Albemarle Conference. Everything proved satisfactory. On January 28, 1984, Ramond Lagcher met with the Board at Free Union Church, near Pinetown, to be examined for license to preach. After questioning and discussion, the board voted to recommend him to be licensed by his church for a period of one year. Also the Board examined Wayne (Garry) Smith for license to preach. The Board voted to recommend him to be licensed by his church to preach for one year.

The Board met at Hickory Chapel Church, July 28, 1984, with Joseph Ratcliff to examine him for license to preach the gospel. He was recommended to be licensed by his church to preach for a period of one year. Also, Brother Bill Gaylord surrendered his license to the Ordination Board that day.

On September 29, 1984, the board met at Malachi's Chapel Church to examine the Rev. James Owens' credentials. We were satisfied with same.

This is to certify that Brother Johnnie Sexton willingly turned in his credentials with his resignation to the Board in 1983.

BOARD OF SUPERANNUATION

It shall be the purpose of this board to organize and unify all superannuation work throughout the State Convention. They shall provide for our aged, retired, and infirm ministers in some form of superannuation program. We also seek to offer to our active ministers some program whereby they may help provide for their future security and retirement.

Last year the Albemarle Conference helped to support and maintain some life insurance for many of our ministers. Seventy-three cents of every dollar went to the ministers through the program.

We have two programs now: Supplemental Retirement, and Disability. Each church is allocated to pay according to size of its membership.

FREE WILL BAPTIST PRESS

This year has been better than the previous ones. We showed a profit of \$20,000, but we are still in debt. We are going to try selling memberships again for \$100 each to the different organizations of the churches.

Brother Joe Griffith is now on the Board. See him for further details.

REPORTS OF TEMPORARY COMMITTEES

RESOLUTIONS

WHEREAS, Mount Zion Church invited the Conference to meet with them today and has extended its hospitality, fellowship and lunch to us, THEREFORE, be it resolved that we acknowledge it by giving a rising vote of thanks. Motion made and carried to let it be known by standing.

WHEREAS, commercials concerning cigarettes have been banished from the air waves because the Surgeon General has determined that they are hazardous to the health of partakers and those in their company. We urge everyone not to partake, and

WHEREAS, alcoholic beverages are just as dangerous to the individual partaking and also to the ones not partaking, their welfare and safety being affected through accidents, spouse and child abuse, etc.

BE IT THEREFORE resolved that we the Albemarle Conference go on record and in accordance with our *Articles of Faith and Discipline* that clearly stated in our Covenant that we are to abstain from all sanction of the use and sale of intoxicating beverages... That we denounce verbally and formally in writing to our Congressmen and Senators and ask for their support in affirmative action to be taken against said practices on the air waves, and

LET IT BE RESOLVED that any of our ministers, serving churches in other conferences and serving on any boards of this Conference be replaced by a minister or layman in good standing with the Conference immediately, that person or persons to serve until the next meeting of this Conference. The appointments are to be made by the Executive Board of this Conference prior to that setting.

Concerning Homosexuals' activities in the ministry and in the churches.

WHERESAS, there have been in recent years increasing cases of known homosexual activities throughout our country, and WHEREAS these activities are often accepted by many of our peers, and WHEREAS there was much discussion at our State Convention this year, and WHEREAS there was a resolution submitted to the Convention on this subject and tabled by the Convention until the Executive Committee could give this matter further consideration and submit their findings to the State Convention to be held in 1985, and WHEREAS the Bible gives us proper instructions and commandments for right and moral living, and WHEREAS, we feel this matter needs the immediate attention of this Conference, to show our feelings to the Executive Committee so that our feelings will be heard before another resolution is presented to the State Convention.

BE IT THEREFORE RESOLVED, that we the Albemarle Conference of Original Free Will Baptists support the resolution presented to the 1984 State Convention PLUS an added statement/amendment that will provide a solution to the possibility of having ministers preaching the gospel with credentials obtained by the Original Free Will Baptists of North Carolina, who are known homosexuals.

We, realizing that the person can experience a change of heart and be forgiven of his or her sins, must have a forgiving heart to those individuals who will profess such sins and are forgiven and repent. This resolution that was submitted and the resolution that we accept will contain the following.

(a) Churches should refrain from accepting homosexuals as members.

(b) The Ordaining Committee of this Conference refrain from licensing and/or ordaining known homosexuals into the gospel ministry.

(c) Any minister licensed or ordained that is a known homosexual surrender his

credentials or if he refuses, that the Conference intervene and have the credentials nullified, revoked and a public notification be presented in The Free Will Bantist.
