#### **PROCEEDINGS**

Wednesday Morning

The Albemarle Conference of Original Free Will Baptists met on October 9, 1991, with Free Union Free Will Baptist Church, Pinetown, North Carolina.

The Conference opened with the congregation singing "Leaning on the Everlasting Arms." The devotions were given by the Rev. Joe Griffith, who used 1 Corinthians 13 as his Scripture. He closed with prayer.

The welcome was by Mr. Charlie Keech and the response was by Mr. Billy Dilday. The Conference was called to order by the clerk, using words of the late Oscar Webster, past clerk. The adopting of the program was the first order of business. The enrollment of the churches was next, with all fifteen represented. The enrollment of ministers followed, with eight present, two absent and two excused (one moved). Visiting ministers and delegates from other church bodies were recognized as follows: the Revs. C. H. Overman, Bobby Taylor, N. D. Beaman, and James Corbett, of the Central Conference; the Rev. James B. Hardee, of Pee Dee Association; the Revs. David

Hines, and Bruce Barrow, of the Eastern Conference; the Rev. Kenneth Littleton, of Cape Fear; and the Revs. Paul Grubbs and Harold Jones of the Western Conference.

The moderator, the Rev. Robert May, gave his address using the words, "Hear Ye the Word of the Lord." He used Scripture from Acts 1:8. His message was on winning the lost to Christ, and the conditions of our churches in the service of Christ today. He then established the rules of the Conference for the day.

The appointment of temporary committees was next. The Resolutions Committee was composed of the Rev. Joe Griffith, the Rev. W. L. Brickhouse, and Mr. Gary Burbage. The Nominating Committee was the Rev. Charlie Overton, Mr. Billy Dilday and the Rev. Frankie Baggett. The Rev. Joe Griffith then brought up the matter of changes to be made in the Albemarle Conference Constitution which read as follows: Article IV paragraphs 2 and 3 to be deleted and replaced as follows: "A board of trustees (3 members), a board of education (3 members), a board of ordination (5 members) and a board of missions (5 members) shall be elected. The term of office for these boards shall be so adjusted as to terminate the office of one member annually." Section 8 of the By-Laws to delete the word temperance. Section 12 of the By-Laws to read "not less than one hour prior to adoption." This matter was tabled to be voted on later.

The morning offering for the benefit of the Conference was taken, while the congregation sang "All the Way My Savior Leads Me." The Rev. James Owens prayed the offertory prayer. The Rev. Charlie Overton then opened the doors of the Conference to receive any new ministers as members. The Rev. James Corbett of the Central Conference petitioned to become a member pending his letter. He was accepted by motion. The Rev. Kenneth Littleton of the Cape Fear Conference petitioned to become a member of our Conference pending his letter. He was accepted by motion.

The clerk gave the report of the Executive Committee which was accepted by motion. (See Reports.)

The report of the Board of Ordination was made by the Rev. Charlie Overton. Report was accepted by motion. (See Reports.)

The following reports were then made: Delegate's report of the State Convention, Mrs. Eunice Sexton; report on denominational ministries, showing slides of these ministries, the Rev. C. H. Overman; the Children's Home, the Rev. Bobby Taylor; Mount Olive College, the Rev. David Hines; Missions, the Rev. David Hansley; Retirement Homes, the Rev. James B. Hardee; Foreign Missions, the Rev. Harold Jones (he reminded us that March 13 would be the World Missions Conference). These reports were received as information. Business ended for the morning session. We entered the worship service.

The congregation sang "Higher Ground" and the Rev. Bruce Barrow led us in prayer. Special music was by the host church, a group called "The New Day Spirituals." They sang "My Jesus Knows Just What I Need" and "O, for a Love of God." They sang beautifully. The Rev. W. S. Burns, pastor of Free Union Church, brought the message, using for his Scripture Ezekiel 37. After speaking on the powerful Word of God, he closed with an altar prayer for himself. The Rev. David Hansley led the others in prayer.

The closing prayer of the morning session was by the Rev. James B. Hardee, who also gave thanks for the noon meal.

#### WEDNESDAY AFTERNOON

The evening session began with the Rev. Luther Swinson giving a devotion. The congregation sang "'Tis So Sweet to Trust in Jesus." He then read Luke 7:1-10. After a few remarks, he closed with prayer.

The Rev. Frankie Baggett led the memorial service, using Scripture from 2 Timothy 4:7-8. He read a poem by Helen Steiner Rice and read the names of the 26 deceased members of all the churches of the past year. After reading another poem, he sang a song, "Welcome Home," and closed with prayer.

A treasury report was given by Mr. Lloyd Jones Jr. The report was adopted by motion. (See Reports.)

A motion was made to move the article of the changes of the Constitution and By-Laws from the table to vote on this matter. After the reading of the changes to be made, a motion was made to accept the changes of the Constitution. Motion carried. A motion was made to accept the changes in the By-Laws. Motion carried. A motion was made to send these changes with a copy of the Constitution and By-Laws to the Press to be printed in the *Yearbook*. Motion carried. Mr. Gary Burbage and Mrs. Eunice Sexton were elected as delegates to the State Convention in 1992.

The Conference was invited to meet next year with Union Chapel Church. We gladly accepted this invitation.

A motion was made that those who do work for the Conference and have to travel be paid 20 cents per mile and also given a meal ticket while serving this cause. Motion passed. An amendment was made to the motion to delete the word *meals* and pay only 20 cents per mile. Motion to accept amendment. Motion carried.

The report of Temporary Committee was made with the Rev. Joe Griffith giving the Resolution Report. Only one was made—That the Albemarle Conference give a rising vote of thanks to the Free Union Free Will Baptist Church for their Christian hospitality. Motion was carried.

#### EXECUTIVE COMMITTEE

The Executive Committee met on March 30, 1991. The first article of business was concerning a letter from the Board of Directors of the Minister's Program asking for our help and support of pastoral ministers retiring with dignity and security.

The second article of business was concerning a revision of the Constitution of the Albemarle Conference.

No changes were made at this time. Copies were made of the last revision and given to all members of the Committee and a copy sent to all ministers of the Conference to study what changes needed to be made and bring them before the next Conference meeting.

# CONSTITUTION OF ALBEMARLE CONFERENCE

#### ARTICLE I

#### SECTION 1: NAME

This organization shall be known as the Albemarle Conference of the Original Free Will Baptists of North Carolina.

#### SECTION 2: PURPOSE

The general purpose of this conference shall be to promote the great cause of Christ among men by means in conformity of the Holy Scriptures.

#### ARTICLE II

#### SECTION 1: COMPOSITION

This conference shall be composed of the ordained and licensed ministers who are members of churches that belong to the conference, all general officers of the conference, the members of standing boards or committees, the president or moderator of each subordinate general organization and the churches that hold their membership with the conference, together with those that may subsequently be admitted.

#### SECTION 2: REPRESENTATION

Every church affiliated with the Albemarle Conference shall represent in its annual session with two delegates, and each subordinate general organization shall represent with one delegate. A report from each church and subordinate organization shall be rendered at the annual session of the conference.

#### ARTICLE III

#### **OFFICERS**

The officers of this conference shall be a moderator, an assistant moderator, a secretary, an assistant secretary and a treasurer, each of whom shall be elected for a term of two years. The term of office for all officers shall begin at the close of the annual session at which they are elected.

Temporary officers, representatives or messengers may be elected at the option of the conference for whatever purpose deemed essential.

#### ARTICLE IV

#### STANDING BOARDS AND COMMITTEES

It shall be the method of this conference to simplify its works by the assignment of specific work to representative units of authority which shall hereafter be known as standing boards and committees.

A board of trustees (3 members), a board of education (3 members), a board of ordination (5 members), and a board of missions (5 members), shall be elected. The term of office for these boards shall be so adjusted as to terminate the office of one member annually.

#### SECTION 1

Standing boards shall have the authority to write their own bylaws and administer their respective programs of work, but each shall remain subject to the authority and approval of the conference.

#### SECTION 2

The executive committee shall be composed of the general officers of the conference and the moderator or president of each subordinate general organization.

#### SECTION 3

Temporary committees shall be appointed at the option of the conference for whatever deemed necessary.

#### ARTICLE V

#### FINANCE

Each church shall contribute to the conference program according to its membership.

Conference funds shall be used for the work and general expense of the conference. The use of all funds to be approved by the conference.

#### ARTICLE VI

#### ADMISSION OF CHURCHES

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Free Will Baptists and desires to help promote the program and work of the Albemarle Conference may submit its petition for membership through an official delegation at any annual session of the conference. If the petition for membership be approved, the moderator shall extend the hand of fellowship to the delegates and declare them duly seated.

#### ARTICLE VII

#### FRATERNAL DELEGATIONS AND VISITORS

Fraternal delegations and visitors shall be extended all the privileges of the conference except that of voting, serving on committees or holding elective offices.

#### ARTICLE VIII

#### MEETINGS

The Albemarle Conference shall meet in annual session on Wednesday before the second Sunday in October of each year. The host church shall be selected by vote of the

conference in annual session by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

#### **BYLAWS**

#### SECTION 1

The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Albemarle Conference; to appoint temporary committees, delegates and representatives; to serve as ex officio member of all standing boards and subordinate general organizations; and to sign official documents that require the signature of the moderator.

#### SECTION 2

The duties of the assistant moderator shall be the duties of the moderator when the officer is not present and assist the moderator when called upon.

#### SECTION 3

The secretary shall record the proceedings of all sessions of the Albemarle Conference and preserve an accurate record of said proceedings in a book provided for this purpose. He shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require his signature.

#### **SECTION 4**

The duties of the assistant secretary shall be the duties of the recording secretary when that officer is not present and to assist the secretary when called upon.

#### **SECTION 5**

The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

#### SECTION 6

The executive committee shall have power to act in the behalf of and for the Albemarle Conference from one regular session to another. It shall organize at will and discharge the administrative duties assigned to it. It shall plan the programs of the conference. The executive committee shall meet as often as necessary for the good of the conference.

#### SECTION 7

The board of trustees shall hold title to all property belonging to this conference. It shall have power to convey such property when authorized by the conference.

#### SECTION 8

The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: obituary, resolutions, nominating and finance.

#### SECTION 9:

All reports, resolutions and recommendations shall be considered properly presented to the conference in written form only.

#### SECTION 10:

No minister, officer or delegate shall be at liberty to retire from the building during a session of the conference without the consent of the moderator.

#### SECTION 11

If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his rights during the remaining part of that session of the conference.

#### SECTION 12

This constitution and bylaws may be altered or amended by a two-thirds favorable vote of the members present in a regular session. All amendments shall be on the table not less than one hour prior to adoption and shall, during that time, be read at least one time.

A REMINDER: Every 20 sessions of the conference minutes shall be bound together into a book for the permanent records of the conference.
