Proceedings

The 53rd Annual Session of the Albemarle Conference of Original Free Will Baptists met October 8, 1997, with Malachi's Chapel, Columbia, North Carolina.

The session opened with singing, "At the Cross," led by the Reverend Mott Batchelor. The Reverend Billy Mobley gave the devotion from Matthew 11:28-30. Sister Kathryn Cooper of the host church gave the welcome and Brother Fentress Simons responded.

The clerk called the 53rd Annual Session to order using the words of the late Oscar Webster and presented the Moderator to preside over the meeting.

By motion, to adopt the printed program and change as needed as we proceed.

Thirteen churches represented by letter. Delegates from 12 churches were seated. There were 9 ministers in the Conference present and 2 were absent with excuse. Five visiting ministers (the Reverends Bruce Dudley, Frank Harrison, Scott Sowers, Bob Harber, and H. P. Norman) were recognized.

By motion, Brother H. P. Norman was accepted into the Conference.

The Reverend Everette Harper gave the Moderator's Address based on Matthew 4:18-22. Jesus called to make "fishers of men." If we do not go fishing for men then we are not "fishers of men."

Following his remarks, Brother Harper presented to the Reverend Robert May a plaque of appreciation for his many years of ministry in the Albemarle Conference and the Original Free Will Baptist denomination.

We worshipped God by singing choruses and giving our offerings.

Sister Eunice Sexton, the Reverend Keith Pelletier, and Brother Billy Dilday were appointed to the Resolutions Committee.

The Executive Committee report was read by the clerk and it was accepted by motion.

The report of the Board of Ordination was read by the Reverend Harold Swinson. It was accepted by motion.

Reports

Board of Ordination

(July 27, 1996)

The Board of Ordination of the Albemarle Conference met July 27, 1996, at St. Paul Church, Elizabeth City with the following members present: the Reverends Everette Harper, Paul Grubbs, William Mobley, Robert May, Harold Swinson. The purpose of the meeting was to discuss a course of action to follow pertaining to a letter from the Board of Deacons of Union Chapel. After much discussion the following motion was passed. *By motion that we, the Board of Ordination of the Albemarle Conference, meet with the Deacons of Union Chapel, with Brother Mike present, to discuss the problems concerning Brother Mike Gray's license.* Motion was passed.

A meeting date was set for August 5, 1996 at 7 PM at Plymouth Church.

(July 29, 1996)

The Board of Ordination met July 29, 1996 at Shiloh Church with the following members present: the Reverends Everette Harper, Paul Grubbs, William Mobley, Robert May, Harold Swinson. The meeting was a discussion concerning the Extension of Brother Mike Gray's license for another year. *By motion: that Brother Mike Gray's license be extended for another year with the opportunity to return to the Board of Ordination within (6) six months and after examination be allowed to take the Ordination Exam following proper procedure according to Articles of Faith and Practices of the Original Free Will Baptist.* Motion was passed.

(August 5, 1996)

The Board of Ordination met at Plymouth First Free Will Baptist Church with the following members present: the Reverends Everett Harper, Harold Swinson, Paul Grubbs, William Mobley, Robert May. The purpose of the meeting was to meet with the Deacons of Union Chapel who had questions about Brother Mike Gray which pertained to his Ordination. After a discussion the questions were answered and the meeting closed with prayer.

(August 29, 1996)

The Board of Ordination met at Hickory Chapel with the following members present: the Reverends Everette Harper, Paul Grubbs, William Mobley, Robert May, Harold Swinson. The purpose of the meeting was a discussion concerning Brother Mike Gray's situation. *By motion: that the Board of Ordination of the Albemarle Conference act as Supervisor for Brother Mike Gray.* Motion passed. The next order of business was: *By Motion: that we as a Board begin to establish guidelines and policies which would be in the form of an Application Kit to be passed to prospective candidates for Licensing and Ordination as well as Ministers transferring to our Conference which would establish and inform each Candidate/Minister the requirements of the Licensing and Ordination and the process of transfer into the Albemarle Conference.* Motion passed.

(September 28, 1996)

The Board of Ordination met at Sound Side Church following the Union Meeting with the following members present: the Reverends Everette Harper, William Mobley, Paul Grubbs, Harold Swinson. The following items were discussed: *(1) Rev. Raymond Lagtcher presented to the Board*

of Ordination his Credentials stating that he wished to go into Full Time Evangelism. The board, after much discussion received his Credentials and shared with Brother Raymond their wishes for reconsideration. After more discussion Brother Raymond stated that this decision had not been reached easily but felt led of God to do as he was doing. By motion: that we receive Brother Raymond's Credentials. Motion passed.

(2) The Board met with Brother Mike Gray to inform him of the action of the Board Concerning his licensing and ordination process. By motion: that Brother Mike would now be under the supervision of the board of Ordination of the Albemarle Conference. By motion: that Brother Mike would be required to report to the Board of Ordination on a Quarterly basis with the following to be included in his report. A. A listing of all speaking engagements. B. A copy of study notes and sermon outlines for the Quarter. Motion passed.

(November 1, 1996)

The Board of Ordination met following the Sunday school Banquet which was at Sound Side with the following members present: the Reverends Everette Harper, Harold Swinson, Paul Grubbs, William Mobley. The board met with the Reverend Bob Harber who had been called to the pastorate at Sidney Church. After much discussion Brother Bob was welcomed to the Albemarle Conference and cleared to work with Sidney. It was noted that Brother Bob's Conference membership still remains in the Western Conference but he is cleared to work in the Albemarle Conference. Motion passed.

(January 3, 1997)

The Board of Ordination met at Plymouth First Church with the following members present: the Reverends Everette Harper, William Mobley, Robert May, Paul Grubbs, Harold Swinson, Brother Mike Gray and the Deacons of Union Chapel Church. It had been brought to the attention of the Board of Ordination that Brother Mike, who was serving as interim speaker at Trinity Church, had been conducting Communion Services and had ignored the Board's recommendation for supervision which had been extended to him. Other problems existed and it was noted at this meeting that Brother Mike's attitude was not desirable to continue working with Trinity and that Trinity had released him as of December 29, 1996, to which he refused to leave. It was with this information that the Board of Ordination of the Albemarle Conference chose to revoke the license to preach in the Albemarle Conference of Original Free Will Baptists. (It should be noted that Brother Mike was given an opportunity to turn in his license but he refused which forced the Board to take the following action.) By motion: to revoke Brother Mike Gray's license as of January 3, 1997, and that he and his family be advised as a directive of the Board of Ordination of the Albemarle Conference NOT to return to Trinity Church. To direct Brother Mike to send said license to the Clerk of Union Chapel who sponsored Brother Mike as soon as possible. Motion passed.

(January 9, 1997)

The Board of Ordination of the Albemarle Conference met at Union Chapel OFWB with the following members present: the Reverends Paul Grubbs, William Mobley, Robert May, Harold Swinson. The purpose of the meeting was upon request of Brother Raymond Lagtcher to have his Credentials returned. By motion: upon receiving the International Credentials and Card from Brother Raymond: that we reinstate Brother Raymond Lagtcher's Ordination Certificate and to

extend to him the right hand of fellowship in the Conference. That Brother Raymond be placed under the watch care of the Board of Ordination for one year. Motion passed.

(June 21, 1997)

The Board of Ordination met at St. Paul Church with the following members present: the Reverends Everette Harper, William Mobley, Paul Grubbs, Harold Swinson. The meeting was called to meet with Brother Kenneth Littleton concerning his return to the Denomination as an Ordained Minister. After much discussion the following motion was offered. *By motion: that we send to Brother Kenneth a letter of general recommendation which would be passed to him for presentation to the church which he now is attending. As he was in good standing at the time of his departure and that we had extended to him an invitation to return to the Conference when his life was in order, said letter of recommendation would assist him in his return to the pastorate in Virginia.* The next order of business was discussed. The Reverend Charles Parrish, who had been a former pastor in the Albemarle Conference petitioned the Board of Ordination for a transfer of his Conference membership to Georgia. After much discussion the following motion was passed. *By motion that we forward a letter to Brother Parrish stating that we could find no records of his membership in the Conference. We would advise him in the letter of this and ask for his assistance or for more information which would assist us.* Motion passed. The next order of business: Steps in Preparation for the Ministry Application Kit. In the past few months, the Ordination Board of the Albemarle Conference has been developing a tool to be used for persons desiring to be Licensed Ministers, Ordained Ministers, and Ministers who transfer into the Conference. *By motion to accept the Steps in Preparation to be instituted as a tool for the Ordination Board of the Albemarle Conference. Minutes to show that motion passed with an unanimous vote.* Motion passed.

(August 30, 1997)

The Board of Ordination met following the Union at Belhaven with the following members present: the Reverends Everette Harper, William Mobley, Harold Swinson, Paul Grubbs, Robert May. The meeting was called to examine Brother Charlie Clark, from Sidney Church for license. During the discussion it was learned that Brother Charlie had been a member for less than one year. After other discussion the following motion was offered: *By motion: the request for license by Sidney Church for Brother Charlie Clark be declared void. That Brother Charlie think and pray about this request and his call to the ministry. At the completion of one year of membership, he may return and begin the license process through the Application and Steps of Preparation in the Ministry.* Motion passed.

(September 17, 1997)

The Board of Ordination met at College Hall, Mt. Olive College with the following members present: the Reverends Everette Harper, Robert May, Paul Grubbs, William Mobley, Harold Swinson. The meeting was called at the request of Brother Dallas Pinkham. Brother Dallas was asking the Board for the correct procedure to follow in returning to the Ministry and to the Albemarle Conference. After much discussion it was learned that Brother Dallas had surrendered his credentials to the Eastern Conference Board of Ordination to which he was a member of at that time. Since then he has not been active in the Ministry. After discussion with Brother Dallas and his wife the following motions were made. *By motion: that Brother Dallas return to the Eastern Conference Board of Ordination and follow their requirements to return to fellowship with the Eastern Conference. Upon completion of this requirement he may return to the*

Albemarle Conference and apply for membership in said Conference. Motion passed. By motion: that Brother Dallas be allowed to speak as a lay speaker at Trinity Church until this process can be completed. He will have the privileges of a licensed minister until his completion of the process with the Eastern Conference as well as the Albemarle Conference. Motion passed.

The Missions Committee report was given by the Reverend Harold Swinson. It was accepted by motion.

Brother Harper read a portion of a letter from Dr. Michael Pelt asking someone to take names of those who wish to purchase his book, *A History of Original Free Will Baptists*. The Reverend Frank Harrison informed us that he had copies of this book at the Conference.

We had a time of testimonies and altar prayer which was voiced by Brother Robert May.

We entered into worship with the Reverend Mott Batchelor leading the congregational hymn, *Praise Him, All Ye Little Children*. The host church provided special music by asking Brother Everett Harper to sing. The Reverend Royce Reynolds, pastor of the host church, proclaimed the Word. His message was taken from 2 Chronicles 34:14-19.

(Afternoon Session)

The afternoon session opened with the congregation singing, "Wonderful Words of Life" led by the Reverend Mott Batchelor. The Reverend Bob Harber gave the devotion based on John 20:30-31.

The Reverend Scott Sowers gave the report of the Convention, and our ministries. The Moderator then recognized the following Ministry representatives: Sister Glenda Philips, Children's Home; the Reverend Frank Harrison, Mount Olive College; the Reverend Bruce Dudley, Retirement Homes; and the Reverend Paul Grubbs, Sunday school Board.

The Memorial Service was led the Reverends Billy Reynolds, Robert May, and Mott Batchelor. Mr. Lloyd Jones, Jr. gave the treasurer's report which was accepted by motion.

By motion: The Albemarle Conference back a tent meeting in Plymouth for one week by money (if needed) and by man-power. AMENDMENT: The details are to be left in the hands of the executive committee.

By motion: The Albemarle Conference will purchase a fire-resistant file cabinet.

The Nominating Committee Report was given by the Reverend Robert May and accepted by motion. The nominees were elected by acclamation.

The Resolution Committee Report was given by Sister Eunice Sexton. There were no resolutions.

By motion: We gave the hosting church a rising vote of thanks for their hospitality.

Our delegates to the 1998 Annual Convention of Original Free Will Baptists will be Sisters Eunice Sexton and Carolyn Reynolds.

The minutes of this Annual meeting of the Conference were read and accepted on motion.

The Reverend H. P. Norman led in the closing prayer.

Reports**Executive Committee****(October 9, 1996)**

The Albemarle Conference Executive Committee met at Mt. Tabor following the Conference meeting with some of our ladies to discuss the "subordinate" issue that was raised during the Conference meeting.

(March 9, 1997)

The Albemarle Conference Executive Committee met at Mt. Zion OFWB Church with the following members present: the Reverend Everette Harper, moderator; the Reverend Keith Pelletier, Brother Lloyd Jones, the Reverend Harold Swinson.

Devotion was by Brother Everette Harper from Matthew 28:16.

Prayer followed by Brother Keith Pelletier

Old Business:

- Information was passed to the committee concerning the action taken with Mr. Mike Gray.
- Information was passed to the committee concerning the action taken with Brother Raymond Lagcher.
- Information was passed to the committee about the meetings of Project Solution and the Family and Youth Committee by Brother Harold Swinson who represents the Conference on the Executive Committee of the Convention.

New Business:

- There was a discussion about the area in which the Albemarle Conference covers and the amount of water and beach that was present. The suggestion was that we consider a Camp of some kind to assist the Conference in its ministry.
- There was a discussion on the development of a mission within the Albemarle Conference. The committee discussed this at great length and after prayer we decided to pass this information on to the churches and ask that they be much in prayer and ask God for guidance in this matter.

Motion was made and passed that we present to Brother Robert May a plaque of appreciation for the number of years of service in the Conference and the Original Free Will Baptist denomination.

- Question was asked concerning the floods and if anything has been put into motion to assist the churches in the area.
- With no other business to come before the committee we were dismissed with prayer.

Note: Minutes were taken by Brother Harold Swinson in the absence of Brother Paul Grubbs, conference clerk.

(May 19, 1997)
