

Proceedings

The 62nd Annual Session of the Albemarle Conference of Original Free Will Baptist met Wednesday, October 4, 2006 at Shiloh Free Will Baptist Church, Pinetown, NC.

The Session began with the singing of "Are You Washed In the Blood," led by Bro. Lloyd Jones and accompanied by Mrs. Lucille Jones. The Reverend H. P. Norman brought the devotion from 1 Corinthians 15:1-4. The Reverend Al Markuson from the host church gave the welcome to the conference and The Reverend Billy Reynolds gave the response.

The clerk called the 61st Annual Session to order using the words of the late Oscar Webster, "I, David Pooser, clerk of the Albemarle Conference of Original Free Will Baptist do declare the 61st Annual Session of the Conference is now officially in session; for prayer and praise to God, for the preaching of His Word, and the transaction of any business pertinent to the ongoing business of said conference. May God to our good and His glory bless our coming together. The Reverend Bill Mobley, moderator, now presiding," and presented the moderator to preside over the session.

A motion was made and passed to adopt the program and to give the Moderator the power to make necessary changes.

The roll call of churches was made with twelve churches present, one excused and one absent.

The roll call of ministers was made with fourteen present, two excused and one absent.

The Reverend Bill Mobley gave the Moderator's address from Malachi 3:6 reminding us that while the world and the ways that are accepted by the world change, our God does not change. God's Word teaches us to dress in moderation, to separate from ungodly activities and that compromise on sin is unacceptable. Our need is to strive to build a Godly foundation and as churches of the Albemarle Conference to have higher standards than the world-God's standards.

The offering was taken.

The moderator appointed the following temporary committees:

Resolutions Committee: The Reverend Al Markuson, The Reverend Robert May, The Reverend Keith Pelletier.

The reports of the standing committees were given with no committee having any report.

Announcements of the revival services and winter events were heard from many churches in the Conference, and from many of the ministries of the Original Free Will Baptists.

Due to the time left before the worship service reports from 10 ministries of the denomination were heard at this time. Reports were heard from: Convention of Original Free Will Baptist, Children's Home, Church Finance, Cragmont Assembly, Sunday School, Home Missions and Evangelism, Free Will Baptist Press, Foreign Missions, Minister's Program, and Mount Olive College.

The Conference entered into worship with the Reverend Michael Williams giving the message.

The time of worship closed and directions were given to lunch.

The afternoon session began with a devotion given by The Reverend Woodrow Freeze from Genesis 1:1.

The remaining denominational ministries gave reports as follows: Retirement Homes, Camp Vandemere, Woman's Auxiliary and the Layman's League.

The nominating committee report was submitted for consideration.

The memorial service was led by The Reverend Bill Mobley.

Business Session

A motion was made and passed to delete unused parts of the annual report form and send the revised form out for the next conference.

The Nominating Committee report was passed as given to the conference.

A motion was made and passed to give \$500.00 to the Sunday School Board to use in mission work in our recovery efforts in Mississippi in the summer of 2007.

The Treasurer's Report was given by Mr. Lloyd Jones and accepted.
