The 63rd Annual Session of the Albemarle Conference of Original Free Will Baptist met Wednesday, October 10, 2007 at Trinity Free Will Baptist Church, Pantego, NC.

The Session began with the singing of "Tis So Sweet To Trust In Jesus," led by Bro. Lloyd Jones and accompanied by Mrs. Lucille Jones. The Reverend Al Markuson brought the devotion from the mission statement of Original Free Will Baptists reminding us of our calling and purpose. The Reverend Keith Pelletier from the host church gave the welcome to the conference and The Reverend Michael Williams gave the response.

The clerk called the 63rd Annual Session to order using the words of the late Oscar Webster, "I, David Pooser, clerk of the Albemarle Conference of Original Free Will Baptist do declare the 63rd Annual Session of the Conference is now officially in session; for prayer and praise to God, for the preaching of His Word, and the transaction of any business pertinent to the ongoing business of said conference.
