Rules of Order

1. The Moderator or Assistant Moderator or in their absence the oldest minister present shall call the Association into conference.
2. Each session shall be opened and closed with prayer.
3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
4. Visiting brethren are invited to seats as advisory members.
5. Those who speak shall arise and address the Moderator. Personal reflection shall be avoided in all debates.
6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
7. Motions made and lost shall not be recorded.
8. No one shall speak more than twice on the same subject without special leave of the Moderator.
9. The Moderator shall not allow discussions when not carried on in a Christian spirit.
10. The ruling of the Moderator may be overruled by a two-thirds majority membership voting.
11. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own Church.
12. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.

Proceedings

The Casa Grande, Arizona church and the Tucson church met in Casa Grande for the purpose of organizing an Association. The meeting convened at 10:00 A. M. on April 3, 1954. Services opened with singing and a portion of God's word was read by Elder J. L. Waltman (John 14: 1 through 23). Prayer was led by Brother German. Called to order by Moderator. Letters called for and read. Letters received and delegates seated. Visitors welcomed by Moderator.

1:00 P. M. Meeting reconvened and services began with singing led by Brother Russ and prayer. Each Church represented gave \$10.00 for the printing of the Minutes. Business being concluded the Meeting closed with singing and Christian handsake. The minutes were read and approved and Motion was made to Adjourn, carried. Closing prayer by Rev. M. W. Atkerson.

Articles of Faith

1. The Bible. We believe the scriptures of the Old and New Testaments were given by the inspiration of God, and are our infallible rule of faith and practice. Matt. 22:29, Mark 15:28; John 5:39; John 2:22; John 7:38; Acts 1:16; Acts 8:35; Acts 18:28; Rom. 15:4; Gal. 1:8; II Tim. 3:16-17; II Peter 1:12; 20-21.

2. God. We believe there are three persons in the Godhead, Father, Son and Holy Spirit, and that all things were created by them. L. John 5:7; Gen. ch. 1 and 2; Ex. 20:9-11; Psalms 33:6; Jer. 51:15; John 1:1-3; Acts 14:14-17; I Cor. 8:5-6; Eph. 3:8-18; Col. 1:9-17; Rev. 4:9-11.

3. Man. We believe that God created man innocent, but by disobedience he fell into a state of sin and death. His posterity, therefore inherited a fallen nature of such tendencies that all who come to the years of accountability, sin and become guilty before God. Gen. 2:15-17; Gen. 3:14-19; Isa. 53:6; Rom. 5:12-15; 1 Cor. 15:21,22; Gal. 3:22; 1 John 1:10.

4. Children Saved. We believe that children are born in a saved state and we must become like unto them if we enter into the Kingdom of Heaven. Mat. 18:2,3; Luke 18:16,17.

5. General Atonement. We believe that Christ died for all and whosoever will may be saved. Matt. 28; 19,20. Luke 24:45-47; John 3:16; I Tim. 2:1-6; Titus 2:11; Heb. 2:9; II Peter 3:9; I John 2:1,2; Rev. 22:17.

6. Terms of Salvation. We believe the terms of Salvation are: 1st. Repentance or sincere sorrow for sin and a hearty renunciation of it. 2nd. Faith or the unreserved committal of one's self to God through faith in Christ with a purpose to love and through faith in Christ with a purpose to love and obey Him in all things. Luke 14:25-27; Luke 24:45-47; John 3:16; Acts 10:43; Acts 15:8,9; Acts 16:31; Rom. 5:1,2; Rom. 10:8-13; Gal. 3:26; Eph. 2:8,9; Heb. 11:6.

7. Divine Call to the Ministry. We believe that God in His wisdom and goodness displays His power of Grace in a great degree in calling and qualifying His servants by the teaching of the Holy Spirit to go forth and proclaim life and salvation. Yet those who are called are commanded to study to show themselves approved unto God, etc. John 5:39; John 1:16,17; Acts 18:27,28; Acts 20:28; Acts 22:14,15; Rom. 10:14,15; Gal. 1:11-23; III Tim. 2:15; Titus 1:7-9.

8. The Church. We believe that the church of God or Christ is the whole body of Christians throughout the world.

Matt. 16:18; Acts 2:46,47; I Cor. 12:13-20; Eph. 1:22,23; Col. 1:18-24; I Tim. 3:14,15; Heb. 3:6; Eph. 4:4-6.

9. A Church of God. We believe that a church of God is an organized body of believers in Christ who statedly assemble to worship God and keep the Ordinances of the Gospel according to the Scriptures Matt. 18:15-17; Matt. 28:18-20; Acts 8:1; Acts 13:1-3; Acts 14:23; Rom. 16:1-5; I Cor. 11:12; I Cor. 11:23-48; I Cor. 16:19; Col. 4:15,16; Titus 1:5; I Peter 5:13; Rev. 1:11.

10. Ordinances. We believe that Baptism, Communion and feet washing are Gospel Ordinances and should be observed by the people of God. Matt. 26:26-28; Mark 14:22-24; Luke 22:18,20; John 13:4-13; Matt. 28:19,20; Acts 2:41; Acts 8:12; Acts 8:35-38; Acts 9:18; Acts 10:47,48; Acts 16:33; I Cor. 11:23-26; I Tim. 5:9,19.

11. Baptism. We believe that immersion in the scriptural mode of baptism. Matt. 3:5,6; Mat. 3:13-17, Mark 1:5-11; John 3:22,23; Acts 8:36-39; Rom. 6:3,4.

12. Open Communion. We believe that the Lord's people are one in Him, therefore should be on at His table. John 15:5; John 17:11-21; I Cor. 11:23-29; I Cor. 12:13-21; Gal 3:26-29.

13. The Christian Sabbath. We believe that the Divine Law requires that one day in seven be set apart for the worship of God and that no work of worldly nature should be done on that day. Work of piety, mercy and necessity excepted. Mark 13:1,2; John 20:1,19,26; Acts 13:27; Acts 16:13; I Cor. 16:1,2; Rev. 1:10,11.

14. Apostasy. We believe that only those Christians who through grace and patience endure unto the end have promise of Eternal Salvation. Ezek. 18:24-26; Matt. 10:22; Matt. 24:12,13; Matt. 24:48-51; Matt. 25:14-30; Mark 13:13; Luke 12:45,46; John 15:1-6; Rom. 11:21; I Cor. 10:11,12; I Cor. 15:12; I Thes. 3:4,5; Heb. 6:4-6; Heb. 10:24-30; Heb. 3:1-6; Peter 1:9-11; II Peter 2:12-16; II Peter 2:20-22; Rev. 2:10; Rev. 3:5.

15. Resurrection. We believe in the resurrection of all men. They that have done good unto the resurrection of life and they that have done evil unto the resurrection of life and they that have done evil unto the resurrection of damnation. John 5:28-29; Acts 4:1,2; Acts 17:18; Acts 23:3; Acts 24:14,16; Acts 26:6-8; I Cor. 15:12,22; I Thes. 4:15-17; Rev. 20:12-15.

16. General Judgement. We believe that there will be a general or universal judgement when all nations will be gathered before the Judgement Seat of Christ, to be judged according to their works. The wicked shall go away into everlasting punishment, but the righteous into life eternal. Eccl. 11:9; Eccl. 12:14; Matt. 12:36,37; Matt. 13:37-43; Matt. 25:31-46; Mark 9:43-48; John 5:28,29; Acts 10:42; Acts 17:30,31; Rom. 14:10-12; II Cor. 5:10; Heb. 9:27,28; Rev. 20:2-15; Rev. 21:7,8.

Church Covenant

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to grow in grace and the knowledge of our Lord and Saviour Jesus Christ.

We will not forsake the assembling of ourselves together for church conferences; public worship, and observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society constantly praying and tilling that the Kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denomination enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the Salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.
