The annual sermon was delivered by Elder A. A. Davis at 10:15 a. m., text, John 3:16, followed by Bro. J. W. Phelps. The moderator proceeded to call the association to order.

The secretary being absent, Brother J. H. Johnston was elected secretary pro tem, and Brother J. L. Redwine reading clerk.

Report on Resolutions was again called for, and reported as follows: We, your committee, beg leave to make the following report:

Important Instructions.

1. Be it Resolved, That we advise the subordinate associations of the state of Arkansas, to hold their annual sessions previous to the third Sunday in October in each year; and that each subordinate association elect its delegates to the State Association to bear the manuscript complete which will represent said association in full; and said manuscript shall be printed with the state minutes as prepared. Said delegates are required to bring with them such contributions as will pay their prorato part for the printing of the But if any subordinate association should fail to delegate to the State Association, the manuscripts shall be sent together with the contribution to the Treasurer of the State Association, whose name and postoffice address appears in the minutes; whose duty it shall be to forward the manuscripts to the clerk of the State Association with a statement of how much money has been sent to him from subordinate associations. shall be the duty of the treasurer to hold the funds sent to him for publication of minutes until the state committee elect, has made a contract with some publisher to publish the minutes, then the treasurer, after being notified by the state committee that the contract is made; shall at the demand of the state committee, send the amount required for publication to the state clerk.

2. The clerk of the subordinate associations should get their manuscripts ready to send to the State Association by the 18th of

October, and if the delegate should fail, it should be sent by the date mentioned above.

3. Resolved, That we elect an additional corresponding clerk, (see above) also a state treasurer.

4. Resolved, That Bro. J. H. Johnston be elected state treasurer. Adjourned to meet at 2:30 p. m.

10. Resolved, That Bros. J E Partain, H Baer and F M Hudson. Jr., be elected state finance committee.

11. Resolved, That said committee have the supervision over the contemplated printing press.

12. Resolved, That this Association empower each pastor of each church to raise at least five dollars at each church for our state evangelist.

13. Resolved, That G W Burris act with the state finance committee.

We, your committee, beg leave to make the following report, It is our honest conviction that intemperance is the direct cause of nine-tenth of all the crimes on earth: that it is the mighty lever prying at the very foundation of Christianity and invades peaceful homes of men, blighting and withering the fairest flowers of our land; clouding the minds, corrupting the morals and deadening the sensibility of both young and old age, making widows of happy mothers and mendicants of orphan children. It wrecks happy lives and families, and laughs at the ruin it has wrought. It corrupts the bar, the bench and the pulpit, the State legislatures and the halls of Congress, and no race of people nor class of society is exempt from its ravages. Therefore, we believe it to be our duty as Christians and children of a pure and holy God, to banish this demon from our church and country; and as a means of so doing, we believe it to be the duty of this Association to have at least one lecture on temperance at its annual session and on all other public occasions, especially our district meetings.

# Constitution of the State Association...

From a long experience, we, the members of the Freewill Baptists Church of Christ, being baptized upon the profession of our faith in Christ, and being convinced of the necessity of a combination of subordinate associations to perpetuate a union and a communion among us and to preserve and maintain a correspondence with each other, do therefore ordain this Constitution for our better gevernment.

Section 1. This Association shall be composed of members chosen by the different subordinate associations in our union not exceeding five delegates each. Provided all ordained min-

isters shall be full ex-officio members when present.

Sec. 2 Letters from different associations shall express their number in fellowship, the number received by experience, letter, recommendation, and that have been dismissed, excluded, died or restored; also time and place of meeting, with name and P. O. Address of the Moderator and the Clerk.

Sec. 3. The members thus chosen and convened shall be denominated the Arkansas State Association of Freewill Baptists and shall have no power to lord it over God's heritage, nor shall have any ecclesiastical power over the associations composing this body, reserving the right of withdrawing from any association becoming disorderly.

Sec. 4. The Association shall have a Moderator and Assistant Moderator, a Recording Clerk and Treasurer, and a Corresponding Clerk, who shall be chosen by the suffrages of the

-members present.

Sec. 5. Newly constituted associations may be admitted

and if upon examination they are found to be orthodox and orderly, may be received into the Association by the right hand of fellowship being extended to them.

Sec. 6. No query from any association shall come under the consideration of this body unless it has first been discussed

in the body in which it originated.

Sec. 7. All motions made and seconded shall come under the considerations of the association unless withdrawn by unanimous consent.

- Sec. 8. This association is to endeavor to furnish the subordinate associations with minutes of this association in proportion to the number of members in each subordinate association, the distribution being at the discretion of the association.
- Sec. 9. It shall be the duty of the Recording Clerk to keep a file of the minutes of each association in a book to be kept for that purpose, and the Corresponding Clerk shall conduct the correspondence.
- Sec. 10. The association shall have a fund for her support, which shall be supplied by voluntary contributions of the subordinate associations, whose duty it shall be to send it by the hands of their messengers; which money so sent shall be deposited in the hands of the Treasurer, and he shall be accountable to the association for all moneys by him received until paid out as it may direct.
- Sec. 11. The association, in case of failure of any subordinate association to attend, may inquire the cause.
- Sec. 12. It is the duty of this association to see after the union of associations.
- Sec. 13. The minutes of the association shall be read, and corrected if needed, and signed by the Moderator and Clerk, before the association shall adjourn.
- Sec. 14. Amendments to this plan of form of government may be made at any time when a majority of the members may deem it necessary.

## Rules of Order.

1. At every sitting of the association, business shall be opened and concluded by prayer.

- 2. Those who speak shall rise, address the Moderator; and personal reflections shall be avoided.
- 3. All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.
- 4. If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken seperately.
- 5. Motions made and lost shall not be recorded on the minutes unless so ordered at the time.
- 6. No one shall speak more than once on the same subject withour special leave from the body.
- 7. All questions shall be decided by a majority of the members present.
- 8. No member shall absent himself without leave of the Moderator.
- 9. At the future sessions of this Association arrangements shall be made so as to insure two sermons, or other devotional exercises which shall be equivalent thereto, during each day of the session, and that the chair announce before adjournment who shall fill the stand at the next meeting.
- 10. Alterations may be made in these rules at any regular session of the Association.



## Articles of Faith.

1. We believe in one true and living God, the Father, Son and Holy Ghost, and these three are equal in divine essence, power and glory. Rom. 1:21. John 5:7.

2. We believe that the scriptures of the Old and New Testaments is the Word of God, and the only infallible rule of faith and practice. II Tim. 3. John 10:30. I John 5:7.

3. We believe that God created man good and gave him holy commandments, whereby he should live holy, but man voluntary disobeyed the commandments of God, trangressed the law and fell under the just condemnation of the same whereby all mankind are sinners, not by constraint, but by choice, being partakers of the sinful nature attained by the

power, But we see Jesus, who was made a little lower than the angels for the suffering of death, crowned with glory and honour; that he by the grace of God should taste death for every man. Gen. 1:31. Heb. 2:9.

- 4. We believe that Christ by his death, burial and resurrection purchased our pardon and offers it freely to all mankind upon the principle of repentance toward God and faith in the Lord Jesus Christ. He now commands all men everywhere to repent: therefore Look unto Me and be ye saved all the ends of the earth, for I am God and there is none else. Matt. 4:17, Isa. 45:22. Acts 20:21,
- 5. We believe that adult persons must be regenerated and born of the spirit of God if they inherit eternal life. John 3: 3, Rom. 5:1-13.
- 6. We believe that all Christians should persevere in grace, and be faithful to the end if they inherit eternal life for blessed are they that do his commandments that they have a right to the tree of life and enter in through the gates of the city. I Cor. 10:12413. Rev. 22:14.
- 8. We belive the visible church of Christ is a congregation of faithful men and women who have obtained fellowship with each other and have given themselves to the Lord and one another, having agreed to keep up good discipline according to the rule of the gospel. I Cor. 1:2-10.
- 9. We believe that Jesus Christ is the great head of the church, and the government thereof is with the body. John 10:7-14. Col. 1:18. Matt. 18:17-18.
- 10. We believe that baptism by Immersion was the apostolic mode, even the burial of a believer in water, and that Christ who is our life showed this humble example to His children and bids us walk therein. Matt. 3:4-16. Rom. 6:4-5. Matt. 28:19-20. Mark 1:9-11.
- 11. We believe that God in his goodness displays power of grace in a great degree in calling and qualifying His servants by the teaching of the Holy Ghost and by the instruction of his blessed word to go forth and proclaim life and salvation, without price. He bids us freely to come and nothing prevents the salvation of any but their own stubborn rebellion and sinful refusal to come. I Cor. 1:23. Eph. 3:7. Rev. 22:17.
  - 12. We believe that baptism, the Lord's Supper and the

washing of the saints feet are ordinances of the gospel of Jesus Christ and that the keeping of the Lord's day holy and abstaining from wordly lusts and carnal cares and the assembling of ourselves together are ornaments which prepare and beautify the soldier of the cross to march onward in the army of the Lord. Matt. 26:28. John 13:14-15. Ex. 20:8-10. Heb. 10:25.

- 13. We believe that none has a right to baptism only those who have obtained a hving hope in the Lord Jesus Christ, and that none a right to administer the same only those who are called of God and have come under presbytery of elders. Tit. 1:15.
- 14. We believe it is the duty of each church to assemble themselves together once a month, and that it is the duty of the pastor of the church when setting forth the Lord's Supper and washing the saints feet, to invite all Christians. Heb. 10:25. I Cro. 11:27.28.

#### Constitution of Subordinate Associations.

From a long series of experience, we, the churches of Jesus Christ, being regularly baptised upon the profession of our faith in Christ, are convinced of the necessity of a combination of churches to perpetuate a union and communion among us, and to preserve and maintain a correspondence with each other, we therefore propose to keep orders and rules of our Association according to the following plan or form of government.

Section 1. This Association shall be composed of members chosen by the different churches in our union, and each church is entitled to three Messengers. All ordained ministers of our faith and order shall be members when present.

Sec. 2 Letters from different churches are to express their number in fellowship, the number received by experience, letter or recommendation, dismissed, excluded, restored, and that have died since last Association, and the name of the Clerk, county, post office, and Sabbath of meeting.

Sec. 3. The members' thus chosen and convened shall have no power to lord it over God's heritage; nor to have any

ecclesiastical power of the churches reserving the right of withdrawing from any church acting disorderly.

Sec. 4. The Association shall have a Moderator and a Clerk, who are to be chosen by the suffrages of the members

present.

Sec. 5. New churches may be admitted into the Association by letter or delegates, if found to be orthodox in the faith of the Freewill Baptists, the Moderator giving the right hand of fellowship.

Sec. 6. No question presented by the delegates of any church shall be discussed in the Association unless it has

been thoroughly discussed in their own church.

Sec. 7. All motions made and seconded shall come under the consideration of the association unless it be withdrawn by the members making it.

- Sec. 8. The association is to endeavor to furnish the minutes of this association in proportion to the number of member in each church, the distribution being at the discretion of the association.
- Sec. 9. It shall be the duty of the Clerk to keep a regular file of the minutes.
- Sec. 10. The minutes of the association shall be read and corrected, if needed, and signed by the Moderator and Clerk before the Association closes.
- Sec. 11. The association shall have a fund for her supportt which shall be supplied by voluntary contributions of the churches whose duty it shall be to send it by the hands of messengers; which money so sent shall be deposited in the hands of the Treasurer for that purpose, and he shall be accountable to the association for all money by him received until paid out as they may direct.

Sec. 12. The association, in case of failure of any church to attend, may inquire into the cause.

Sec. 13. It is the duty of this association to see after the union of the churches.

Sec. 14. Amendments to this plan of form of government may be made at any time when a majority of the members may deem it necessary.

To the Freewill Baptists throughout the State of Arkansas:


