Report of Ministers' meeting at Little Rock, by L. C. Doyle. A very interesting talk was made by F. M. Hudson on Bill No. 1, pending in the coming election, in regard to the evolution theory being taught in our public schools. He advised the people to vote for the bill.

Special song by W. M. Guinn, L. C. Doyle, J. W. Coffman and J. D. Coffman. Text. Heb. 12-1. In this service an old time revival broke out and people shouted while the preachers preached.



#### SATURDAY MORNING BUSINESS SESSION

Called to order by Moderator, scripture lesson, first chapter of John. Prayer by L. J. Smith.

The new list of articles of faith was read section by section and voted on in the same way. All were unanimously approved of by the convention, except Article 17, on the Sabbath Day, which was referred back to the committee, and later approved. Be sure to see the report of the committee that will appear in the report of committees, on these articles. These committeemen were chosen by the different associations in the state, to draft a code of articles, that all associations could approve of, in order that each association would have identically the same worded articles, and if adopted by the majority of the associations, between now and the next state meetings, they will become the treatise of the Freewill Baptists in Arkansas, and each association, who is a part of the state association, must approve of, and carry these treatise in their minutes. The Free Will Baptists want to preach and speak one and the same thing in Arkansas. They will appear in these minutes for your approval or rejection. Read them carefully, use both, your English and scriptural reference to see if they can be improved upon, in order that the doctrine that we stand for, and believe the Bible to teach may be more intelligently put before the world.

Business session recessed until two o'clock p. m.

Devotional service at eleven o'clock. Preaching by Eld-

ers M. G. King and T. H. Dixson. Song service directed by J. W. Coffman. Scripture lesson, twenty-third chapter of Psalms. Song by W. M. Guinn. Text, Tim. 4-2. A wonderful message was delivered to those present by these brethren. All surely enjoyed the hour.

#### SATURDAY AFTERNOON SESSION

Song directed by J. W. Coffman. Prayer by E. W. Tucker. Article on the Sabbath Day that had been referred back to the committee was returned and approved in its original form, by the convention.

Report of Committee on Sabbath Schools received.

Report of Committee on Non-represented Associations was received.

Report of the State Sunday School Convention was received and the minutes ordered printed in the state minutes.

Motion to empower the chair to appoint such members as would be necessary for any organization work in associations not represented by delegations.

Resolutions number one, two, and three adopted.

It was reported that the Free Will Baptists had a church house and lot in Tyronza that was worth several hundred dollars, and the church at that place had gone down. Brothers Blaylock, Smith and Million was appointed to look after this matter and report to the board of trustees, who will have the power to dispose of it if they see fit.

A hot contest was waged between Branch, of the Arkansas Association, and Mt. Bethel, of the New Hope Association, for the next state meeting. The vote standing 29 to 22 in favor of Branch. This place is near the center of the state in Logan county, a few miles east of Charleston. Those going from north and east of the Arkansas River will cross the river at Dardanelle, and travel the river road west by way of Paris, Highway No. 22.

The meeting will convene, Thursday night before the first Sunday in October, 1929. Elder Geo. W. Million of Pocahontas and County Judge of Randolph county will preach the introductory sermon.

Recess was declared by the Moderator until the night session.

Saturday night service was opened with singing by the choir, directed by J. W. Coffman. Prayer by L. J. Smith. Song by choir.. Prayer by L. C. Doyle. Special Song by W. M. Guinn and Miss Edith Brooks.

Paper on "Communion and Feet-Washing," that had been prepared by G. W. Burris, read by Miss Irene Burris.

Scripture lesson, the fifth chapter of Romans. Preaching by Elder L. C. Doyle, Text from the chapter read. Brother Doyle who lives at Newport, Arkansas, is a very able minister. He has ably met men of other faith in public discussion, and he sure did use this lesson in a very instructive and constructive way, and it was enjoyed by all present. The close of the business session of this meeting was by taking the parting hand, by the delegates and those present at the close of this service. Thus goes into the records, another great service of this convention.

Adjourned to meet Sunday morning at ten o'clock.



#### SUNDAY MORNING SESSION

Was opened at ten o'clock, with singing by the choir, and a special song, "Jacob's Ladder," by J. D. Coffman. Thirty minutes' talk on Sabbath School, W. F. McGee of Russellville, President of the state Sunday School Convention.

The eleven o'clock service was assigned to Elder T. H. Dixson, with a special subject, "The General Church Question." Text, "The Foundation of the Apostles and Prophtes, Jesus Christ Being the Chief Cornerstone." Eph. 2:19-20. This message was very deliberative, carrying with it, the theory, that all persons needing salvation, from the fall of man, in the Garden of Eden, to the restitution of all things, are saved on the same foundation, and that foundation is Christ, and that the Church of God or Christ is the redeemed in the aggregate. At the close of this service, many penitents came to the alter weeping, and one precious soul was redeemed.

Elder Dixson is devoting his entire time to the cause, and is doing a great work throughout the entire state, preached some in Oklahoma and Texas. Has met scholarly men in public discussion, on the church question.

At the close of this service the delegates took the parting hand, and left for their homes, praising God for the wonderful blessings of this convention, and the association and hospitality of the good people of Sharum community.

Elders T. H. Dixson and W. M. Guinn remained over and held a week's meeting, which resulted in a number of conversions and several additions to the Church.

#### TEMPERANCE

We, your Committee on Temperance, wish to submit the following:

We are truly glad of the Eighteenth Amendment, and the Volstead Act, with the effect it has had on our great nation and Christian Society. We point with pride to these records: Prohibition stopped the annual production by licensed dealers of over two billion gallons of intoxicating liquor. The report of the federal commissioner on prohibition for April, 1928, shows the production of distilled spirits, (whiskey, rum, gin, brandy and alcohol) produced in the United States by licensed distillers fell from two hundred and eighty-six million gallons in 1917, to eighty-two million gallons in 1922. A falling off in the manufacture of over two hundred million gallons of strong drink the first year of war prohibition.

Nor was that all. The importation of seventeen million gallons of liquor was stopped.

Nor was that all. In 1918, there were fifty-one million gallons of wine manufactured in the U. S. A. by licensed makers; in 1927, there were four million gallons produced.

Nor was that all. In 1917, there was one billion eight hundred seventeen million gallons of beer manufactured by licensed brewers, today there is not a licensed brewer in the United States.

The following tabluation shows the reduction of liquor produced in the United States by licensed dealers since prohibition came into effect:

Total 2,050,000,000 Prohibition has stopped the legal manufacture of over two billion gallons of intoxictaing liquors, and yet there are those

who claim there is more liquor consumed today than there was prior to prohibition.

The death rate in the United States declined over ten per cent following prohibition. In New York City, where prohibition is least enforced, the death rate shows to be twenty-five per cent less the five years following prohibition than it was the five years prior to it. The Metropolitan Life Insurance Company showed a death rate of 8.5 in 1925, its lowest rate on record.

We only wish that we could give to our members the records in full on prohibition, but space will not permit. May we ever be on our guard and keep the liquor demon warded off.

## ARTICLES OF FAITH

#### (Reported by Committee and Adopted by Convention) (See Report of Committee)

1. GOD—We believe in one true and living, Triune God; Composed of the Father, Son and Holy Spirit, equal in divine essence, Purpose, Power and Glory. St. John 1:1; I Cor. 8:6; I John 5:7; St. John 10:30.

2. CHRIST--We believe that Jesus Christ is the divine son of God. Was with the Father and the Holy Spirit at the time of the Creation, ieft the Courts of Heaven and came to this earth. Took upon himself the form of humanity, sin accepted, by being born of the Virgin Mary, manifested his power, was crucified, placed in Joseph's new tomb, arose from the dead the third day, completing the great plan of salvation, walked and talked with his deciples, publicly ascended up to heaven, and that he will descend again to gather his jewels home. Isaiah 9:6; St. John 1:14; Luke 1:26-28; Math. 14:13-21; Mark 16:9-19; Luke 24:50-53; Acts 1:9-12; Mark 15:22-41.

3. HOLY SPIRIT—We believe the the Holy Spirit has visited true believers in all ages, and especially since the ascension of the SON back to the Father, and its coming on the day of Penticost. Has taken up its office work among all nations of people, as a Divine Reprover, Comforter and Guide. Judges 6:34; 11-29; St. John 16:8-14; Isaiah 63:10-12; Eph. 4:30; Acts 8:17-20.

4. THE BIBLE--We believe the Bible which is composed of the scriptures of the old and new testaments was given by Inspiration of GOD, is our waybill from earth to heaven, and only infallible rule of faith and practice. II Peter 1:19-21; II Tim. 3:14-17; Daniel 10:21; Acts 1:16-17; Math., 21:42.

5. THE FALL OF MAN—We believe that GOD created man good, gave him a just law by which he should be governed, with promises of reward for faithfulness and with penalties of punishment for disobedience. Gave man power of free moral agency to choose the right and reject the wrong. But our first parents heeded the voice of the great enemy of Souls, voluntarily transgressed the law of GOD, fell with all their posterity, under the just penalty of the same, and was unable of their own power to extricate or save themselves from the great dilemma into which they had fallen. God gave to them the hope of salvation through the coming CHRIST. Gen. 1:27; Gen. 2:16-17; Rom. 11: 11-35; Psalms 37:23-24; Rom. 5-18.

6. REDEMPTION, SALVATION, ADOPTION—We believe that Jesus Christ by his birth, death, burial, resurrection and ascension, paid the purchase price of the redemption of the whole human race, arranged a pardon for all who come to him upon Gospel terms; and a law of adoption into the Kingdom of Heaven, and an eternal inheritance into the glorified Kingdom above. Heb. 9:12; Gal. 3:13; 4:4-5; Titus 2:14; Heb. 1:4; St. John 3:16; Isa. 45:22.

7. CONDITIONS OF SALVATION—We believe that all persons dying in infancy; and all idiots are saved by the atoning merits of the Son of GOD without any act upon their part; that persons coming to the years of accountability, transgressing the law of God, must upon their part exercise faith in Jesus Christ through repentance toward God, at the completion of which pardon takes place in the mind of the Father and by the Holy Spirit they pass through the ordeal of regeneration, are washed in the blood of the lamb and are planted in the Kingdom of Christ. John 3rd chapter; Math. 19:13-22; Sec. Cor. 7:10; Luke 18:16-17; St. John 4:11-16; Psalms 98:3.

8. SALVATION FREE—We believe that God desires the salvation of all; Christ died for all; the gospel invites all; the Holy Spirit strives with all, and whosoever will may come and be saved upon the terms of the gospel. First Peter 1:9-13-25; 2:9-24-25; Rev. 22-17.

9. BAPTISM—We believe that christian baptism is the immersion of believers in water, in the name of the Father, the Son and Holy Spirit, in which is represented the burial and resurrection of Christ; also represents our death to sin, and only those who have come under the presbytery of elders are qualified to administer the same. Math. 3:14-15-16; 3:5-6; First Peter 3:21; St. John 3:23; Acts 10:47; Math. 28:19.

10. COMMUNION AND FEET WASHING—We believe that the Lord's supper and the washing of feet are ordinances of the gospel of Christ; the Lord's supper was instituted by our Savior to commemorate



his broken body and shed blood for the sins of the world, and to show our remembrance of him till he comes. All christians have a right to the Lord's supper and should be invited; "let a man examine himself and so let him eat."

The washing of feet was instituted by our Lord at the same time that the supper was instituted as an act of humility to show our love for each other and both ordinances should be perpetuated by all christians until His second coming. Luke 22:19-20; First Cor. 11:20-29; St. John 13:1-18; Math. 26:26-27-28-29.

11. THE SABBATH—We believe that the Christian Sabbath should be observed as a day of rest and for the worship of God; that we should abstain from all sinful amusements and secular employments, works of mercy and piety excepted. Exodus 20:11; Exodus 31:12-18; Deut. 5; 12-15; Ezek. 20:12; Math. 28:1; Luke 23:56; Acts. 13-42-48; Mark 2-27.

12. CALL TO THE MINISTRY—We believe in a divine call of the ministry; that God in his goodness and power of grace, impresses His ministers with the burden of lost souls, to the extent that the call becomes irresistible with personal contentment; that when they yield to the call and exercise their native gifts according to the scriptures with a full reliance upon him, he accompanies them in the person of the Holy Spirit to guide them in the way of truth and to bless their labors according to his purpose. Jonah 1:1; Jer. 1:5; Mark 3:14; Acts 1:22-26; Math. 28:19. 13. THE INVISIBLE CHURCH—We believe that the Invisible or

Spiritual Church is the redeemed in the aggregate, is the family of God, is composed of all true christians of every congregation from righteous able to the restitution of all things, from every kindred, nation, tongue and people. Ephes. 3:16-21; Heb. 12:22-23; First Peter 2:5; Ephes. 2:20-22; Acts 2:47; Math. 16:18.

14. THE VISIBLE CHURCH—We believe that a visible Church of Christ is a congregation of faithful men and women, having obtained fellowship with the Lord and with each other, agreeing to keep up a good discipline and doctrine according to the rules of the gospel. PERSEVERANCE—We believe that all true believers in Christ should persevere in divine grace, and in the knowledge of the truth and that God's grace is sufficient to help them to overcome all the obstacles of life and that all the combined forces of the great enemy of souls on earth and in Hell (or in his eternal abode) are not able to pluck them from his hand so long as they walk in the path of duty; but those who sidestep and wilfully refuse or neglect to perform their duty they would backslide and is persistently continued would be eternally lost. Sec. 1:12; Second Cor. 9:10; Second Peter 1:4-8; First Peter 2:2; Rom. 8:35-39. Apostasy: Second Peter 1:8-9; First Cor. 10:1-13; Heb. 12:15-17; First John 5-16; Heb. 6:1-6; First Tim. 4:1-2; Heb. 3:12; St. John 15:1-7; Math. 12:31-32.

16. CHRIST THE HEAD OF THE CHURCH Be believe that Christ is the great head of the Church, and that the government of the local church is with the body. Col. 1:18-19; Math. 16:18; Heb. 12:23; Math. 21:42; Ephes. 1:22; Acts 16:4-5.

17. SANCTIFICATION—Sanctification is a work of God's grace, by which the soul is cleansed from all sin and wholly consecrated to Christ. It takes place in regeneration, and the christian can and should abide in this state to the end of life, constantly growing in the grace and knowledge of our Lord Jesus Christ. I Cor. 6:11; II Thes. 2:13; Heb. 12:14; Phili. 3:21; Sec. Thes. 5-19-23; St. John 17-17-19; Sec. Tim. 2-20-21.

19. THE RESURRECTION—We believe in the resurrection of the dead, both of righteous and the wicked. When the resurrection shall take place, the soul and body shall be reunited, the righteous shall be received into everlasting happiness to reign with God forever; but the wicked shall go away into everlasting punishment. Math. 28:6; St. John 5:28-29; I Cor. 15: 51-58.

18. THE SOUL—The soul is endless, hence does not die with the body, but immediately after death enters into conscious state of happiness or misery according to the spiritual character here possessed. Phil. 1-23; Luke 23-43; Rev. 6-9; Luke 16:19-25; Math. 10:28.

20. JUDGMENT—We believe that there will be a general, universal judgment, when all men shall be judged according to their works whether they be good or bad, and that immediately thereafter the wicked shall enter into everlasting punishment, and the righteous into eternal happiness. II Thes. 1:4-9; Rev. 14:9-13; Luke 16:23; Rev. 21:8; II Cor. 5:10; Math. 12:36-37; Rev. 20:12-13; Acts 17:31.



## CONSTITUTION

From a long series of experiences, we, the Association of Jesus Christ, being regularly baptized upon the profession of faith in Christ, are convinced of the necessity of a combination of Associations to perpetuate a union and communion among us, and to preserve and maintain a correspondence with each other, we therefore purpose to keep order and rules of our Association according to the following plan of government:

1. The State Association shall be composed of five Messengers chosen by each District Association of this union and all regularly ordained ministers.

'2. Letters from different Associations shall express their number in fellowship, the number received by experience, letter or recommendation, dismissed, restored, and that have died since our last Association; and the name of the clerk, moderator, county, postoffice, Sabbath of meeting, and the amount paid for Minute Fund.

3. The members thus chosen and convened, to be denominated the State Association of Freewill Baptists, being composed of the subordinate Associations of the State of Arkansas, and the Association to have no power to Lord it over God's heritage, nor to have any ecclesiastical power of the Association, reserving the right of withdrawing from any Association becoming disorderly.

4. The Association shall have a Moderator, Clerk, and a Corresponding Clerk, who are to be chosen by the suffrage of the members present.

5. New Associations may be admitted into the Association by letter and delegates, if found orthodox in the faith of the Freewill Baptists,

the Moderator giving the right hand of fellowship.

6. Every motion made and seconded shall come under the consideration of the Association unless it be withdrawn by the members making it.

7. This Association is to endeavor to furnish the subordinate Associations with the minutes of this Association, in proportion to the number of members in each Association, the distribution being at the discretion of the Association.

8. It shall be the duty of the Clerk to keep a regular file of the Minutes.

9. The Minutes of the Association shall be read and corrected, if needed, and signed by the Moderator and Clerk before the Association closes.

10. The Association shall have a fund for her support, which shall be supplied by voluntary contribution of the Association, whose duty it shall be to send it by the hands of messengers, which money so sent shall be deposited in the hands of the Treasurer for that purpose, and he shall be held accountable to the Association for all money received by him until paid out as they may direct.

11. The Association, in case of failure of any Association to attend, may inquire into the cause.

12. It is the duty of the Association to see after the union of the Associations.

13. Amendments to this plan of government may be made at any time when the majority of members may deem it necessary.



## RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded with a prayer.

2. Those who speak shall rise, address the Moderator, and personal reflections shall be avoided.

3. All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.

4. If any proposition or motion under debate contain two or more points, it shall be divided at the request of any member and the vote taken separately.

5. Motions made and lost shall not be recorded on the Minutes, unless so ordered at the time.

6. No one shall speak more than once on the same subject without special leave from the body.

7. All questions shall be decided by a majority of the members present.

8. No member shall absent himself without leave of the Moderator.

9. At the future sessions of this Association arrangements shall be made so as to insure two sermons, or other devotional exercises which shall be equivalent thereto, during each day of the session, and that the chair announce just before adjournments who shall fill the stand at the next meeting.

10. Alterations may be made in these rules at any regular meeting of the Association


