

PROCEEDINGS

WEDNESDAY EVENING, SEPTEMBER 28, 1960

The Sixty-third Annual Session of the Arkansas State Association of Free Will Baptists met at the Youth Camp, on Tunnel Road, Conway, Arkansas.

Registration began at 6:45 with Sis. Delois Loveless, as chairman.

Hymns, "He Brought Me Out," and "I Am Resolved," were led by Sis. Helen Day with Sis. Shirley Waldo as pianist.

The Association was called into official Session by the clerk who introduced the Assistant Moderator, Rev. Tommy Breashears in the absence of Rev. J. Reford Wilson, the Moderator, who has moved to Oklahoma.

A welcome to the facilities of the Youth Camp was given by Rev. William J. Mishler, Secretary of the League Board, who introduced the other League Board Members present.

FOREIGN MISSION BOARD: From September, 1959, to September 19, 1960, Arkansas paid \$6,073.18 to Foreign Missions. Our state was visited during the past year by Wesley and Aileen Calvery, returned missionaries from Japan, and Bobby and Sue AyCock, candidates to Brazil. Arkansas will have provided another of our missionary personnel with the going of Sis. AyCock, originally from Warren.

The Mission Board met in Hot Springs in February and discussed the possibilities of Missionary Conferences in our churches. A portion of our state quota money was allotted to each association. We have set three months in which to reach our quota. We urge each of our churches to support Foreign Missions and our pastors to offer their churches some definite, systematic way for doing so.—Rev. Earnie Deeds, Chairman, Rev. Zane Kirkland, Rev. Opie Hargrave, Rev. Glenn Dipboye and Rev. Elbert McClellan.

SUNDAY SCHOOL BOARD: The State Sunday School Board met November 29, 1959, at Searcy, Arkansas, and organized with Rev. William J. Mishler as Chairman of the Board. Rev. Alton Loveless as Secretary.

We would recommend to each district association represented or not represented to organize **District Sunday School Conventions.**

We would through the mode of this district Sunday School Convention

encourage a district Sunday School Workshop.

We would on the local level recommend and encourage a Sunday School Worker's Course at least one a year. We would further urge a Sunday School Worker's Conference at least quarterly. We would recommend that each local Sunday School adopt the Standard of Excellence for Free Will Baptist Sunday Schools. We would further recommend that Free Will Baptist Literature be used in all Free Will Baptist Sunday Schools.

3. The dividing of the Camp session into two groups. The Pre-Teen Camp and the Teen Camp. This proved to be a great blessing to the campers and staff workers.

The Camp enrollment for this year was: Pre-Teen Camp, 87 campers with 31 staff and camp helpers. The Teen-Camp, 130 campers with 42 staff and camp helpers. Making a total of 290 for both camp sessions. There were 22 conversions and a number of rededications in the Pre-Teen Camp. And all who were not Christian that attended the Teen Camp were converted, and there were also quite a number of dedications.

We wish to express our sincere thanks to the staff and kitchen help that so faithfully served during the youth camp session, also to the Churches, Auxiliaries, Leagues and Associations that have so faithfully supported the Youth Camp over the years of existence.

ARKANSAS STATE ASSOCIATION CONSTITUTION

PREAMBLE: From long experience, we, the members of the Free Will Baptist denomination, having been baptized upon our profession of faith in Christ as our Saviour and realizing the necessity of a bond of union and fellowship among our churches for the purpose of coordinating our efforts for the Kingdom of God, do therefore ordain this constitution for our denominational government.

ARTICLE I

Name: This organization shall be known as the Arkansas State Association of Free Will Baptists.

ARTICLE II

Purpose: The object and purpose of this organization shall be to unify the work of the various bodies composing the State Association and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may be hereafter represented.

ARTICLE III

Representation:

Section 1: This association shall be composed of all ordained ministers and deacons with membership in a church belonging to a district association, the district associational clerks and executive board members.

Section 2: Each District Association shall be entitled to five lay delegates at large and, in addition, each local church which holds membership in a District Association affiliated with this body shall be entitled to send one lay delegate.

Section 3: In the event a part, or all of the elected delegation fails to report by 1:30 p.m. Thursday, said vacancies may be filled, provided someone from said Association recommended others for said vacancies.

Section 4: New associations desiring membership in the state association shall send messengers bearing a petitionary letter. If found orthodox, upon examination by the credentials committee, they shall be received by the association and given the right hand of fellowship by the moderator.

ARTICLE IV

Finance: This association shall be supported by 28% of the Cooperative receipts that come to the State Treasurer. Also each district association shall send \$3.00 for each church belonging to said association, which money will go to the host church for entertainment expenses.

ARTICLE V

Discipline:

Section 1: This state association shall have the right to settle any question of discipline, doctrine, or practices that may properly come before it from any of the bodies composing said organization. Furthermore, if there be any question of discipline, doctrine or practice on the part of a district body,

delegates of that association shall not be seated until these questions have been settled to the satisfaction of the credentials committee.

Section 2: The decision of the credentials committee may be appealed to (1) the state association sitting in a committee as a whole, or (2) to a special committee whose report shall be voted on without discussion.

ARTICLE VI

Officers:

Section 1: The officers of the state association shall consist of a moderator, assistant moderator, clerk, assistant clerk, an executive secretary who shall also serve as the treasurer, and a statistician.

Section 2: Committees, as necessary, shall be appointed by the committee on committees which will be elected by the body on the opening night of the association.

ARTICLE VII

Boards: All standing boards shall be composed of five (5) members who shall serve terms of 5, 4, 3, 2, and 1 year. The standing boards shall include the Executive Board, Home Mission Board, Foreign Mission Board, League Board, and a Sunday School Board.

ARTICLE VIII

Duties and Rules of Standing Boards:

1. Executive Board. To this board is delegated the power to act in behalf of and for the state association from one meeting to another and shall have power and authority to elect such officers as might be deemed best for its own government and to carry out the plans and undertaking of the state association. The board shall have power to fill vacancies that may occur in its own body. To this Executive Board is further designated power to collect funds and employ and superintend such work for the field as may seem best and the means on hand may warrant. They shall deliver oil and gas leases upon any real property owned by the association, for such bonuses and rentals as in the discretion of the said board.

This Executive Board shall keep a record of all work done, money raised, meetings held, and make a full and complete report to the regular meeting of the association and shall further receive, hold, manage, use, control, and convey any property entrusted to said state association.

The chairman and secretary of said Executive Board shall sign all deeds and bonds, notes, etc., and any other papers by which the state association is to become legally held.

The board shall have the power to call the association in conference by notifying each district association at least ten (10) days prior to conference.

2. Home Mission Board. It shall be the duty of this board to work in connection with the national mission board in arranging an active missionary program in and for the state of Arkansas. They shall elect a treasurer who shall handle all home mission money.

It will be their responsibility to investigate and assist, if necessary, any new church. This board should thoroughly investigate the ability of a church to support an organization before assistance is pledged.

3. Foreign Mission Board. It shall be the duty of this board to work in connection with the national foreign missions board in arranging itineraries, missionary conferences, etc., and promote in every way possible the foreign missions program in the state of Arkansas.

4. League Board. It shall be the duty of the state league board to plan and assist in every way possible the league work throughout the state. It will also be their responsibility to promote an active league work in each association and to encourage league rallies. They will also plan and carry out the annual

league conference and camp.

5. Sunday School Board. It will be the duty of the Sunday School Board to work in cooperation with the National Sunday School department in arranging Sunday School conferences and workshops, teachers training courses, in recommending methods and materials for the Sunday Schools of the State of Arkansas.

ARTICLE IX

This constitution may be amended or altered at any regular session of the state association by a two-thirds vote of members present, provided proposed amendment or alteration be presented in writing to the body one day in advance.

RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded with a prayer.

2. Those who speak shall rise, address the Moderator, and personal reflections shall be avoided.

3. All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.

4. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.

5. Motions made and lost shall not be recorded in the Minutes unless so ordered at the time.

6. No one shall speak more than once on the same subject without special leave from the body.

7. All questions shall be decided by a majority of the members present.

8. No member shall absent himself without leave of the Moderator.

9. Arrangements shall be made so as to insure two sermons or other devotional exercises equivalent thereto in addition to the business session each day, and the Moderator announce at the adjournment of each business session who is to have charge of said service.

10. Alterations may be made in these rules at any regular meeting of the Association.
