### REPORT NO. 2: CREDENTIALS COMMITTEE:

We, the Credentials Committee, find that the Big Springs, Central, Harmony, Little Missouri River, New Hope, Polk Bayou, Rich Mountain, Saline, and Unity Associations have represented by letter, delegates and fees.

### REPORT NO. 3: EXECUTIVE BOARD:

Your State Executive Board has had one of its most active years in its history. We feel that great progress has been made for our Arkansas Free Will Baptists. Throughout the past association year, we have met nine times. Our first meetings were held in a Sunday School room of the Free Will Baptist Church in Conway. From there we began meeting in our rented office space in the McNutt Building. We are very happy to report to you that our last meeting was held in

the very comfortable facilities of our new State Headquarters Building. We feel that this is a tremendous accomplishment for a one year period of time.

Following are some of the highlites of our actions this year:

The Board met on August 14, 1971, immediately after the adjournment of the State Association at the Youth Camp. Brother Marion Petus was elected chairman. Brother Richard Bowers was elected secretary. It was voted to raise Mrs. Kirkland's salary from \$45 to \$55 per week. She was also given a \$100 bonus for extra work done during Vacation Bible School rush. We instructed our promotional secretary to rent a house and this Board would pay rent and utilities. We voted to pay cooks \$350 for cooking during our State Association.

Our next meeting was September 11, 1971. At this meeting we decided to raise \$1,200 to \$1,500 through Vision throughout our Association to aid in the expense of Robert Partee who went to Japan to build the Youth Center in Sopor. We voted to give promotional director a housing allowance of \$225 a month starting on October 1, 1971. We voted to raise promotional secretary's salary from \$125 per week to \$135 per week.

In our October 23, 1971 meeting, Mr. Cook, Mr. Cummings, and Mr. Robbins were present at the meeting to discuss the branch church problem. The motion was made and passed that the Executive Board request that the tenth Chancery District Court reopen the Consolidated Cases number 722 and 723 of Charleston District-Franklin County Chancery. The reason being that an agrieved faction came to us and pointed out that their district association, the Arkansas District Association, had been by-passed in the normal chain of appeals. In this meeting the Board appointed Brother Oris Doggett to finish the unexpired term of Brother Gilbert Pixley after Brother Pixley's resignation.

On November 23, 1971 the Executive Board met by telephone. Brother Fred Warner informed the Board that the Conway zoning and planning commission had refused to re-zone the property located at the corner of Washington Avenue and Tyler Street which this Board was considering buying to use for an office building and bookstore. Since the property could not be zoned where we could use it, we decided that it would be of no further use to this Board. At this time, we voted to rent office space in the McNutt Building located east of the Christian Supply Store until other arrangements could be made.

Our meeting held December 11, 1971 was in the city of Texarkana. We voted at this time to give Mrs. Kirkland \$50 for a Christmas bonus plus \$1.40 per hour for extra work required during the Christmas rush. We voted to pay part-time help \$1.40 per hour on a temporary basis. We appointed Bill Whittaker to the State Sunday School Board to fill the unexpired term of Brother Ken Doggett who moved from our state to Missouri. We appointed Bob Followwill as our trustee to Hillsdale College.

The Board met on February 12, 1972 in the State Office in Conway. We voted for our state to begin shipping Sunday School literature. We gave Brother Fred Warner authority to sign the contract with the National Sunday School Department. We voted to hire Deborah Osborne as part-time secretary (three days per week for now). Salary is to be \$1.75 per hour. She shall receive one week vacation after the first year of service. Vacation time shall be counted from



the time she begins working three days per week. We voted to purchase property for the purpose of building a state office building bookstore and Sunday School shipping complex. We gave Brother Warner the authority to offer Gulf Oil Company \$25,000 for the property that we had under consideration. After checking a number of pieces of property in Conway, we feel that the fact that we were able to purchase this property and building for the sum of \$25,000 was a miracle from God. We were prepared to offer as much as \$32,000, but they took our first bid of \$25,000. This property had been appraised by a professional appraiser for \$32,000.

In our meeting of April 28, 1972, we voted to sign a paper from the bank stating that the Executive Board has the right to borrow money from the bank for Arkansas Free Will Baptists, We voted to be our own contractors in building the new state headquarters building. We gave Brother Warner and Brother Kirkland authority to over-see the construction of the new building.

Our last meeting was held on August 12, 1972 in our new State Headquarters Building. We voted to raise money to buy furniture for the new office building by an appeal for direct giving from our churches. We voted to pay our promotional secretary's hospitalization insurance beginning in August of '72. This report is respectively submitted by:

## REPORT NO. 5: BOARD OF CHRISTIAN EDUCATION:

# ARKANSAS STATE ASSOCIATION CONSTITUTION

## PREAMBLE

From long experience, we, the members of the Free Will Baptist denomination, having been baptized upon our profession of faith in Christ as our Saviour and realizing the necessity of a bond of union and fellowship among our churches for the purpose of coordinating our efforts for the kingdom of God, do therefore ordain this constitution for our denominational government.

## ARTICLE I

Name: This organization shall be known as the Arkansas State Association of Free Will Baptists, affiliated with the National Association of Free Will Baptists.

## ARTICLE II

Purpose: The object and purpose of this organization shall be to unify the work of the various bodies composing the State Association and to devise and execute measures for the extension of the Kingdom of God in connection with the various bodies in the Association, or that may be hereafter represented.

## ARTICLE III

### Representation:

Section 1. This association shall be composed of all ordained ministers and deacons with membership in a church belonging to a district association, the district association clerk and executive board members.

Section 2. Each District Association shall be entitled to five lay delegates at large and, in addition, each local church which holds membership in a District Association affiliated with this body shall be entitled to send one lay delegate.

Section 3. In the event a part, or all, of the elected delegation fails to report by 1:30 P.M., Wednesday, said vacancy may be filled, provided someone from said association recommended others for said vacancies.

Section 4. New Associations desiring membership in the state association shall send messengers bearing a petitionary letter. If found orthodox upon examination by the credentials committee, they shall be received by the vote of the association and given the right hand of fellowship by the moderator.

## ARTICLE IV

Finance: This association shall be supported by a percentage of the Cooperative receipts and earmarked gifts which come into the state treasury as designated by the state association when in conference. Said allocations to national and state work to be recommended to the association by the budget committee.

Each District Association belonging to said body shall send \$10.00 for each church belonging to said District Association, which shall be for entertaining State Association. And \$3.00 for each church belonging to said



District Association for minutes and general expenses.

In the event any church within a local association does not pay their fee, the delegates, deacons and ministers of that church shall not be seated.

## ARTICLE V

### Discipline

Section 1. This state association shall have the right to settle any question of discipline, doctrine, or practice that may properly come before it from any of the bodies composing said organization. Furthermore, if there be any question of discipline, doctrine or practice on the part of a district body, delegates of that association shall not be seated until these questions have been settled to the satisfaction of the credentials committee.

Section 2. The decision of the credentials committee may be appealed to (1) the state association sitting in a committee as a whole, or (2) to a special committee whose report shall be voted on without discussion.

## ARTICLE VI

### Officers:

Section 1. The officers of the state association shall consist of a moderator, assistant moderator, clerk, assistant clerk, promotional secretary-treasurer, and statistician.

Section 2. Committees, as necessary, shall be appointed by the committee on committees which will be elected by the body on the opening night of the association.

## ARTICLE VII

Boards: All standing boards shall be composed of five (5) members who shall serve terms of 5, 4, 3, 2, and 1 year. The standing Board, and a Sunday School Board and the Board of Christian Education.

## ARTICLE VIII

### Duties and Rules of Standing Boards:

Section 1. All boards and committees of this association shall organize at the beginning of each associational year. They shall elect a chairman, vice-chairman, and secretary. Each board shall keep a written report of each annual association of meetings held, work done and monies received and expended during the year.

Section 2. Executive Board: This board shall have power to fill irregular vacancies which may occur in its own body, and shall also have power to fill any irregular vacancies which may occur in any department of the work between sessions of the state association. (This Board shall have the authority to employ the State Promotional Secretary-Treasurer).

In the event no District Association requests to entertain the State Association it shall become the responsibility of the Executive Board to make the necessary arrangements when held at the camp at Conway, receiving of all entertainment fees, furnish all food and kitchen help and be responsible for all expenses incurred in the entertainment of the State Association.

This Executive Board shall keep a record of all work done, money raised, meetings held, and make a full and complete report to the regular meeting of the association and shall further receive, hold, manage, use, control, and convey property entrusted to said state association, except as stipulated elsewhere in the constitution.

The chairman and secretary of said Executive Board shall sign all deeds and bonds, notes, etc., and any other papers by which the state association is to become legally held.

The Board shall have the power to call the association in conference by notifying each district association at least ten (10) days prior to conference.

Section 3. Mission Board: It shall be the duty of this board to promote an active missions program within the State. It shall work in conjunction with the National Home and Foreign Missions Boards in the arranging of Missionary conferences, Missionary itinerary and assist in the raising of the state quota for the National Missions Programs.

This board shall investigate, and assist, in the establishing of new churches and missions, particularly where there is no Free Will Baptist work. This board shall not participate in the organization of any church or mission that is located within common boundaries of a district association that has no such board, then this board, upon consultation with officials of said district association, shall assist in such work.

Furthermore, this board shall not participate in the organization of any church or mission in a town, city or community where there is an organized Free Will Baptist Church without seeking the cooperation of said church. Neither shall this board assist in the organization of a group that is out of fellowship with an established church.

Section 4. Church Training Service Board: It shall be the duty of the State Church Training Service Board to plan and assist in every way possible the Church Training Service work throughout the state. It will also be their responsibility to promote an active Church Training Service work in each Association and to encourage Church Training Service rallies. They shall be entrusted to hold, manage, use, control, or convey the Youth Camp property. Also, this board shall be responsible for the selection of the Youth Camp director. They will also plan and carry out the annual Church Training Service Conference and Youth encampment.

Section 5. Sunday School Board: It will be the duty of this Sunday School Board to work in cooperation with the National Sunday School Department in arranging Sunday School conferences and workshops, teachers' training courses, in recommending methods and materials for the Sunday Schools of the State of Arkansas.

Section 6. Promotional Secretary-Treasurer: The Promotional Secretary-Treasurer shall assist in the coordinating of the work of the various boards of the State Association and shall serve as State Treasurer. He shall promote through his office, both the State and National denominational programs, and arrange or assist in the arranging of itineraries for State or National Workers, Missionaries, Mission Conferences, etc. He shall also assist as far as is practical, in the establishing of new churches, and missions within the state. Furthermore, it shall

be his duty to edit and publish VISION, our State Magazine.

He shall receive, hold and disburse money as is made available by the State Association to the various boards, state offices and departments. Disbursement to various boards will be made when requested by requisition.

A bookstore shall be operated from the State Headquarters with the profits going into the general fund.

He shall present a complete written report of all work done to each annual session of this Association, with a financial statement of all monies received and disbursed to each board, National programs, etc.

The work of the Promotional Secretary-Treasurer shall be under the supervision of the Executive Board.

Section 7. Board of Christian Education: It shall be the duty of this board to establish and promote a high standard of Christian Education within the framework of this Association. It shall be responsible for an annual Ministers' Retreat. It shall also assist, through the conducting of Bible Institutes, in the teaching and training of the ministry and other interested laymen as requested by the local churches or associations of this body.

The doctrine of the Free Will Baptist as defined in the "Treatise of the Faith and Practice" shall be the guide of theological positions for the Institutes.

## ARTICLE IX

This constitution may be amended or altered at any regular session of the State Association by a two-thirds vote of members present, providing proposed amendment or alteration be presented in writing to the body one day in advance.

## RULES OF ORDER

1. At every sitting of the Association, business shall be opened and concluded with a prayer.
2. Those who speak shall rise, address the Moderator, and personal reflections shall be avoided.
3. All motions made and seconded shall be open for discussion, but debate may be shut off at any time by a majority of the members of the Association.
4. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.
5. Motions made and lost shall not be recorded in the minutes unless so ordered at the time.
6. No one shall speak more than once on the same subject without special leave from the body.
7. All questions shall be decided by a majority of the membership present.
8. No member shall absent himself without leave of the Moderator.
9. Arrangements shall be made so as to insure two sermons or other devotional exercises equivalent thereto in addition to the business session each day, and the Moderator announces at the adjournment of each business session who is



to have charge of said service.

10. Alterations may be made in these rules at any regular meeting of the Association.
