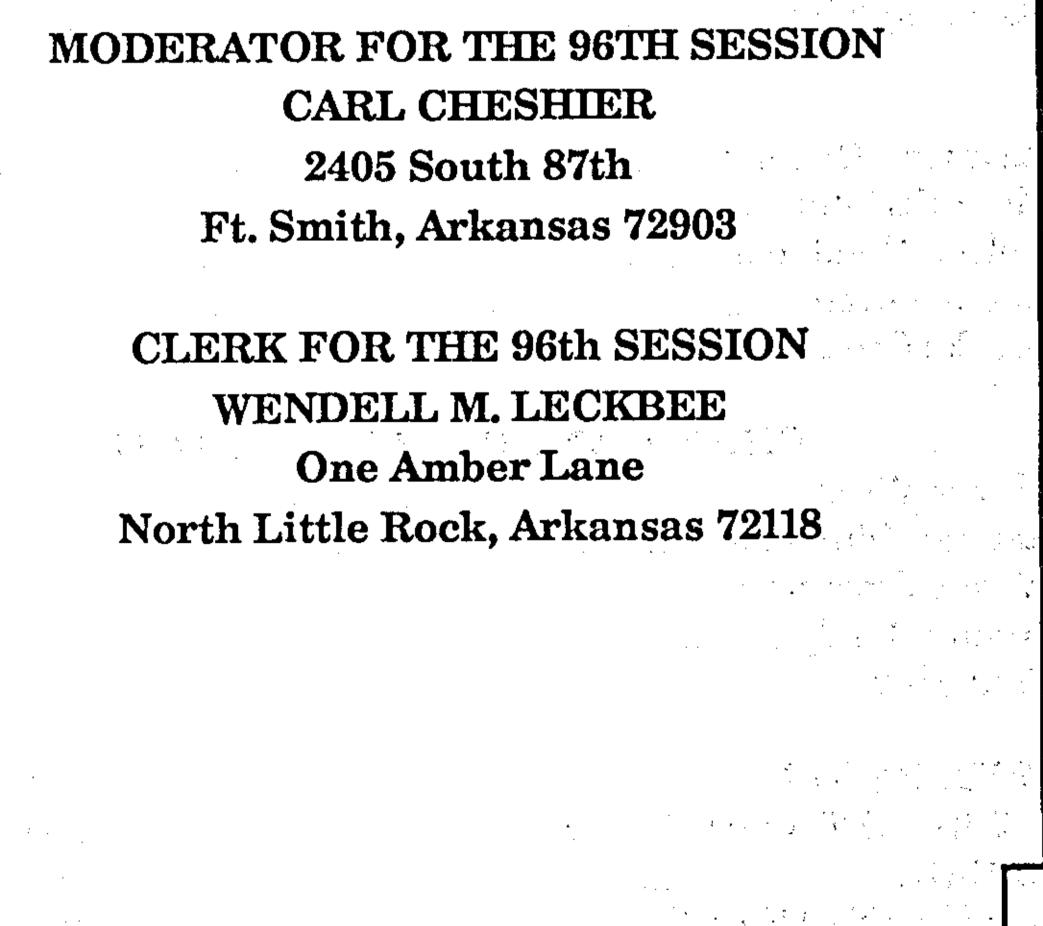

PROCEEDINGS TUESDAY EVENING, AUGUST 11, 1992

The 95th annual session of the Arkansas State Association of Free Will Baptists met at Camp Beaverfork, Conway, AR on August 11, 1992. The convention theme was — "Spiritual Warfare," Ephesians 6:10-18.

Levan Hubbard served as song director, with Sue Patton as pianist and Jayne Hannah as organist. The Hubbard family provided the prelude music for the evening services.

The service was opened with the congregation singing "He Keeps Me Singing" and "Nothing But The Blood." Wendell Leckbee, clerk, called the meeting to order and introduced the Moderator, Carl Cheshier. The Moderator welcomed all those present.

Rue Dell Smith, Raymond Chonister, Randall Williams, Bill Johnson and Wayne Smothers were elected to the Committee on Committees.

A missions offering was taken, to be divided 1/3 to National Home Missionaries present (Harvey, Doggett, Parker), 1/3 to Foreign Missionaries present (McFall, Deeds, Richards) and 1/3 to State Missionaries present (Winfrey, Hubbard). Rupert Pixley led in prayer.

The congregation sang "Saved, Saved." The Legacy of Praise quartet, from Phillips Chapel, sang—"Your First Day In Heaven," "What You Gonna Do," "The Midnight Cry" and "Miracle In Me."

The Moderator introduced Roger Harwell, pastor of First Church, Fort Smith, as the evening speaker. He spoke on the subject "Acknowledging Our Adversaries," using Ephesians 6:10-12 for a text.

Report No. 1: Report of the Committee on Committees was given and accepted. After announcements the service was dismissed in prayer by Fred Warner.

WEDNESDAY MORNING, AUGUST 12, 19932

The service opened with David Winfrey leading the congregation in the singing of "Revive Us Again." Thurston Taylor, deacon at Oak Park, Pine Bluff, brought the morning devotion from Ephesians 6:18 using the subject—"We need to be practicing Christians every day of the week."

The standing delegates were recognized by the Moderator and visitors were welcomed.

Report No. 2: Report of the Credentials Committee was given and accepted with the delegates seated.

Report No. 3: Report of the Executive Board was given by David Bishop. The report was accepted. The recommendation on the constitutional change, Article III, Section 1, was tabled until Thursday. The Co-Op budget was adopted, noting that 21/2% more was going to the National Association. The recommendation to appoint a five (5) member committee, to draft employment guidelines for various agencies, was adopted.

Report No. 4: Report of the Promotional Director was presented by David Joslin. The report was accepted and the budgets adopted. Information on the Stewardship Campaign, Retirement Program and the Benevolent Fund was presented. Terry White and Matthew Green, from Brotherhood Mutual, thanked all the churches participating in the insurance program. The state received a dividend of \$6,248.00 from the company.

Melvin Worthington, Executive Secretary of the National Association, presented the 1992 Denominational Report from the National Offices. He encouraged the review of material on the Stewardship Campaign and the subscribing to Contact.

Report No. 5: Report of the Christian Supply Store was presented by Keith Johnson. The report was accepted and the budget adopted. Fred Warner, representing the Foreign Missions Department, thanked Arkansas Free Will Baptists for the \$188,000 sent to the Department during 1991. Report No. 6: Report of the CTS Board was presented by Brooks Crossno. The report was received and the budget adopted. Jackie Brown, CTS Director, reported on the work of the Camp and competitive activities. He presented plaques to Bill and Rosie Wheeler in appreciation for their years of service to Camp Beaverfork. Bob Shockey brought greetings from the Bible College and expressed appreciation to the state for their support to the college. He reported that the college was debt free. Arkansas people were commended for sending students, supporting the college dinners and giving prayer support throughout the year. Jack Richeybrought greetings from Hillsdale College. He thanked the state for their prayers, students and general support of the college. He asked Arkansas people to be mindful of the "Have A Heart For Hillsdale" campaign in February and challenged them to raise \$25,000. He announced that students from a church that supports the Co-Op plan will receive a \$10.00 per hour discount.

WEDNESDAY MORNING WORSHIP SERVICE

The service opened with the congregation singing "This World Is Not My Home." Randy Scott led in prayer. The congregation sang "Victory In Jesus." Josh Butler and Bethann Bowman, from Allens' Chapel, sang "Our Calvary Lamb." Randy Scott, Assistant Moderator, introduced Tim Landers, pastor of First Church, Newport, as the morning speaker. He spoke on the subject "Appropriating Our Authority" using Matthew 7:28 as a text. Benediction by Wendell Leckbee.

WEDNESDAY AFTERNOON BUSINESS SESSION

The session opened with the congregation singing "The Longer I Serve Him." John Lau, deacon at First Church, Batesville, brought a devotion from John 10:22.

Report No. 7: Report of the Missions Board was given by Paul Payne. The report was received and the budget adopted. John Hewett, pastor of the Mansfield Church, and Andy Pearcy, former pastor, presented a check for \$4,400 as payment in full for their loan from the Apple Fund.

Report No. 8: Report of the Christian Education Board was given by Fred Scott. The report was received and the budget adopted.

Richard Adams, representing the Home Missions Department, presented information on Benjamin Randall Day (November 22), Build My Church campaign and other activities of the department. He recognized Home Missionaries—Ron Parker, Ken Doggett, Levan Hubbard and George Harvey.

Report No. 9: Report of the Sunday School Board was given by Levan Hubbard. He presented plaques to Gladys Smith—Teacher of the Year, from the First Church, Walnut Ridge; Wayne Crawford— Superintendent of the Year, from the Wilson Church, Belleville; and Dolan Burris—Award of Distinction, from the Mt. Vernon Church, Russellville. The report was received and the budget adopted.

Report No. 10: Report of the Woman's Auxiliary was given and received as information.

Report No. 11: Report of the Hillsdale College trustee was given by Will Harmon. He brought greetings on behalf of Hillsdale. He stressed the importance of encouraging our young people to attend Hillsdale or the Bible College. The report was received as information.

Report No. 12: Report of the Resolutions Committee was received.

Motion and second to amend the resolution was defeated. The resolution was defeated.

Roger Reeds brought greetings from Randall House. He requested that our churches use the Free Will Baptist Sunday School literature. He pointed out that the new literature would have more color, and that the lessons were available on cassette.

Report No. 13: Report of the Nominating Committee. A partial report of the committee was given and those nominated were elected.

Bob Carey, Mrs. Rue Dell Smith, Randy Ledbetter, Brenda Hutsell and Marilyn Wilson were elected as delegates to the 1993 National Association.

It was voted to have evening services at Conway High School during the 1993 State Association.

Norman Richards, missionary to Africa, presented a plaque to Ted Henry, from First Church Russellville, on behalf of his work in Master's Men Hands project in Cuba.

After announcements the benediction was given by Rue Dell Smith.

WEDNESDAY EVENING WORSHIP SERVICE

The service opened with the mass youth choir, directed by Mark

Stripling, singing "Be The One." The congregation sang "The Banner of the Cross." A missions offering was taken, prayer by David Copeland. The total missions offering was \$1,064.75. The congregation sang "He Lives." The North Little Rock Church choir sang—"Everytime I Feel the Spirit," "Find Us Faithful," "Praise Medley," and "Triumphantly the Church Will Rise."

The moderator introduced the speaker, David Sutton, pastor First Church, Duncanville, TX. He spoke on the subject "Assembling Our Armor," using Ephesians 6:10-13 for a text. Benediction by Ken Doggett.

THURSDAY MORNING—AUGUST 13, 1992

The service opened with the congregation singing "At The Cross." Prayer by James Forlines.

The devotion was given by Wendell Leckbee, deacon at First Church, N. Little Rock. His text was John 10:14—"God Understands."

Report No. 15: Report of the Master's Men was given by Carmen Rushing. The report was accepted. The proposed constitution change was removed from the table and passed.

Report No. 16: Report of the Registration Committee.

Report of the Nominating Committee was completed with state officers and General Board Member being elected.

Report No. 17: Report of the Obituary Committee was read and accepted.

David Copeland, Nelson Henderson, Dwayne Goforth, Will Harmon and Ben Scott were appointed to the employment guidelines committee. They were instructed, by the moderator, to bring a report to the all states board meeting.

George Harvey reported on his work in Phoenix, AZ thanking AR people for their prayer and financial support.

Ron Parker reported on his work in Shreveport, LA. He reported a prospect list of 75.

Norman Richards reported on his work in Africa. He expressed appreciation for the prayers and support of Arkansas people.

Levan Hubbard reported on his itinerate work and on the building of the new church in Maumelle.

O. D. Winfrey reported on the work in Wynne and thanked everyone for their support in both prayers and financial.

It was mentioned that the use of the auditorium, at Conway High School, was contingent on its availability.

THURSDAY MORNING WORSHIP SERVICE

Service opened with the congregation singing "To God Be The Glory" and "I Will Serve Him." Roy Wilson led in prayer.

Special music was presented by a trio and quintet from the Vista Church. They sang "I'm Going To Live Forever" and "When The Lord Saved Me." REPORT NO. 3: REPORT OF THE EXECUTIVE BOARD

The State Executive Board met six times during the past year and had one conference call. The business was conducted as follows:

<u>October 8, 1991</u>

All members were present, including Moderator Carl Cheshier, Promotional Director David Joslin, and Keith Johnson, Christian Supply Store Manager.

1. Motion passed to elect Bobby Shepherd as Chairman; Rupert Pixley, Assistant Chairman; and Dwayne Goforth as Secretary.

2. Motion passed to accept the report as given by Keith Johnson on the Christian Supply Store.

3. Discussion of computerization in the bookstore led to a motion passed to table any decisions concerning equipment until the January meeting at which time the Board would review the options available. The Board instructed Dwayne Goforth to investigate options with local companies..

4. Motion passed to retain Barton & Taylor CPAs for the 1991 fiscal year audit.

5. Motion passed to accept the reports as presented by Promotional Director David Joslin which included the Promotional Director's contract, the State Office budgets, and financial reports.

6. Motion passed to recommend to district associations who retain a portion of the Cooperative Plan receipts to re-evaluate the amount which they keep within the local association.

7. Motion passed to allow the Promotional Director to look for a new vehicle to replace the aging station wagon currently in use.

November 14, 1991

A conference call was made with all board members, including Moderator Carl Cheshier. Promotional Director David Joslin informed the board that two members from the State Sunday School Board had resigned: Larry Hughes and David Gentry. Motion passed to elect Earl Stapleton to replace David Gentry for a two-year term and Will Harmon to replace Larry Hughes for a one-year term.

January 28, 1992

Members present were: Bobby Shepherd, Rupert Pixley, David Bishop, and Dwayne Goforth. Also present were Moderator Carl Cheshier, Assistant Moderator Randy Scott, Promotional Director David Joslin, and Christian Supply Store Manager Keith Johnson. The following business was conducted:

1. Motion passed to accept the Christian Supply Store report given by Keith Johnson. He reported that the auditor, Ricky Taylor was present while the year-end inventory was taken, and that the bookstore would have an unqualified audit this year since all requirements were met.

2. Dwayne Goforth presented cost comparisons from local computer companies and recommended the CD-Word Library, due to the support given by a company offering exactly what was needed in the bookstore. Motion passed to purchase the computer equipment and software from CD-Word. Motion was passed to secure a loan from Security Savings for \$14,000.00, at an 8% rate of interest for a period of 3 years. Motion was also passed to use the Improvement Fund to help repay the loan for the new system.

3. Motion passed to use last year's improvement fund amount of \$689.96 for the purchase of needed furniture and supplies for the new computer system.

4. Motion passed to accept the reports as given by Promotional Director David Joslin.

5. Motion passed to adopt the proposed Constitutional change concerning state boards. The change would be as follows:

Article III (Representation) Section 1.

Amend by addition, following the words, "State Boards." - "...and standing officers of the state association."

Section 1 would then read:

"This association shall be composed of all ordained ministers and deacons with membership in a church belonging to a district association, the district associational clerk, all members of State Boards, and standing officers of the state association."

February 11, 1992

Executive Board met during the Minister's Retreat at Lake DeGray near Bismarck, Arkansas, for the purpose of replacing State Mission Board member, Zane Kirkland, who passed away February 2, 1992, on the State Mission Board. David Copeland was appointed to fill the term.

April 14, 1992

All board members were present, including Promotional Director David Joslin and Christian Supply Store Manager Keith Johnson at the state office in Conway, Arkansas. The following business was conducted:

1. Motion passed to accept the reports given by Christian Supply Store Manager Keith Johnson.

2. Promotional Director David Joslin gave reports on the State Mission progress at Maumelle, Arkansas; the "Million More By '94" campaign, and the 1994 National Association which will meet in Little Rock, Arkansas. Motion passed to give David Joslin the authority to advance a program to raise \$20,000.00 to host the National Association. It was recommended that a fee of \$50.00 per church per year for 1992 and 1993 be added to the state fees.

3. Motion passed to accept the financial reports given by Promotional Director David Joslin. July 14, 1992

All board member were present, including Promotional Director David Joslin and Christian Supply Store Manager Keith Johnson at the state office in Conway, Arkansas. The following business was conducted:

1. Motion passed to accept the reports given by the Christian Supply Store Manager Keith Johnson.

2. The 1993 budget for Christian Supply Store was read and approved.

3. Promotional Director David Joslin opened a discussion on potential problems with overcrowding with the State Association and Youth Conference being slated for the same time period. The possibility of considering the State Meeting being held in the high school auditorium was also discussed. A meeting is to be held with the CTS Board on July 31, 1992, at the state offices, Conway, Arkansas, to discuss these issues.

4. Promotional Director David Joslin read report on the state office plus the proposed budgets for Coop, General Fund, THE VISION, Contingency Fund, Sunday School and Operational Fund. Motion passed to approve all reports.

5. The auditor, Ricky Taylor, CPA, joined the meeting and gave a brief summary of the audits of Camp Beaverfork, Arkansas Free Will Baptists, and Christian Supply Store. Motion passed on recommendation from Ricky Taylor that purchases of assets of \$500.00 or more be classified as fixed assets that would be capitalized: purchases less than \$500.00 be classified as operational expenses for the state office and the Christian Supply Store.

6. The Executive Board, acting as the Budget Committee of the State Association, recommended the following Cooperative Plan Budget for 1993:

July 31, 1992

A special called meeting between the State Executive Board and the CTS Board was held at the State Office in Conway, Arkansas to discuss matters concerning the hiring of relatives in state department positions. Executive Board members present were: Bobby Shepherd, Sidney Sawrie, Dwayne Goforth, David Bishop. CTS Board members present were: Brooks Crossno, Kevin Jewel, Nelson Henderson, and Mark Stripling. Also present were Moderator Carl Cheshier, Promotional Director David Joslin, and Camp Director, Jackie Brown.

Discussion was opened about the proposed salaries to be paid at Camp Beaverfork which included the camp maintenance position. A lengthy discussion followed with comments being made from both boards with emphasis on the potential problems in the hiring of close relatives in these positions. The following motion was drafted for presentation to the State Association for its approval:

Whereas, there is a need for uniformity in the employment of personnel with the various agencies of the Arkansas State Association of Free Will Baptists...

Be It Resolved That:

The moderator be empowered to appoint a committee of five to draft employment guidelines for the various agencies. This committee's work will include nepotism, pay scales, hiring, and termination procedures, and any other such matters relating to employment.

REPORT NO. 4: REPORT OF THE PROMOTIONAL DIRECTOR

I remember my first state association in 1947 at the age of ten. It was conducted at the First Free Will Baptist Church in Fort Smith, Arkansas. A tent was used to accommodate the large crowds.

I remember the purchase of Arkansas Free Will Baptist Youth Camp in Conway, Arkansas, in 1951, and the annual State League conventions conducted there.

I remember the first youth camp for Arkansas Free Will Baptists at Camp Peniel, north of Morrilton, Arkansas, in 1957. It was rented from the Cumberland Presbyterians. My sister, Rachel, who is now married to Fred Warner, and I rode a bus to Morrilton, and took a taxi to Camp Peniel. Mary Kay Kelley was elected secretary of the League Convention, and I served on the Business Committee. She and I were married August 22, 1958. I remember Alton Loveless' election to be the Treasurer. I recall Clarence Burton's giving to me a sheet with which to make my bed. The boys' cabins did not have mattresses. No one had bothered to publish information that everyone was responsible for his own bedding. Brother Loveless was to become Promotional Secretary of Ohio, and Brother Burton was to become Executive Secretary for the State of Missouri.

I remember the years of growth in the 60's, and the steady progress of Arkansas Free Will Baptists.

I remember November 1, 1973, when I came to Conway to the position of Promotional Director for Arkansas Free Will Baptists.

I hope for the future of Arkansas Free Will Baptists that wisdom will prevail in the plans for the denomination and its constituency.

I hope that Arkansas Free Will Baptists will welcome change as a friend and not an enemy. The 21st Century beacons us to accept the greatest challenge yet to minister for Christ.

I hope that unity and growth will continue in our churches and association.

I hope that Arkansas Free Will Baptists will remain a "team-player" as we associate and interact with other state associations within the National Association of Free Will Baptists.

I hope that our preachers, churches, and boards will initiate innovative ideas, programs, and plans to evangelize the lost, and edify the believers in the 21st Century.

I fondly remember the past, but I fervently hope for the future.

INDEPENDENT AUDITOR'S REPORT

To The Board of Directors Arkansas Free Will Baptist, Inc.

I have audited the accompanying balance sheet of Arkansas Free Will Baptist, Inc. (a non-profit corporation) as of December 31, 1991, and the related statements of revenues and expenditures, statement of fund balance, and changes in cash flows for the year then ended. The financial statements are the responsibility of the Organization's management. My responsibility is to express an opinion on these financial statements based on my audit.

Except as discussed in the following paragraph, I conducted my audit in accordance with generally accepted auditing

standards. These standards require that I plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. I believe my audit provides a reasonable basis for my opinion.

The Organization has elected to record the values of land and buildings, specifically the state offices and the state mission church at Wynne, Arkansas, at the current appraised values. Generally accepted accounting principles require that operational assets be valued at actual cost less appropriate adjustments for depreciation and substantial decreases for obsolescence. Due to limited records and the extensive use of donations relating to the establishment of the above mentioned properties, it was not practical for me to extend my examination of such records beyond the amounts recorded.

NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

GENERAL - The Arkansas Free Will Baptist, Inc. is a nonprofit corporation organized to provide central leadership and representation for the Free Will Baptist of Arkansas and to handle certain receipts and disbursements of the Free Will Baptist Churches. The corporation uses the fund method of accounting, whereby the fund balance represents the equity the corporation has in its assets. This accounting method is generally accepted among non-profit organizations as the most feasible way of reflecting their financial activity and position.

AUTO, OFFICE FURNITURE & EQUIPMENT, BUILDING IMPROVEMENTS -Auto, office furniture and equipment and building improvements are recorded at cost. Depreciation is computed using the straight-line method based on the estimated useful lives of the related assets. Expenditures for repairs and maintenance are charged to operations when incurred, while major betterments and renewals are capitalized. The following useful lives were used to calculate depreciation: Auto 5 years

CASH AND CASH EQUIVALENTS - For the purposes of the statement of cash flows, the company considers all investment instruments purchased with a maturity of six months or less to be cash equivalents.

INVENTORY - Inventory is recorded on the lower of cost of market using the first-in, first-out method of accounting.

INCOME TAXES - The corporation is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Service Code.

NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

GENERAL

Camp Beaverfork, Inc. (the Camp) is a non-profit corporation established to serve the Arkansas Free Will Baptist Youth by providing summer camp and retreat facilities.

METHOD OF ACCOUNTING

The Camp maintains its financial records on a basis of cash received and cash disbursed for internal purposes, with appropriate accruals for receivable and payable balances at the end of each fiscal period for financial statement purposes. This accounting method is generally accepted among non-profit organizations as the most feasible way of reflecting their financial activity and position. The fund balance represents the Camp's equity in its assets.

LAND, BUILDINGS AND EQUIPMENT

Due to limited records and the extensive use of donations related to the establishment, development, and maintenance of the campground facilities, the land and buildings are recorded at their current appraised value. Generally accepted accounting principles require that fixed and operational assets be recorded at cost less appropriate adjustments for depreciation and substantial decreases for obsolesence. Equipment and auto are recorded at cost and appropriate provisions for depreciation have been applied. The current year provision is \$ 1,687.

CASH AND CASH EQUIVALENTS

For purposes of the statement of cash flows, the company considers all investment instruments purchased with a maturity of three months or less to be cash equivalents.

INCOME TAXES

The corporation is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Service Code.

ACCOUNTS RECEIVABLE

Accounts receivable represent the balance of the co-op monies and contributions held by the Arkansas Free Will Baptist, Inc. as of December 31, 1991, due and payable to Camp Beaverfork, Inc.

REPORT NO. 14: REPORT OF STATISTICIAN

The Arkansas State Association of Free Will Baptists reports 15 associations comprised of 218 churches. The statistics for membership, baptism, etc., are based on the 205 churches who reported.

There are 103 churches located in a city/town, 115 churches in rural, 97 with full-time pastors, and 104 part-time pastors.

There are 350 ordained ministers, 39 licensed ministers, and 562 ordained deasons.

The churches reported 680 baptisms with 1,147 members added, 718 members lost, and a total membership of 19,149.

Sunday School enrollment was 11,826; CTS enrollment was 3,170; Woman's Auxiliary membership was 1,347; and Master's Men membership was 266.

There were four churches with kindergartens, two with Christian day schools, and one district Bible Institute.

The total income of all churches reporting was \$4,565,405.87, and 30 churches with budgets.

There were 68 churches with parsonages, and a total value of all church property, including parsonages, of \$32,258,200.00.

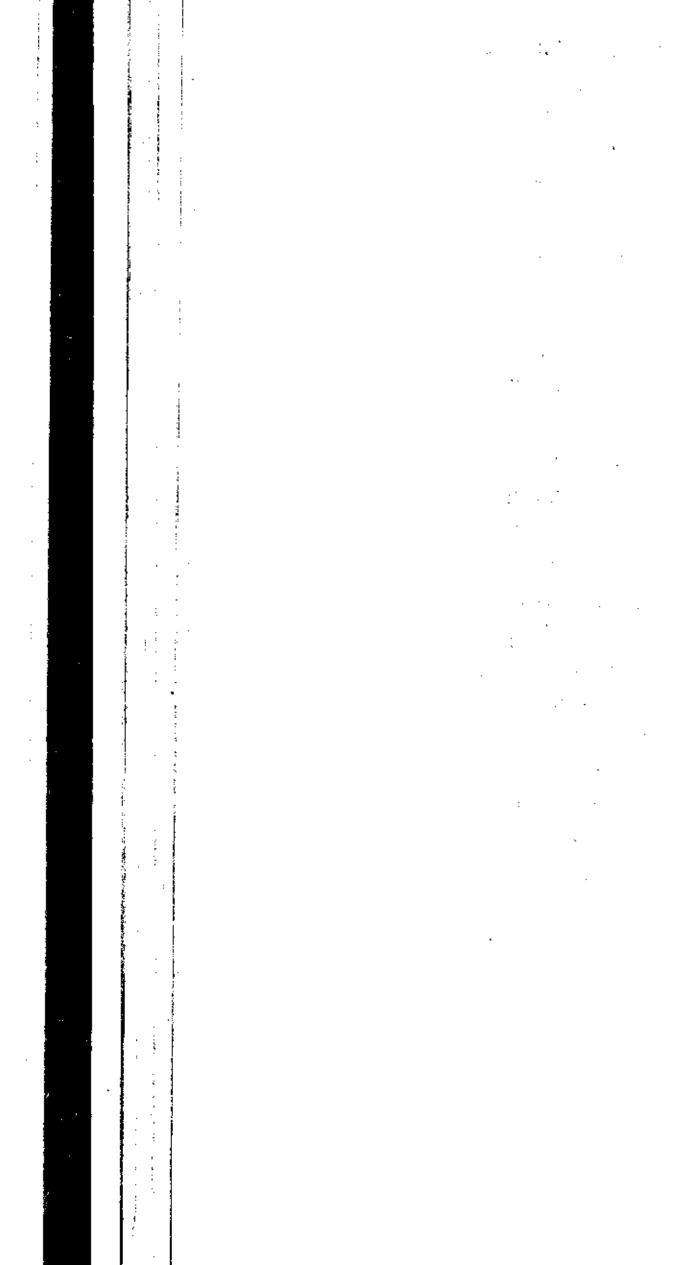

ARKANSAS STATE ASSOCIATION CONSTITUTION

PREAMBLE

From experience we, the members of the Free Will Baptist denomination, being regularly baptized upon a profession of our faith in Jesus Christ and realizing the necessity of a bond of union and fellowship among us; to preserve and maintain correspondence and coordination with us; to unify the work of the various districts composing the State Association; and to devise and execute measures for the extension of the Kingdom of God in cooperation with the various districts of the Association, or that may be hereafter represented therein, do therefore ordain this Constitution for our better denomination government.

ARTICLE I

Name: This organization shall be known as the Arkansas State Association of Free Will Baptists, Affiliated with the National Association of Free Will Baptists.

ARTICLE II

Purpose: The purpose of this organization shall be to unify the work of the various districts composing the State Association and to devise and executive measures for the extension of the Kingdom of God in connection with the various districts in the Association.

ARTICLE III

Representation:

Section 1. This association shall be composed of all ordained ministers and deacons with membership in a church belonging to a district association, the district associational clerk, all members of state boards, and standing officers of the state association.

Section 2. Each district association shall be entitled to five (5) lay delegates at large. Each local church which holds membership in a district association affiliated with this body shall be entitled to send one lay delegate.

Section 3. Associational Delegates:

A. In the event any of the elected delegates fail to report, said vacancy may be filled by appointment of the moderator of said district or by the delegates present from said district.

B. In the event the elected delegate from a local church is not present, the Pastor of that local church shall have the authority to appoint a delegate to serve in place of the absent delegate.

Section 4. New associations desiring membership in the state association shall send messengers bearing a petitionary letter. If found orthodox, upon examination by the credentials committee, they shall be received by the vote of the association and given the right hand of fellowship by the moderator.

Sectopm 5. The State Convention shall convene annually on the Tuesday following the second Sunday in the month of August.

ARTICLE IV

Finance:

Section 1. This association shall be supported by a percentage of the Cooperative receipts as designated by the State Association and by designated gifts. Said allocations to national and state work

to be recommended to the association by the budget committee.

Section 2. Each district association shall send \$20.00 for each church belonging to the district association for the purpose of entertaining the State Association; \$10.00 for each church for National Association fees; and \$5.00 per each church for minutes, for a total of \$35.00.

Section 3. In the event any church within a local association does not pay its fee; the delegates, deacons, and ministers of that church shall not be seated.

ARTICLE V

Discipline:

Section 1. This State Association shall have the right to settle any questions of discipline, doctrine, or practice that may properly come before it from any of the districts composing said organization. If there be any question of discipline, doctrine, or practice on the part of a district body, delegates of that association shall be not seated until these questions have been settled to the satisfaction of the credentials committee.

Section 2. The decision of the credentials committee may be appealed to the State Association sitting in a committee as a whole.

ARTICLE VI

Officers:

Section 1. The officers of the State Association shall consist of a moderator, assistant moderator, clerk, assistant clerk, promotional director, and statistician. Each of these, with exception of the promotional director should be elected annually.

Section 2. The Moderator shall be an ex-officio member of the Executive Board. The Promotional Director shall be an ex-officio member of all standing boards.

Section 3. A committee on committees shall be elected by the body on the opening night of the association. All other committees shall be appointed by the committee on committees.

Section 4. The moderator, assistant moderator, promotional director, clerk, and assistant clerk shall serve as the program committee for the State Association.

ARTICLE VII

Duties and Rules of Standing Boards: Section 1. All standing boards shall be composed of five (5)

members, each of whom shall serve for five years. No board member shall immediately succeed himself after having served a full term on said board.

Each board shall prepare a budget of its proposed financial expenditures at the beginning of each fiscal year and shall present same for approval by the Akransas State Association along with an audit made by an independent certified public accountant, which audit shall lead to the expression of an unqualified opinion on the financial statements. The auditor's report shall include, where applicable, a balance sheet and income statement and other schedules as may be necessary for a proper presentation of the financial condition and results of operation.

Section 2. All boards of this association shall organize immediately following the annual association meeting. They shall elect a chairman, vice-chairman, and secretary. Each board shall give a written report at the annual association of meetings conducted, work accomplished, monies received and expended during the year.

Section 3. Executive Board: This board shall have the authority to fill irregular vacancies which may occur in its own body, and any irregular vacancies which may occur in any standing board between sessions of the state association. An office may be declared vacant for the following reason: if a member moves from the State; if a member fails to attend the board meetings for a period of one year without providential hindrance; or if for any reason he submits a statement of resignation.

A bookstore shall be operated from the state headquarters under the supervision and direction of the Executive Board.

This board shall have the authority to employ the state promotional director.

In the event that none of the district associations request to entertain the State Association, it shall become the responsibility of the Executive Board to make the necessary arrangements when it is to be conducted at the camp at Conway.

The Executive Board shall keep a record of all work accommplished, money raised, meetings conducted, and make a full and complete report at the annual association of the State Association. The Executive Board shall receive, hold, manage, use control, and convey property entrusted to the State Association, except as stipulated elsewhere in the constitution.

The chairman and secretary of the Executive Board shall sign all deeds, bonds, notes, etc., and any other papers by which the State Association is to become legally responsible. In case of an emergency situation, the Executive Board shall have the authority to call the State Association in conference by notifying each district association at least ten (10) days prior to the conference.

No board shall buy or sell real estate without the approval of the Executive Board, when such transactions are made between sessions of the State Association.

Promotional Director

The promotional director shall assist in coordinating the work of the various boards of the State Association and shall serve as state treasurer. He shall promote both the state and national workers, missionaries, mission conferences, etc. It shall be his duty to edit and publish the state paper.

He shall receive, hold, and disburse money as is made available by the State Association to the various boards. Disbursements to the various boards will be made when requested.

He shall present a written report of his work at each annual session of this association, with a financial statement of all monies received and disbursed. These books shall be audited annually.

Section 4. Mission Board: It shall be the duty of this board to

promote an active missions program. It shall work in cooperation with the national home missions and foreign mision boards in the arranging of missionary conference, of missionary intineraries, and shall assist in the raising of the State quota for the national missions program.

The board shall not participate in the organization of any church or mission in a town, city or community where there is an organized Free Will Baptist church without seeking the cooperation of said church. Neither shall this board assist in the organization of a group that is out of fellowship with an established church.

This board shall be entrusted to receive, hold, manage, use, control, or convey State Mission Property.

Section 5. Church Training Service Board: It shall be the duty of the state Church Training Service Board to plan and assist the Church Training Service work throughout the state. It will be their responsibility to promote an active Church Training Service work in each association and to encourage Church Training Service rallies. They shall be entrusted to receive, hold, manage, use, control, or convey the youth camp property. This board shall be repsonsible for the selection of the youth camp personnel. They will plan and promote the annual Church Training Service Conference and Youth Encampment.

Section 6. Sunday School Board: It will be the duty of this board to work in cooperation with the National Sunday School Department in arranging Sunday School conferences and workshops, teacher's training courses, and in recommending methods and materials for the Sunday schools of the State of Arkansas. Section 7. Christian Education Board: It shall be the duty of this board to establish and promote a high standard of Christian Education within the framework of this association. This board shall be responsible for Bible Institutes, the teaching and training of the ministry and other interested laymen. The Treatise of the faith and practices of Free Will Baptists shall be the guide of theological positions for the institutes.

ARTICLE VIII

Amendments:

This constitution may be amended at any regular session of the State Association by a two-thirds vote of the members present, providing proposed amendment is presented in writing to the body one day in advance.

ARTICLE IX

Parliamentary Procedure:

This meeting of the State Association shall be governed by the rules of parliamentary law as set forth in Robert's Rules of Order.
