- 3. We recommend that all deacons be given a certificate of standing as requested by their churches.
- 4. We recommend that the body give the Moderator the power to appoint three men to investigate the conduct of Bro. Joseph Spradley, Pell City.

 Bro. Drummonds, Chairman; Bro. Morris and Bro. M. C. Isbell.
- 5. We recommend that Bro. George W. Cochrans future unofficial ministerial work be revoked as he has no license and that our churches accept this action and be governed accordingly, and that Sis. Gamel turn his license over to the clerk of the association
- 6. We find that J. W. Hollis has left the Free Will Baptist and has turned his ordaination papers over for this body to accept.
- 7. We recommend that the body give the Moderator power to appoint a field evangelist, and give him power to call any five ministers and deacons to assist him in organizing new churches. Bro. Ritch appointed.
- 8. We recommend that item 16 of our rules of Decorum be changed to read, "We recommend that all preachers and churches coming from other associations or denominations be examined by a committee before being received into the body."

We your ordaining council have examined Bro. Fields and found him worthy to be ordained to preach the gospel. Bro. Isbell, Chairman; Bro. Burrell, Bro. Davis, Bro. Morris and Bro. Horn.

Move and second to turn Bro. Fields over to the ordaining council to be ordained. We had a song and everyone shook hands with Bro. and Sis. Fields.

Standing of ministers report—We recommend that all minister who gave a report be given a certificate of standing. Move and second that the ministers receive their certificates and the committee be dismissed.

Auditing committee report—We would like to report that we find the books of our secretary and treasurer of the camp ground correct and neat and commend him for his faithful service. Committee dismissed.

Bro. Patterson, Bro. Donnie Layton, Sis. Gamel and Sis. Isbell were appointed as delegates to the state association.

Devotion committee report—Bro. Ford is to bring the night message. Move and second to receive report and dismiss the committee.

Bro. Drummonds made a motion to adjourn until tonight. Dismissed in prayer.

SATURDAY NIGHT

The night service began with singing of good songs. A wonderful message was brought by Bro. Ford which was enjoyed by all.

Communion service was held with feet washing following. Most everyone took part. Dismissed in prayer.

RULES OF DECORUM

- After an introductory sermon is preached the association shall be called together by the Moderator who presided at the last session. In case of his absence, the assistant Moderator shall call the body together, the former clerk also officiatin until organized.
- The association when assembled shall be composed of all the Ministers and Ordained Deacons, and Delegates chosen by the differene churches composing the body.
- 3. The officers of the association shall consist of a Moderator, Assistant Moderator, and a Clerk to be chosen from the members present.
- 4. It shall be the duty of the Moderator to preside over the body during the session at which he is elected, to call the next session to order and preside until reorganization and the elections and installation of his successor. It shall be his duty to keep order, enforce the Rules of Decorum, decide all questions, discipline, and in case of a tie vote to cast the deciding ballot. He may speak on any subject but must call on the Assistant Moderator to preside while he is speaking.
- 5. It shall be the duty of the Clerk to keep the minutes of the proceedings and to read the same when upon by the body, and shall prepare the minutes for publication.
 - 6. Each church is entitled to three delegates.
 - . A majority of the members shall rule in all cases.
- 8. No member shall absent himself from the house without leave from the Moderator.
- 9. All business shall be brought before the body by a motion and second and shall be disposed of by vote of the body.
- 10. No person shall be allowed to speak more than twice on the same subject, nor more than ten minutes each time, without permission of the Moderator.
- 11. No brother shall be interrupted while speaking unless he departs from the subject under discussion or uses words of personal reflection.
- 12. Only one person shall be allowed to speak at a time and he must arise and address the Moderator.
 - 13. That no business be voted on without the whole delegation present.
- 14. This decorum may be altered, amended or abridged if any session of the association by a majority of the members present.
- 15. The minister that receives the most votes shall be elected Moderator, and the next highest, Assistant Moderator.
- 16. We recommend that all preaheers and churches coming from other associations or denominations be examined by a committee before being received into the body.
- 17. We recommend that we correspond and ask correspondence with other associations.

FREE WILL BAPTIST ARTICLES OF FAITH

- THE BIBLE—The Scriptures of the Old Testaments were given by inspiration of God and our infallible rule of faith and practice.
- 2. GOD—There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good Whom all intelligent creatures are supremely to love, adore and obey. 1 Cor. 8:6; 28:19.
- 3. CHRIST—Christ is God manifest in the flesh; in His divine nature truly God in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified and is our ever present Savior and Lord. St. John 1:1-12.
- 4. THE HOLY SPIRIT—The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men. St. John 16:7-8; Acts 2:4; Eph. 4:14.
- 5. THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.
- 6. THE SINFULNESS OF MAN—Man was created innocent, but by disobedience fell into a state of sin and condemnation. He posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2:17; 3:19.
- 7. THE WORK OF CHRIST—The Son of God by His incarnation, life, sufferngs, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith. 1 John 2:2.
- 8. THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance of sincere sorrow for sin and the hearty renuciation of it. 2. Faith or the unreserved of one self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death. 2 Cor. 7:10; Prov. 28:13.
- 9. ELECTION—God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.
- 10. FREEDOM OF WILL—The human will is free and self controlled having power to yeild to the influence of the truth and the Spirit and live, or to resist them and perish. Joshua 24:15.
- 11. SALVATION FREE—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.
- 12. PERSERVERANE—All believers in Christ, who through grace, persevere in holiness to end of life, have the promise of eternal salvation. Rev. 22:17; St. John 15:6; Jeter 2:20-22.

- 13. GOSPEL ORDINANCES—Baptism, or the immersion of believers in water and the Lord's Supper are ordinances to be perpetuated under the Gospel; Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers. St. John 15:6; Peter 2:20; Mark 16:15; or. 4:5, St. John 13:14.
- 14. THE HRISTIAN SABBATH—The Divine law requires that one day in seven be set apart from secular employment and amusement for rest, worship, holy works and activities, and for personal communication with God. Gen. 2:3; Exodus 20:8-11.
- 15. RESURRECTION JUDGMENT AND FINAL RETRIBUTION—The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life and they that have done evil unto the resurrection of damnation; then the wicked shall "go away into eternal punishment but the righteous into eternal life." John 5:9; Matt. 25:46.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We will everywhere hold Christian principle sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprise, the support of Missions, the success of Sunday School, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
