Green have the timber for \$1,000.00 with us having to redeem the timber at the same price. The Executive committe, ewith the camp ground committee met in Leeds on Feb. 22, 1958 to discuss the making of the deeds and arrange to complete the purchase of the camp ground. Having \$1,000.00 in the camp ground fund Bro. Hanks agreed to borrow the other thousand with him holding the deeds. We have twenty months in which to pay the money back. Interest on the money will be \$105.00.

The Executive committee met June 28, 1958 at Riverview and voted to Incorporate the Birmingham District Association to read on all official papers, The Birmingham District Association of Free Will Baptist Incorporated.

The Executive committee met June 28, 1958 at Riverview and voted to turn the deeds back to the Alton Free Will Baptist Church.

Sis. Whitten led a song while everyone shook hands with Bro. and Sis. Venable. Bro. Finch delivered the charge to Bro. Venable.

Ladies Aux. gave a report at this time with Sis. Parker giving the report. Motion to adjourn. Bro. Thomas dismissed us in prayer.

RULES OF DECORUM

- 1. After an introductory sermon is preached the association shall be called together by the Moderator who presided at the last session. In case of his absence, the assistant Moderator shall call the body together, the former clerk also officiating until organized.
- 2. The association when assembled shall be composed of all the Ministers and Ordained Deacons, and Delegates present chosen by the different churches and quarterly meetings.

 The officers of the association shall consist of a Moderator, Assistant Moderator, Clerk, and Assistan Clerk, to be chosen from the members present.

- 4. It shall be the duty of the Moderator to preside over the body during the session at which he is elected, to call the next session to order and to preside until reorganized and the elections and installation of his successor. It shall be his duty to keep order, enforce the Rules of Decorum, decide all questions, discipline, and in case of a tie vote to cast the deciding ballot. He may speak on any subject but must call on the Assistant Moderator to preside while he is speaking.
- 5. It shall be the duty of the Clerk to keep the minutes of the proceedings and to read the same when called upon by the body, and shall prepare the minutes for publication.
 - 6. Each church is entitled to three delegates.
 - 7. A majority of the members shall rule in all cases.
- 3. No member shall absent himself from the house without leave from the Moderator.
- All business shall be brought before the body by a motion and second and shall be disposed of by vote of the body.
- 10. No person shall be allowed to speak more than twice on the same subject, nor more than ten minutes each time, without permission of the Moderator.
- 11. No brother shall be interrupted while speaking unless he departs from the subject under discussion or uses words of personal reflection.
- 12. Only one person shall be allowed to speak at a time and he must arise and address the Moderator.
 - 13. That no business be veted on without the whole delegation present.
- 14. This decorum may be altered, amended or abridged at any session of the associaion by a majority of the members present.
- 15. The minister that receives the most votes shall be elected Moderator and the next highest, Assistant Moderator.
- 16. We recommend that all preachers and churches coming from other associations or denominations be examined by a committee before being re-

ceived into the body.

- 17. We recommend that we correspond and ask correspondence with other associations.
- 18. We recommend that all deacons and ministers attend or represent by letter before receiving a certificate of standing. P. S. And that this item be strictly enforced.
- 19. We recommend that all ministers that reach the age of 60 be giving a lifetime certificate of standing.

FREE WILL BAPTIST ARTICLES OF FAITH

- 1. THE BIBLE The Scriptures of the Old Testament were given by inspiration of God and our infallible rule of faith and practice.
- 2. GOD There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good Whom all intelligent creatures are supremely to love, adore and obey. 1 Cor. 8:6; 28:19.
- 3. CHRIST Christ is God manifest in the flesh; in His Divine nature truly God in His human nature truly man. The mediator between God and man once crucified. He is now risen and glorified and is our ever present Savior and Lord. St. John 1:1-12.
- 4. THE HOLY SPIRIT The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men. S. John 16:7-8; Acts 2:4; Eph. 4:14.
- 5. THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constituion and laws of nature He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.
- 6. THE SINFULNESS OF MAN Man was created innocent, but by disobedience fell into a state of sin and condemnation. He posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God. Gen. 2-17; 3:19.
- 7. THE WORK OF CHRIST The Son of God by His incarnation, life, sufferings, death and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith. I John 2:2.
- 8. THE TERMS OF SALVATION The conditions of salvation are: 1. Repentance of sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved of one self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death. 2 Cor. 7:10; Prov. 28:13.
- 9. ELECTION God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.
- 10. FREEDOM OF WILL The human will is free and self controlled having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish. Joshua 24:15.

11. SALVATION FREE — God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.

12. PERSEVERANCE — All believers in Christ, who through grace, presevere in holiness to end of life, have the promise of eternal salvation. Rev.

22:17; St. John 15:6; Peter 2:20-22.

13. GOSPEL ORDINANCES — Baptism, or the immersion of believers in water and the Lord's Supper are ordinances to be perpetuated under the Gospel; Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers. St. John 15:6; Peter 2:20; Mark 16:15; or 4:5, St. John 13:14.

14. THE CHRISTIAN SABBETH — The Divine law requires that one day in seven be set apart from secular employment and amusement for rest, worship, holy works and activities, and for personal communication with God. Gen. 2:3; Exodus 20:8-11.

15. RESURECTION JUDGMENT AND FINAL RETRIBUTION — The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life and they that have done evil unto the resurrection of damnation; then the wicked shall "go away into eternal punishment but the righteous into eternal life" John 5:9; Matt. 25:46.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word for God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight on all men."

We wil everywhere hold Christian principle sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominatinal enterprise, the support of Missions, the success of Sunday School, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
