

AUDITING COMMITTEE

We, the Auditing Committee, have examined the Clerk's accounts and found them to be in order.

BUSINESS COMMITTEE

We, the Business Committee, have read and discussed he requests of the churches. We recommend that the ollowing be accepted by the Body in proper form.

ITEM NUMBER ONE

THAT THE RULES OF THE DECORUM BE AMENDED TO READ AS

- 1- The Clerk shall call Association to Order. In his absence the eldest Minister will call meeting to order.
- 2- Association shall be opened by reading of Scripture and Prayer by the Moderator.
- 3- This Body shall be composed of Ministers, Deacons and Delegates present from each church.
- 4- By a two thirds(2/3)vote, any decision of the Moderator may be ammended.
- 5- The officers of the association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, to be chosen from the members present.
- 6- It shall be the duties of the Moderator to preside over the Body during the session, to keep order, enforce the rules of the Decorum, and decide all questions, discipline, and in a tie vote, cast the deciding ballot. He may speak on any subject, but must call on the Assistant Moderator to preside while he is speaking.
- 7- It shall be the duty of the Clerk to keep the minutes of the proceedings and read them when called upon by the Body. The Clerk shall prepare the minutes for publication. The Clerk Assistant Clerk shall serve a five (5) year term.
- 8- Each church is entitled to three(3) Delegates.
- 9- A majority of the members present in each session shall rule in all cases.
- 10- No Delegate shall absent himself from the house without the consent of the Moderator.

BUSINESS COMMITTEE CONTENUED

11-All business shall be brought before the Business Committee and shall be disposed of by the Body.

12-No person shall be interrupted while speaking, unless he departs from the subject under discussion, or uses words of personal reflection.

13-No person shall be allowed to speak more than twice on the same suject nor more than five(5)minutes each time without permission of the Moderator.

14-Only one person shall be allowed to speak at a time and he must stand and address the Moderator.

15-Theterms of office for the Moderator and Assistant.
Moderator will be one(1) year. (These Officers shall be elected at the Annual Conference).

THE BUSINESS COMMITTEE RECOMMENDS THE FOLLOWING GUIDE LINE FOR ORDINATION

1-This Association Ordains no man that has more than one(1)living wife, nor a man, whose wife has more than one(1)living husband.

2-Every Minister carry a license until he is either called to a church or enters full time Evangelistic work. The license of Ministers licensed by this Association are to be reissued each year, if if and only if the church of which they are a member makes this request.

3-This Association Ordains no one that doesnot believe and practice tithing.

4-This Association Ordains no one that doesnot believe fully the Faith and Practice of the Eree Will Baptist Treatise.

5-This Association will not Ordain women to preach the Gospel.

BUSINESS COMMITTEE CONTENDUED

6-This Association Odains no one that doesnot beleive in the verbal inspiration of the word of God.

7-This Association willnot Ordain anyone that is affiliated with the World Council Of Churches.

8-This Association willnot Ordain, with a bad character with them that are without.

9-This Association willnot Ordain anyone that doesnot believe and practice the Ordinances of the Church (A)-Baptism by immersion, (B)-Communion, and (C) Feet Washing.

10-This Association willnot Ordain anyone that doesnot believe a person can Apostalize and be lost.

ITEM NUMBER THREE

We, the Business, recommend that the following from Hanks Memorial Free Will Baptist, if found worthy, to be Ordained as Deacons. Bro: C.E.Henderson, Bro: J.A. Cox, and Bro: H.M.Bailey.

ITEM NUMBER FOUR

We, the Business Committee, recommend that the following from Bonita Park Free Will Baptist, if found worthy, to be Ordained as Deacon. Bro: Lonnie Bernard Williams, Bro: Alfred lynn Overton, and Bro: James Bradford.

ITEM NUMBER FIVE

We, the Business Committee recommend that the following from Bonita Park Free Will Baptist, if found worthy, be licensed to preach the Gospel: Bro: Randy Alan Keef.

ORDAINING COUNCIL

Bro: Dutton gave a short message concerning the duties and characteristics of a Deacon and their wives. Using 1st Timothy: 3:8-13 for his thought.

A Deacon is to be, according to the Bible Standards ahelper to the Pastor, a servant to the Church, reliable reserved in conduct, prove themselves, not coveteous, Holy, Godly and proficient.
