RULES OF THE DECORUM

1-The Clerk shall call Association to order. In his abstrace, the eldest Minister will call Meeting to Order.

2-Association shall be opened by reading of SCRIPTURE, and PRAYER by the Moderator.

3-This BODY shall be compsed of, Ministers and Deacons, and DELTGATES present from each CHURCH.

4-By two thirds(2/3)votes, Any Decision of the Moderator may be Ammended.

5-The Officers of the Association shall consist of a Moderator Assistant Moderator, Clerk, and Assistant Clerk; to be chosen from the members present.

6-It shall be the DUTY of the Moderator to Preside over the Body during the session, to KEFF ORDER and ETHORCE the NULLES of the DECORUM, and decide all Questions, Discipline, and in a tie VOTE, cast the Deciding Ballot. He may speak on any Subject, but fust call on the Assistant MODERATOR to PRESIDE while he is SPEAKING.

7-It shallbe the Duty of the CLERK: to keep all the Minutes of the Proceedings and read them when called upon by the BODY. The Clerk shall PREPARE the Minutes for PUBLICATION. The Clerk and Assistant Clerk shall serve FIVE(5) year TERMS.

3-Each CHURCH is ENTITLED to THREE(3) DELEGATES.

9-A Majority of the Members Present in each Session shal RULE in all cases.

10-Delegates SHALL NOT absent himself from the House without the consent of the MODERATOR.

11-All Business shall be brought before the BUSINESS CMMITTEE and shall be disposed of by the Boty.

12-No PERSON shall be interrupted while SPEAKING, UNLESS he departs from the SUBJECT, under discussion or uses words of PERSOAL reflection.

13-No Person shall be allowed to speak more than TWICE(2)on the same SUBJECT, nor more than FIVE(5) Minutes each time without PERMISSION of MODERATOR.

14-Only one Person shall be allowed to SPEAK at a TIME, He MUST STANO and ADRESS the MODERATOR.

15-The TERMS of office for the MODERATOR and the Assistant MODERATOR shall be for ONE(1) year

16-The Clerk and Assistant Clerk ELECTED to serve for FIVE(5) years for both , Semi-Annual and Annual.

GUIDE LINE FOR ORDINATION

1-This Association Ordains no one that has more than ONE(1)living WIFE, nor a man who's wife has more than ONE(1)living HUSBANd.

2-Every LICENSED MINISTER carry a LICENSE until he is eather called to a church or enters full time EVANELISTIC WORK. The LICENSE of MINISTERS LICENSED by this Association are to be reissued each year, IF and ONLY IF the CHURCH of which they are a member, makes this Request.

3-This Association Ordains no ONE that DO NOT BELEIVE and PRACTICE TITHING.

4-This ASSOCIATION ordains no ONE that DO NOT BLEAVE FULLY, the FAITH and PRACTICE of the FREE WILL BAPTIST TREATY.

5-This Association WILL NOT Ordain Women to Preach the GOSPEL.

6-This Association Ordains NO ONE that DO NOT beleave in the VFRBAL INSPIRATION of the WORD of GOD.

7-This Association WILL NOT Ordain Anyone that is Affiliated with the WORLD COUNCIL of CHURCHES.

8-This Association WILL NOT Ordain Anyone with a Bad Character with them that are without.

9-This Association Will NOt Ordain that does not Beleave and Practice the ORdinances of the CHURCH.

10-This Association Will NOT Ordain Anyone that DO NOT beleive a Person can APOSTIZE and be LOST.

CHURCH COVENANT

Have given Ourselves to GCD, by Faith in CHRIST and Adopted the WORD OF GOD as our RULE of FAITH and FRACTICE, WE now give OURSELVES to one another by the WILL of GOD in this Solem COVENANT.

We will, everywhere HOLD CHRISTIAN PRINCIPLES, SACRED and CHRISTIAN OBLIGATIONS and INTERPRISES SUPREME: counting it OUR CHEIF BUSINESS in LIFE to extend the INFLUENCE of CHRIST in SOXIETY, constantly PRAYing and TOILING that the KINGDOM of GOD may come and WILL be done on EARTH as it in HEAVEN.
