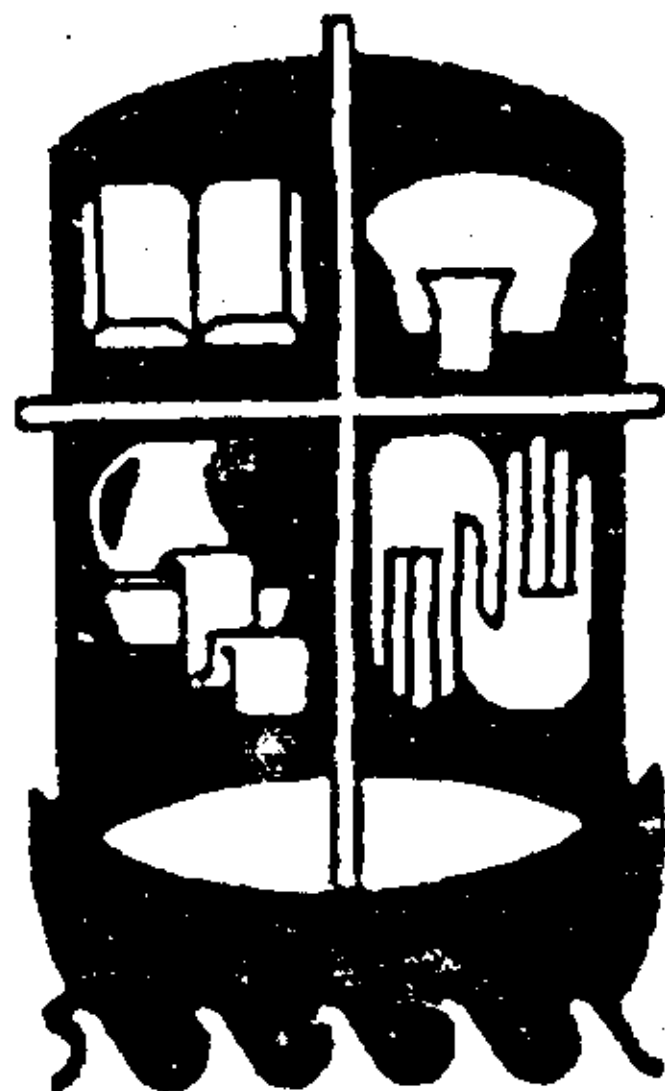

Please pray for the Children's Home every day. The new director is Bro. Randy Key. A motion was made by Bro. Curtis Todd to accept the Children's Home report. Bro. E. M. McDaniel seconded the motion. Questions were called for, there were no questions. An offering was taken for the Children's Home. \$439.10 was collected.

Sis. Belinda Barber sang, "Still On Time". Sis. Nedra Golden sang, "I Wish It Would Rain". Bro. Rick Andrews had comments and then introduced the morning speaker, Bro. Robert.

Bro. Robert preached from Acts 27:1-33. God has a plan and it is a perfect plan. When the sea of life is calm anyone can mind the helm. Times have been good in America. We have

plenty. But there's a storm on the horizon. Don't hide your head in the sand. We all have the same God. We all preach out of the same Word. The water is starting to get troubled. Judgement has begun in the house of God. Don't think that God can't turn your world upside down. When God gets hold of the helm, watch out. As long as God runs the show there will not be a problem. RULES OF THE DECORUM

1. The Clerk shall call the Association to order. In His/Her absence, the oldest Minister will call the meeting to order.
2. The Association shall be opened with reading of scripture and prayer by the Moderator.
3. This body shall be composed of Ministers, Deacons, and delegates present from each church.
4. By two-thirds ($2/3$) vote, any decision of the Moderator may be amended.
5. The officers of the Association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, to be chosen from the members present.
6. It shall be the duty of the clerk to keep all the minutes of the proceedings and present them when called upon by the body. The clerk shall prepare the minutes for publication. The clerk is to serve two (2) years at a time.
7. It shall be the duty of the Moderator to preside over the body during each session, to keep order, and enforce the rules of the Decorum, and decide all questions, discipline, and in a tie vote cast the deciding ballot. He may speak on any subject, but must call on the Assistant Moderator to preside over the meeting.

8. Each church is entitled to three (3) delegates.
9. A majority of the members present in each conference shall rule in all cases.
10. No delegate shall absent himself/herself from the meeting without the consent of the Moderator.
11. All business shall come before the Business committee and shall be disposed of by the body.
12. No person shall be interrupted while speaking, unless he/she departs from the subject of discussion, or uses words of personal reflection.
13. No person shall be allowed to speak more than twice(2) on the same subject. Nor shall they speak for more than five (5) minutes at a time, without the consent of the Moderator.
14. Only one person shall be allowed to speak at a time, that person must stand and address the Moderator.
15. The terms of office for Moderator and Assistant Moderator are for one (1) year only.
16. The terms of office for the Clerk and Assistant Clerk are for two (2) years.

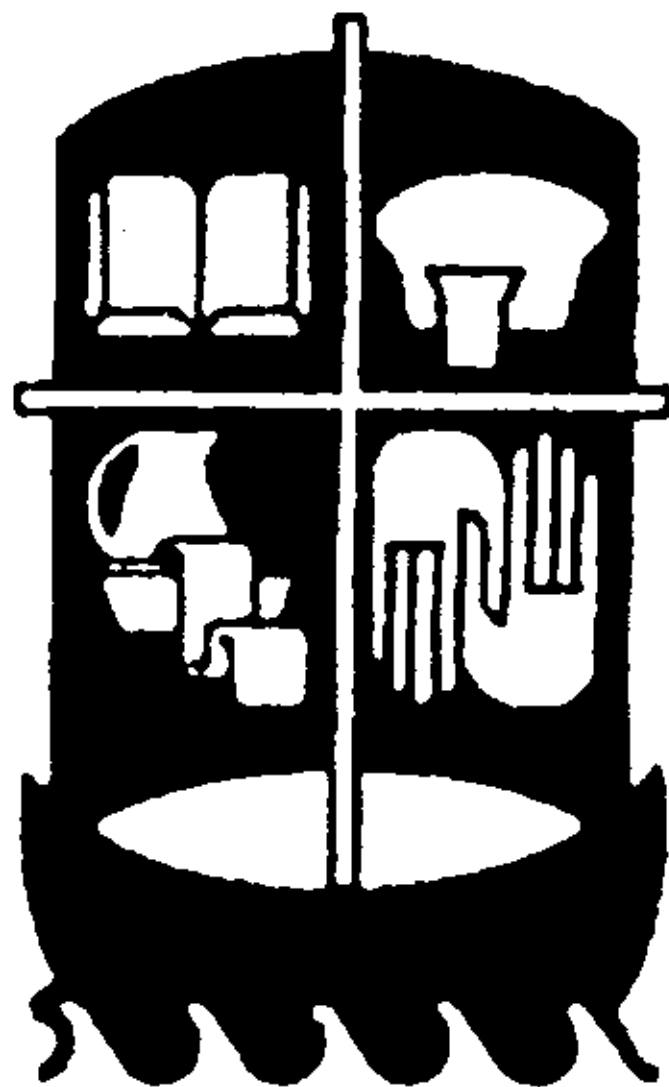
