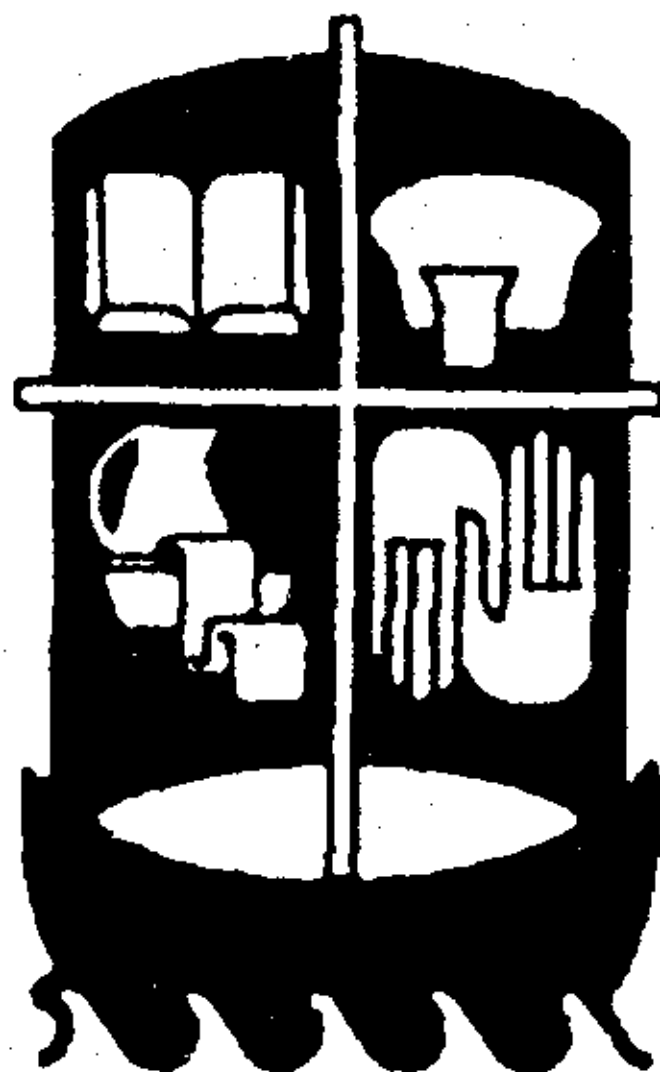

Bro. Rick Andrews welcomed everyone to the 63rd Semi-Annual meeting. Bro. Jackie Adcox came and welcomed everyone to Liberty FWB Church. Bro. Jackie led the congregation in prayer.

Bro. Rick came and gave the Moderator message. He spoke from Psalm 33:8-12. "Blessed is the nation whose GOD is the LORD." He spoke of the tragedy of last September and the nation turning toward GOD. Or the others who have asked why GOD allowed this to happen. We need to live our lives as if everything has been recorded on videotape. Our GOD sees everything and knows everything. II Chronicles 7:14 We need to live our lives pure and holy before GOD. Are our churches social stations or soulsaving stations?

The Association clerk declared the meeting open for business.

The congregation sang pg. 265, "Victory in Jesus". Roll call of the delegates was made

and substitutions were made where appropriate. Bro. E.M. McDaniel made a motion to accept the delegates. Bro. Curtis Fountain seconded the motion. Motion carried 100%.

Bro. Curtis Todd made a motion to accept the minutes from the last meeting and the spreadsheet. Sis. Alice Perry seconded the motion.

Roll call of the Business committee was made. Substitutions were made where appropriate.

Roll call of the Ordaining committee. All members were present.

Sis. Dorothy Foster led the congregation in singing "I'll Fly Away" and "It's That Old Time Religion". Bro. Gary Heliker played the piano and sang "I'm Still Holding On". Bro. Frank Lackey sang "The Rose Among The Thorns". Sis. Peg Baxter sang "How Great Thou Art".

The Moderator dismissed the Business committee.

Sis. Virginia Adcox sang, "Take Off Those Rags Lazarus". Bro. Tim Roulaine sang, "Pass Me Not".

The congregation was dismissed for a short break. Bro. Robert Richardson said the dismissal prayer.

After a short break and refreshments, the Moderator welcomed everyone back. Bro. Scott Isbell came and gave the report on the Children's Home. Dedication of the new handicapped accessible cottage is set for April 27, 2002 at 11:00 AM with a ceremony and BarBQ. There are 25 children presently at the home. 15 boys and 10 girls. there will be a total capacity of 40 children with the new cottage. The new cottage is equipped with a storm shelter. Remember to pray for the Children's Home. Luke 18:16. Bro. Curtis Todd made a motion to accept the Children's Home report as read. Bro. E.M. McDaniel seconded the motion. Motion passed 100%.

An offering was received for the Children's Home. Bro. Jim Roulaine sang, "Baptism". The total of the offering was \$193.61. Sis. Belinda Barber sang "The Anchor Holds". Sis. Helen Stephenson sang "Let's Have Church", accompanied by Sis. Francis Langston.

The Moderator called for the Business committee report which was read by Bro. Curtis Fountain. Bro. Fountain read: the Friday night before the Annual Association meeting there will be a Preachers and Deacon's meeting at 7:00 PM. This meeting will be hosted by Trinity Christian Fellowship FWB church. A motion

was made by Bro. Mike Jackson. Bro. Frank Lacey seconded the motion. Motion passed by 100%.

Liberty FWB church choir came and sang, "I've Got A Love" and "Jesus Is". Bro. Curtis Todd came and preached the morning message. He preached from Joshua 1:1-9. GOD is moving today, GOD is bringing revival all over the land. GOD was talking to Joshua, Mose's Minister. Moses had died and GOD instructs Joshua to continue on. John 14:12. JESUS has not changed-We have changed. GOD has not moved. We have. We need to get back to serving GOD. Numbers 14:24. We need a different spirit in the church. Step out, don't let fear stop you. Phillipians 1:28. Isiah 41:10.

Christians in the church are our worst enemies. We need a new spirit in our churches. We need to back our fellow Christians when they step out in faith. A lot of Christians don't move until a tragedy falls upon them. Acts 14:28. Let's have church! Be in the Spirit and serve GOD. Pray for a new SPIRIT.

Announcements were made. Bro Ralph Foster. closed the meeting with prayer.

RULES OF THE DECORUM

1. The Clerk shall call the Association to order. In His/Her absence, the oldest Minister will call the meeting to order.
2. The Association shall be opened with reading of scripture and prayer by the Moderator.
3. This body shall be composed of Ministers, Deacons, and delegates present from each church.
4. By two-thirds ($2/3$) vote, any decision of the Moderator may be amended.
5. The officers of the Association shall consist of a Moderator, Assistant Moderator, Clerk, Assistant Clerk, to be chosen from the members present.
6. It shall be the duty of the clerk to keep all the minutes of the proceedings and present them when called upon by the body. The clerk shall prepare the minutes for publication. The clerk is to serve two (2) years at a time.
7. It shall be the duty of the Moderator to preside over the body during each session, to keep order, and enforce the rules of the Decorum, and decide all questions, discipline, and in a tie vote cast the deciding ballot. He may speak on any subject, but must call on the Assistant Moderator to preside over the meeting.

before he may speak.

8. Each church is entitled to three (3) delegates.
9. A majority of the members present in each conference shall rule in all cases.
10. No delegate shall absent himself/herself from the meeting without the consent of the Moderator.
11. All business shall come before the Business committee and shall be disposed of by the body.
12. No person shall be interrupted while speaking, unless he/she departs from the subject of discussion, or uses words of personal reflection.
13. No person shall be allowed to speak more than twice(2) on the same subject. Nor shall they speak for more than five (5) minutes at a time, without the consent of the Moderator.
14. Only one person shall be allowed to speak at a time, that person must stand and address the Moderator.
15. The terms of office for Moderator and Assistant Moderator are for one (1) year only.
16. The terms of office for the Clerk and Assistant Clerk are for two (2) years.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by his grace, to love and obey him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in sight of all men".

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bounds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday school, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

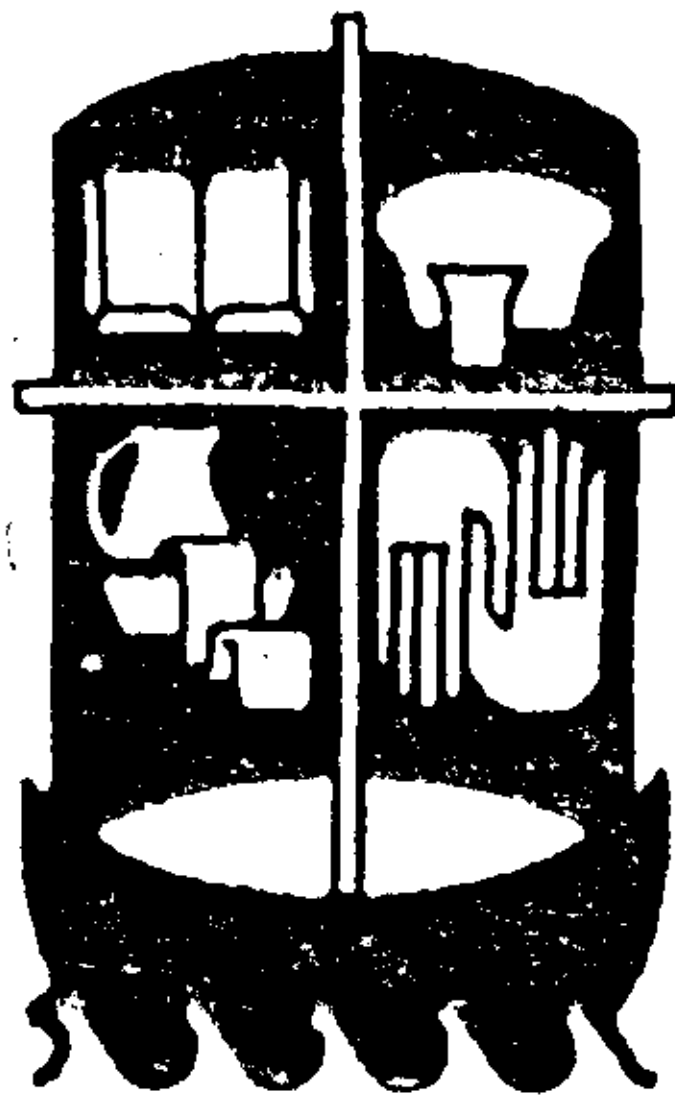

A motion was made by Bro. A.J. Davis to accept the committees. Sis. Marsha Graves seconded the motion.

Bro. Mike Jackson led the congregation in singing "Just A Little Talk With Jesus".

Bro. Randy Key came and gave the Children's Home report. He shared a story about the children at the home. Five children have left the Home in the past two months. Twenty-seven children are presently at the Home. Four cottages are

completed, along with the multi-purpose building. The total for all the construction has been \$800,000. All paid for. The Children's Home also owns 200 acres on the hill across the highway. They are developing the area for hunting, fishing, and camping for churches who support the Children's Home. An offering was collected, the total amount was \$504.25. Bro. Harold Latta led the congregation in prayer for the Children's Home.

Bro. Randy Key prayed before the meeting took a short break.

Moderator welcomed everyone back from the break. The Committees began their reports.

Devotional Committee report read by Sis. Belinda Barber. The selected speakers for the Semi-Annual meeting in March are Bro. Curtis Todd. The alternate is Bro. Lee Bevan. The selected speaker for the Annual meeting in September is Bro. Robert Richardson. The alternate is Bro. Rick Andrews. A motion was made to accept this report by Bro. Lester Graves. Motion was seconded by Sis. Mollie Freeman.

Temperance Committee report was read by Sis. Francis Langston. As Christians we need to listen long and think hard before we speak. James 1:19-20. "Wherefore, my beloved brethern, let every man be swift to hear, slow to speak, slow to wrath. For the wrath of man worketh not the righteousness of GOD." A motion was made by Sis. Marsha Graves to accept this report as read. A second was made by Sis. Sheryl Summers.

Sunday School Committee report was read by Sis. Sheryl Summers. The Sunday School Committee would like to stress the importance of participating in Sunday School.

Bro. Harold Latta led the Ordination ceremony. He gave the charge to Bro. Lee Bevan and Mrs. Bevan. The scripture he referred to was II Timothy 4:2-3. Everyone came around and welcomed the new Minister and his wife. while Bro. Buddy Isbell sang "The Lighthouse." The ordained men present came and laid hands on the couple and prayed for them and their ministry. A round of applause was given.

Bro. Wallace and Bro. Moore will be ordained when the Association meeting is at their home church, Liberty FWB, so their families can be present.

Bro. Rick Andrews introduced the speaker, Bro. Jim Gothard. The title of his message was "New Ground."

I Chronicles 4:9. There are Christians and then there are CHRISTIANS! Jabez was more honorable than his brethren. What do you want from GOD? Do you barely want to get in the door? Do you want your way in church? Do you want everyone to look and behave as you do? Everyone has a call on their lives, not only the Ministers. Everyone needs to

preach the Gospel. It's going to take something for the church to grow. It begins with you. You are important to GOD. Give everything, give it all to GOD. Go ye therefore. Do you want to be heavy for the LORD? Do you want to be a David? David was heavy, he was more honorable. He had big peaches on his tree. Do not be ashamed to be more honorable, to try harder than your brethren. It is going to take some toiling, some sorrow to get where you are going. Enlarge my coast, give me some more rope, LORD. Some of you have knots in your rope, some of you need to chew that rope off. Some of you don't even have your rope dirty, some are content to sit by your doghouse. You need to get moving.

If you want GOD to bless you don't ask him to bless you so you will feel better or have a newer car or bigger house. Ask GOD to bless you so that you will see people get saved. We don't need a move of GOD, GOD has never stopped moving. We need to move.

If you are sitting still in church, you are doing nothing for GOD.

What are you expecting out of GOD? What is GOD expecting out of you?

When you get what GOD wants you to have you have everything.

An altar call was held.

Bro. Lee Bevan prayed over lunch and the congregation was dismissed for lunch.

After a wonderful lunch, everyone reconvened and sang, "Victory in Jesus". The Moderator came forth and asked that the business meeting continue. Bro. Curtis Fountain made a motion to retain the same Ordaining Council. Bro. Jim Freeman seconded the motion. Bro. J.A. Cox made a motion to select a new Business committee member from the replacements made today. Bro. Curtis Fountain was selected to serve on the Business committee.
