# CONSTITUTION AND BY-LAWS OF THE BLUE GRASS CONFERENCE OF FREE WILL BAPTISTS

ARTICLE I <u>NAME</u>

This conference shall be known as the Blue Grass Conference of Free Will Baptists. ARTICLE II

#### **PURPOSE**

The object and purpose of this organization shall be to unify and strengthen the work of the various churches, composing the Blue Grass Conference of Free Will Baptists, and to devise and execute measures for the extension of the Kingdom of God in connection with the various churches in the Conference or that may be hereafter represented therein.

## **ARTICLE III**

#### **DELEGATES**

The Blue Grass Conference shall be composed of its general officers, the members of all standing boards or committees, and duly appointed delegates as chosen by the churches belonging to said conference.

## **ARTICLE IV**

### REPRESENTATION

Representation in the Blue Grass Conference is to be by the churches which are affiliated with five (5) elected delegates from the laity, ordained ministers, deacons, licensed preachers, church clerks, general Sunday School Superintendent, general CTS Director, President of the Woman's Auxiliary, and Master's Men President representing as standing delegates, providing the delegates are members in good standing of the local church they represent.

## **ARTICLE V**

## <u>FEES</u>

We recommend that each church send a minimum of \$50.00 to the General Fund with it's letter to the Conference. This is to be used in the various phases of the denominational work at the discretion of the Conference, and the ministers and deacons will strongly urge each church to comply as much as possible.

## **ARTICLE VI**



All matters involving disciplinary measures and local church relationships shall be handled according to the Treaties of the National Association of Free Will Baptists.





#### **ARTICLE VII**

#### MEETINGS

Section 1. SCHEDULED MEETINGS. The meeting of the Blue Grass Conference shall be held each Construction of Squarter (February, May, August, and November) according to churches in alphabetical order and shalls a second state of the second convene on the first Saturday of the month designated at 10:00 a.m. The May meeting shall be designated as the annual meeting. The November meeting shall be designated as the Annual Missions' Conference and the second state of the meeting.

Section 2. PROGRAMS. The pastor of the host church shall select the speaker for the morning service set and se working with the Moderator. If the host church should be without a Pastor, the Moderator is to be an an and the second state of the The second of the second of the consulted.

### **ARTICLE VIII**

#### **BOARDS/COMMITTEES**

Section 1. STANDING BOARDS. The Standing Boards of the Conference shall consist of the Presbytery Board, the Mission Board and the Youth Board.

The Standing Boards shall be composed of five (5) members each and may be elected either from the ordained authority or the laity. The Presbytery shall consist only of ordained ministers. The members of Standing Boards shall be elected for a term of five (5) years, with their term of office to expire alternately.

The duties of the various Standing Boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and as may be found in harmony with the principles and tenants of the Blue Grass Conference. All Boards shall be chaired by an ordained authority with the exception of the Youth Board and the majority membership of each board shall consist of males.

#### A. PRESBYTERY BOARD

The purpose of the Presbytery shall be for the mutual improvement of the ministry, their protection against hostile influence, for the maintaining of a clean character among those of the licensed and ordained ministry. It shall also become the duty of the Presbytery to examine all candidates for license to preach the Gospel or to ordain the same at the request of the local church.

#### **B. MISSION BOARD**

The purpose of the Mission Board shall be to promote world evangelism.

#### **YOUTH BOARD**

The purpose of the Youth Board shall be to plan youth activities and services.

Section 2. COMMITTEES. All Committees shall be chaired by an ordained authority with the majority of the second se membership of each committee consisting of males. A set the set of a set of the set of t

## A. EXECUTIVE COMMITTEE

Each church of the Blue Grass Conference may appoint one (1) person who is approved and a second sec by the local church to the Executive Committee. This representative's name and an additional sector is the sector of the sector alternate's name must be submitted on the Annual letter to the Conference. A quorum of majority members must be present to conduct business. The Committee's responsibility will include making recommendations of business and the state of the state of the finance. The Moderator shall be the chair and the Clerk shall be secretary of the Executive Committee. This Committee is to meet at 9:30 a.m. on the morning of the Conference. The Moderator has the privilege to call a meeting at his discretion.

## **B. OTHER COMMITTEES**

Any other committee that shall be deemed necessary shall be appointed by the Moderator annually and shall hold office for one (1) year. The Nominating Committee seven as a shall be appointed in February to report in May. A selection of the second second second second second

## **ARTICLE IX**

AUXILIARIES

The District Woman's Auxiliary Convention, Master's Men Organization, the District Sunday School Convention and the District CTS Convention shall be recognized as subordinate organizations to the Blue Grass Conference. They shall report their accomplishments quarterly to the Conference.

## **ARTICLE X**

AMENDMENTS

This Constitution may be amended or altered at any regular session of the Blue Grass Conference by a second s two-thirds vote of the members present, provided proposed amendment or alteration be presented to the state of the state o body in writing in advance. All amendments or alterations must be tabled for a period of three (3) adda and the second of the second se months.

## **ARTICLE XI**

#### OFFICERS

The officers of this Conference shall be elected annually and consist of a Moderator, Assistant Moderator, Clerk and Treasurer. The retiring Moderator shall be an ex-officio member of the Executive Committee for one year.

Any officer or board member failing to discharge their duty shall be subject to the next quarterly meeting and may be removed from office.

# **BY-LAWS**

#### MEMBERSHIP

All churches belonging to this Conference must agree with the Treatise of the Faith and Practices of Free ab Will Baptists.

#### HONORARIA & REIMBURSEMENT

Section 1. HONORARIUM. The Moderator, Clerk and Treasurer shall receive an honorarium per quarter and the second for their services. This honorarium shall be reviewed at the annual meeting by the Conference.

Section 2. CLERK. The Clerk is given the responsibility of buying supplies needed.

Section 3. SPEAKERS. The Executive Committee shall be given the privilege of setting speaker honorariums.

#### PRESBYTERY BOARD

Section 4. PRIVILEGES. All ordained ministers in good standing with this body have the privilege of sitting in council with the Presbytery at any time, but will not be permitted to vote unless he is appointed to serve as proxy by an absentee member or selected by a majority of the members present.

Section 5. LICENSE. The local church shall notify the Clerk of the Conference that they have a candidate that needs examination by the Presbytery. The Clerk shall notify the Chairman of the Presbytery of the local church's request. All appropriate questions (not to be less than twenty-five (25) and prepared by the Presbytery) shall be forwarded to the Chair of the Presbytery, who shall appoint a state of the second sta time for the Presbytery to meet with the candidate. The candidate is interviewed to his gifts, personal decision of the candid piety, doctrines, his call to the ministry, his adaptability and devotional life, his reputation, character, double and devotional life, his reputation, hi ability and his present and prospective educational qualifications. After the interview, the Presbytery shall make a recommendation to the Conference. The Conference will vote on the recommendation. The decise decise decises are decised as a subsequence of the second secon licensed candidate is placed under the watch-care of the local church for a period of one (1) year. At the second end of the year, the local church and candidate agreeing together can ask for an extension of the license or to be ordained into the ministry. Once the candidate is found qualified, he may have his license extended or be ordained into the ministry. If the candidate at anytime during this process is found to be inadequate in doctrine or conduct, the candidate will be brought before the Presbytery for recommendation. The Conference shall vote on the Presbytery's recommendation.

Section 6. ORDINATION PROCESS. The local church shall notify the Clerk of the Conference that they have a candidate that needs examination by the Presbytery for ordination. The Clerk shall notify the Chairman of the Presbytery of the local church's request. All appropriate questions (not to be less than twenty-five (25) and prepared by the Presbytery) shall be forwarded to the Chair of the Presbytery, who shall appoint a time for the Presbytery to meet with the candidate. The candidate is interviewed for his spiritual maturity, assurance of call and commitment to practice and preach Free Will Baptist doctrine according to the Treatise of the Faith and Practices of Free Will Baptists. Section 7. ORDINATION QUALIFICATIONS. The candidate for ordination must a Pastor, Assistant and the section of Pastor, Youth Director, Evangelist, Missionary or a Bible College student. He must meet the Biblical description in 1 Timothy 3:1 - 7.

Section 8: TRANSFERRING MINISTERS.

A. OTHER DENOMINATIONS. Any minister transferring from another denomination must first be a second second second member of a local church in the Blue Grass Conference for a period of six (6) months. B. NATIONAL ASSOCIATION OF FREE WILL BAPTISTS. The local church shall notify the Clerk of the Conference that they have a candidate that needs examined by the Presbytery. Section 9. GUIDELINES FOR ORDAINED MINISTERS.

A. CARD OF GOOD STANDING. All ministers of the Blue Grass Conference are required to report in person or by contacting the Clerk or Moderator at least fifty percent of all Conference meetings a year. Failing to answer by reporting in person or contacting the Clerk or Moderator will result in their names not being sent to the State Association for a card of good standing. At the end of the Annual Conference, the Chair of the Presbytery shall give a list of names to the Clerk to be submitted to the State Meeting. The Presbytery could handle this on a case by case basis, and each individual would be dealt with by an interview. Any action taken will be in accordance with the Treatise of Faith and Practices of Free Will Baptists and any discipline be carried out according to chapter 2, section 2 of the Treatise. A retired or disabled minister will receive his card of good standing yearly or as provided by the Kentucky State Association of Free Will Baptists as long as he maintains the Christian minister's standards set by the Blue Grass Conference and the Word of God.

Ministers in college will receive their cards of good standing while furthering their education, but they are still required to report in person or by contacting the Clerk or Moderator at least fifty percent of all states Conference meetings a year.

All ordained ministers in the Blue Grass Conference must belong to a local church in the Blue Grass Conference to maintain a card of good standing.

B. FINANCIAL OBLIGATIONS. All ministers must meet their personal financial obligations or come before the Presbytery for a report.

C. DISCIPLINE. Any minister requiring discipline from the Blue Grass Conference shall report to the Presbytery who shall follow the procedure in chapter 2, section 2 of the Treatise of the Faith and Practices of Free Will Baptists.

D. DOCTRINE. All ministers must teach and preach according to the doctrines set forth in the Treatise.

Section 10. CHURCH RELATIONSHIPS.

A. CHURCH AFFILIATION. The local church shall write a letter to the Clerk of the Conference stating its purpose to unite with the Conference. The Clerk shall notify the Moderator of the Conference and he is a state of the conference and h shall call the Assistance Committee. Once the Presbytery has completed its work, the Presbytery Chair shall notify the Moderator. > B. CHURCH PASTORS. All Churches belonging to the Blue Grass Conference must be pastored by a Free Will Baptist minister who is in good standing with a Free Will Baptist Conference in the National Association of Free Will Baptists.

#### C. BIBLICAL STANDARDS.

1. *Baptism* - We believe that after you have been saved and made a profession of faith you must be baptized by emersion. This must be done by an ordained minister of God, in the name of the Father, the Son, and the Holy Ghost, that is, providing you have the opportunity before death. This must be done to become a member of a local church body.

2. Feetwashing and the Lord's Supper. - Members of a local church must observe the practice of feetwashing and the Lord's Supper at least once yearly.

3. Tongues - The practice of speaking in tongues shall not be condoned by the local church.

4. Second and third works - The practice of sanctification and receiving of the Holy Ghost as a second and third work of grace shall not be permitted. We believe this takes place at conversion and is one work of the Spirit without which we are not saved.

5. Women Preachers - This Conference will not permit a woman to preach or be ordained in any capacity. 1 Timothy 2:11, 12, &15; Titus 2:3, 5 and 1 Corinthians 14:34, 35.

6. Homosexuals - No church or minister shall allow those who would practice homosexual lifestyle to preach or teach in their local church. No known practicing homosexual shall be admitted to the membership of a local church.

#### YOUTH BOARD

The Youth Board shall have five (5) persons from five (5) different churches elected by the Blue Grass Conference for five (5) year terms, with their terms of office to expire alternately. This board shall be responsible to the Conference for all youth activities. The individual elected should be a youth worker who faithfully attends the Blue Grass Conference.

This board shall work with a group of five (5) representatives from five (5) different churches who shall be decided at the second state of the se

The Youth Board and Teen Representatives shall plan a minimum of two (2) activities or services a year. This is a minimum, hopefully more activities will be planned. The board shall include the teen representatives in all planning of activities. Also, keep in mind to use talents and participation both from within and without the churches of the Blue Grass Conference for such things as drama, music, skits, etc.

The board shall elect a chairman. This board shall give a report at each Blue Grass Conference. It shall be in charge of raising funds for activities and requesting amounts from the Conference. It shall also be the board's responsibility to notify all churches in a timely manner about activities.

#### **RECOMMENDATIONS**

For further information pertaining to the officers of the local church and their duties, the church should consult the Treaties of the National Association of Free Will Baptists, Chapter 1, under the Church.

This Conference shall also adhere to the Constitution and By-Laws of the Kentucky State Association of Free Will Baptists and the Treatise of the Faith and Practices of Free Will Baptists.

#### <u>AMENDMENTS</u>

These By-Laws may be amended or altered at any regular session of the Blue Grass Conference by a twothirds vote of the members present, provided proposed amendment or alteration be presented to the body in writing in advance. All amendments or alterations must be tabled for a period of three (3) months.
