THE BLUE RIDGE YOUTH CAMP DRESS CODE
INFORMATION SHEET

The influence of today's society and its "uni-sex" philosophy upon Christian people has prompted the Blue Ridge Youth Camp to issue a more specific code of dress for those participating in our camping programs. It concerns us to see the erosion of the distinction between the Christian and the world, and between male and female.

1. Girls and ladies must wear dresses or skirts (must come at least to the middle of the knee) for any trips away from the camp. (Example: field trips, evangelism, medical clinic, etc.).

2. Girls and ladies are NOT to wear men's slacks or jeans. This would eliminate girls' wearing corduroy or denim jeans with back pockets, painter pants, or overalls. Most men's styles have back pockets. Some girls' styles now do, also. Most of the girl's jeans or slacks that are designed with back pockets are trying to give the "boys' jeans" look. (Example: Taken from a Wrangler jean tag: "Boy-O-Boy . . . First jeans to look like boys' but fit girls . . . If the hips fit, so does the waist.") Often both the boys and the girls sizes are printed on the same tag.

Though there are few men's styles **without** back pockets, and some girls' styles **with** back pockets, the best, most obvious, and easily understood policy is the "no back pockets" for the girls jeans and slacks. By far the majority of cases involving a uni-sex trend in girls' jeans will be eliminated by this simple standard.

3. No campers are to wear imprinted T-shirts that glorify or advertise the world. (Examples: KISS, Chicago, Farrah Fawcett Majors, The Fonz, John Denver, etc.)

4. Those in violation of this code will be asked to change. If acceptable clothes are not immediately available, it will be the responsibility of the sponsoring church to see that they are supplied or acquired.

5. There will be no mixed swimming. Ladies must wear bath towels or robes to and from the swimming area.

6. The following dress code will be observed for all campers, counselors, staff members and workers: Girls: modest apparel, no shorts, or tight clothing. Slacks or pants suits will be permitted during recreation and free time but dresses must be worn during class time, meal time, and all worship times. Dresses must be knee length. All girls' swim suits must be modest and one piece only.
