BUILDING NEARS COMPLETION



The final phase of excavation and grading is being completed as the bulldozer operator smooths the entrance way to the south side of the new Dining Hall and Student Center. Beyond the bulldozer can be seen the addition to the auditorium. Under this section is a basement approximately 30 x 40 feet which will accommodate a large storage room, heating plant, and rest rooms.

Work on the Dining Hall and Student Center is nearly two-thirds complete, according to the contractor's estimate at the end of December.

The walls, roofing, heating, and plumbing are 90% complete. The contractor at present is tying in the new structure to the auditorium, which includes the moving of the stage back approximately 18 feet. This will provide space for 100 additional seats in the auditorium.

Inside the new structure work yet to be done includes electrical wiring, concrete floors for resilient tile, concrete stairways, plastering, quarry tile, glass, and painting. It is estimated that two more months will be needed to ready the building for full occupancy. The completion date, first set for January 1, has been rescheduled because of extra excavation and weather conditions.

Churches and individuals are urged to send donations to pay for this building within the next two months. Some churches have written, stating they are preparing to make donations for the Improvement Program. The amount needed will be in the neighborhood of

\$60,000 since the contractor's bid was \$66,000 to which will be added the architect's fee and extras that have been necessitated by changes. Approximately \$9,000 has been paid from Improvement Program funds on this contruction work.

The construction has been financed by a loan from a local bank until the building is completed. It was hoped by College officials and Board of Trustee members that gifts to the Improvement Program would enable the cost of construction to be paid by the time the building is completed.

Keep the Mail Green

Approximately \$60,000 is needed between now and March 1.

New Enrollment Record Expected Second Semester

Twelve additional students expected to enroll January 22 for the second semester will set a new record in enrollment for one year, according to Dean Charles A. Thigpen.

Last year's registration of 189 students was the previous high; however, this number will be exceeded if second semester expectations are realized.

Total registration for the current year will include the summer school last June as well as the fall and spring semesters, 1957-58.

Other Free Will Baptist churches in the Tulsa area were represented at the meeting by pastors and members. An offering of \$167 was received for the Bible College, and many responded with pledges to be paid over a twelvemonth period.

President Outlines School Needs

President L. C. Johnson has outlined the basic needs of the Bible College following the close of December, the seventh month of the present school fiscal year.

"Primarily, we must urge the financial support of the school's operating fund. We should receive \$7,000 in general fund gifts each month to operate the Bible College properly. This would permit us to develop in several areas in the general program of the school." General fund gifts are averaging about \$5000 each month, he reported.

"Another very urgent need this year is a denominational-wide support of our Improvement Program to increase the school's facilities for the present student body of approximately 200 and to provide a 50% increase in students within the next few years," Dr. Johnson stated.

"The present phase of this program is the Student Center and Dining Room building being erected at present at a cost of \$70,000. Since the Improvement Program was officially approved by the National Association in 1956, a total of \$28,254.68 has been received. Out of this amount a \$15,000 building was purchased along with financing the costs of the campaign for the first year, and approximately \$9,000 has been paid on the new Student Center building.

"This means the Bible College must receive as much as \$60,000 by the completion date of the building if the costs of construction are to be paid." Gifts to the Improvement Program are averaging about \$2000 monthly, and at this rate it will take some time to raise the money for this building.

Dr. Johnson urges every church or individual who has not done his best to support the present Improvement Program to send the best gift he can as soon as possible.

93 Ministerial Students

Out of a student body of 169 those registering as ministerial students this year number 93, according to registrar's records.

Before the year is over some of the freshmen students will probably announce their call to the ministry, if this year follows the usual pattern. To be sure, this group is a vast potential, and to the end of training them for the gospel ministry Free Will Baptist Bible College was organized and is dedicated.

Surely a denomination that has approximately 100 ministers in training each year will be receiving manifold returns as these young men take their places in the pastorate and in evangelistic work.

\$100 Gifts Climb to 100

During the past two months 22 additional gifts of \$100 or more were received, bringing the total number of such gifts to an even 100.

This is one-fifth of the goal set in the fall of 1956 to challenge Free Will Baptists to raise five hundred \$100 gifts for the Improvement Program.



SUMMER SCHOOL PLANS ANNOUNCED

Summer school this year has been set for May 27-June 6, according to an announcement from the Dean's office.

The school will cover two weeks of intensive training, and three semester hours of work may be earned from seven courses offered.

This is the second year that a summer session is to be offered by the Bible College. Fifteen students enrolled for the three-weeks' course last June. The enrollment this summer is expected to more than double that of last year since several regular students plan to attend and more pastors will be able to attend this year because they will miss only one week end from their churches.

The following one-hour courses will be offered according to the demand of the students. Names of instructors are given in parentheses. Romans and Free Will Baptist Doctrine (Forlines); I Corinthians (Thigpen); Doctrine of God (Barrow); Hymn Directing (Dowden); Pastoral Problems (Johnson); and Producing the Church Play (Mrs. Thigpen).

The maximum load is three semester hours. Full college credit will be granted for all credits earned. Those not desiring credit are encouraged to attend.

The expenses for the two-week session will be \$59, including tuition, fees, and room and board. A student's wife may attend and take a full load for a minimum charge of \$10 not including room and board. Books will be

College dormitories will be available for summer students, including a limited number of couples. Meals will be served in the College dining hall. Students with families may obtain furnished apartments in the city.

College officials feel the summer school is a wonderful opportunity for pastors, Sunday school teachers, and other Christian workers to receive some study that will be a real blessing. Churches are urged to send their pastors to the two-week school as a supplement to their vacations.

An informative folder on the summer school will be mailed later to all ministers on the College mailing list. The folder will contain an application blank.

The summer session will actually begin two days before the regular second semester is completed, but after all classroom work is over. Summer students will attend Graduation exercises May 29.

A record attendance is expected at the 15th annual Bible Conference to be held March 23-27 in Memorial Auditorium at Free Will Baptist Bible

President L. C. Johnson said the auditorium has been enlarged to accommodate a larger attendance this year, and it is hoped the new dining hall will be in operation so Conference guests can obtain meals on campus.

A special invitation has been extended to all former students of the Bible College to attend the Conference and to see the new student lounge-dining hall building now under construction.

The program outlined by Dr. Johnson presents an array of outstanding speakers, music, and special services. Speakers include Rev. Frank H. Sells, Rev. Bobby R. Jackson, Rev. Leroy Forlines, Miss Laura Belle Barnard, and Rev. and Mrs. Carlisle Hanna.

Ross Dowden, music department director, has planned special music by the College choir, freshman choir, male quartet, male trio, and girls' trio.

Mr. Sells, Bible teacher at Columbia Bible College, Columbia, S. C., for the past 20 years, is a widely-used speaker at meetings and conferences. He was sponsored by the College student body last year for a week of services. His messages are expected to be a high point in the Conference.

Rev. Bobby Jackson, Greenville, N. C., has had a very fruitful ministry in evangelistic work since his graduation from the Bible College four years ago. This is his first appearance as a Conference speaker.

Mr. Forlines, Bible College faculty member, is dean of men and teaches Bible and theology.

Bringing missionary messages will be Miss Barnard and the Hannas. They will speak each day at a special missionary service. Miss Barnard is a senior Free Will Baptist missionary, having served 23 years in India. The Hannas are recently returned from their first term as missionaries to India. They are graduates of the Bible College.

The first service this year will be at 6:45 Sunday evening, March 23, Dr. Johnson announced. The opening speaker will be Frank Sells. Services will begin each morning at 8:40 and the night services at 6:45. There will be three speakers each morning Monday

There are many interesting stories in the Bible that point out the importance of little things. I think of at least three instances when insignificant things became great when the Lord got hold of them.

One has to do with God's dealings with Moses when he was trying to get him to go into Egypt to deliver His

people. Moses was a meek men and felt that he was too insignificant for r such a great job. God taught him through an object lesson that He could use anything surrendered to Him. The Lord asked Moses to cast the rod he held on the ground. He did and it became a serpent.

The Lord told him to take it by the tail; he obeyed and it became a rod in his hand.

Moses saw that if God could do such unusual things with a common, ordinary rod, that surerly He would be able to use him to accomplish great things.

Another instance is found in I Kings where the widow was asked to surrender all the meal that she had to the Lord to make the Prophet Elijah a cake. It was an insignificant amount of meal, just enough to make her and her son a cake. But the Lord asked her to surrender what she had to Him. She did and the insignificant became great. This widow was desperate and God wanted to meet her need. But in order to do so a miracle had to be performed. Before God performed the miracle He demanded that she surrender all she had to Him.


We all have needs that require miracles to meet. When we surrender our all to Him, He can work the miracle.

Work yet to be completed includes the final stages of the roof, plumbing, and electrical fixtures; tile floors, ceiling, and painting. The walls, concrete roof beams, concrete floors, and most of the glass, plumbing, heating, and electrical wiring are finished. The addition to the auditorium including basement is complete.

The Bible College hopes to have the new construction ready for the Bible Conference so guests can enjoy the extra accommodations and can take their meals in the new dining hall.

Construction costs will be approximately \$70,000 and the cost of new furniture and equipment will be \$15,000. Receipts to the Improvement Program from June to January have amounted to \$16,000, and \$12,000 of this has been paid to the contractor. Almost \$55,000 is needed by April 1 if the building is to be paid for in full at the time of completion.

The new dining hall will more than double the capacity of the present facilities, thus providing for an increased number of students for several years to come. The student lounge will provide an attractive area for day students, visitors, and social activities, filling an urgent need.

TISDALE & TISDA

Along with the new dining hall and student lounge has been the addition of approximately 30 feet to the auditorium. This extension contains a basement under the main floor, housing a large storage room, wash rooms, and heating plant. The main floor extension to the auditorium furnishes five rooms to be used by the music department and provides space for enlarging the original auditorium to accommodate approximately 100 more seats.

When the College occupies the new units, released space will permit other crowded departments to stretch out, such as the library and offices.


Choir to Visit Churches In Va. and N. C.


The enrollment this year should go well over the 200 mark by including summer school students and new students to register the second semester. Last year's total registration was 197, also a new record.

I Corinthians 10:31 "Whether therefore ye eat, or drink, or whatsoever ve do, do all to the glory of God."

This verse of scripture tells us that whatever a Christian does should glorify God. The same thing applies to a Christian institution. Every decision that Free Will Baptist Bible Col-

Attend the Victory Celebration Dec. 17-18

President L. C. Johnson has invited the churches in the denomination to have a representative at the Bible College December 17 and 18 to present a gift from their church to help retire an indebtedness of \$60,000 on the new student lounge-dining hall building.

Churches may send a cash offering or a pledge from the church to be paid during the next year so that the total of all cash and pledges will bring a Victory Celebration in paying the \$60,000 note.

Many churches have already sent in their "Debt Retirement" gift early although some of them will send a representative in December for the celebration.

Those attending the Victory Celebration will be guests of the Bible college for supper December 17 and breakfast December 18, and the school will sleep as many as possible the night of December 17, meals and sleeping accommodations free of charge. A barbecue supper is planned. Each pastor is invited to be present and bring a carload from his church.

a carload from his church.

On the morning of December 18 all gifts since July, 1956, on the Improvement Program will be posted in the Auditorium so that all the people can join together in one large effort to celebrate the victory of raising \$60,000.

Jimmy Hughes, senior from New Bern, North Carolina, is student body president this year. He will be assisted by Charles Hampton, Modesto, California, who is a member of the junior class. Serving as secretary is Sarah

Brown, Dorsey, Mississippi, senior.

The student body officers are in charge of many activities concerning the students. In addition to having charge of a weekly student chapel program, the officers guide the Student Council in carrying out its purpose to cultivate high standards in every phase of campus life—spiritual, social, scholastic, cultural, and recreational.

From July 1, 1956 to October 31, 1958 \$41,852.28 has been given to the Improvement Program. Expenditures in carrying out this program so far have been a \$15,000 building purchased for additional dormitory space, \$70,000 spent for the construction of the new student lounge-dining hall building, approximately \$10,000 spent on new furniture and equipment, and \$9,000 campaign expenses and interest on borrowed money.

This leaves approximately \$60,000 needed to be raised to completely pay for the first step of the Improvement Program. Free Will Baptists can raise this December 17 and 18 by every church cooperating.

Many pastors have written their intentions to bring a gift from their church on Victory Celebration Day.

Bible College Granted Accreditation

Free Will Baptist Bible College was accepted into the membership of the Accrediting Association of Bible Colleges at the annual meeting of the association in Chicago October 30-31, according to an announcement by President L. C. Johnson.

The action by the association followed a self-evaluative study by the College begun in the spring of 1957 and an inspection by the association in May of 1958.

The Accrediting Association of Bible Colleges is made up of more than thirty Bible institutes and Bible colleges which have as a requirement in their curriculum a major in Bible and theology. The association bears its authority from the U. S. Office of Education in Washington.

Dr. Johnson stated that the College has been thinking in terms of applying for accreditation since 1949 when the Board of Trustees approved such a recommendation by the president. One of the largest problems in seeking accreditation, the College official explained, has been a larger portion of non-high school students in the student body than the accrediting association permits. This problem was solved last year by forming a two-year institute program for these students separate from the Bible College operation, thus continuing the training of many worthy students in this classification and at the same time being able to meet standards for the entrance requirements of students in the regular College course.

Accreditation means that the Bible College will maintain the standards set by the association in the school's operation both as to its teaching program and business operation. On the student level, accreditation means that students from the Bible College will be accepted by member schools in the association upon transferring. Schools outside the association will consider a transfer student from the Bible College on the basis of its own policies.

Victory Celebration Gifts Reach \$18,000

Gifts on the Improvement Program since August 1, 1958, have counted on the Victory Celebration Drive in an effort to clear the Bible College of the indebtedness on the dining hall-student lounge building. Up through December the Victory Drive resulted in \$18,597.09.

On Victory Day, December 18, students, faculty, and visitors watched the tabulation of more than \$17,000 received since August 1 and at the Victory service. Dr. L. C. Johnson directed the service in listing the state gifts and also read a report of all gifts of \$50 or more given to the Improvement Program since its beginning in July, 1956.

Pledges amounting to \$9,000 were added to the gifts already received, making a total of \$26,000 for the Victory service. College officials believe that within one year when the pledges are due that \$30,000 will have been received on the Victory Drive, bringing to the half-way mark the objective of \$60,000 needed to clear the indebtedness.

Bible Conference Scheduled March 15-19

The 16th annual Bible Conference will be held on the campus of Free Will Baptist Bible College March 15-19, as announced by Dr. L. C. Johnson, president

Guest speakers will be Rev. Harold A. Pitts, Winfield, Alabama; and Rev. Billy A. Melvin, Norfolk, Virgin'a.

The five-day inspirational meeting occurs earlier in March this year to avoid the pre-Easter week of prayer observed by many Free Will Baptist churches. Pastors and lay leaders can attend the conference and return to their churches in plenty of time for special services before and after Easter.

The conference program will again emphasize Bible preaching, evangelism, music, and drama.

All pastors and friends of the College are urged to lay plans to attend the conference, one of the greatest spiritual highlights each year for many Free Will Baptist ministers and laymen. Former students and parents of present students are especially urged to attend the service.

Those who desire accommodations at the College or in the city should write early. Meals will be available in the College dining hall.

Summer School To Begin May 25

The 3rd summer school session is scheduled to begin May 25 and will close June 5 to complete a two-week program, as announced from the dean's office

The short training program is devised to provide refresher courses and additional studies for pastors, students, and laymen. College credit will be given for the three semester hours of work that may be earned from the various courses offered.

For the past two years there has been a growing interest among pastors for this program. The first year 15 students enrolled, and the second year this number was increased to 20.

Teaching will be done by the College faculty and students will be housed in the dormitories with meals available in the dining hall.

The two-week program is set up so a pastor will be away from his church only one weekend.

From My Desk ...

L. C. JOHNSON, L.H.D.

"... follow after ... reaching forth ... press toward. ... "Philippians 3:12, 13, 14.

These three statements found in Paul's letter to the church at Philippi suggest much of the character of the apostle Paul. These terms suggest that the experience which Paul had in the

Lord served as a platform from which he was operating to gain other things that he knew could be gained in Christ.

Sometimes our previous experience in Christ and the assurance of salvation serves as a platform upon which we rest while we sing "Blessed Assur-

ance." But the thing Paul had learned from his experiential knowledge in Christ, stimulated him, and we might say, excited him to bend all of his energy to finding out more about his Lord. I do not believe the "follow after" and "reaching forth" and "press toward" statements have to do so much with things Paul wanted to do FOR Christ as it had to do with things he wanted to learn ABOUT Him . Sometimes in reading the life of the apostle we are greatly impressed with the number of things he did and overlook the important fact that all this came about because of the wonderful knowledge he had about the person he was serving.

Perhaps your problem and mine and the problem of many Christians would be more nearly solved if we would get better acquainted with the WHO and think less about the WHAT and HOW. I would like to appeal to you, as I appeal to myself, that we major on "following after" HIM, and "reaching forth" unto HIM, and "pressing toward" HIM in 1959. The more we know Him, the stronger our purpose. The more we know Him, the clearer our vision. Vision and purpose will serve as a magnet to draw us into meaningful service for Him.

Day of Prayer Held In December

December 4 was observed as Prayer Day, and the daily schedule of classes was called off and other activities restrained so all students and faculty members could devote as much time as possible to prayer, praise, and Bible study.

The value of prayer in the student's life was emphasized by President Johnson, who pointed out that the aim of the Bible College is to help the student know God better. "Students come here to attend a school where Christ is put in the center of things," he said.

Quartet Holds Services In Near-By Churches

Continuing to hold services on weekends, the Bible College quartet visited 29 churches in November, December, and January.

The quartet—consisting of Robert Picirilli, Bob Wilson, Harold Teague, and R. J. Kennedy, Jr.—held eight services in Mississippi and four in Tennessee during November. A weekend trip was made to Kansas City, Missouri, for the Central Western Quarterly Meeting December 13, and four services were held in four churches in the Kansas City area December 14.

Services in January included two in Tennessee (Post Oak Shade, Cookeville, and Fellowship, Kingsport), two in Kentucky (Payne Gap, Jenkins, and Seco Church, Seco), and another in Virginia (Valley View, Clintwood).

The singers conducted services in seven Georgia churches at the beginning of the second semester, January 21-25, at Pine Level, New Ebenezer, Christian Hill, Mt. Ararat, Pleasant Hill, Double Branch, and Turner's Chapel. Rev. Charles Clark of Warner Robins arranged the services.

The quartet plans services at Mt. Pleasant, Cookeville, Tennessee, February 6; at three churches near Clintwood, Virginia, February 7-8; and another at Johnston City, Tennessee, February 8. Services are planned in the Cumberland Association churches in February and March.
