PRAYER Bible Conference **EVANGELIST** SPEAKS AT DAY OF

December 14 was one of the most moving days this year as the College faculty, staff, and students were united in a day of prayer highlighted by a chapel service featuring Dr. Hyman Appleman, internationally known evangelist, as speaker. Accompanying Dr. Appleman were Rev. Charles Short, superintendent of the Nashville Union Mission, and 80year-old Sylvester Sanford, evangelistic singer.

Dr. Appleman spoke on the necessity of the power of the Holy Spirit in the Christian, confirming the emphasis of the day of prayer.

The day's activities began at 8 a.m. with scriptural passages read in a chapel meeting followed by group prayer meetings at 9, which lasted until the regular chapel at 10. After the chapel service with Mr. Appleman, everyone gathered in the auditorium for further instructions in prayer, and the morning was concluded with a women's prayer meeting in Ennis Hall while the men met in the auditorium. The afternoon was given to individual prayer, Bible reading, or work according to the student's need.

Particular objectives determined by the time of prayer were requests for the denomination's pastors to be empowered to preach the gospel during these days of pressures and complexities, and for the need of financial support for the Bible College during the present fiscal year of \$75,000 for the general fund and \$66,000 for the building fund to clear indebtedness.

To Be April 2-6

The date for the 18th annual Bible Conference will be April 2-6, as announced by President L. C. Johnson.

Special guest speakers this year will be Rev. Wade Jernigan, Norman, Oklahoma, pastor and church leader; and Rev. Jim Mercer, evangelist from Pontiac, Michigan. In addition to these speakers, several messages will be brought by College staff members.

The five-day meeting of Bible preaching, Bible study, evangelism, and missions will be held as usual in Memorial auditorium starting Sunday evening, April 2, and concluding with the morning service ending at 12 noon on Thursday, April 6.

In addition to the program of speakers will be special music and drama presented by the music and speech departments.

Ministers and church workers who plan to attend the conference are requested to make plans now. The school cannot offer dormitory accommodations to guests this year since the student body is larger, but will be glad to handle requests by securing the most practical accommodations available.

The Bible Conference is enjoyed each year by a good number of Free Will Baptist pastors, Christian workers, prospective students, parents of students, as well as the College family.

The books are closed on 1960. Free Will Baptist Bible College can look back upon the year as bringing many ac-



complishments and blessings. One of the outstanding things of 1960 was a record student body which registered in September. Along with the record enrollment is also the blessing of having the fewest drop outs perhaps in the history of the institution. Al-

most every student who registered will complete at least the first semester. We trust few will have to drop out then. Some of the students face real financial difficulties.

Another accomplishment and blessing was the purchase of property on West End Avenue. This property is proving to be a greater asset than had even been anticipated. The administrative offices and some classrooms are located in this newest addition.

The addition of some wonderful people to our faculty has been an outstanding blessing. Miss Laura Belle Barnard, who spent twenty years in India and who took her master's degree in missions at Columbia Bible College last year, is heading a new missions department. Miss Barnard is also teaching some in the field of Bible. Mr. Don Clark is a wonderful asset to our music department. Miss Phyllis Rivers from the state of Kentucky is heading a new business education department.

The year also saw a rapid growth in our library. All these things make us realize that the Lord is ever gracious and good to those who would honor Him.

The one point that I would call to your attention as an item of prayer is in the area of finances. With seven months of the fiscal year gone we are \$10,000 from having met the budget up to this point. The budget to the general fund calls for \$6,250 monthly. The average receipts for the first seven months of the fiscal year ran slightly over \$4,800 per month. Instead of launching a pressure campaign to try to raise this money, we are asking the friends of the Bible College to make this a real item of prayer. I feel certain that when enough of us seriously pray about this matter, the Lord will hear and will lav it upon the hearts of His people to meet this need. In fact, on the Day of Prayer before Christmas, we were challenged to ask the Lord for the entire budget plus enough to retire the \$66,000 building indebtedness. For this need to be met it

Robert E. Picirilli

Chosen as the alumni member of the month for January is Robert E. Picirilli, promoter for the Alumni Building Project. Mr. Picirilli was elected at the annual Alumni meeting last spring to be the coordinator and promoter of the Alumni Drive to raise \$37,500 for the purchase price of the 3606 West End Avenue property.

Among his duties as promoter, Mr. Picirilli has written informative pamphlets about the Alumni work, helps in the mailing of the Alumni Newsletter, and has written several letters to the Alumni mailing list in behalf of the drive —results now totaling about \$9,000.

This alumni member is professor of New Testament Greek at the Bible College and teaches in the field of Bible as well, having been with the school since the fall of 1955.

He gives his birthplace as High Point, N. C., and was a member of the Mt. Elon Free Will Baptist Church, Pamplico, S. C., when he enrolled at the Bible College in 1949. He received his B.A. degree in 1953 and earned his M.A. degree with a major in theology at Bob Jones University in 1955, and taught there as a graduate assistant in the Greek department during the 1954-55 academic year.

Mr. Picirilli has continued his education since coming to the Bible College and except for his thesis has finished practically all his requirements for his Ph.D. degree in New Testament text.

Mr. Picirilli is married to the former Clara Mae Lee of Coward, S. C., and they have four daughters: Jean 6 years, Jane and June 5, and Joy 2 weeks old. They make their home at 3710 Richland Avenue.

Twenty Five States Give During November And December

Support was received from 25 states during November and December with gifts to the general fund in December climbing to a new high for Decembers at \$5,109.03. The average monthly gifts for June through December are \$4,809.83, which is \$1,440.17 per month less than proposed gift income of \$6,250.00 each month.

The College quartet holds services during the summer and on week ends during the school year to promote more support; however, the quartet can get to only a limited number of churches each year. The best method of raising the gift income to the school is for churches to include in their budget a monthly gift for the Bible College. The need is for more and more churches to start a systematic giving program and for churches that are already giving to increase their support according to their ability.

When enough churches give, it will be no longer necessary to go to the expense of sending out a quartet to solicit funds. If the \$4,800 per month average is the level at which Free Will Baptist churches can support the school, heavy appeals will have to be made for more individuals to support over the program of the church if the \$6,250 per month level is met. The only alternative to this will be that the school must curtail its present services to the students, or the students themselves (and eventually our people, their parents) will have to carry a heavier part of the school expense in increased fees.

Special guest speakers are Rev. Wade Jernigan, pastor of First Free Will Baptist Church, Norman, Oklahoma; and Dr. Jim Mercer, interdenominational evangelist of Pontiac, Michigan. In addition to these speakers, President L. C. Johnson and Dean Charles A. Thigpen will be bringing messages.

Many of our Free Will Baptist people are acquainted with the Rev. Mr. Jernigan. He is a native of North Carolina,



was reared in a Free Will Baptist home, and is an alumnus of the Bible College. He has been a Free Will Baptist pastor and evangelist for the past 15 years, serving churches in Oklahoma and California. He has held more than 207 revivals and has organized 10 Free Will Baptist churches. He is at present serving as moderator of the Oklahoma State Association and is a member of the National Home Mission Board.

Speaking on evangelism and soul-winning will be Dr. Jim Mercer, a full-time evangelist for the past 30 years. Dr. Mercer's present ministry is given over largely to city-wide revival crusades. He received his education at Bob Jones University from where he was granted the D.D. degree.



Six Courses To Be Offered At Summer School

Dean Charles A. Thigpen has ananounced that persons enrolling for the summer school May 23-June 2 may select from six courses to be offered.

Three courses are in the nature of Bible study and three are related to meeting the practical needs of the local church. Bible courses are Epistles of Peter, I and II Timothy, and the Doctrine of Salvation. Practical courses are Pulpit Speech, Parliamentary Law, and Advancing the Smaller Local Church.

The school includes ten days of classroom work with costs of room, meals, and fees at \$59.

I have just been reading Isaiah's vision of Judah and Jerusalem as described in the first chapter of Isaiah. In verse 4 of this chap-



ter, he begins the description of the conditions he saw in this vision. He saw a sinful nation that had forsaken the Lord. He describes the head as being sick and the heart faint. "The whole head sick" suggests that they were

mixed up in their concept of right and wrong. "The whole heart faint" suggests that they lacked courage to do right when they knew it.

As I read the newspapers and listen to the newscasts about the conditions in our own country, I see a direct parallel between Israel of Isaiah's day and our own nation. Some of the highest corporations in our country have just been exposed and sentenced in court for unethical business practices. It has come to be almost accepted for politicians to use deceit and falsehood to gain their ends. The church of Jesus Christ is filled with modernism, and many who are not modernistic have lost their courage and conviction to speak up and take stands. Competition for members among the denominations has brought compromise and lowering of standards on the part of many preachers of the gospel. There is only one conclusion that a person can reach and that is that we have a desperately sick and wicked society.

In the light of the above-mentioned conditions, it makes one realize all the more the desperate need we have in our own denomination for an institution that will re-establish Biblical standards and principles in the hearts and lives of young men and women who are going to be our church workers in days to come. Free Will Baptist Bible College has dedicated itself to maintaining the highest Christian standards in this day of moral decay and letdown.

The administration and Board of Trustees believe that most Free Will Baptists want an institution that will take such a stand. This is the reason that we ask you to pray for Free Will Baptist Bible College and support it. Probably the first male student to enter Free Will Baptist Bible College without feeling a call to full-time Christian work was Howard Lyle, Cincinnati. Ohio-whom we salute as Alumni Association member for the month of February.

Good English Emphasis

An emphasis on good English has been observed during the month of February. Examples of common grammar mistakes were given by Miss Mary Wisehart, English instructor.

The month's emphasis included the preparation of posters listing errors in grammar made by the students during the month.

Mrs. Polston Speaks at Chapel

\$37,000 NEEDED IN FOUR MONTHS

With eight months of the current fiscal year already gone, a total of \$36,986 is needed to complete the quota for general fund gifts for the year. A total of \$38,014 has been given (see State Quotas Report on page 4) against the \$75,000 goal for the year. January gifts amounted to \$4,345.13; average monthly gifts this year are \$4,751.75. More than \$9,000 is need each month February through May if the proposed general fund gifts are realized.

The Alumni Association of Free Will Baptist Bible College, which includes more than 600 former students of the school, held its annual banquet and business meeting April 5 with Rev. Ronald Creech, president, in charge.

Following an interesting address by Dr. H. C. Gabhart, president of Belmont College, Nashville, and special music by Donald Clark, professor of music at the Bible College, the election of officers was held with the Rev. Ronald Creech, Durham, N. C., being re-elected as president, Rev. Joe Haas, Nashville, reelected as vice president, and Miss Mary Wischart elected as secretary-treasurer.

The association pledged to continue the Alumni campaign of raising \$37,500 to pay for the school's new administration building at 3606 West End Avenue. A total of \$13,000 was reported raised during the first year of the project.

Miss Wisehart replaces Mrs. Geraldine Hall, English instructor at the Bible College, who served as the association's secretary-treasurer during 1960-61. The new secretary is also a member of the Bible College faculty, teaching courses in English and Spanish.

Since that time she has continued her education at Peabody College, Nashville, and in 1960 earned her master's degree. She has served on the College faculty for the past five years and as secretary of the Alumni Association for four years.


Three seniors and one sophomore were elected as student body officers for the 1961-62 year as a result of a recent election by the Bible College students.



PRESIDENT'S ANNUAL REPORT

L. C. JOHNSON, L.H.D.

The largest enrollment, a high quality of students, the almost perfect harmony among faculty and staff, the small per cent of student drop-outs, the high morale of our students and faculty—make this one of the greatest years in the history of Free Will Baptist Bible College. It is hoped that all of us and Free Will Baptists everywhere will give due thanks to God for these blessings.



JOHNSON

For 19 years Free Will Baptist College has been working to establish a more effective ministry for the Free Will Baptist denomination. It is not always easy from statistics to determine the effectiveness of an institution. Any claim that this institution might make concerning its contribution to the progress of our denomination could be challenged by any critic by saying many of these accomplishments would have happened anyway. Others who wish to be critical might say that even though we have accom-plished much, how do we know but that we could have done much more. So any way you look at a report, the conclusions you reach are determined in large measure by the attitude of those who study it. I think Free Will Baptist Bible College is entitled to the benefit of a comparison between the years immediately preceding its establishment and the years that have followed.

Missionary Program

The missionary vision of our denomination was almost nil dur-

ing those years prior to the establishment of this institution. It would be safe to say that the only missionary vision existing in the pre-Bible College era was a few men who had attended institutions where a missionary vision was given. Since Free Will Baptist Bible College became a reality, it is now an exception to find a pastor who does not have at least an average missionary concern. Free Will Baptist Bible College has had the privilege of training almost all our missionary personnel, both home and foreign. I believe the type educational program this institution has followed has gotten more immediate results in this area of Christian endeavor than any other type program we could have inaugurated. It is a statistical fact that more than fifty per cent of the missionary personnel of the world has been trained in similar institutions to our own.

Evangelistic Ministry

Prior to 1942 the Free Will Baptist denomination did not have a single full-time evangelist. There were some men who felt called to this ministry who attempted it for a short period of time but soon found that the evangelistic interest in our denomination could not sustain their ministry. Today we have at least two full-time evange-lists who stay booked months in advance and whose services are hard to secure because of demands from Free Will Baptist churches. These two young men received their training in Free Will Baptist Bible College. The evangelistic interest within our denomination could possibly support more full-time evangelists. This institution has made its contribution in this direction.

Full-Time Pastors

Before 1942 it was the exception to find a Free Will Baptist church supporting a full-time pastor. Almost all the rural churches operated on quarter-time basis-a few had half time. Perhaps there has been no denomination in America that has gone more rapidly from a quarter-time pastoral ministry to a full-time ministry. Today it is the exception for a church to be quarter time. The rule is full-time pastors. I feel Free Will Baptist Bible College has not only enabled the denomination to have the personnel to make this improvement but has created the spirit of desire that has prompted this growth.

Establishment of City Churches

The Free Will Baptist denomination has been known for its rural ministry. It has been in the last few years that we have begun our ministry in the metropolitan areas. Most of the churches that are now being organized are in the urban areas. It is an accepted fact that in years past our denomination avoided the cities because of an unprepared ministry. We no longer suffer from this overwhelming inferiority complex. We now feel that we have a ministry in the cities and that we are able to meet the demands of the metropolitan areas. The ministry of Free Will Baptist Bible College has helped erase this inferiority complex and instead has instilled in our young ministers a concern for lost men everywhere and a willingness to accept the challenge of a more sophisticated society.

Quality of Preaching

It is difficult to make comparisons in this area lest we appear boastful; but with proper humility and appreciation of those who have gone before us, I believe we can say that as a result of Free Will Baptist Bible College and its ministry the preaching quality is the best in the history of our denomination. I am humbly grateful as I sit and listen to messages delivered by young men whom we have had the privilege of training in this institution. The content of their messages is Biblical, and the manner of delivery is with earnestness. Their scope of interest in the gospel ministry is wellrounded.

Let me list in summary the things that I believe have characterized Free Will Baptist College: (1) Evangelistic spirit; (2) High standards of Christian conduct; (3) Orthodoxy with life; (4) Academic soundness; (5) Business integrity.

Free Will Baptist Bible College enjoys a high rating with our people. This is evidenced by a continued growth in our student body—a growth that is making its demands upon the Board of Trustees and our entire denomination as never before. The question is not, can we make this institution acceptable to the youth of our denomination, but can the denomination meet the needs created by the acceptance of the institution on the part of our youth.

ANNIVERSARY YEAR 1961-62 MISHLER ELECTED TO **BOARD OF TRUSTEES** 20 Years of Service to Free Will Baptists

In recognition of 20 years of service to the National Association of Free Will Baptists, Free Will Baptist Bible College is asking Free Will Baptists in every state to join in celebrating our 20th anniversary.

One feature of the anniversary celebration is to invite thousands of individuals to give an anniversary gift. This is the plan: 5,000 Free Will Baptists giving \$1 representing each of the 20 years the College has served our denomination. This would be 5,000 people giving a special anniversary gift of \$20, which would amount to \$100,000. Any church having five individuals participating will be counted a member of the anniversary year club and be properly recognized at a special 10 o'clock service on Thursday morning, April 5, at Memorial Auditorium. This will be the last day of our annual Bible Conference.

We are asking our pastors across the denomination to cooperate in getting the necessary number of individuals within their churches to make them club members. RICHLAND HALL TO BE USED EXCLUSIVELY AS A DORMITORY

With the removel of the library from the first floor, Richland Hall will be used altogether this year as a women's dormitory, housing women students on all three floors. The building is expected to take care of approximately 90 students along with the dean of women and five women staff members.

The Richland Building was purchased in 1952 for \$65,000 and was paid for within two years by Free Will Baptists over the denomination. In addition to housing the women students and the dean of women since it was first occupied, the building furnished space on the first floor for the administrative offices until a year ago and also provided space for the library. Now the demand for additional space for women students necessitates the relocation of the library until a suitable building can be erected.

The bookstore and snackshop will still be located in the basement area of the building.

when finances permit. The school owns a 100 x 200 foot lot for this purpose. Construction will not begin until the \$59,000 loan has been paid which covers the balance due on the construction of the Lounge-Dining Hall and the purchase of the Alumni Building.

\$75,000 SOUGHT IN CHURCH GIFTS

Gifts of \$75,000 for the general fund are sought from churches and individuals in the denomination for the 1961-62 fiscal year, as approved by the National Association in July. This is the same amount in gifts as last year's Suggested State Quotas and means that the Bible College should receive each month gifts amounting to \$6,250, which would be an increase of \$1,250 each month over actual gifts in 1960-61.

College officials feel that every Free Will Baptist Church should consider the growing needs for educating the youth of our church and put the College in its giving program. Whereas some Free Will Baptist churches already have a systematic method of supporting the school, others may need to determine a specified amount for the Bible College in the church budget. If the church does not operate on a budget system, a monthly offering can be designated for this purpose, or individuals in the church may wish to give directly to the school to share in its support.

The denomination's gifts of \$75,000 enable the students to attend school at \$300 less per year than would be the case if the students paid the full costs.



President Presents Challenge Of 20th Anniversary Year

President L. C. Johnson challenged the Bible College officers, faculty, staff, and students in chapel services September 15 to join the Anniversary Year Program in which five thousand Free Will Baptists are asked to make a gift of \$1 for each of the 20 years of service rendered by the Bible College in the training of Christian youth.

"We have had a 40 percent increase in students in the past two years," the president stated. "The facilities of the school are at the saturation point, and our people must be aroused to provide this year for the needs of the growing student body."

The Anniversary Year Celebration, instituted by the Board of Trustees recently, calls for 5,000 people to express their appreciation for Free Will Baptist Bible College by this special gift. Churches or families having as many as five Anniversary Year donors will be awarded a special citation on April 5 at the 10 a.m. service of the annual Bible Conference at the school's Memorial Auditorium.

Gifts have already started coming in since the campaign was announced in the August BULLETIN.

Five thousand donations of \$20 each would provide \$100,000 to undergird the financial operation of the Bible College.

Fall Enrollment Sets New Record

The 20th year of the Bible College has jumped to a record-breaking start with an enrollment of 242, according to Dean Charles A. Thigpen. This figure does not include late enrollees or evening school students, he reported.

A breakdown of the students by classes shows 21 seniors, 34 juniors, 52 sophomores, 112 freshmen, and 23 special students.

The students come from 24 states and one foreign country. North Carolina leads with 65 students, a record number from that state; Tennessee follows with 25; Missouri, 20; Arkansas, 19; etc. A complete list of the students by states with class rank and hometowns follows.

She graduated from Itawamba Agricultural High School in 1955 and entered the Bible College in the fall of that year.



Anniversary Campaign Meets With Early Response

A wide-spread interest in the 20th Anniversary Campaign has been expressed by our people, President L. C. Johnson reported recently. "Early responses indicate that our people are accepting the challenge to give a *special* gift of \$1 for each of the 20 years of service the Bible College has rendered to the denomination and to Christ," he said.

The celebration of the school's 20th anniversary during 1961-62 calls for 5,-000 Free Will Baptists to make special gifts of \$20 each to provide \$100,000, which would pay off all indebtedness and open the way for needed expansion.

Some pastors and individuals have already registered their plans to honor the school in its 20th year with \$20 *special* gifts. Churches having as many as five or more such donors will be designated "Anniversary Club Churches" at the 10 o'clock morning service on April 5 of the annual Bible Conference.

The school official stressed that the Anniversary gifts be *special*, that is, gifts in addition to those already designated for the Bible College. Churches already planing to be "Anniversary Club" members are encouraged to enroll as many Anniversary Campaign donors as possible for extra special recognition. Some churches have as many as 20 members or more who can give \$20 each.

More than 120 units have been registered among the Bible College faculty and students, Dr. Johnson announced. This represents approximately \$2,500 already from this source, he said.

CONFERENCE ATTRACTS GOOD ATTENDANCE




Dr. George Delamarter, Rev. Homer Willis, and Rev. Roy Thomas appeared on program at the Missionary Conference October 3.



From My Desk ...

John 4:35 "Say not ye, There are yet four months, and then cometh harvest? behold, I say unto you, Lift up your eyes and look on the fields; for they are white already to harvest."

A few months ago when our new administration took over in Washington much was said in our papers and magazines about the need for a "crash program" launched by our State Department. This program was to be designed to win the friendship of neutral nations and some of those that had been lost to the side of the United States. In substance this was saving that the ordinary was not sufficient and that there was the need for the extraordinary.

If this is true of our government, and no doubt it is, it is much more true for the church of Jesus Christ. If there has ever been a time when the extraordinary was needed, it is today. This seems to be what Jesus was saying here in John 4:35. The ordinary channels of religion had bypassed the Samaritans. Custom, tradition, and prejudice had tied the hands of the religious system of the day, and it was impotent in the situation which Jesus faced. Jesus challenged His disciples to break out of the mold of the ordinary and let the need of the hour dictate their action. This He did and saved a village.

Sychar, the village where the Samaritan woman lived, can easily represent our world. The Christians have the Water of Life, and if we can be seized with the same spirit of urgency Jesus had men can be saved. The preoccupation of the disciples with their material interest is in sharp contrast to the urgency Jesus experienced to save the souls of the men of Sychar.
