

## Bible Conference Scheduled April 1-5

The 19th annual Bible Conference is scheduled April 1-5, beginning as usual on the first Sunday in April and running through Thursday at noon, according to President L. C. Johnson. The first service will be on Sunday night, April 1.

Special guest speaker this year will be Rev. John Gamble, evangelist from Lynchburg, Va., popular Bible Conference speaker two years ago. Other speakers will be members of the College faculty and staff.

The Bible Conference offers each year five days of Biblical preaching, messages on evangelism and missions, and a wellprepared program of Christian music.

The services will be held in Memorial Auditorium on the College campus. Although the school dormitories are almost filled with students, the administration will take prospective students into the dormitories until the capacity is reached.

Pastors, church workers, and other Christian friends are invited to attend these five days of enrichment in Bible knowledge, fellowship, and inspirational services.

## Summer School Dates Announced

Dean Charles A. Thigpen has announced that the 6th annual summer school session will be June 4-15. Registration will be held on the night of June 4 and classes will begin June 5.

Three hours of college credit may be earned in the 10 days of classroom work. A variety of courses in Bible and church work will be offered.

The total cost for the two weeks including all fees and room and board is \$59.

## Anniversary Celebration Marks 20 Years of Progress

Serving as the denomination's training center for pastors, missionaries, and Christian workers since its opening in 1942, Free Will Baptist Bible College has experienced 20 years of steady growth and progress. Beginning as a two-year Bible Institute with an enrollment of 16 students the first year, the institution has earned the confidence of pastors and parents over the years to the extent that 247 day students were registered in September of 1961 not counting the evening school students or the summer school students. The educational program was increased to a four-year, B.A. degree program in 1951, and today majors in Bible-theology and English and minors in five areas are offered. A one-year Business Education program was added in 1960 as well as a B.S. program for nurses.

Along with this growth in student body has been a growth in appreciation for Christian higher education by Free Will Baptists so that the annual gifts to the Bible College have risen from \$10,000 in 1942 to nearly \$70,000 annually at present.

Starting with only one three-story building in 1942, the physical plant has grown with the demands of the increasing student body to eight buildings today valued by a recent insurance appraisal at more than five hundred thousand dollars.

But the educational program and the school buildings serve only as a means to a greater end—getting out the gospel to the ends of the earth and winning the lost to Christ. To this end was the Bible College founded and for this purpose has the training program been developed so that over the past 20 years approximately 500 Free Will Baptists pulpits have been occupied by Bible-believing, Bible-preaching, soul-winning ministers; mission stations are being served by almost 50 young dedicated Christian missionaries; and Sunday school classes and church choirs are being taught by other Christian workers.

At this point during its 20th year, the Bible College Board of Trustees and the administration with faculty and staff along with the students are asking Free Will Baptists everywhere to join with them in expressing appreciation for the Bible College, for what it has done, for what it has meant to hundreds of young men and women, and for opportunities as it looks forward to greater service.

Five thousand Free Will Baptists are challenged to observe the Bible College's 20th Anniversary by giving \$1 for each of the 20 years to total five thousand \$20 gifts, or \$100,000. These Anniversary gifts will be used to pay off an indebtedness on buildings which was \$61,000 at the beginning of the present year and to enable the school to provide for needed expansion next year.

A number of churches and individuals have already sent in their Anniversary gifts or indicated the gifts would be forthcoming soon. Many more churches and individuals must be heard from to insure the success of this goal.

# From My Desk ...

Christians should be very conscientious in spending that portion of their income which is set aside in worship unto the Lord. Some Christians feel they are relieved of all responsibility after making their gifts to the church. Even though it is a good plan to make gifts through the church and then have the church distribute it to the needs of the kingdom work nowhere in the scripture is it indicated that it is not a personal responsibility on the part of the steward to give his money in a way that will glorify the Lord. As the individual has a serious responsibility in determining the leadership of the Lord in his giving, so does the church that becomes the custodian of the gifts of its membership have a grave responsibility in its stewardship ministry. The handling of money which is an expression of the worship of God's people cannot be taken

With this in mind, it is easy to see that every denominational agency that appeals to our churches and to individuals for a portion of their income should be very careful that every such request is fully justified. No department of our denominational work has a right to request a share of the money given in worship in a local church in order to build a big treasury for the department. No department has a need for a high balance that is out of line with its current needs. In all fairness to our departments, I know of no department that is near having a sufficient reserve in the light of its current operation.

The purpose of my discussing this is to say that Free Will Baptist Bible College does not take lightly the requests that it makes from the churches and individuals of our denomination. We feel that we only have a right to ask for gifts when a real need exists. There are so many needs within our denomination that no one department, no matter how pressing the needs, would be wise in asking or demanding more than a proportionate share of the gifts of our Free Will Baptist Churches.

In spite of a busy revival schedule, Bobby wrote and published in 1960 a book of sermons, Messages That Matter.

### Gifts Continue at \$5,000 Per Months Level

Gifts to the general fund of the Bible College have averaged almost \$5,000 each month from June through December, the recent financial statement shows.

Free Will Baptists must step forward and up their giving from the present \$5,000 per month level (about the same for the past three or four years) to at least \$6,250 per month needed to provide the \$75,000 asked from the denomination each year.

Principal on loan

Dr. L. C. Johnson, Bible College president and director of the 20th Anniversary campaign, states: "I have recently traveled in several states among our Free Will Baptist people, and they are interested in our Anniversary project and want to have a part in it."

Dr. Johnson emphasized that these Anniversary gifts are to be *special* gifts, over and beyond the regular support to the church. "Letting up on our regular giving to make a gift to the Bible College for its Anniversary Year program will not help us," he said.

Literature explaining the program and an envelope have been mailed to you or to your church. Send your special appreciation gift of \$20 (\$1 for each of the 20 years of the school) to the Bible College immediately. Better still, send \$20 for each member of your family. Special recognition will be given to families or churches making donations of five or more \$20 gifts. Gifts should not be limited to five units, but each church should allow the people to push the number of gifts as high as their interest and appreciation reach.

One church has already given more than \$1,000; other churches are giving up to \$500. Let the people be challenged and then let them give.

A service recognizing Anniversary gifts amounting to five or more \$20 donations will be held at 11 o'clock a.m., April 5 during the annual Bible Conference. Everyone who possibly can is urged to have his gift in by that date.

The Anniversary Year, however, continues on through May 31, and gifts may be made up to this time. A complete report will be given at the National Association in July.

### 15 Students Expected For 2nd Semester

## Alumni Challenged to Complete Campaign by April 1

Interest in the alumni campaign has been increased recently, according to Robert Picirilli, campaign director. A new style of reports and an attempt to get alumni to underwrite the campaign with a monthly check-book plan have contributed to this new concern.

One report, sent out in December, notified the alumni that they had raised half the original goal of \$37,500, the purchase price of the alumni building.

Another report in January sent blank \$5-per-month checkbooks to alumni members. To this date, 14 persons have signed checkbooks for a total of \$860. Various other alumni have sent in individual gifts, meaning that approximately \$1,000 has been given during the month.

The alumni campaign was begun at Bible Conference in April, 1960, and was scheduled for two years. This time will have expired by the Bible Conference this April, and alumni are making special plans to attempt to raise the remainder of the goal by that date. Approximately \$20,000 has been raised so far.

In addition to the drive for signed \$5 checkbooks, the various alumni who are pastors are being asked to observe a special "College Sunday" in their churches before the Bible Conference and to receive an offering on the drive. The suggested date for this day is March 25.

## OBJECTIVE AND ADVANTAGES OF THE SUMMER SESSION

The charter of Free Will Baptist Bible College states that

The Free Will Baptist Bible College is devoted to the promotion and impartation of higher Biblical education and such other education, instruction, and training as may be deemed essential to the equipment of Christian workers, teachers, ministers, and misionaries of both sexes of Christian service.

The objective of the summer session is parallel and complementary to this general objective of our college. The need has long been felt for training that will be accessible to Free Will Baptist workers already engaged in such services as pastoral or lay work. Here, then, are two weeks of intensive training designed especially for these persons who cannot take out time to attend the ordinary college term.

The advantages of such an arrangement are easily seen. There is, first of all, the intensiveness of the work which enables the accomplishment of a few courses in a short period of time. There is also the fact that this period of study will take the pastor or other church worker away from his own church for

only one week end (and those who live near enough will not even miss this). This is an opportunity for pastors, Sunday school teachers, and other Christian workers to gain a new perspective and a refresher course in the Word of God.

#### ACADEMIC LEVEL OF COURSES

Free Will Baptist Bible College will allow full college credit for the courses taught in the summer session toward a degree. However, those who do not wish to take these courses for college credit are encouraged to attend and will not be required to achieve the same level of work done by the college student.

#### RESIDENCE

Regular provision for room and board will be made in the dormitories and dining hall, and these accommodations will be available to any student, married or single. Room and board in the dormitory may also be available for a limited number of married couples, though private cooking privileges will not be possible. The charges for these provisions are listed under the section on expenses.

#### ADMISSION

Admission into the summer session

But God hath chosen the foolish things of the world to confound the wise." I Corinthians 1:26-27.

The one thing I believe you think of concerning Free Will Baptist Bible College is its emphasis on exalting our Lord Jesus Christ. Some might question whether an institution that actually puts Jesus Christ before everything else and the spiritual above every other consideration, can meet modern-day educational standards. There are those who would prefer to be known by their academic and scholastic standards. When any Christian institution comes to be known better for its academic rating than its Christian testimony, it has lost its basic distinctive character. The thing that makes an institution basically Christian is not the kind of clothes the young ladies wear or whether or not they wear make-up. The difference does not lie in the kind of athletic program sponsored by the institution. The basic difference is whether or not Jesus Christ and the Word of God are exalted in creed and practice above everything else. It


During her first three years at college, Lissie worked in the school office, serving part of this time as secretary to the dean and the registrar.

## February Gifts

After holding to an average monthly income of \$4,800 for the first eight months of the present fiscal year, general fund gifts dropped in February to \$3,609.53.

College officials explained the decline in gifts to two things: (1) the short, 28-day month; and (2) special gifts being sent to the Anniversary Campaign. "We must have operating funds first," President L. C. Johnson said, "for we are deceiving ourselves if we discontinue our regular support in order to make Anniversary gifts. Anniversary gifts are to be "special" gifts, that is, over and beyond the regular needs of the school."

A total of \$6,250 is needed each month in general fund gifts. General fund gifts this year average \$4,679 monthly. A balance of \$32,822.81 is needed in March, April, and May to supply the yearly gift income budget of \$75,000.

Dean Charles A. Thigpen has announced that the Bible College faculty and administration have approved the addition of a fifth year for ministerial students. The new program will begin in September of 1962.

The graduate of this program will earn the bachelor of theology (Th.B.) degree. The student will take the regular requirements for the four-year B. A. degree plus an additional year of courses in Biblical theology, philosophy, church history, Greek synoptic gospels, and supervised pastoral internship.

The internship program will place the ministerial student under the care of a Free Will Baptist pastor in the Nashville area where he will have actual responsibilities in church services and activities throughout the year.

Instructors for the fifth year will be Dean Thigpen, Dr. J. D. O'Donnell, and Leroy Forlines.

The expansion of the curriculum is the result of a long-felt need in the Free Will Baptist Church for further training of ministerial students.

The school's original two-year program begun in 1942 was extended to three years in 1950 and to four years in 1951. Since that time additional minors and majors have been developed and new departments have been added. The faculty has grown in number and in academic preparation as well as in teaching experience.

This addition to the educational program of the institution comes within the framework of its charter—"The Free Will Baptist Bible College is devoted to the promotion and impartation of higher Biblical education and such other education, instruction, and training as may be deemed essential to the equipment of Christian workers, teachers, ministers, and missionaries of both sexes for Christian service."

When money for the \$30,000 loan is in sight, the Board of Trustees can set in motion plans to meet the most pressing need for additional space and facilities.

There are three things that every person should know about himself. The first is who he is. This is self-identification. Second is why he is here. This is the purpose of life. The third is where he is going. This has to do with immortality. All these questions seem simple on the surface, but in reality are the most profound questions man has ever entertained.

"Who am I?" We need to identify ourselves. Communism is based on the philosophy that man is a material being. He has no soul. When he dies, that will be the end of his existence. He did not have divine origin; neither does he have divine existence nor divine destiny. Man, to the Communist, is nothing more than the highest being in the animal kingdom. Many professors in our high schools, colleges, and universities accept this same philosophy. Many preachers in our pulpits do not give God credit for creating the world or man. Man to them is a social being; his highest goal in life is to adapt himself to the norm of society and be a good citizen. Many deny that man is an immortal being and will live forever.

On the other hand, if you believe you were created in the image and likeness of God, life takes on a new dimension. It is easy to believe God had a purpose for you if He made you. Logically it follows that you are accountable to Him for your life.

It is very important to know who you are. Free Will Baptist Bible College fully accepts the truth that we were created by God and are accountable to Him.

The second question is "Why am I here?" Many who accept the truth that God created them fail to realize God has a purpose for them. If God has a purpose for your existence, your first duty is to find out what it is. We tell our students that God has a blueprint for their lives. Many young people have found God's will for their lives at Free Will Baptist Bible College.

The next thing you need to know is "Where are you going?" You are an immortal being. The grave is not the end of existence, but is just a passageway out of time into eternity. You must live somewhere forever. The Bible tells us of two places where the souls of men will be in eternity; one is hell, the other is heaven. So with each heartbeat, we are being pushed by an invisible hand through the gate of death into the arena of eternity.



### **Annual Report to Board**

By L. C. Johnson, President

This is the 17th annual report that I have made to the Board of Trustees of Free Will Baptist Bible College. In two areas this our twentieth year has been the greatest in the history of our institution. This has been a record year in number of students and also in gifts. Notwithstanding some factors that might have worked against an increase in enrollment, this year brought one of the greatest increases in the history of the institution.

Prospects for next year are for another increase even beyond the 58 per cent increase of the past two years. A chart study of our enrollment indicates that from past growth patterns we are due for a leveling off. However, with more of our churches being pastored by those who have received their training here, we might well expect a consistent growth in our student body if we are able to accept it.

If you will note in the financial section of this report, we have broken all records in income. While gifts to the general fund held steady, gifts to the Alumni Campaign and to the Twentieth Anniversary Campaign shoved the total giving to its highest point. I think this Board will wish to express its thanks to the Alumni Association for its enthusiastic support. At its annual meeting in April it was voted to continue the campaign to pay for the Alumni Building. The Alumni are to raise \$12,500 to complete this project.

The Anniversary Campaign has been moderately successful. One last appeal is being made before the National Association for enough funds to retire the indebtedness. With the Alumni Association assuming the completion of its project and with what is now on hand, \$10,000 in extra funds will put the institution debt free.

Adequate buildings to take care of the needs of the institution remain our most acute problem.

To illustrate the acuteness of our housing problem, I bring to your attention this situation: If applications from women students come in in proportion to last year, we will be forced to turn down a number of applicants. Notwithstanding the critical need in this area, it is the feeling of the administration that a classroom-library building is even more necessary than to increase housing for students.

The fifth year Th.B. program has been worked out and is listed in this year's catalog. It is our feeling that this should be offered only if there is suf-

#### OBJECTIVE AND ADVANTAGES OF THE SUMMER SESSION

The charter of Free Will Baptist Bible College states that

The Free Will Baptist Bible College is devoted to the promotion and impartation of higher Biblical education and such other education, instruction, and training as may be deemed essential to the equipment of Christian workers, teachers, ministers, and misionaries of both sexes of Christian service.

The objective of the summer session is parallel and complementary to this general objective of our college. The need has long been felt for training that will be accessible to Free Will Baptist workers already engaged in such services as pastoral or lay work. Here, then, are two weeks of intensive training designed especially for these persons who cannot take out time to attend the ordinary college term.

The advantages of such an arrangement are easily seen. There is, first of all, the intensiveness of the work which enables the accomplishment of a few courses in a short period of time. There is also the fact that this period of study will take the pastor or other church worker away from his own church for only one week end (and those who live near enough will not even miss this). This is an opportunity for pastors, Sunday school teachers, and other Christian workers to gain a new perspective and a refresher course in the Word of God.

#### ACADEMIC LEVEL OF COURSES

Free Will Baptist Bible College will allow full college credit for the courses taught in the summer session toward a degree. However, those who do not wish to take these courses for college credit are encouraged to attend and will not be required to achieve the same level of work done by the college student.

RESIDENCE

Regular provision for room and board will be made in the dormitories and dining hall, and these accommodations will be available to any student, married or single. Room and board in the dormitory may also be available for a limited number of married couples, though private cooking privileges will not be possible. # Largest Income Shown in Annual Financial Report

The Bible College's 20th year of operation set new records with more income and expenditures than in any previous year. With its largest student body, the income to all funds totaled \$250,708.05, which is \$46,199.03 more than any previous year's income. General fund gifts were \$57,511.96, anniversary gifts \$28,634.19, building fund gifts \$11,223.16, and student income \$60,673.33. General fund gifts were \$1,929.58 less than for the previous year.

Expenditures were also at the highest point with \$211,-435.69 being expended for school operation and \$33,650.02 being spent by the plant fund as payment on the bank loan, interest, and expense.



Four new members were elected to the College Board of Trustees at the National Association meeting in Nashville July 10-12. Each person will be serving in this capacity for the first time.




The nine-member Board meets twice annually and is composed of two laymen and seven ministers.

# 42 Room Apartment Building Purchased



To meet the need of crowded conditions in general on the Bible College campus, the Board of Trustees recently purchased the Belle Haven Apartment building at 3619-21 Richland Ave., adjoining the present campus.

Costing \$27,500, the 42-room brick building will be used eventually as a dormitory to house all the single men with an expected capacity of 75 students and a supervisor's apartment. The present men's dormitories can accommodate 65 men.

Since some of the tenants are still living in the apartment building, the College does not plan to use the building until about January 1, school officials have stated.

The space at present occupied by the men will be used to alleviate the crowded conditions in classrooms and to provide additional teachers' offices.

A bank loan was secured to finance the purchase of the property. Regular payments on the loan are expected to be made as income enables the school to do so.

Freshman students number 111, sophomores 44, juniors 28, seniors 19, and special students 22, and evening school 26.

tation work to secure financial support for several months and will probably go to the field sometime next year, Rev. J. Reford Wilson, Foreign Missions director, has reported.

The addition of the above seven persons to the 38 Bible College alumni now

serving as missionaries brings to 45 the number of former students which can be counted in our Foreign missionary force.

The missionary director also reported that 22 applications for missionary service are on file and that most of these are students at the Bible College.

We all know that Brother and Sister Willey and Miss Barnard are outstanding missionary personnel that any denomination would delight in having. The same could be said of many others that were not privileged to be in our Missionary Conference.

The things I refer to concerning our Missionary Conference and our missionary personnel could be said concerning our pastoral leadership. Perhaps no denomination has made greater advances in these areas than our own. Free Will Baptist Bible College is grateful to have had a part in making these things possible. Your gifts and prayers have been turned into a pastoral and missionary force which gives a new frontier to our Free Will Baptist denomination.

**Supply Line**

Returning home from a recent trip, I found myself waiting at the ramp of a ferry that was carrying other cars across a small river. The river barred me from my duties and obligations on the other side. I was forced to wait for transportation across that river before I could be active on the other side.

Twenty-five years ago, Free Will Baptists sat at the side of a river of lethargy, discouragement, and carelessness, looking across to the place where they knew they should be in their denominational program. On one side of the river were thousands of young people who would give themselves in service and on the other side lay the fields of the world in which they should serve. But there was no ferry. There was not even a ramp to approach a ferry. Through the vision of dedicated men the approach was built, the ferry was set into operation, and more and more Free Will Baptists are being transported across that river into dedicated service for Christ.

Free Will Baptist Bible College has served as God's means of moving our people to His service in many parts of the world.

Two mission fields manned by four missionaries have expanded through the vision given by God's faithful teachers of the Word at the College into more than a dozen fields and 68 missionaries. Besides these missionaries some five to six hundred ministers have received training in Free Will Baptist Bible College in the past twenty years. Several hundred other Christian workers serving as educational directors, pastor's wives, musicians, Sunday school teachers, evangelists secretaries, etc., have

From time to time it is important to discuss the particular area of education in which our Bible College functions. The reason for this is that the Bible college program of education is comparatively new to the majority of us. In essence, however, the Bible college type of education was the earliest known in America. Studying the early history of some of the great colleges and universities, we find in their curriculum a similar pattern of education to the modern Bible college pattern. It is well to remember that the church was the first to enter the field of higher education in this country. The church saw to it that the Word of God and Christian morals had the central place in the curriculum and general emphasis in these institutions. Of course, the institutions were not always called Bible colleges, but the courses of study and general emphasis were very similar to our Bible colleges of today.

As our country developed and life became more complex, the state through taxation entered the fields of education and has greatly taken over the responsibility of educating the citizenry. The church seemed to be willing to relinquish its rights in the educational field and let the state assume more and more of this responsibility. The state has made less and less room in its curriculum for the Bible and morals. Its program of education is almost totally secular. It prepares the student to be the master of the physical world about him. It is almost lacking in effort to show man his relationship to God. Any system of education that fails to do this is secular.

Public education has come to so dominate the educational system that private education must allow it to determine the policies, curriculum, and standards of education. The problem private institutions face is how to meet all the demands of public education and have any room left to teach and emphasize those things for which the private institution was specifically created. At this point is where Bible college education boldly declares its dedication to the church that created it and to the cause of Jesus Christ. Bible college education is not defiant in its attitude, but declares itself to be wholly committed to the cause of Christ and to the church and to those principles which secular education overlooks or minimizes. The Bible college has other interests that it must attend to that are not a part of the public system of education.

been trained at the College. More than two hundred students are at this minute in preparation for the task of manning new fields, serving as replacements, etc. Since 1942 our people have invested some \$300,000 in property for our present campus. This figure divided by the twenty years of service would mean that we have invested \$1,250 per month to purchase property. This is less that one cent per month given by each Free Will Baptist. Has this amount been adequate? Could we have grown more if facilities had been more ample? How many mission fields are unmanned today or insufficiently manned and equipped because we failed in providing means to afford adequate training for all who would have come? How many cities are without a church because of our unwillingness

This does not mean that the Bible college program of education is not standardized. While public education is standardized to develop the student horizontally, that is to bring him into masterful relationship to the world about him, the Bible college system is standardized perpendicularly and horizontally. It brings the student into proper relationship with God (perpendicular) and then seeks to bring him into a servant's relationship to men (horizontal).

Bible college education believes firmly that it has a particular task to do. Not being able to harmonize this task with all the demands of general education, it set about to standardize its own program of education in the light of its purpose. The Accrediting Association of Bible Colleges, which is fully recognized by the United States Office of Education and meets the highest educational standards, was created to accredit institutions functioning in the Bible college areas of education. Free Will Baptist College is fully accredited by the Accrediting Association of Bible Colleges.

Bible college education would re-establish God and His Word in education. Bible college education would integrate all true knowledge with the Word of God. Bible college education is based upon the belief that the Word of God is true and the mind is free to discover all truth as it relates to its teachings. Bible college education repudiates the "open mind" concept of education which feels free to question the miracles of the Word of God and all that is supernatural. Your Bible College is committed to the great fundamentals of the Christian faith and to separated Christian living.



With the increasing growth of our world population, the modern modes of transportation, the improved studies in linguistics, the outreach of modern communications systems, we must recognize an ever-increasing responsibility for this and future generations to herald forth the Gospel message of salvation through Jesus. "And how shall they hear without a preacher?" (Romans 10:14). Free Will Baptist Bible College remains the chief source of supply for trained workers who have been called of God into special service.
