THURSDAY 7:30 P. M. OCTOBER 1, 1936

FRIDAY 11:00 A. M.

The message was brought by Elder Henry Black. Scripture reading St. Matt. 22:31-46. Text St. Matt 22:42. Subject—"What think ye of Christ?"

This soul-thrilling message was followed by another inspirational message by Elder Wilkerson, after which the benediction was given by Elder Black.

FRIDAY 1.00 P. M.

Devotional services were conducted by the moderator. Scripture reading Psalm 1.

The clerk then called the house to order and the Body proceeded to business.

The moderator appointed as Auditing Committee Bros. Cecil Kendrick, Thomas Rogers and G. I. Riley.

The Business Committee made a partial report which was accepted.

By motion the Executive Committee was empowered to authorize the Ordaining Councils of the Quarterly Conferences to ordain deacons for Mt. Olive and Bethel Churches.

By motion Bro. H. W. Smith was granted a certificate of license to preach the Gospel for one year and if he proves himself steadfast in the doctrine of the Free Will Baptist, he will at the end of this time, be restored to the full function of the ministry.

The doors of the conference were opened for reception of new churches. A petition for membership was presented from the First Free Will Baptist Church of Sylocauga which by motion, was accepted. The right hand of Christian fellowship was extended to the delegates and pastor of this new church.

The Business Committee made a partial report which was received. By motion each item was adopted.

The following Committees rendered their reports which were by motion accepted and Committees released: Family Religion, Auditing and Education.

SATURDAY 8.00 A. M.

The house was called to order by the clerk. Devotions conducted by the moderator. Scripture reading 1 Corinthians 13. Prayer by Bro. C. F. Kendrick.

The letter from Hepsabah Church was read and accepted.

The minutes of this session of the Association to date were read and approved.

The following committees made their reports which by motion were accepted and Committees released: Temperance, Literature, Deceased members, Standing of the Ministry, Business, and Devotional.

A report from the Chairman of the Home Mission Board was read and accepted.

The Committee on Resolutions made their report which was by motion accepted.

Business was then suspended until 1:30 P. M. for the eleven o'clock service.

SATURDAY 11:00 A. M.

The message was brought by Elder E. L. Isbell. Scripture reading Revelations 12. Text Revelations 12:1 "And there appeared a great wonder in heaven; a woman clothed with the sun and the moon under her feet, and upon her head a crown of twelve stars." This wonderful message was ably delivered and the accompaniment of the Holy spirit was made manifest.

SATURDAY 1:30 P. M.

The house was called to order by the clerk. Devotions conducted by Elder J. E. Hodgens. Scripture Reading Psalm 133. Prayer by Elder Henry M. Black.

The moderator then took charge and the Body proceeded to business.

The moderator appointed Elders T. J. Adair, L. L. Davis, R. H. Howard, L. M. Davis and Bro. J. M. Shirley as a council to organize the First Free Will Baptist Church of Alabama City with two other churches into a Quarterly Conference, said conference to be known as the third district.

By motion the clerk was instructed to have five hundred minutes printed.

By motion the clerk was paid ten dollars for her clerical duties.

Bro, A. M. Roberts of Alabama City was appointed to serve on the Executive Committee with Bros. Rufus Franklin and J. D. Kilburn.

Elder V. L. Yancey was appointed to represent this Body in the State Conference convening in Millport, Ala. on Monday after the fourth Sunday in October 1936.

By motion the clerk was instructed to notify Liberty Church that Bro. H. W. Smith's name will be carried on the ministerial roll as a licentiate for another year.

By motion the business part of this Association stands adjourned to convene again on Thursday night before the first Sunday in October 1937 with Pleasant Valley Church near Chelsea, Ala.

SATURDAY 7:00 P. M.

After special singing and prayer Elder J. E. Hodgens took charge to conduct the communion and feet-washing service. Scripture Reading Genesis 17:1; 1 Corinthians 11:23-34. Text Hebrews 10:9. "Then said he, Lo, I come to do thy will, O God. He taketh away the first, that he may establish the second."

Surely our hearts were borne Heavenward and our cup of joy was filled to the brim as this dear old servant of God poured out his soul in defense of the ordinances of the Lord's house, and plead so earnestly for a closer walk with God and a stricter obedience to the commands and examples of our Saviour on the part of the church. This service was a glorious one and one never to be forgotten by those whose hearts were in it.

ARTICLES OF FAITH

- 1. THE BIBLE—The scriptures of the Old and New Testaments were given by inspiration of God and are our infallible rule of faith and practice.
- 2. GOD.—There is one living and true God, revealed in nature as the Creator, Preserver and Righteous Governor of the Universe, and in the scriptures as Father, Son and Holy Spirit, yet one God infinitely wise and good, whom all intelligent creatures are to supremely love, adore and obey.
- 3. CHRIST.—Christ is God manifest in flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man; once crucified, He is risen and glorified and is an ever present Savior and Lord.
- 4. THE HOLY SPIRIT.—The scriptures assign to the Holy Spirit all attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.
- 5. THE GOVERNMENT OF GOD.—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man may require.
- 6. THE SINFULNESS OF MAN.—Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to the years of accountability sin and become guilty before God.

- 8. THE TERMS OF SALVATION.—The conditions of salvation are: First, repentance or sincere sorrow for sin and hearty renunciation of it. Second, faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul, renewed by the Holy Spirit, freed from the dominion of sin, becomes a child of God. Third, continuance in faith and obedience until death.
- 9. ELECTION.—God determined from the beginning to save all who should comply with the conditions of salvation. Hence, by faith in Christ, men become His elect.
- 10. FREEDOM OF THE WILL.—The human will is free and self-controlled, having power to yield to the influence of the truth and the spirit and live, or to resist them and perish.
- 11. SALVATION FREE.—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take the water of life freely.
- 12. PERSEVERENCE.—All believers in Christ, who through grace persevere in holiness to the end of life, have the promise of eternal salvation.
 - 13. GOSPEL ORDINANCES .- Baptism, or the immersion of believers in

water, feet washing and the Lord's Supper are ordinances to be perpetuated under the gospel of universal obligation, and to be administered to all true believers.

- 14. THE CHRISTIAN SABBATH.—The divine law requires that one day in seven be set apart from secular employment and amusements, for rest, worship, holy works and activities, and for personal communion with God.
- 15. RESURRECTION, JUDGMENT AND FINAL RETRIBUTION.—The scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life and they that have done ill unto the resurrection of judgment; then the wicked will go into eternal punishment, but the righteous into eternal life.—John 5:29, revised version; Matt. 25:46.
- 16. WAR.—War destroys the lives of the innocent, and is contrary to the teachings of the new Testament, therefore, we are opposed to war.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopting the word of God as our rule of faith and practice, we now give ourselves one to another by the will of God, in this solemn Covenant.

We promise, by His grace, to love and obey Him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world; from all sanction of use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the scriptures, secret prayer, family devotions and social worship; and by self-denial, faith and good works endeavor to grow in grace and the knowledge of our Lord and Savior, Jesus Christ.

We will not forget the assembling of ourselves together for church conference, public worship, and the observance of the ordinances of the gospel, nor fail to pay according to our ability for the purpose of the church, of its poor and its benevolent work.

We agree to accept Christian admonition and reprove with meekness, and to watch over one another in love, endeavoring to "keep the unity of the spirit" in the bond of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring and, as far as we are able, promote the success of the church of the gospel. We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme, counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the kingdom may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of education and denominational enterpises, the evangelistic efforts for the salvation of souls and the conversion of the world. And may the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus.
