

PROCEEDINGS

8:30 A.M. to 9:00 A.M. - Registration

9:00 A.M. — The conference opened with congregational singing. Prayer by Rev. Gerald Baxley. The Moderator's message was given by Rev. Glenn A. Hood. Subject was "The Five Sides of the Cross" using as scripture: Leviticus 1:9 and I Timothy 2:5. Prayer by the Moderator. The conference was called to order by the Clerk. The Credentials Committee report was given and accepted. We then had a roll call of delegates allowing time for substitutions where needed. A motion was then passed that the delegates, including the substituted delegates be seated. The visitors were welcomed and recognized. The Home Missions Board report was given by Rev. W.H. Ryland, Chairman with the financial report being given by Rev. Donnie Hussey, Sec. & Treasurer. A motion was passed to accept this report. The Youth Camp Board of Trustees report was given by Bro. Lecil Gardner, Chairman. A motion that this report be received as given was accepted. The Youth Camp report was given by Rev. Wayne McDaniel, Director. A motion was passed to accept the report. A special presentation was made at this time. Rev. Jack Rollins gave a brief history of Rev. J.J. Staab and Rev. W.H. Ryland and their work for the Lord and Free Will Baptists. A plaque was presented to Bro Staab and Bro. Ryland for their faithful and dedicated service to Cahaba River Association of Free Will Baptists. The following is a brief history of Bro. Ryland and Bro. Staab as prepared by them and presented to the conference by Bro. Rollins.

REV. WILLIAM HARMON RYLAND

Born in the little town of Cottondale, Ala. June 4, 1906. Lived in the suburbs of Tuscaloosa and attended school in Peterson, Ala. and Tuscaloosa, Ala. Moved to Walker County to the city of Cordova, where the school grades were completed. Converted in the year of 1926 in a revival conducted by the Rev. J.B. Bloss in Cordova, Alabama. Married in 1926 to Verla Mae Mays of Cordova. Ordained to preach the Gospel in 1928 under the auspices of the Cordova Free Will Baptist Church and the Muscle Shoals Free Will Baptist Association. Worked as a carpenter for the Indian Head Milling Company and attended college classes during the evening classes of Howard College institutes of Birmingham, Alabama. Later completed the requirements for B.A. Degree from Howard, which later was named Samford University.

Worked as a building engineer for a number of years while pastoring and evangelizing and had the honor of building fourteen church buildings plus a number of commercial and dwelling buildings. At present time, registered for the 40th year in Boy Scouts of America. Served as First Aid Instructor for the Bureau of Mines, Red Cross and Boy Scouts of America. Trained near 4000 people in first aid. Saved the lives of five people and many lives were saved by those trained by Ryland. Author of a book "A LIVING GOSPEL FOR A DYING WORLD". Served 4 years as Moderator of the Alabama State Association. Moderator 2 years of the Cahaba River Association. Superintendent, Free Will Baptist Childrens Home 10 years. Pastored the following churches: Dovertown — Brookside, Carbon Hill — West Corona - Carbon Hill - Studdard Cross Roads - Prospects - Pleasant Valley - Laodecia - Mt. Zion, Pell City - Townley - Leeds - Sylacauga - North Birmingham - Fairview, Leeds - New Liberty - Eldridge -Calument - Sulpher Springs, Samantha - Graysville. During my years in pastoral work, I pastored 2, 3, or 4 churches during several years of my work.

I attended the Cahaba River Association for my first time in the year of 1930. I met many of Gods servants then, who most of them have already gone to their reward. In the late 1930's I had the privilige of meeting Rev. J.J. Staab, a man I enjoyed working with and having him in a revival at the Brookside Church, Carbon Hill. Rev. J.J. Staab was a wonderful co-worker in the revival in Graysville, Alabama which resulted in the organization of the Graysville Church. Ryland and Staab, under the direction of the Cahaba River Association, went to Montgomery, Alabama and conducted a mission in a rented building which resulted in many souls being saved. Following our work in Montgomery, the National Association sponsored the mission there which resulted in a wonderful church.

Due to ill health, I am giving up my pastoral and evangelistic work. I have had the joy and glory of a wonderful life in serving my good people during these years. Yours in Him - Rev. William Harmon Ryland.

A BRIEF HISTORY OF THE ACTIVITIES OF REV. J.J. STAAB AS A

FREE WILL BAPTIST MINISTER AND CHRISTIAN.

He was converted in April, near the end of the month, 1931. "This was my experience, the Good Lord lead me to repentance on my job early one morning as I started to work at the Stockham Valve & Fittings Company. I prayed and God saved me in a marvelous way. In a short time, on Mothers Day, 1931, God saved my wife and shortly after this God called me to preach. At this time we were attending a small Weslyn Methodist church. This is where our first christian experience began. In about a month, my wife and I were baptized in a small creek in Tarrant, Alabama. I then began to attend church services and cottage prayer meetings. We went everywhere. We lost our love for the moving pictures and other worldly activities. People began to call on me to take the lead of their services, and I began to preach

at most of them."

We moved north of Tarrant, Alabama to Robinwood. There we started to attend services at a small community church. The people wanted me to preach for them. I preached and acted as Sunday School Supt. for about a year. This is really the place and time that I began to preach the gospel. I preached at several small churches in the Christian Missionary Alliance, for about three years and began to gather information about the Free Will Baptist beliefs, doctrines and practices, gathering as much information as I could find. My decision was to be a Free Will Baptist. The first church I joined was Crocker Junction, south west of Gardendale, a rural church which later became known as Oak Grove church at Fieldstown, Alabama. At this time, my friends asked me to obtain a license to preach. I went to one of our associations, to get this license. Some of the brethren wanted me to preach for one year and prove myself. This brought a debate in the conference. The Rev. John Davis rose to his feet and asked, why compell him to wait one year since he has already been preaching about four years already? He made the motion while he was on the floor to ordain me without delay and it passed. I was ordained at an annual association of the Cahaba River Association at Union Hill Free Will Baptist Church at Vandiver Alabama in October, 1935.

My wife and I moved to North Birmingham. I became burdened to think that we did not have a Free Will Baptist Church in the city of Birmingham. I set out to organize one. The first attempt was the use of an old abandoned foundry. We worshiped for awhile here and then moved our equipment to a store building on the corner of 33rd Avenue and 29th Street. This started the First Free Will Baptist Church in Birmingham. This was depression years and things were hard. I remained pastor for approximately 7 years. (This church has left North Birmingham and has moved to Fultondale and is known as the Fultondale Free Will Baptist Church now.) Leaving North Birmingham, I began working up an organization at the Black Creek community, northeast of Birmingham. This work went to the Missionary Baptist. I helped Bro. Floyd Burrell start the Crocker Junction Church which died out soon. I decided to try and organize a Free Will Baptist in Tuscaloosa, Alabama. I had no automobile, and no money. I had a job that I had to work at to make a living for my family in Birmingham, Alabama. I made some contact and we with some of the brethren that we got acquainted with obtained the use of a court room at the Tuscaloosa County Court House. We held services several months in this court room. Thus the beginning of the First Free Will Baptist Church in Northport, Alabama, We moved across the river and conducted a revival in our State tent. We had received 8 members in the court house room and in the meeting under the tent, we received 17 more. Then we bought property and built our first church in Northport, Alabama, November 3, 1946. The Northport Free Will Baptist Church is a real beautiful church today.

I first became Moderator of our State Association in 1941 and served in this capacity for several times. (Nine years all together.) I also worked as Moderator and held several other offices in our local conferences of the Cahaba River Association of which I was a member. I conducted radio broadcasts in addition to the other work I was doing. I carried on one over radio station WLBS, One over WJRD, Tuscaloosa and one at Hamilton, Alabama. All of these were carried on over a period of three years. We raised money over the State of Alabama to purchase a large tent. We and some other ministers did some good work with this tent. God blessed in a

great way.

With the help of some other brethren, we started the Childrens Home at Eldridge, Alabama. God blessed us even though it was a hard job. Much work

was put into this project, but it still stands to speak for itself.

I was an uneducated preacher, so my lot was that I stayed up most all night studying the Bible many nights. Trying, trying, trying. I have organized and helped organize many other Free Will Baptist Churches and pastored many Free Will Baptist Churches. These are some of them: In depression days, I pastored Railroad Avenue Church in Alabama City, Alabama. I also pastored Mt. Zion, Pell City; First Church (North Birmingham); Oak Grove (Fieldstown); Pleasant Valley (Chelsea); First Church of Northport; East Birmingham Free Will Baptist Church; Center Point; Belview, Leeds; Fairview No. 1, Trussville. I conducted many revivals, an estimate of approximately 500 marriages and

baptized an estimate of 1000 people. After I had preached several years, I came in contact with the Rev. W.H. Ryland. We worked successfully together in many projects mostly church expansion. Bro. Ryland and I worked on the Mission Board of the State Association and developed the following: First Church at Graysville, Ala., First Church of Montgomery, Ala., The Pleasant Site Free Will Baptist Church east of Hanceville, Alabama. We tried and failed in several communities, but we continued on doing our best for the Good Lord. Bro. Ryland and myself have just about finished our call of duty. We are both of the age of 72. It will not be long until we will drop forever the working tools of life. And that will be the time we will be able to accept that new and glorious body the Lord has waiting for us in the Glory World. When the battle is over I shall wear a crown, I shall wear a crown.

I have been a working man all of my life since I was a child. I became an employee of the Stockham Valve and Fittings Company and worked at this company for 44 years. I was successful with the help of some real good friends in getting Christian services started at the noon day service. I retired April 30, 1971 at the age of 65. I am now 72 years of age and still pastoring. We at present are pastoring the Davis Chapel Free Will Baptist Church, Sterrett,

Summary of the Churches that I organized: First Church of Birmingham -Alabama. Black Creek Community (Baptist) - Small Church Crocker Junction -First Church, Northport, Alabama - East Birmingham Free Will Baptist -Center Point.

The congregation had a handshake of fellowship and to show our appreciation to Bro Staab and Bro. Ryland and their wives. A special was sung by a group from the Davis Chapel Church. Also, a special was sung by the "Walker Family".

The morning message was brought by Rev. Eugene Howard. The title of the message was "Put Christ on Display". The scripture used was St. Luke 10:25-37 and Acts 3:1-6. Rev. Larry Morgan dismissed with prayer and

asking the Lord's blessing on the food.

BY-LAWS OF MINISTERS AND DEACONS

Conference of Cahaba River Association

- The Clerk or Assistant Clerk, or the Senior Minister in years, may call the meeting to order and shall have charge until Moderator assumes his place.
- 2. It shall be the duty of the Clerk to enroll all Ministers present who are in good standing. If there are questionable characters they shall be referred to an appointed Credential Committee for advice but not for trial. They may be seated if found worthy, if not they are referred to their church.
- 3. Each meeting shall be opened with scripture reading and prayer.
- 4. By a two-thirds vote any decision of the moderator may be overruled.
- 5. This meeting shall sit with open doors unless it goes into a committee as a whole.
- 6. Any person, not a member of the body shall be allowed to take part in discussion, with Moderator's permission, but shall have no vote.
- 7. All members of the body are expected to be present throughout the session unless excused by Moderator.
- 8. No person shall be allowed to nominate more than one officer or committeeman if his nomination is elected.
- 9. The Moderator must not allow any discussion to be carried on in an unchristian spirit.
- The person who desires to speak, must first rise and address the Moderator and when recognized shall proceed.
- 11. The votes on any question must be counted upon request of one-fifth of members present.
- 12. No member shall be allowed to speak more than ten minutes, nor twice on the same subject unless given permission by Moderator.
- 13. All Ministers belonging to this body are required to support all committees and boards elected or appointed by Association, (such as Home Mission Board, Building Committee, etc.)
- 14. Every Minister carries a license until he is either called to a church or enters full time evangelistic work. The license of ministers licensed by this Association are to be reissued each year, if the church of which they are a member makes this request.

CHURCH COVENANT

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by His grace, to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to 'provide things honest in the sight of all men.'

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to 'grow in grace and the knowledge of our Lord and Savior Jesus Christ.'

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel; nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to 'keep the unity of the Spirit' in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic effort; for the salvation of the world. And may the God of peace sanctify us wholly, and spreserve us blameless unto the coming of our Lord Jesus Christ.

CONSTITUTION

- Article I The Association shall be known as The Cahaba River Association of The Free Will Baptist.
- Article II The Association shall be composed of ordained Ministers, Deacons and Delegates of different churches forming the same.
- Article III All Ministers and Churches wishing to become members of this body must willingly submit to the Articles of Constitution and all rules of same.
- Article IV Each church composing this Association shall be entitled to three (3) delegates of the first 100 members and one (1) for each additional fifty (50) or fraction thereof.
- Article V All church clerks shall mail church letters to the Association clerk not later than four weeks in advance of the first day of the beginning of the Association.
- Article VI A. The officers of the Association shall be composed of Moderator, Assistant Moderator, Clerk-Treasurer, and Assistant Clerk-Treasurer. The Moderator and Assistant Moderator shall serve one (1) year terms, and the Clerk-Treasurer and Assistant Clerk-Treasurer shall serve two (2) year terms. They shall be elected by the body. The Clerk-Treasurer shall handle all money of the Association, except the Home Missions Fund and the Youth Camp Fund. The Clerk-Treasurer and Assistant Clerk-Treasurer shall be elected on even numbered years.
- B There shall also be a Home Mission Board. The Home Mission Board shall consist of seven (7) members with three (3) members coming off each year. When vacancies occur, the body shall elect. The Home Missions Board shall elect their own Clerk-Treasurer which shall keep minutes of Home Missions Board meetings and shall handle all money belonging to the Home Missions Fund.

C - There shall also be an Executive Board. The Executive Board shall consist of three (3) members, each serving a three (3) year term with one member coming off each year. When vacancies occur the body shall elect.

D - There shall also be a Board of Trustees for the Youth Camp. Each Church that is a member of the Association shall be entitled to one (1) Trustee. Each Church may elect or re-elect a Trustee each year, from their Church and send his name and address in their letter to the Association. The Board of Trustees for the Youth Camp shall elect their own Clerk-Treasurer which shall keep minutes of their meetings and shall handle all money belonging to the Youth Camp Fund. The Board of Trustees for the Youth Camp shall also elect their own Chairman.

Article VII - All Committees shall be appointed in advance by Moderator. At end of session their responsibility shall cease.

Article VIII - The following committees shall meet in advance and be prepared to make their report at the beginning of session: Credential and Nominating, Deceased, Sunday School and C.T.S., Temperance, and Family Devotion.

Article IX - This Association shall meet on Saturday morning before the first Sunday in October of each year.

Article X — This article removed from constitution at conference on March 4, 1978.

Article XI - Each church shall pay a representation fee for each conference (annual conference and semi-annual conference) of \$5.00 for each delegate that the church is entitled to according to article IV of this constitution.

Article XII - The Clerk-Treasurer shall be paid \$75.00 annually. The Moderator shall be paid \$25.00 annually. The Assistant Moderator shall be paid \$12.50 annually. All other expenditures not specified shall be by decision of the body.

Article XIII - This Constitution may be amended or altered at any regular session of the Association by two-thirds (2/3) vote of members present, provided proposed amendment or alteration be presented in writing to the body and lay on the table from morning session until afternoon session or from afternoon session until evening session.

TREATISE ARTICLES OF FAITH

Chapter I - The Holy Scriptures

These are the Old and the New Testaments. They are written by Holy Men, inspired by the Holy Spirit and are God's revealed word to man. They are a sufficient and infall ble rule and guide to salvation and all christian worship and service.

Chapter II - Being and Attributes of God

The Scriptures teach that there is only one true and living God, who is spirit, selfexistent, eternal immutable, omnipresent, omniscient, omnipotent, independent, good, wise, holy, just, and merciful, the Creator, preserver, and Governor of the universe; the Redeemer Savior, sanctifier, and judge of men; and the only proper object of worship.

The mode of his existence, however is a subject far above the understanding of manfinite beings cannot comprehend him. There is nothing in the universe that can justly represent him, for there is none like him. He is the fountain of all perfection and happiness. He is glorified by the whole creation, and worthy to be loved and served by all intelligence.

Chapter III - Divine Government and Providence

- 1. God exercises a providential care and superintendence over all His creatures, and governs the world in wisdom and mercy, according to the testimony of His word.
- 2. God has endowed man with power of free choice, and governs him by moral laws and motives; and this power of free choice is the exact measure of man's responsibility.
- 3. All events are present with God from everlasting to everlasting; but His knowledge of them does not in any sense cause them nor does He decree all events which He knows will occur.

Chapter IV - Creation, Primitive State of Man and His Fall

Section I - Creation

1. OF THE WORLD, God created the world, and all things that it contains, for HIs own pleasure and glory and the enjoyment of His creatures.

2. OF THE ANGELS, The angels were created by God to glorify Him and obey His commandments. Those who have kept their first estate He employs in ministering blessings to the heirs of salvation and in executing His judgments upon the world.

3. OF MAN, God created man, consisting of a material body and a thinking, rational soul. He was made in the image of God, to glorify his Maker.

Section II - Primitive Man and His Fall

Our first parents, in their original state, were upright. They naturally preferred and desired to obey their Creator, and had no preference or desire to transgress His will until they were influenced and inclined by the tempter to disobey God's commands. Previous to this, the only tendency of their nature was to do righteousness. In consequence of the first transgression, the state under which the posterity of Adam came into the world is so different from that of Adam that they have not that righteousness and purity which Adam had before the fall; they are not willing to obey God, but are inclined to evil. Hence none, by virtue of any natural goodness and mere work of their own; can become the children of God, but they are all dependent of salvation upon the redemption effected, through the blood of Christ, and upon being created anew unto obedience through the operation of the Spirit, both of which are freely provided for every descendent of Adam.

Chapter V – Of Christ Section I

Jesus Christ, the Son of God, possesses all divine perfections. As He and the Father are one, He in His divine nature, filled all the offices and performed the works of God to His creatures that have been the subjects of revelations to us. As man, he performed all the duties toward God that we are required to perform, repentance of sin excepted. His divinity is proved from His titles, His attributes, and His works.

1. HIS TITLES. The Bible ascribes to Christ the titles of Savior, Jehovah, Lord of Hosts, the First and the Last, God, true God, Great God over all, mighty God, and the everlasting Father.

2. HIS ATTRIBUTES. He is eternal, unchangable, omnipresent, omniscient, omni-

potent, holy, and is to be worshipped.

3. HIS WORKS. By Christ the world was created. He preserves, and governs it; He has provided redemption for all men and He will be their final judge.

Section II - The Incarnation of Christ

The Word, which in the beginning was with God and which was God, by whom all things were made condescended to a state of humiliation in being united with human nature and becoming like us, pollution and sin excepted. In this state, as a subject of the iaw, He was liable to the infirmities of our nature, was tempted as we are, but lived our example, perfect obedience to the divine requirements. As Christ was made of the seed of David according to the flesh, He is 'the Son of man,' and as the divine existence is the fountain from which He proceeded, and was the only agency by which He was begotten, He is 'the Son of God,' being the only begotten of the Father, and the only incarnation of the Divine Being.

Chapter VI - The Atonement and Mediation of Christ

1. The Atonement - As sin cannot be pardoned without a sacrifice, and the blood of beasts could never wash away sin, Christ gave Himself a sacrifice for the sins of the world, and thus made salvation known possible for all men. He died for us, suffering in our stead, to make known the righteousness of God, that He might be just in justifying sinners who believe in His Son. Through the redemption effected by Christ salvation is actually enjoyed in this world, and will be enjoyed in the next by all who do not in this life refuse obedience to the known requirements of God. The atonement for our sin was necessary. For present and future obedience can no more blot out our past sins than past obedience can remove the guilt of present and future sins. If God pardoned the sins of men without satisfaction for the violation of His law it would follow that transgression might go on with impunity; government would be agrogated, and the obligation of obedience to God would be in effect, removed.

2. Mediation of Christ Our Lord not only died for our sins, but He arose for our justification, and ascended up to Heaven, where, as the only Mediator between God and

man, He makes intercession for us, until He comes again.

3. We believe that all children dying in infancy, having not actually transgressed against the Law of God, in their own persons are only subject to the first death which was brought on by the fall of the man Adam, and not that anyone of them dying in that State shall suffer punishment on Hell by the guilt of Adam's sin for of such is the Kingdom of God.

Chapter VII - The Holy Spirit

 The Scriptures ascribe to the Holy Spirit the acts and attributes of an intelligent being. He guides, knows, moves, gives information, commands, forbids, sends forth, reproves, and can be sinned against.

2. The attributes of God are ascribed to the Holy Spirit.

3. The works of God are ascribed to the Holy Spirit; creation, inspiration, giving of life, and a sanctification.

4. The Apostles assert that the Holy Spirit is Lord and God. From the foregoing the conclusion is that the Holy Spirit, is in reality God, and one with the Father in divine perfections. It has also been shown that Jesus Christ is God - one with the Father. Then these Three: The Father, Son and Holy Spirit, are One God.

The truth of this doctrine is also proved from the fact that the Father, The Son, and The Holy Ghost are united in the authority by which believers are baptized; and in the benedictions pronounced by the Apostles, which are acts of the highest religious worship.

Chapter VIII - The Gospel Call

The call of the Gospel is co-extensive with the atonement to all men both by the Word and strivings of the spirit, so that Salvation is rendered equally possible to all, and, if any fall of eternal life, the fault is wholly his own.

Chapter IX - Repentance

The repentance which the Gospel requires includes a deep conviction, a penitential sorrow, an open confession, a decided hatred and an entire forsaking all sin. This repentance God has enjoined on all men, and without it in this life the sinner must perish eternally.

Chapter X - Faith

Saving faith is an assent of the mind to the fundamental truths of revelation, an acceptance of the Gospel, through the influence of the Holy Spirit, and a firm confidence and trust in Christ. The fruit of faith is obedience to the Gospel. The power to believe is the gift of God, but believing is an act of the creature, which is required as a condition of pardon, and without which the sinner cannot obtain salvation, all men are required to believe in Christ, and those who yield obedience to this requirement become the children of God by Faith.

Chapter XI - Regeneration

As man is a fallen and sinful being, he must be regenerated in order to obtain salvation. This change is an instantaneous renewal of the heart by the Holy Spirit, whereby the penitent sinner receives new life, becomes a Child of God, and is disposed to serve him, this is called in scripture being born again - born of the spirit, being quickened, passing from death unto life, and a partaking of the divine nature.

Chapter XII - Justification and Sanctification

1. Justification. Personal justification implies that the person justified has been guilty before God, and in consideration of the atonement of Christ, accepted by faith, the sinner is pardoned and absolved from the guilt of sin and restored to the divine favor. Christ's atonement is the foundation of the sinner's redemption, yet, without repentance

and faith, it can never give him justification and peace with God. 2. Sanctification is the beginning of God's Grace by which the christian man con-

stantly grows in grace and in the knowledge of our Lord Jesus Christ.

Chapter XIII - Perserverance of the Saints

There are strong grounds to hope that the truly regenerate will perservere unto the end, and be saved, through the power of divine grace which is pledged for their support, but their future obedience and final salvation are neither determined nor certain, since through infirmity and manifold temptations they are in danger of falling, and they ought therefore to watch and pray lest they make ship-wreck of their faith and be lost.

Chapter XIV - The Sabbath

This is one day in seven, which from the creation of the world God has set apart for sacred rest and holy service. Under the former dispensation, the seventh day of the week as commemorative of the work of creation, was set apart for the Sabbath. Under the Gospel, the first day of the week, in commemoration of the Ressurection of Christ, and by authority of Christ and the Apostles, is observed as the Christian Sabbath. On this day all men are required to refrain from secular labor and devote themselves to the worship and service of God.

Chapter XV - The Church

A Christian Church is an organized body of believers in Christ, who statedly assemble to worship God, and who sustain the Ordinances of the Gospel according to the Scriptures. Believers in Christ are admitted to this church on giving evidence of faith in Christ obtaining consent of the body, being baptized, and receiving the right hand of fellowship.

The Church of God, or members of the Body of Christ, is the whole body of christians

throughout the whole world, and none but the regenerate are its members.

Chapter XVI - Tithing

Both the Old and New Scriptures teach tithing as God's Financial Plan for the support of His work.

Chapter XVII - The Gospel Ministry

1. Qualification of Ministers. They must possess good, natural and acquired abilities, deep and ardent piety, be especially called of God to the work, and ordained by prayer and the laying on of hands.

2. Duties of Ministers. These are to preach the word, administer the Ordinances of

the Gospel, visit their people, and perform the work of faithful ministers.

Chapter XVIII - Ordinances of the Gospel

1. Christian Baptism. This is the Immersion of Believers in Water in the name of the Father, the Son, and of the Holy Spirit, in which are represented the Burial and Resurrection of Christ, the Death of Christ, the death of christians to the world, the washing of their soul from the pollution of sin, their rising to newness of life, their engagement to serve God, and their resurrection at the last day.

2. The Lord's Supper. This is a commemoration of the death of Christ for our sins, in the use of bread which He made the emblem of His broken body, and the cup, the emblem of His shed blood, and by it the believer expresses his love for Christ, his faith

and hope in Him and pledges to Him perpetual fidelity.

It is the priviledge and duty of all who have spiritual union with Christ to commemorate His death; and no man has a right to forbid these tokens to the least of His Disciples.

3. Washing the Saints Feet. This is a sacred Ordinance, which teaches humility, and reminds the believer of the necessity of a daily cleansing from all sin. It was instituted by the Lord Jesus Christ, and called an 'example' on the night of His betrayal, and in connection with the institution of the Lord's Supper. It is the duty and happy perogative of every believer to observe this sacred oridnance.

Chapter XIX - Death
