RULES OF ORDER

- 1. The Moderator or Assistant Moderator or in their absence the oldest minister present shall call the Association into conference.
 - . 2. Each session shall be opened and closed by prayer.
- 3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such quorum is present.
- 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the Moderator. Personal reflection shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.
 - 7. Motions made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. The Moderator shall not allow discussion when not carried on in a Christian spirit.
- 10. The ruling of the Moderator may be overruled by a twothirds majority membership voting.
- 11. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- 12. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.

COMMITTEE REPORTS

Resolution No. 1—Be it resolved that the Home Mission, League and Auxiliary be given one hour each for their work, each annual session of Association.

No. 2—Be it resolved that a vote of thanks be given the Turlock Church for their kind hospitality during this Association.

No. 3—Be it resolved that our Association begin on Wednesday night before the First Sunday in May, 1948, instead of Thursday night, in order to have more time for business.

Temperance: We your committee report as follows: That

we recommend we be temperate in all things, and obstain from the uses and sale of intoxicating beverages, all worldly amusements and shun the appearance of evil, be temperate in all conversations, and be patient with all men. Scripture, 1st, Thes. 5-22, 1st. Peter 2-11, 2nd. Peter 1-6, 1st. Cor. 9-25, Gal. 5-23, Titus. 2-2, and Gal. 3-8.

Home Mission: We recommend that more Home Missions be organized in our churches. There are four of our churches that already have Home Missions.

Publication: We recommend that Five Hundred (500) Minutes be printed. We also recommend that each family buy a treaty and study it.

Sunday School: We recommend that our pastors and deacons together with the ministers who have no churches give more attention to our Sunday Schools, for in our youth there is hope for more peaceful cooperation among our church leaders. Therefore we urge that careful and prayerful consideration be given our youth. We recommend that all Sunday Schools use Free Will Baptist literature.

OBITUARY: We, your committee on Obituary, beg to leave to report we find that God seen fit to call home by death: Bro. Ernest Philips of Kerman Church, little Margurett Lapenskie, infant daughter of Bro. and Sister Lapenskie of Orange Cove and infant daughter of Bro. and Sister Frank Trip of Firebaugh church.

Education: Seeing the need of Education, we recommend that our young ministers whenever possible attend the Free Will Baptist Bible College. And that our Sunday School and League Teachers study more carefully, that they may be more able to teach our young people. We also recommend that more of our young people take piano and voice training that we may have better qualified musicians in our churches.

League: We recommend that all Leagues use Free Will Baptist Literature, and go by the League Manual in all League services, and all League members attend the rallies. We also recommend each church who have Junior Leagues to attend rallies, and the rally have a separate banner for the juniors.
