COMMITTEE REPORTS

Resolution No. 1 — Be it resolved that the State Association be held Wednesday night after the second Sunday in June. We recommend that each church elect their pastor in May.

Resolution No. 2 — Be it resolved that a state reporter be elected and that all churches and individuals cooperate with the reporter.

Resolution No. 3 — Be it resolved that the Associations meet on the following dates:

Southern — Thursday night May 10, 1951.

Center — Thursday night May 17, 1951.

Golden Gate — Thursday night May 24, 1951.

State — Wednesday night June 13, 1951.

Resolution No. 4 — Be it resolved that if the duly elected delegates are not present at the beginning of the business session that the alternates taking their place serve throughout the session.

Resolution No. 5 — Be it resolved that this church be given a standing vote of thanks for their fine hospitality. Business Committee

Report No. 1 — We recommend "The Small Voice" (Free Will Baptist Publication) be adopted as a state paper for California, supporting it with our subscriptions and news material.

Report No. 2 — We recommend that no Free Will Baptist Church in California call any minister as pastor who is not recognized, or can not secure recommendation from the California State Minister's and Deacons Conference.

Temperance Committee

We should abstain from places of worldly amusement and strive to not patronize places that sell intoxicating drinks; that we provide some kind of clean entertainment and social activities for our children and teach them the Kingdom of God first. We believe we should be temperate in all things. We urge our people to oppose any and all encroachments of intemperate business in the vicinity of our churches and homes.

Obituary Committee

We find there have been two (2) deaths in the Golden Gate Association, five (5) in the Southern Association, and six (6) deaths in the Center Association, making a total of thirteen (13) deaths.

Publication Committee

We recommend that the clerk of each church or duly elected reporter cooperate with the state reporter by sending news of progress of their church each month.

Finance Committee

We recommend that this Association pay former Clerk, Delmer Priest \$17.06 which we owe him for last years minutes. We further recommend that the clerk notify the churches to send in an offering for minute fund.

We report that Southern Association paid \$55.05, Center Association \$55.00, and Golden Gate Association \$55,00 for expense. Churches sending offerings were Richmond \$15.00, Modesto \$5.00, Hanford \$5.00, Porterville \$5.00, Orange Cove \$3.64, Parlier \$3.00, Bakersfield \$2.50, and Women's Auxiliary \$15.00. Total \$222.69.

Mission Committee

Seeing that the State of California is a great Mission field for Free Will Baptists and inasmuch as we need an extension program which would receive the support of every church, we recommend that this state association adopt the plan, or one similar, to the Progressive Building Fund adopted by the Southern Association. We submit the following Rules and By-Laws governing Progressive Building Fund:

- 1. This fund shall be composed of voluntary members, each member to pay (\$1.00) one dollar as membership fee and (\$1.00) one dollar every three months thereafter.
- 2. This fund shall have a Board of five Supervisors including a Secretary Treasurer to be elected by this State Association. One on this board shall be elected annually.
- 3. The Treasurer must be able to make a substantial bond, if necessary.
- 4. The Money raised in the Fund may be used to help any new Church secure a building, building material or property on which to build, provided said church is an orthodox Free Will Baptist Church and a member of the

State Association of Free Will Baptist of the State of California.

- 5. Such building or real estate to be purchased must be approved by the Board of Supervisors.
- 6. This money may also be used to assist other Churches of the State Association of Free Will Baptist which have their building but may be having financial difficulties.
- 7. No church or churches may receive aid from this fund without first agreeing to repay all money received, according to their ability to do so. Thus creating a revolving fund to be used to the Glory of God and the advancement of the Gospel.
- 8. All requests for aid shall be made to the Sec.-Treas. of the fund. The Sec. shall in turn notify the board. It shall then become the duty of the board to investigate the request and if approved notify the Sec. Treas. in writing, signed by at least 3 of the board members.
- 9. The Sec.-Treas, shall issue no money to any person or group of persons, without a written order from and signed by a majority of the board members.
 - 10. No interest is to be charged for the use of this money.
- 11. It shall be the duty of each Pastor to encourage and promote this program in his church.
- 12. It shall be the duty of each church clerk or whomsoever the church may elect, to act as a representative of the fund, and to collect and forward the dues to the Secretary of the fund.
- 13. The Sec.-Treas. shall give an official receipt to each church for all money received.
- 14. The Sec.-Treas. shall make a complete report, each year at the regular session of the State Association of Free Will Baptists. Such a report must give all financial and business transactions.
- 15. These By-Laws may be ammended at any regular session of the State Association by a two-thirds vote of members present.

League Committee

We find 13 active leagues in the state. We urge every church to organize a league.

Auxiliary Committee

We report that six churches having auxiliaries have organized a convention which met at the Bakersfield Church April 19, 1950 and would like the minutes of the convention printed with the state minutes. We send \$15.00 to pay for them. The next convention meets August 2, 1950 at the Turlock Church, Landers and "C" Streets. Everyone is invited. BY-LAWS

1. The Moderator or assistant Moderator or in their absence the oldest minister (in the work) present shall call the Association into conference.

- 2. Each session shall be opened and closed by prayer.
- 3. Fourteen members from two or more associations shall constitute a quorum. A less number may adjourn until such quorum is present.
- 4. Visiting brethren are invited to seats as advisory members.
- 5. Those who speak shall arise and address the Moderator. Personal reflection shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any members and a vote taken.
 - 7. Motion made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special leave of the Moderator.
- 9. The Moderator shall not allow discussions when not carried on in a Christian spirit.
- 10. The ruling of the Moderator may be overruled by a two-thirds majority of members voting.
- 11. No question from any association shall come under the consideration of the Association unless it has first been discussed in its own Association.
- 12. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
- 13. The State Association shall have no power to fill vacancies in the delegation from any composite body.

CONSTITUTION

Preamble: From long experience, we the members of the Free Will Baptist Denomination, being regularly baptized upon the profession of our faith in Christ and realizing the necessity of a bond of union and fellowship among us as an association of churches and to preserve and maintain correspondence and coordination with us, do therefore ordain this constitution for our better denominational government.

Article 1

This organization shall be known as the State Association of Free Will Baptists of the state of California.

Article 2

The object and purpose of this organization shall be to unify the work of our churches and associated bodies of this state and to devise and execute measures of expanding our work in the cause of Christ into broader fields.

Article 3

This state association shall consist of delegates duly appointed or elected by the subordinate association they represent and all ordained Free Will Baptist ministers, their wives, all ordained Free Will Baptist deacons and their wives.

Article 4

Representation to the state association is to be by subordinate associations. Each subordinate association shall be entitled to seven delegates to be selected from the laity.

Article 5

The state association shall have the right to settle any and all questions of dicipline, doctrine or practice that may properly come before it from any of the bodies composing this organization or act upon an appeal that may be made by any church or individual which is a component part of this body. Said appeal shall have been written and properly signed by the constituent body or bodies making such appeal from the lower to the next higher body.

Article 6

Officers. The officers of this state association shall consist of a moderator, assistant moderator, clerk and assistant clerk and treasurer, each of whom shall be elected at the opening of each setting of the state association.

Section 2. Committees as necessary shall be appointed by the moderator unless otherwise provided for and shall hold office until their work is completed or thier successors are

appointed.

Article 7

The executive board shall be composed of five members. Each member shall be an ordained minister in good standing in the state association and their terms of tenure shall be as follows:

- (1) one for one year
- (1) one for two years
- (1) one for three years
- (1) one for four years
- (1) one for five years

Succession to office thereafter shall be determined as order requires.

Article 8

The state association shall hold its meetings annually, the date and place to be decided upon at each previous setting of said state association.

Article 9

Should necessity arise which calls and requires immediate action, the State Executive Board shall convene upon call of its chairman and shall take whatever action it deems necessary in the best interest of the cause of Christ. The action however shall not conflict with the purpose and edicts of the Constitution as set forth in the preceding articles.

Article 10

This constitution may be altered or amended at any regular session of the state association by a two-thirds vote of members present and voting. All proposed alterations or amendments shall be presented in writing to the body one day in advance.

CHURCH COVENANT

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God, in this solemn covenant. We promise by His Grace to love and obey Him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations to reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Savior, Jesus Christ." We will not forget the assembling of ourselves together for church conference, public worship, and the observance of the ordinance of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work. We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bond of peace, to be careful of one another's happiness and reputation, and to seek to strengthen the week, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the churches and the Gospel. We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of souls and the conversion of the

world.

ARTICLES OF FAITH

- 1. The Bible The Scriptures of the Old and New Testament were given by inspiration of God, and are our infallible rule of faith and practice.
- 2. GOD There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the Scriptures as Father, Son, and Holy Ghost, yet as one God infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.
- 3. CHRIST Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.
- 4. THE HOLY SPIRIT The Scriptures assign to the Holy Spirit, all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

- 5. THE GOVERNMENT OF GOD God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.
- 6. THE SINFULNESS OF MAN Man was created inneent, but by disobedience fell into a state of sin and condemnation. His Posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability, sin, and become guilty before God.
- 7. THE WORK OF CHRIST The Son of God, by his incarnation, life, sufferings, death and resurrestion affected for all a redemption from sin that is full and free and is the ground of salvation by faith.
- 8. THE TERMS OF SALVATION The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death.
- 9. ELECTION God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men become His elect.
- 10. FREEDOM OF WILL The human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.
- 11. SALVATION FREE God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.
- 12. PERSEVERANCE All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.
- 13. GOSPEL ORDINANCES Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; Feet Washing, an ordinance teaching humility, of universal obligation, and to be adminstered to all true believers.
- 14. TITHING God commanded tithes and offerings in the Old Testament: Jesus Christ indorsed it in the Gospel (Matt. 23:33) and the apostle Paul said, "Upon the first day

of the week let every one of you lay by him in store as God hath prospered him." (I Cor. 16:2.)

- 15. THE CHRISTIAN SABBATH The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.
- 16. RESURRECTION, JUDGMENT, AND FINAL RETRIBUTION The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked shall "go away" into eternal punishment, but the righteous into eternal life."
