The Association was called into session by the Clerk, Mr. Delmer Priest, who introduced the Assistant Moderator, Rev. F. A. McCage. The Moderator, Rev. Ralph C. Hampton, had moved from the state.

First Modesto Boys Quartet sang "He Will Lead His Children Home," and "Bound For That City."

Board of Directors for State Book Store was elected as follows: Charles Vance (5 year), Rev. Boyd Allen (4 year), Rev. Jerry Dudley (3 year), Rev. Weldon Wood (2 year), and Rev. Lonnie Rolen (1 year).

Motion carried that Rev. E. E. Morris be paid 1c per mile travel expenses as the minutes of 1959 inadvertently stated mileage to State Executive Secretary 5c and should have been 6c.

Motion carried that a standing vote of thanks be given Rev. Jerry Dudley and Mr. Charles Vance and Rev. E. E. Morris for work on "Voice" and Promotional Department.

Motion carried that salary for State Executive Secretary be \$90.00 per week and six cents (.06c) per mile travel expense and State Book Store pay house rent as long as located in the present building.

Report of Sunday School Board was given by Rev. Clark Casteel. (see reports). Rev. Charles Flynn was elected as 5 year member of Sunday School Board. Rev. O. H. Doss resigned as 4 year member of Sunday School Board. Resignation was accepted. Rev. Riley Haskins was elected as 4 year member.

Motion carried to adjourn business until Friday morning. Dismissed by Rev. J. S. Cox, Merced.

Resolution No. 1 was read and accepted.

Resolution No. 2 was read and accepted. Motion carried that Ministers Retreat be held first week of Bible Institute at Richmond.

Resolution No. 3 was brought from the table and read and accepted.

Resolutions Nos. 4 and 5 were read and accepted. Motion carried that a committee of five be elected, one from each association and one at large to serve on Policy Committee.

Rev. Jerry Dudley was elected to be recommended as member of General Board of National Association

Mr. Delmer Priest, Mrs. Charles Vance, Mrs. Vida Fry, Mr. Homer Kline, Miss Vivian Sweeten were elected as delegates to National Convention.

Mr. C. M. Goff, Mrs. Kitty Martin, Mr. Chuck Guinn, Mr. Leroy Burger, and Mrs. Adelle Ice were elected as alternates.

Motion carried that Golden Gate Association's recommendation concerning Youth Camp be given to State League Board.

### Resolution Committee:

No. 1 Whereas, we being Baptist in faith, we hereby recommend that we reaffirm our position of separation of church and state and voice our opposition to any person being elected to public office who would advocate or pledge allegiance to any hierarchy advocating oneness of church and state

No. 2 Be it resolved, that the Ministers of this state come together in a Ministers' Retreat for purposes of studying our Treatise together for one week, the place and date to be set at this conference.

- No. 3 Be it resolved, that Constitutional changes be made in Articles 3 and 6 and 7. Article 3 read "This state association shall consist of delegates duly appointed or elected by the subordinate association they represent; and all ordained Free Will Baptist ministers, their wives and all officers and members of standing boards." Article 6 read "The officers of this state association shall consist of a moderator, assistant moderator, clerk and treasurer, Executive Secretary, and such standing Boards deemed necessary, each of whom shall be elected at the closing of each setting of the state association." Article 7 read "All standing boards shall be composed of five members Each member shall be in good standing in the state association and their tenure of office shall be as follows: (1) one for one year; (1) one for two years; (1) one for three years; (1) one for four years; (1) one for five years.
- No. 4 Whereas, the members of the State League Board are the only official officers of the State Association in guiding the course of the league work, therefore be it resolved that they shall be charged with the responsibility of directing the activities of the State League Rally; accumulating reports from the district and state rallies of all of the activities within their areas and shall make this accumulated report at each setting of the association.
- No. 5 Be it resolved, that a policy committee be elected at this setting and charged to report at the next annual session a constitution designating the duties of each officer and standing board of this association

#### **Finance Committee:**

- No. 1 We recommend \$20.00 be paid the Moderator, \$35.00 paid to the clerk, and \$15.00 paid to assistant clerk.
- No. 2 We recommend that \$30.00 be sent to the National Association for minutes.
- No. 3 We recommend that each association send \$.25c per capita member to the 1961 session of the State Association.
- No. 4 We recommend that the State Association pay Rev. O. H. Doss for his moving expense to Concord.
- No. 5 After prayerful consideration of each phase of the

State work, we recommend the Cooperative Plan be allocated as follows:

National Association	27½%
State Mission Board	12½%
Christian Education	22½%
Promotional Department	37½%

### **Obituary Committee:**

2. In mental activities
  - a. By guiding our thoughts
  - b. By carefully selecting our reading material
  - c. By carefully selecting our radio and television programs
3. In social activities
  - a. By refraining from participation in questionable amusements.
  - b. By indulging only in wholesome and constructive conversation.

### **Publication Committee:**

No. 1 We recommend that this association print 1500 minutes of the proceeding of this setting of this association.

No. 2 We recommend that the publication "The Voice" be continued as the official organ of this association.

No. 3 We recommend that our Sunday Schools use literature published by the Sunday School Board of Oklahoma State Association of Free Will Baptists.

No. 4 We recommend that Sunday Schools using graded series literature, Vacation Bible School literature, and any literature or publications, purchase these through the Bible Book and Church Supply Store in Concord.

**REPORT OF STATE EXECUTIVE BOARD**

The State Executive Board met in Buena Park, August 8, 1959 with four members present. Rev. Jack Dodson was elected as Chairman and Rev. Winston Lawless was elected as clerk. The purpose of the meeting was to answer request of Rev. C. C. Hood to advise and make recommendations regarding a resolution in West Coast Association. Rev. Gene Rogers served temporarily in this meeting.

Rev. Jack Dodson Chairman called a meeting February 2, 1960. Rev. E. E. Morris, Promotional Secretary, and Rev. F. A. McCage and Mr. Pete Conner of the Board of Christian Education were present with four members of the Executive Board. The purpose of this meeting was to discuss the possibilities of establishing a Free Will Baptist Book Store. After prayerful

Morris was going back into pastoral work, the meeting was necessary to select someone to take over the operation of the store. Rev. O. H. Doss was employed to operate the store until State Association in June 29, 1960.

### **Recommendations**

- No. 1 We recommend that the Promotional Secretary's office and the operation of the Book Store be combined for the next year.
- No. 2 We recommend that the loan that was secured from the Centralization Fund be without interest and payment begin June 29, 1961 (one year from date of State Association.)
- No. 3 We recommend that a Board of Trustees or Directors be elected for Book Store.

Board met on July 1, 1960 and organized with Rev. Jack Dodson elected as Chairman and Rev. Winston Lawless as Clerk.

## BY-LAWS

1. The Moderator or assistant Moderator or in their absence the oldest minister (in the work) present shall call the association into conference.

2. Each session shall be opened and closed by prayer.

3. Fourteen members from two or more associations shall constitute a quorum. A less number may adjourn until such quorum is present.

4. Visiting brethren are invited to seats as advisory members.

5. Those who speak shall rise and address the Moderator. Personal reflections shall be avoided in all debates.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and vote taken.

7. Motion made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. The Moderator shall not allow discussions when not carried on in a Christian spirit.

10. The ruling of the Moderator may be overruled by a two-thirds majority of members voting.

11. No question from any association shall come under the association unless it has first been discussed in its own association.

12. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.

13. The State Association shall have no power to fill vacancies in the delegation from any composite body.

# CONSTITUTION

**PREAMBLE:** From long experience, we, the members of the Free Will Baptist Denomination, being regularly baptised upon the profession of our faith in Christ and realizing the necessity of a bond of union and fellowship among us as an association of churches and to preserve and maintain correspondence and coordination with us, do therefore ordain this constitution for our better denominational government.

## Article 1

This organization shall be known as the State Association of Free Will Baptists of the State of California.

## Article 2

The object and purpose of this organization shall be to unify the work of our churches and associated bodies of this state and to devise and execute measures of expanding our work in the cause of Christ.

## Article 3

This state association shall consist of delegates duly appointed or elected by the subordinate association they represent, and all ordained Free Will Baptist ministers, their wives, all ordained Free Will Baptist deacons and their wives, all officers and members of standing boards.

## Article 4

Representation to the state association is to be by subordinate associations. Each subordinate association shall be entitled to one delegate per each fifty members.

## Article 5

The state association shall have the right to settle any and all questions of discipline, doctrine or practice that may properly come before it from any of the bodies composing this organization or act upon an appeal that may be made by any church or individual which is a component part of this body. Said appeal shall have been written and properly signed by the constituent body or bodies making such appeal from the lower to the next higher body.

## Article 6

**Officers:** The officers of this state association shall consist of a moderator, assistant moderator, clerk, assistant clerk and

treasurer, Executive Secretary and such standing boards deemed necessary, each of whom shall be elected at the closing of each setting of the state association.

Section 2. Committees as necessary shall be appointed by the Moderator unless otherwise provided for and shall hold office until work is completed or their successors are appointed.

### **Article 7**

All standing boards shall be composed of five members. Each member shall be in good standing in the state association and their tenure of office be as follows: (1) one for one year; (1) one for two years; (1) one for three years; (1) one for four years; (1) one for five years. Succession to office thereafter shall be determined as order requires.

### **Article 8**

The state association shall hold its meetings annually. The date and place to be decided upon at each previous meeting of said state association.

### **Article 9**

Should necessity arise which calls and requires immediate action, the State Executive Board shall convene upon call of its chairman and shall take whatever action it deems necessary in the best interests of the cause of Christ. The action however shall not conflict with the purpose and edicts of the Constitution as set forth in the preceding articles.

### **Article 10**

This constitution may be altered or amended at any regular session of the state association by a two-thirds vote of members present and voting. All proposed alterations or amendments shall be presented in writing to the body one day in advance.

### **Article 11**

No minister will be received into this association who cannot obtain a recommendation from the association from which he comes, and that said association be a member of the state or national association.

### **Amendment 1**

No person shall serve on more than one standing board of this association.

## CHURCH COVENANT

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His Grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the scripture, secret prayer, family devotion, and social worship, and by self denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Savior, Jesus Christ." We will not forsake the assembling of ourselves together for church conferences, public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work. We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity of the Spirit in the bonds of Peace, to be careful of one another's happiness and reputation, and to seek to strengthen the weak encourage the afflicted, admonish the erring and as far as we are able, to promote the success of the church and the Gospel. We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme, counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday School, and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

## ARTICLES OF FAITH

**1. The Bible.** The Scriptures of the Old and New Testament were given by inspiration of God and are an infallible rule of faith and practice.

**2. God.** There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the Scripture as Father, Son, and Holy Ghost, yet as one God infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.

**3. Christ** is God manifest in the flesh; in His divine nature truly God, in His human nature, truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.

**4. The Holy Spirit.** The Scriptures assign to the Holy Spirit, all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

**5. The Government of God.** God exercises a wise and benevolent providence over all being and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

**6. Sinfulness of Man.** Man was created innocent, but by disobedience fell into a state of sin and condemnation. His Posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

**7. The Work of Christ.** The Son of God, by His incarnation, life, suffering, death, and resurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.

**8. The Terms of Salvation.** The conditions of salvation are: 1. Repentance of sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey him in all things. In the exercise of saving faith the soul is renewed by the Holy spirit, freed from the domination of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

**9. Election.** God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men become His elect.

**10. Freedom of Will.** The human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

**12. Perseverance.** All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.

**13. Gospel Ordinances.** Baptism, or the immersion of believers in water, and the Lord's Supper are ordinances to be perpetuated under the Gospel; Feet washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers. e

**14. Tithing.** God commanded tithes and offerings in the Old Testament: Jesus endorsed it in the Gospel (Matt. 23:33) and the apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him." (I Cor. 16:2).

**15. The Christian Sabbath.** The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

**16. Resurrection, Judgment, and Final Retribution.** The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked shall "go away into eternal punishment, but the righteous into eternal life"
