

## **RESOLUTION COMMITTEE**

1. Recommendation from Center Association. "Be it resolved that the Center Association of Free Will Baptists recommend to the California State Association that it be recommended to the National Association that no local church be permitted to represent directly to the National.

In cases where there is a single local church in a state, that church should be encouraged to unite with the nearest association that holds membership in the National following the example of the Ancorage, Alaska, church that has united with the Northwest Association." Carried.

- 2. Be it resolved that the names of the deceased members be reported each year by the local church to the district association and from the district to the state association and said names be listed in district and state minutes.
- 3. Be it resolved that the people be admonished to support the Cooperative Plan of support as has been recommended through the years.
- 4. Be it resolved that a standing vote of thanks be given to the Garden Grove Church for their hospitality shown the State Association while meeting in their beautiful new sanctuary.

## FINANCE COMMITTEE

- changed 1. We recommend that \$35.00 be paid to the Moderator, \$25.00 to the Assistant Moderator, \$55.00 to the Clerk-Treasurer, and \$35.00 to the Assistant Clerk-Treasurer.
- 2. We recommend that \$55.00 be sent to the National Association for representation fees.
- 3. We recommend that each district association represent with \$.25 per capita member for the 1975 session of the state association.
- 4. We recommend that \$200.00 be given to guest speaker, Rev. Roger Reed, Director of the National Sunday School Department.
- 5. We recommend that the support through the Cooperative Plan be allocated as follows:

6. We recommend that the state clerk-treasurer be responsible for the printing and mailing of "The Voice," the bookkeeping of the state office, and be paid \$175.00 per month for his/her labors.



We recommend:

- 1. That 650 minutes be printed.
- 2. That "The Voice" be printed bi-monthly beginning September 1974, and that it be sent to churches in bundles at a subscription rate of \$2.00 per individual copy annually (subscription price to be paid in advance), and that the state clerk-treasurer send a letter immediately to every church in the state informing each church locally of this change (subscription form to be enclosed with each letter). All this to be contingent upon Post Office approval.
- 3. That a ten-person Historical Commission, chaired by Jack L. Williams, be elected by the state association for the purpose of writing and publishing in book form a History of California Free Will Baptists, to be completed by 1980.

# **OBITUARY COMMITTEE**

We report that God in his infinite wisdom has called several from our midst. We have no report at this time as to the number, or names of the ordained. We recommend a moment of silent prayer in memory of those that have gone on to be with the Lord.

## **TEMPERANCE COMMITTEE**

Preamble:

We believe that the responsibility of this committee is to bring before the body of the Association a meaningful report which calls for a relevant response from our people; we feel that the report and recommendations which we bring must have as its basis the statement of the Word of God in I Corinthians 6:19, "What! Know ye not that your body is the temple of the Holy Ghost, which is in you, which ye have of God, and ye are not your own?" As Christians and Free Will Baptists we must be personally and deeply concerned about every moral issue.

1. With the increasing acceptance of social drinking and the all too evident

evil results of the use of alcohol, we urge all our people to not only accept but also actively promote the standard of total abstinence, to do so as a meaningful aspect of their Christian witness. And that they have no part in any area of either the production or sale of any intoxicating beverages.

- 2. We recommend to our people that they totally refrain from all use of tobacco in any form.
- 3. With the appalling growth of the vile disease of pornography, we recommend:

- a. That all our parents be much more alert and concerned about all that their children watch and read; this includes some of the books, etc. that are set for reading by some of our schools.
- b. That our people accept as their responsibility under our holy God the need to actively take the initiative in any community program which is aimed at not only resisting the continuing spread of pornography, but to turn it back.
- 4. We believe that our people should be much more concerned about the influence of the modern music which so many of our young people listen to, including:
  - a. Rock and roll, because it encourages radical attitudes and actions which are totally foreign and repugnant to our Free Will Baptist heritage.

  - b. Country and western, as it has increasingly encouraged attitudes of immorality and rejection of true Christian relationships.
  - c. So-called Gospel Rock, which although it masquerades as Christian, has very little in the way of true Gospel value or use in edification.
- 5. We feel that the Association must speak clearly and decisively to the challenge of movie films and their influence.
  - a. The Exorcist, which is a weapon of the devil which promotes and vaunts his power, exalts the Roman Catholic Church, and uses behavior and language that is completely immoral. Our people should be warned to have nothing to do with this film.
  - b. In general, movies are increasingly a threat to the moral and spiritual health and growth of our people, being marked as they are by an increasing moral degeneration in content and expression. Christians should abstain from having any part of such a pagan atmosphere.
- 6. We believe that Free Will Baptists must reassert their stand against the practice of mixed bathing, recognizing that it is a threat to the moral and spiritual lives of our people.
- 7. Finally, we recommend, that in every area of life, conduct, dress and witness the Free Will Baptists of California accept positively the Biblical standard of personal holiness for the glory of the Lord, and that the adults in our churches, both by precept and example, seek to effectively encourage our youth to overcome all these and the many other temptations which constantly confront them.

# <u>RETROSPECT</u> 1973-1974 DIGEST OF REPORTS

During 1974 the western vanguard of the National Association of Free Will Baptists flourished in California despite geographical coexistence with the infamous Los Angeles SLA shootout, San Francisco's Zebra killings and the continuing antics of the San Clemente Watergate stars.

California churches grappled with spiraling cost-of-living increases and paralyzing wage freezes. They adjusted and then readjusted to galloping gasoline prices. They watched the ebbing tide of "street people" life styles dwindle from the freeways and retreat to centralize in the ever-restless campus hotbeds which spawned the do-your-own-thing philosophy nearly a decade ago. THE church in California society did not change; the society around the church did.

The Free Will Baptists in California quietly maintained an upward trend begun almost three decades ago. This year the total giving through the State Promotional Department proper topped \$76,000, an increase for the fiscal year of \$15,000. National Home Missions giving in the state jumped \$9,500. National Foreign Missions giving up \$2,500. Total gifts through the State Office for National Home Missions was \$15,700, National Foreign Missions weighed in at \$16,000. CCC Co-op funds climbed \$3,000 over last year.

But a somber note! State Home Missions funding was off \$1,000. Although total Co-op monies were up \$500, five churches which had been supporting the Cooperative Plan financially dropped out of the Co-op picture since the last State Association. The seven churches which began supporting cooperatively helped offset the vacancies left by the five.

Accumulated gifts for the printing of "The Voice" tallied \$322.06 from twenty-five churches. Twenty-five churches pay for "The Voice"; eighty churches receive it!

In the past twelve months the Hanford Church grew from a mission to a church through an expansion program to a new sanctuary supporting all phases of state and national work every step of the way. Village Chapel Church in Ceres leads the state in giving to foreign missions and state home missions. El Sobrante is at the forefront in national home missions gifts while Memorial Church in Fresno does the same in CCC giving.

Every church record is here in stark black and white facts.



I. What progress has the west coast Free Will Baptist Bible College made for 1973-1974?

Having footed the bill for another fiscal year, every supporting Free Will Baptist has the right to expect, and is entitled to, an answer. CCC has made some reportable progress through the year. Three areas:

A. Outstanding personnel addition.

Mr. Sam Goossen, former missionary to China, twelve years the president of Pacific College (formerly Pacific Bible Institute), and an outstanding public school educator, joined the faculty of the College. Students throughout the year have expressed their appreciations for such an experienced and knowledgeable professor.

B. Administration building brought up to present city codes.

Much work and a considerable amount of finance went into the updating of CCC. Solid core doors, fireproof drapes, corrected wiring and plumbing, plus several other changes were called for by three major city departments. These things were not anticipated when the budget was made, but nonetheless had to be paid. All of these things, however, added to the old mansion. New carpet was put in all upstairs classrooms and in much of the downstairs area.

C. Retaining wall adds to the attractiveness of the campus on the east side.

Bill Airington (Corcoran) and his crew just simply came by and did a great job. A quick glance will catch the improvement. Many other incidental things have enhanced the looks of the campus.

- II. For what shall God be praised?
  - A. The largest on-campus student body to date.

They were mostly Californians with a representative or two from Arizona and Idaho. At times they got on each others nerves; at other times they got on each others hearts. Some of the dormitory boys were called to preach this year. The eternal attention of God keeps a vigilant watch over the dorm residents.

B. 1974 graduating class numbered fourteen.

It included two lay missionaries, two Home Missionary appointees, two pastor's wives, five pastors, two Bible College transfers

and one foreign student. This has to be the high watermark in the 1974 CCC reportable progress: The Largest Commencement in School History.

C. Construction begun on new chapel.

The large new chapel structure was far enough along so that the mid-May graduation exercises were conducted in it. The additional space provided by the chapel will greatly alleviate campus traffic jams during special conferences.

- III. Projections for the 1974-1975 year fall into three categories.
  - A. The cost of operations will reach an all-time high.

This is an irreversible trend that we must face. We are committed to giving our students the highest quality education possible. With quality education comes quality expenses. But the high cost of operating a Bible College offsets the higher cost of not having a college when we consider the alternatives.

B. Student body increase will be slow and steady, not mushrooming to astronomical figures.

CCC will never rival the California State University system in student population. This disturbs most Bible College supporters, but it shouldn't. Basically, we narrow our prospects to only the eighty Free Will Baptist churches in the state. Then we further narrow from every church to only those who feel called or led to special training in Christian education. Even so, the gradual growth could and should climb with more resolve if students in local churches are informed and encouraged by pastors.

C. Administrative and curriculum guidelines to be more clearly defined.

One of the most difficult areas in an effective college program is how to define and delegate areas of authority. Gradually, the CCC Administration is solidifying specific responsibilities in certain offices. The Academic course loads will each undergo reevaluation as the courses are scheduled to be taught.



### SATURDAY MORNING


The Saturday morning business session opened with singing led by Darwin Kelton followed with prayer by Rev. Dale Vanderburg.

## **CONSTITUTION AND BY-LAWS**

CALIFORNIA STATE ASSOCIATION of FREE WILL BAPTISTS

From long experience, we the members of the Free Will Baptist denomination, being regularly baptized upon the profession of our faith in Christ, and realizing the necessity of a bond of union and fellowship among us as an association of churches, and to preserve and maintain correspondence and coordination with us, do therefore, ordain this constitution for our better denominational government.

### **ARTICLE I - NAME**

The name of this organization shall be the California State Association of Free Will Baptists.

### **ARTICLE II - PURPOSE**

The purpose of this organization shall be to coordinate efforts and policy for the primary cause of the evangelization and unifying the efforts of its constituency in denominational work in the State of California and to aid in spreading the gospel of Jesus Christ unto the "uttermost parts of the earth."

### **ARTICLE III - DELEGATION**

Delegates to this association shall consist of two types. One shall be those defined as elected delegates representing the affiliated associations and the other shall be defined as standing delegates.

1. STANDING DELEGATES. Standing delegates shall be all ordained members of any district association being a constituent part of this association, and in good standing with the association of which they are members, their wives, all officers and members of standing boards of this association and the unmarried widows of deceased ordained members.

2. ELECTED DELEGATES. Elected delegates shall be those delegates duly appointed or elected by the affiliate association which they represent. They shall in all cases be members in good standing in the affiliated association from which they come.

Representation in this association shall be by affiliated district associations. Each affiliated association shall be entitled to one (1) delegate per each fifty (50) members. Each affiliated association shall represent by a letter giving all of the statistical information called for by this body and listing all delegates by name. Representation fees as set by this association shall



accompany the letter of information.

### ARTICLE IV - MEETINGS

This association shall meet annually. The date and place shall be chosen by the association. In the event of an emergency, the General Board shall set the date and place of the annual meeting.

## **ARTICLE V - OFFICERS and BOARDS**

The officers of this association shall be:

- 1. Moderator
- 2. Assistant Moderator
- 3. Clerk/Treasurer
- 4. Assistant Clerk/Treasurer
- 5. Executive Secretary (not being elected presently)

Each of these except the Executive Secretary shall be elected at the closing session of this association.

Committees, as necessary, shall be appointed or elected as this association shall provide, and shall hold office until their work is completed or their successors are appointed. Each board, committee or officers' meeting shall keep accurate minutes of their meetings and shall make these minutes available for reading at the request of this association.

The standing boards of this association shall be:

- 1. Mission Board
- 2. California Christian College Board of Trustees
- 3. General Board

The General Board will be elected annually and shall be governed by the following:

- 1. It shall meet at the request of the chairman or on a pre-arranged date.
- 2. It shall have an annual meeting prior to the opening session of this association.
- 3. It shall serve in the capacity of the association when the association is not in session but shall answer to this association for all actions.

Each board shall be composed of members serving terms, the number and length of term to be designated by this association, so arranged that members shall be elected in staggered terms as defined in the section of these bylaws entitled "Description of Duties." Vacancies occuring on any board shall come by reason of:

1. Resignation. Any member of any board shall be allowed to

resign at his pleasure except in cases where resignation would be to avoid discipline or an accounting of the stewardship of his office.

2. Death.

- 3. Dismissal. Members of boards may be dismissed by this association for unchristian conduct or conduct detrimental to the general welfare of this association. Any member who is declared out of fellowship or against whom charges of heresy or unchristian conduct are being pressed shall be suspended from active service on the board of which he is a member until the consummation of the charges made in the affiliated association by which he is disciplined. If found guilty of charges as described above, he shall be dismissed from this board and his position shall be declared vacant.
- 4. Removal from the territorial bounds. Any member who unites with a church outside the territorial bounds of this association shall be considered automatically dismissed from membership on the board on which he serves.
- 5. Failure to serve. Members of boards who fail to serve in the capacity allotted them shall upon the approval of this association be dismissed from the board.

No member of this association shall be allowed to serve on more than one standing board or committee at any one time nor shall any member serve as an officer and on any board or standing committee except the General Board.

# DESCRIPTION OF DUTIES

- A. The Moderator. The moderator shall be chosen by majority vote of the delegates present and voting at the closing session of the association to serve one year.
  - 1. He shall be the presiding officer at all business sessions of this association and shall be an ex-officio member of all committees and auxilities and board of this association.
  - 2. He shall maintain order in all business sessions and allow full and free debate on all issues, but recognize no one or allow debate by any demonstrating an unchristian spirit.
  - 3. He shall serve as chairman of the General Board and Executive Committee.
- B. The Assistant Moderator. The assistant moderator shall be chosen by the majority vote of the delegates present and voting at the closing session of this association to serve a term of one year.
  - 1. He shall assist the moderator in all business sessions of this association.



- 2. In the absence of the moderator, the assistant moderator shall become the moderator and be governed by the duties allotted to the moderator.
- 3. The assistant moderator shall serve as parliamentarian at all sessions of this association.

C. The Clerk/Treasurer. The clerk/treasurer shall be elected by the majority vote of the delegates present and voting at the closing session of this association to serve a term of one year.

- 1. The clerk shall keep a true and accurate record of the proceedings of the association and have same printed in book form for distribution to all affiliated associations. The clerk shall also keep an accurate record of all officers' and committee meetings. The clerk shall keep all papers and documents of this association unless otherwise ordered and shall conduct all correspondence for the association.
- 2. The clerk shall also serve as clerk of the General Board and the Executive Committee.
- 3. The treasurer shall receive and receipt all monies from whatever source contributions may be made and deposit same in a bank.
- 4. All bills and accounts owed by this association shall be paid by check drawn against the association account signed by the treasurer.
- 5. The treasurer shall give a report of all funds received and expended. The report shall be accompanied by an accurate balance sheet of approved standards of accounting.

D. The Assistant Clerk/Treasurer. The assistant clerk/treasurer shall be elected by the majority vote of the delegates present and voting at the closing session of the association to serve a term of one year.

- 1. The assistant clerk shall assist the clerk in recording the minutes of the proceedings and shall make himself available to assist in any of the labors of the clerk.
- 2. In the absence of the clerk, the assistant shall become the clerk and the duties of the clerk shall then be applied to him.

E. The Executive Secretary. The executive secretary shall be elected after his report is given, to serve a term of two years. Be it understood that upon acceptance of this position the executive secretary shall serve a minimum of six months, the sole exception being for reasons of health. In the event of his resignation, he shall give a minimum of sixty days notice. In the event of resignation or disciplinary action, it shall become the duty of the General Board to effect the dismissal and/or replace the executive secretary.

The executive secretary shall be responsible for the general promotion of all branches and departments of this association. It shall be his duty to promote the general welfare of this association with regular reports of the work made to the general membership of this body. It shall be his duty to work closely with the moderator in coordinating denominational efforts and making known by publication these efforts and their successes.

The executive secretary shall serve as treasurer of the cooperative plan of support and shall disburse the receipts as directed by this association. He shall make every effort to enlist all churches within the general framework of this association to support the cooperative plan of support with a tithe, and shall promote each department or agency of the association where designated offerings are needed or sought. All offerings received shall be forwarded to the agency to which they are directed.

He shall serve as managing editor of the VOICE or other publication.

He shall make periodic visits to each affiliated association and there inform them of the progress of the overall work of this association. Even though some other agencies may have executive secretaries, it shall be his duty to promote these agencies in the coordinated denominational effort.

F. The General Board. The personnel of the general board shall be composed of the moderator, the clerk/treasurer and the executive secretary of this association and the chairmen of all standing boards. There shall also be elected annually by this body one member for each affiliated district association.

The general board shall have power to act in behalf of, and for, this association from one regular session to another. It shall be the duty of this board to make written reports of all its work to each annual session of this association. This board shall stand liable to this body for discipline or dismissal for actions contrary to the general policy and intent of this association and these Articles and By-Laws. No decision shall be rendered by this board that will affect this association which could normally be detained and decided by this body in session.

An executive committee consisting of nine members shall be selected from the general board. This committee shall be composed of the moderator, clerk/treasurer, executive secretary, and the six members representing the affiliated associations.

The duty of this committee shall be to act on all matters coming within the scope of the work of the board when said general board is not in session.

In cases of disputes from, or within, an affiliated association, this committee shall serve as a mediatorial committee. This committee shall have no dictatorial powers whatever, but shall mediate attempts to settle such disputes as may be referred to it. If a satisfactory settlement cannot be executed by mediation, the matter shall be referred to this body in session. In no case shall either the general board or the executive committee issue a verdict or edict that could or would supercede this association in its decision.

This committee shall hear all disputes or question of discipline, doctrine, or practice that may properly come before it from any of the bodies composing this association, or any appeal that may be made by any association, church or individual person which is a component part of this body. Said appeal shall have been made in writing and properly signed by the constituent body or bodies or person making such appeal from the lower to the higher body. This committee shall be limited to making recommendations to these affected parties and if not accepted by all concerned, shall refer the signed allegation to the general board, and if mediation proves unsuccessful shall in turn refer the signed allegation to this association for final action.

G. The Mission Board. The mission board shall be composed of five members elected by popular vote of this body. Their terms of office shall be staggered from one to five years so arranged that one member shall be elected each year. In the event a member moves from the state, his membership shall terminate and the remaining members shall elect his successor until this body meets in session and fills the vacancy.

The duties of the mission board shall be to labor to further the gospel of Jesus Christ "unto the uttermost parts of the earth." In accomplishing this, they are to endeavor to establish missions and churches in communities within the bounds of this association with whatever assistance deemed necessary. Also, in cases of small churches failing to function, every assistance possible shall be rendered to maintain the effective witness of that church.

The promotion of missionary endeavors from a local, state and

national level of both home and foreign nature shall be the obligation of this board. The board shall assist in maintaining prayer and financial support to the entire missionary program of the denomination.

This board shall orient itself and elect its own officers.

This board, being an agency of this association, shall be empowered to have its own constitution and by-laws, which shall not be repugnant to this constitution or the general policy of this association.

The treasurer of this board shall receive and receipt all monies coming to it from all sources. The money shall be deposited in a bank or banks and all debts and accounts of this board shall be paid by check drawn against this treasury and signed by the treasurer.

Accurate minutes shall be kept of all meetings of this board and shall be available for reading at the request of this association. A complete report of all activities of this board shall be made in writing to this association while in session and an accurate balance sheet of approved standards of accounting of all funds received and disbursed shall accompany these reports and shall be signed by the officers of this board.

H. California Christian College Board of Trustees. The California Christian College Board of Trustees shall be composed of nine members to be elected by popular vote of this body. Therir terms of office shall be so arranged that one member shall be elected each year to serve a term of nine years. In the event a member moves from the state, his membership shall terminate and the remaining members shall select his successor until this body meets in session and fills the vacancy.

The Board of Trustees shall establish and promote a high standard of Christian education within the framework of this association. In the consummation of its duties this board shall promote a high level academic institution wherein fundamental, orthodox, evangelical training may be obtained by those availing themselves to higher education. The highest academic standard possible shall be attained and maintained. The doctrines of Free Will Baptists as defined in the "Treatise of Faith and Practice of Original Free Will Baptists" published by the National Association of Free Will Baptists shall be the guiding theological position of the institution.

This board shall orient itself and elect its own officers. It shall meet upon call of its chairman at any time.

This board, being an agency of this association, shall be empowered to have its own constitution and by-laws which shall not be repugnant to this constitution or the general policy of this association.

An accurate record shall be kept of all meetings of this board and shall be available for reading at the request of this association. A complete report of the activities of this board shall be made in writing to the annual session of this association with an accurate account of all receipts and disbursements made. An accurate balance sheet of approved standards of accounting shall accompany the reports and shall be signed by the officers of this board.

This board shall seek to work harmoniously with the other denominational academic institutions.

# **ARTICLE VI - CHURCH GOVERNMENT**

The government of this association shall be congregational in form and democratic in its practice. Congregational church government shall be defined as: "The local church is an independent body, as far as it relates to its own government, the transaction of its business, the choice of its officers, and the disciplining of its members. The local church holds the deed of its own property and is responsible for its own financial obligations and there is no authority by any ecclesiastical power that can revert or change the decision of the local church. When a majority of a congregation in regular conference votes for or against, their decision cannot be reversed by any other authority." However, an appeal may be made by common consent by an aggrieved minority to the quarterly meeting for mediation. If the quarterly meeting or other associations are dissatisfied with the ruling of the majority of a local church, they may withdraw the hand of fellowship from the local church but it still leaves the local congregation in full charge of the church property and cannot



interfere with its decisions any further.

### ARTICLE VII - DISCIPLINE

This association shall have the right and authority to discipline its members and shall be recognized as the final ecclesiastical, tribunal within the state of California for Free Will Baptists.

### **ARTICLE VIII - AMENDMENTS**


These By-Laws may be amended by a two-thirds majority vote of the delegates present and voting at any session of this association provided that all proposed amendments are presented in writing to the association one day in advance of action upon the proposed amendments.

#### **CHURCH COVENANT**

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by His grace, to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel; nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness,

and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

### ARTICLES OF FAITH

1. THE BIBLE. The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

2. GOD. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the Scriptures as Father, Son, and Holy Ghost; yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. CHRIST. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Saviour and Lord.

4. THE HOLY SPIRIT. The Scriptures assign to the Holy Spirit all the attributes of God.

5. THE GOVERNMENT OF GOD. God exercises a wise and benevo-

lent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.

6. THE SINFULNESS OF MAN. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

7. THE WORK OF CHRIST. The Son of God by His incarnation, life, sufferings, death, and resurrection effected for all a redemption from sin that is full and free, and is the ground of salvation by faith.

8. THE TERMS OF SALVATION. The conditions of salvation are:
 1. Repentance or sincere sorrow for sin and hearty renunciation of it.
 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. 3. Continuance in faith and obedience until death.

9. ELECTION. God determined from the beginning to save all who should comply with the conditions of Salvation. Hence by faith in Christ men become His elect.



10. FREEDOM OF THE WILL. The human will is free and selfcontrolled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

11. SALVATION FREE. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. PERSEVERANCE. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

13. GOSPEL ORDINANCES. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER, are ordinances to be perpetuated under the Gospel. FEET WASHING, an ordinance teaching humility, is of universal obligation, and is to be ministered to all true believers.

14. TITHING. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23;23), and the apostle Paul said, "Upon the first day of the week let every one of you lay by him in store, as God hath prospered him" (I Cor. 26:2a).

15. THE CHRISTIAN SABBATH. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

16. RESURRECTION, JUDGMENT, AND FINAL RETRIBUTION. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."
