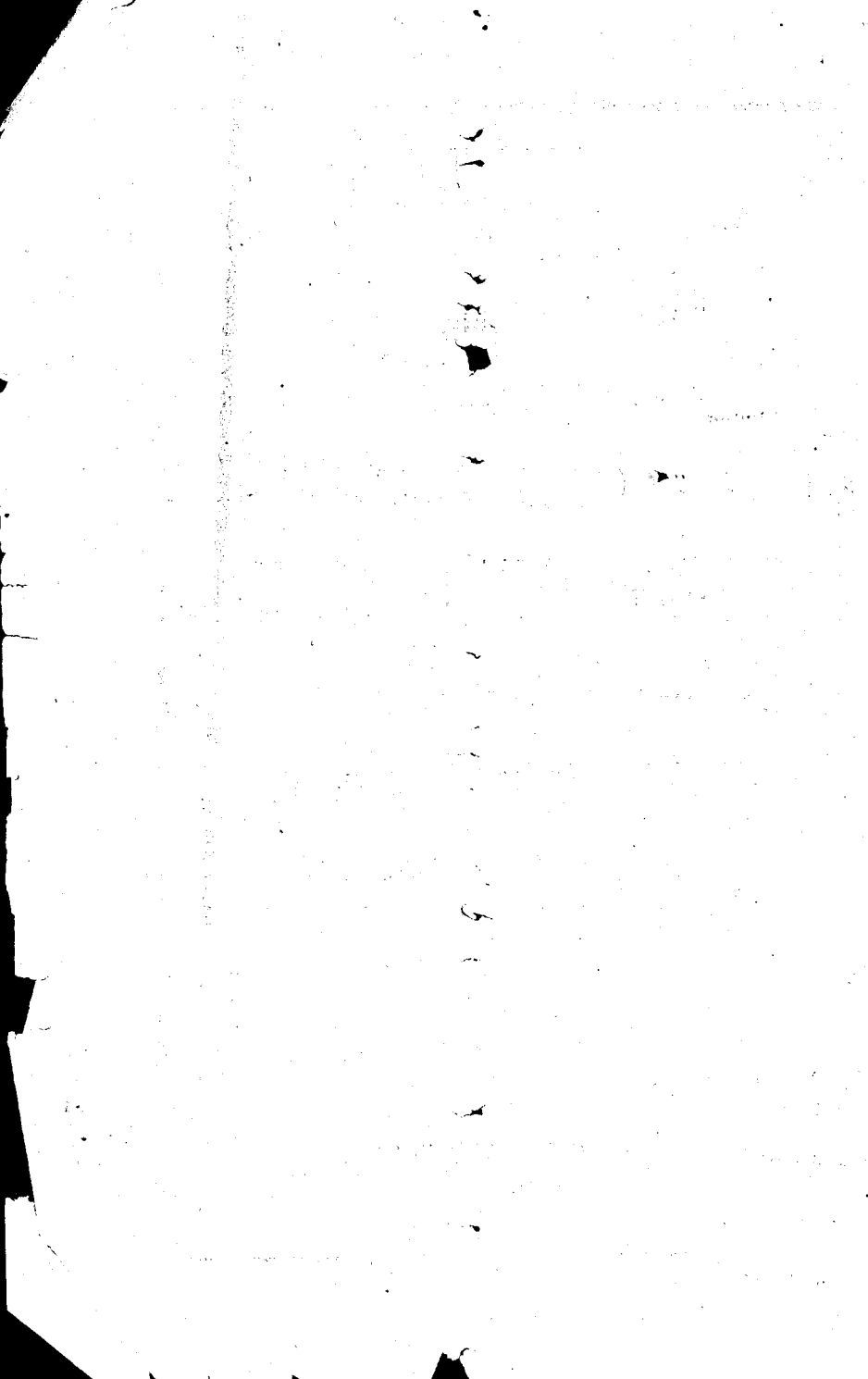

PROCEEDINGS.

FIRST DAY.

COLYER'S CHAPEL CHURCH, CUMBERLAND Co., N. C.
THURSDAY, Nov. 6th, 1884.

The congregation assembles and in the absence of Elder Hill, who was elected by last Conference to preach the introductory sermon, Elder Fowler his alternate being present, proceeds and preaches the introductory sermon from Acts, 10c. 33v.

After an intermission of 10 minutes, Conference is called to order by Elder R. A. Johnson, the assistant Moderator. The names of members present are enrolled as follows:

In the absence of the former Moderator, J. F. Hill, Elder R. A. Johnson is elected Moderator of this Conference, and calls to his assistance Elder Wm. Byrd. The Secretary being present, tenders his resignation, which is accepted, and the names of A. W. Gregory, J. P. Canaday and N. H. Lucas are put in nomination for Secretary. Elders Byrd and Lee, are appointed Tellers for the same. Bro. A. W. Gregory is elected Secretary of the Conference and calls to his assistance Bro. James P. Canaday.

The call for petitionary letters is made, and a letter is presented from New Chapel Church, asking for admission as a member of this Conference, which is granted and the name of her delegate, Devereaux Crocker enrolled.

The name of Elder B. W. Nash of the Union Association is enrolled as a visiting minister; also the name of Rev. E. Pope, of the M. E. Church is enrolled a visiting minister.

The Moderator appoints a committee on religious exercise consisting of the Pastor and Delegates of Colyer's Chapel Church.

On motion, Bro. H. W. Jernigan is elected Treasurer of this Conference.

Committee on religious exercise report to preach on tomorrow, Elder Moore followed by Rev. E. Pope. 9:30 is the time agreed on to meet to-morrow morning.

On motion, Conference adjourns. Devotional exercise by Elder Johnson.

SECOND DAY.

FRIDAY, Nov. 7th.

Conference opens at 9:30 A. M., with devotional exercises by Elder John Moore. Roll is called and members answer to their names. Elder Robert Strickland arrives and his name is enrolled. The names of J. L. Blackman, J. B. Jernigan and W. B. Jernigan delegates from New Hope; J. W. Lucas, Delegate from Pleasant Grove; and J. N. Gregory and J. P. Stepenson, delegates from Union Springs, are enrolled.

Minutes of yesterday are read and approved.

On motion, it is agreed that any member of this Confer-

ence being absent at roll call, shall pay a fine, not less than five nor more than ten cents.

Bro. J. G. Johnson is added to the committee on obituaries, and the committee allowed until the next annual meeting of the Conference to make a report.

On motion, the committee on Discipline is discharged. Elder R. A. Johnson is added to the committee on Temperance; and Brethren N. H. Lucas, W. H. Barber and J. J. Wade are appointed a committee on Finance. Letters from the churches are read, and by their tidings it is conceded that more interest and greater encouragement are attained, than has heretofore been perceivable.

Conference adjourns thirty minutes for dinner. Leave of absence is granted Elder William Byrd, for the remainder of the day. The question of Union is made a special order of business for to-morrow at 1 o'clock, P. M.

Committee on religious exercise report to preach to-morrow Elder Lundee Lee followed by Elder B. W. Nash. Elder Nash by his own request is excused from service at the stand, and by the request of the committee, Elder Pope occupies the time.

On motion, the time agreed upon to meet is to-morrow at 9:30, A. M.

On motion, Conference adjourns with devotional exercise conducted by Elder Fowler.

THIRD DAY.

SATURDAY, Nov. 8th.

Conference is opened at 9:30 A. M., with religious exercise conducted by Elder Lundee Lee. The names of J. M. Avery of Prospect, and Daniel Faircloth of Pleasant Grove, are enrolled as delegates.

Roll is called and members answer to their names. Elder William Byrd, and brethren I. W. Wade, J. J. Wade and J. P. Canaday are absent.

Minutes of yesterday are read and approved.

On motion, the order of business of 1883 is adopted for 1884. The rules of business is suspended and the hearing of reports

of the several committees is made a special order for 2 o'clock, P. M.

On motion, it is agreed that the Moderator shall decide what the fine of the delinquents shall be. The decision is that each member who is absent at roll call pay ten cents.

Resolution offered by Elder Lundee Lee is received, and after discussion is adopted. (See Resolutions).

Resolution of Elder John Moore, and amended by Elder Byrd, is received and adopted. (See Resolutions).

A committee consisting of Bro. N. H. Lucas, of Bethsaida, Ransom West, of Shady Grove, J. G. Johnson, of Prospect, J. B. Jernigan, of New Hope, and J. P. Canaday, of Johnson's Chapel, are appointed a committee, to look after the general character and deportment of the ministers of Cape Fear Conference, and make a report at each annual Conference.

The name of Bro. R. C. Wallace is enrolled as a licentiate.

Petitions for the next Conference were voted on, and it was decided that the next session be held with Pleasant Grove church, Harnett county, N. C., commencing on Thursday before the second Sunday in November, 1885.

On motion, Elder William Byrd is elected to preach the introductory sermon; Elder John Moore alternate.

On motion, the fines which have been collected are paid to the Treasurer of this Conference.

An intermission of 30 minutes is taken for dinner.

The letters from the churches show, that a majority of them voted to continue their connection, with the United Baptist Conference.

The Union subject is harmoniously discussed by Elders Nash, Johnson, Byrd and others.

On motion, Conference agrees that each church of the Cape Fear Freewill Baptist Conference, elect and send one or more representatives to the United Conference to be held in the year 1885.

On motion, the report of the Sunday School Board is received. (See Report.) Bros. J. G. Johnson and J. R. Barnes of the Sunday School Board tender their resignation which is accepted.

The report of the committee on soliciting funds for the purpose of erecting a Monument over the grave of Elder

Turnage, is received and committee continued. See Report.

On motion, it is agreed that the United Baptist Conference will be held with Hood Swamp Church, Wayne Co., N. C., Thursday before the fourth Sunday in October, 1885.

The report of the Finance Committee is received, and committee discharged. (See Report.)

On motion, the Secretary is ordered to have 500 copies of the proceedings of this Conference published and he is allowed \$10.00 for his services out of the remainder of funds in hand, after paying for printing and distributing the same.

Committee on Temperance, is granted further time to report.

Committee on religious exercise report to preach to-morrow at the stand, Elder Johnson followed by Rev. B. W. Nash.

A vote of thanks is tendered the people of this vicinity for the kindness and hospitality shown to us during this session.

On motion the report on religious exercise is received and committee discharged.

The funds in the hands of the Treasurer amount to \$33.15 and is paid to the Secretary of this Conference.

The minutes of the day are read and adopted.

Conference adjourns with closing remarks and devotional exercise, by Elder R. A. Johnson.

CONSTITUTION.

ARTICLE 1. This body shall be known as the Cape Fear Free-Will Baptist Conference.

ART. 2. The object of this Conference shall be to promote Christ's kingdom among men by means in strict conformity to the Holy Scriptures.

ART. 3. This Conference shall be composed of its own officers, of the ministers who are members of the churches belonging to the body, of delegates from the churches, each church being entitled to three delegates, and one representative from each Board and Standing Committee.

ART. 4. The delegates from each church shall bear to the Conference a letter certifying their appointment, showing the condition and statistics of the church, and giving a statement of all funds raised during the year for denominational or other benevolent purposes.

ART. 5. The officers of this body shall be a Moderator, Treasurer, Corresponding and Recording Secretary, who shall remain in office until their successors are elected.

ART. 6. This Conference may, at each regular meeting, elect as many Boards or Standing Committees as may be necessary in carrying out its benevolent purposes. These shall keep a record of their proceedings and make a report at each regular meeting of this Conference.

ART. 7. Any church desiring to become a member of this body shall present her petition at a regular session of Conference through delegates appointed for that purpose. If she be received, the Moderator shall extend to her delegates the hand of fellowship.

ART. 8. The Conference may extend to visiting brethren all the privileges of the body save that of voting.

ART. 9. This Constitution may be amended at any regular session by a vote of four-fifths of the members present.
