

FIRST DAY—NOVEMBER 3, 1898.

## SECOND DAY—NOVEMBER 4.

On motion by Bro. D. R. Jones, the next session of the Cape Fear Conference will be held with the church at Wood's Grove, Wayne county, N. C. Wood's Grove is about eight miles northeast of Goldsboro.

Pleasant Grove and Shady Grove petition for the first session of the Southern Cape Fear Conference.

By vote the first session of the Southern Cape Fear Conference will be held with the church at Pleasant Grove, Harnett county, N. C. Pleasant Grove is about 3½ miles northwest of Dunn.

On motion the Southern Cape Fear Conference convenes Thursday before the second Sunday in Oct. 1899, at 12 m.

Stewart to keep a minute of the day. After the necessary arrangements were made the different classes arranged themselves, and after offering prayer, proceeded to sing according to the programme. Number of classes present, 9; number of reports, 5.

We ask the pastors of the different Churches to lecture some time during the year on the subject of Sunday Schools, and ask the Schools to send in reports.

## RESOLUTIONS.

Resolution by N. W. Colville as amended by A. W. Gregory, 1898.

Believing that the interest of the churches demand, and in order to extend the bounds of the Conference; therefore, be it

*Resolved*, That the committee of five equalizing the work of the ministry be elected every two years as other officers are now elected by the body.

Resolution by A. W. Gregory, 1890.

*Resolved*, That after the ensuing year closes no minister's name shall be continued upon the minutes of the Cape Fear Conference unless he present himself at each annual Conference either in person or by letter.

Resolution by Elder John Moore, 1894, as amended by Elder William Byrd.

*Resolved*, That a committee of five laymen, members of the Cape Fear Conference, be appointed to have an over-sight of the character of the ministers of this Conference and that said committee report at each annual Conference.

Amendment. That the committee shall constitute a part of said Conference.

Resolution by Elder Lunda Lee, 1893:

Seeing the necessity of a better system of Sabbath School work, be it, therefore, resolved,

First. That this Conference organize a Sabbath School Convention, to be held on Saturday before the first Sunday in October of each year.

Second. That this body elect the necessary officers to govern said Convention, who shall remain in office until their successors are elected.

Third. That each Sabbath School is entitled to one representative, whose duty it shall be to carry a report of his School.

Fourth. That a condensed report of said Convention be made yearly on our minutes.

Fifth. That visiting classes be made welcome in said Convention.

Resolution by A. W. Gregory, 1893:

*Resolved*, That the Church Letters state to each Annual Conference the number of male and female members in their respective Churches.

Resolution by I. W. Taylor, 1895:

WHEREAS, The present system of Churches in regard to the work of the ministry is insufficient; therefore, be it resolved,

First. That this Conference appoint a committee of five of its members to assign the work of the ministry to the Churches composing this Conference.

Second. That the Clerk of each Church in the Conference is requested to correspond with the chairman of this committee immediately after the appointment of the pastor assigned that Church and inform him whether or not the Church is having preaching.

Third. That said committee shall have power to investigate any rumor or general report against any minister and remove him from any work assigned him and report same to the next Annual Conference for final action, and fill any vacancies.

Fourth. That all laws and clauses of laws in conflict with this act be, and the same is, hereby repealed.

Fifth. That these resolutions shall be in force from and after their ratification.

Resolution by W. A. Jackson, 1898:

*Resolved*, That no class be allowed to sing in Sunday School Convention unless it brings a report of its work during the year.

Resolution by John L. Ennis, 1898:

*Resolved*, That Article V. of the Constitution be, and the same is, hereby amended, to read as follows:

"The officers of this body shall be a Moderator, Treasurer, Corresponding and Recording Secretary, who shall be elected for a term of two years, and said election to take place one year prior to their entering upon the duties of said offices.

Resolution by J. W. Lucas, 1898:

*Resolved*, That this Conference recommend the discontinuance of fermented or intoxicating wine, and the fruit of the vine be used in the sacramental services in the local churches of the Cape Fear Free-Will Baptist Conference.

Resolution by J. E. Wilson, 1898:

Owing to the extensiveness of the Cape Fear Conference and its extreme boundaries, we think it every way better for a mutual division for the convenience of the weak churches; therefore, be it resolved,

First. That this body appoint a committee to draw up the boundary lines and report at the sitting of this Conference of proposed mutual division.

Second. Said committee shall bring in a name for that group of churches to be organized into a new Conference.

Resolution by F. M. Dameron, 1898:

Seeing the necessity of knowing the value of the Church property belonging to the Cape Fear Free-Will Baptist Conference, be it, therefore, resolved,

First. That the Clerk of each local church be requested to state the aggregate value of their church property each year in their church letter.

Second. That the Secretary shall make up the total aggregate of said churches and state same on each minute.

## CONSTITUTION.

ARTICLE I. This body shall be known as the CAPE FEAR FREE-WILL BAPTIST CONFERENCE.

ARTICLE II. The object of this Conference shall be to promote Christ's Kingdom among men by means in strict conformity to the Holy Scriptures.

ARTICLE III. This Conference shall be composed of its own officers of the ministers who are members of the churches belonging to the body of delegates from the churches, each church being entitled to three delegates and one representative from each Board and Standing Committee.

ARTICLE IV. The delegates from each church shall bear to the Conference a letter certifying their appointment, showing the condition and statistics of the church, and giving a statement of all funds raised during the year for denominational or other benevolent purposes.

ARTICLE V. The officers of this body shall be a Moderator, a Treasurer, Corresponding and Recording Secretary, who shall be elected for a term of two years, and said election to take place one year prior to their entering upon the duties of said office.

ARTICLE VI. This Conference may, at each regular meeting, elect as many Boards or Standing Committees as may be necessary in carrying out its benevolent purposes. These shall keep a record of their proceedings and make a report at each regular meeting of this Conference.

ARTICLE VII. Any church desiring to become a member of this body shall present her petition at a regular session of Conference through delegates appointed for that purpose. If she be received, the Moderator shall extend to her delegates the hand of fellowship.

ARTICLE VIII. The Conference may extend to visiting brethren all the privileges of the body, save that of voting.

ARTICLE IX. This Constitution may be amended at any regular session by a vote of four-fifths of the members present.
