# OBITUARIES.

We, the Committee on Obituaries, beg to submit the following report: Elder S. B. Thain departed this life July 25th, 1901. He was born in Annapolis, Nova Scotia, Nov. 4th, 1806. He joined the Sabbath School first in New York City at the age of eight years, and was a Sabbath School attendant for 86 years. He first joined the Missionary Baptist Church at Wilmington, N. C., in 1842. In 1850 he moved to Johnston county, North Carolina, and served Smithfield Baptist Church as deacon for a number of years. After the Civil War, he purchased a farm near Bentonsville, N. C., where he lived the remainder of his life. In 1866, he connected himself with the

Free Will Baptist Church. In 1870, he was ordained and given pastoral charge of New Hope Church. He was a faithful soldier in the Master's army till death. Elder D. R. Stafford conducted the burial service using the 103d Psalm. He had expressed his readiness to die, and all who knew him had the utmost confidence in him. May the God of all grace and love bless and keep his beloved family till Jesus comes. "It is not all of life to live nor all of death to die," and while his body has been taken from our presence by reason of death, yet his influence still lives with us and we believe our loss is his eternal gain.

# REPORT OF COMMITTEE ON EDUCATION.

We, the Committee on Education, respectfully submit the following report: Owing to the fact of a great need of ducational training and equip ment in our ranks, and believing that this brotherhood is desirous of coping with other denominations and doing her utmost in the advancement of truth-her Mission-the work of her Head even Christ; We, therefore, recommend for the consideration of this honorable body: First, The establishment of a school, which shall be an educational centre for the Conference; that a Board of Directors consisting of twelve brethren be elected to have the supervision of the school; that five of the Board of Directors shall compose a committee on Location and Arrangements. Second, The establishment of a paper as a medium of circulation and communication; that the Board of Directors appointed for the school shall have the supervision of the management of the paper. Third, That a special prayer be offered and that the Brotherhood be requested to invoke God's blessings upon this work.

On motion by Eld. A. J. Bordeaux, the first four named of above Board of Directors are elected for a term of three years, and the next four for a term of two years, and the last four for one year.

# REPORT OF COMMITTEE ON LOCATION AND ARRANGEMENT.

We, the Committee selected out of the Board of Directors met at Stony Run Church on the 14th day of November, 1901, and after hearing propositions and offers adopted the following offer by Bro. W. J. Powell:

Location at Beulah, three and one-half miles from Clinton, N. C., including 13 acres of land, one good School House furnished with stoves and one good plano—all valued at one thousand dollars at, a cost to the Conference of two hundred and eighty only. Also, in connection with this property is a suitable building for the Printing Press; and we also agree to purchase it, if it can be bought for thirty dollars, as is supposed it can be.

We ask all the local churches through their clerks and pastors to raise

and send in at once to our treasurer, Ransom West, Timothy, N. C., an amount equal to 20 cents per capita of the church membership, for purchasing site, preparing building to put the press in, &c.

We ask all the members of the Board of Directors to meet us promptly

at Beulah, N. C., on Tuesday, Dec. 17th, 1901, at 11 o'clock a. m.
