The following motion by Rev. B. P. Parks and amended by Bro. W. A. Jackson, was offered and adopted:

On motion that all ministers be and are hereby required to comply with the rules set forth in our discipline in receiving members into the church, also in carrying out any other pastoral work. Amended: That the committee on Ministerial Labor be required to make a thorough investigation each year of the work of each minister as to his loyalty in complying with all the rules of order as set forth in the book of discipline, and that they make report from time to time of any that shall fail to acquaint himself with, and comply to the same.

A committee on religious exercise report to preach at 11 A. M., Elder W. B. Everett. At 7 P. M., Elder W. H. Lancaster and Elder H. R. Faircloth. Sunday 10:30 A. M., Elder D. C. Johnson and Elder W. R. Coats. (By Committee.)

On motion the Secretary be instructed to prepare and have printed a sufficient number of report blanks for the Sunday schools to make their reports on to the various Sunday school conventions and distribute same as needed to the different Sunday schools throughout the conference.

On motion a vote of thanks be extended Bethel church and community for the hospitable manner in which they have entertained the conference.

On motion that a former resolution whereby the pastor of the church where the conference convenes should preach the introductory sermon be and is hereby repealed and that the conference at its annual session elect some minister to preach the introductory at the opening of each conference.

The conference elected Elder W. R. Coats to preach the introductory sermon at the next conference at 12 M., on the first day.

On motion the secretary have 1,000 copies of the proceedings of this conference printed and have them distributed among the various churches and conferences. On motion the secretary be allowed to draw on the treasurer for \$10.00 for his services, also all cost of having minutes printed and distributed.

On motion the treasurer be required to turn over at his earliest convenience all money on hand to the various causes for which it is appropriated, retaining on hand such money as is not otherwise ordered out.

On motion the money appropriated to the disabled ministers fund be used at the discretion of the Union Meeting Committee for this purpose and in connection with the funds of the Union Meeting.

On motion conference adjourn to meet with the church at Prospect on Thursday before the 1st Sunday in November 1923, at 12 M.

### RESOLUTIONS

Seeing the need of a better system of securing a statistical report of our Sunday schools throughout the entire conference, be it

Resolved 1. That the conference be re-districted into four Sunday school districts.

Resolved 2. That a Sunday school convention be annually held in each district during the month of October.

Resolved 3. That the moderator of this conference shall appoint a temporary president for each district whose duty it shall be to preside over the first meeting of each district when it will elect its own officers consisting of a president, vice-president, secretary and treasurer; also such committees as they may need to carry out the purpose of the convention.

Resolved 4. That at each meeting in each of said districts it shall be their purpose to arrange such program as they may think best to create and maintain a greater interest in the Sunday school work.

Resolved 5. That all schools shall be entitled to one delegate for each 50 members or fractional part thereof.

Resolved 6. That all Sunday schools whose officers or a majority of them are Free Will Baptist and all Sunday schools supported by some Free Will Baptist church and use the Free Will Baptist literature and shall be able to furnish a report of this work, be entitled to membership in this convention.

Resolved 7. All schools that cannot conform to the requirements set forth in section six of this resolution may be admitted in the discretion of each convention to participate and take any active part in making the program interesting and beneficial to the great Sunday school work which shall be upon invitation by the president and program committee.

Resolved 8. That it shall be the duty of each Sunday school to forward to said convention annually with



their report a sum not less than one or more than five cents per capita to defray any incidental expense that may occur from time to time.

Resolved 9. It shall be the purpose of this convention to see that a properly organized Sunday school is maintained in each church and at other places where the convention may think needful.

Resolved 10. That a special effort be made by each convention to see that a Sunday school is maintained in each church throughout the entire year.

Resolved 11. That in order that we may obtain each year an accurate report of each Sunday school we ask that a complete record be made each Sunday of its work, the same to be preserved in the Sunday school library or some place of safe keeping from year to year, and an annual report sent to each convention giving the following information, viz:

1st Name of school. 2nd Name of Superintendent. 3rd Name of delegate. 4th Members on roll. 5th Average attendance. 6th Members of Sunday school on church roll. 7th Number joining the church from the Sunday school. 8th Number of classes in school. 9th Are classes organized? 10th Number of teachers in school. 11th Amount of money paid for literature. 12th Amount paid for all other purposes.

Resolved 12. The Secretary of each district convention shall annually forward to this conference a tabulated report of the Sunday schools in its district giving the information asked for in section eleven of this resolution the same to be placed in the minutes and recorded in the book of records of the conference.

Resolved 13. That the following division or groups be made, District 1: Prospect, Pleasant Grove, Rock Ridge, Union Spring. District 2: Corinth, Lee's Chapel, Oak Grove, Roberts Grove, Shady Grove, St. Paul.

District 3: Bethel, Johnson Union, Hopewell, Powhatan, St. Marys, Grove, Yelverton Grove.

District 4: Casey's Chapel, Daly's Chapel, Goldsboro, Riverside, St. John, La Grange.

Resolved 14. That we as a church and as a denomination join hand to hand and heart to heart as one solid band of christian workers in an effort to enlist into the work of the Sunday school the entire popula-

tion of our respective communities and may we earnestly pray that in making this great effort in behalf of the Sunday school cause that the pronounced purpose shall be to make of them God-fearing and God-loving men and women, ever pointing them to the Lamb of God which taketh away the sin of the world.

In carrying out the foregoing resolution may we ever have the presence of the Giver of all good and perfect gifts to guide and direct us in all of our undertakings for him and for his cause and finally when our mission here is ended may we be permitted to hear Him say: "Thou hast been faithful over a few things, I will make thee ruler over many things, enter thou into the joy of thy Lord.

Resolved 15. That we join in with the state Sunday school work in helping to carry out the work that has been already started by the State Sunday School Board.
