#### AFTERNOON—SECOND DAY

Conference reassembled at 1:20. Song service. Prayer by Elder Ezekiel Westbrook.

Business was continued under the head of reports from churches.

On motion of the ministers, reports be read before the body. Motion carried and the secretary proceeds to read said reports.

Dr. Hinnant, treasurer of the orphanage, makes a very pointed talk concerning the work of the orphanage.

On motion the Cape Fear Conference erect one of the proposed buildings at the Free Will Baptist Orphanage at a cost of not less than \$3,000, nor more than \$5,000, the building to be built in accordance with the building plan.

On motion a committee of three be appointed to prepare plans for the purpose of getting the proposition before the various churches at once in order that we may raise the money immediately. The following

are appointed, viz: B. P. Parks, D. R. Ennis, and A. C. Snipes.

Committee on religious exercises report to preach at 7:30 p. m., Elder H. R. Faircloth.

On motion the conference give an opportunity to those present to subscribe to orphanage building funds. The sum of \$855 was readily subscribed.

On motion conference close till tomorrow 9:30 a. m. Prayer by Elder W. B. Everett.

### THIRD DAY—NOVEMBER 3, 1923

Conference convened according to adjournment.

Devotional exercises conducted by Elder J. R. Wallace. Roll call. Minutes of yesterday read and approved. Elder L. R. Ennis presented to the conference the idea of arranging to have at the annual conference and union meeting a book table to consider some of the best religious books.

Committee on religious exercises report to preach at 11 a. m., Elder W. B. Everett. By Committee.

Report of committee to draft plans to raise funds for the orphanage building was read before the body and adopted. (See report.)

Mission Board reports. (See report.)

Ordaining Council make their report. (See report.)

Executive Committee make their report. (See report.)

On motion a committee on resolutions be appointed. The following are appointed on said committee, viz: B. P. Parks, J. F. Davis, M. A. Warrick.

Elder D. C. Johnson offers his resignation as a member of the ordaining council. Resignation accepted and Elder B. P. Parks is elected in his place.

Resolutions were called for with only a few being offered and the following being adopted: Resolution of L. R. Ennis in regard to ministers and delegates is offered before the body and adopted. (See resolutions.)

A recess of ten minutes was given when the congregation reassembled to hear Elder W. B. Everett present his Educational address which he did in a very forceful manner. One hour is given for dinner.

Conference reassembled at 1:30. Business was continued under the head of reports.

On motion the treasurer pay to the church of Pleasant Grove the sum of \$15.00, out of any funds he may have in his hands.

On motion we pay Elder J. W. Moore \$25.00 from the disabled ministers fund.

On motion the entire fund apportioned for Educational purposes be paid over to the college fund at Ayden.

On motion the secretary have 1,000 copies of the proceedings of their conference printed and distributed among the various churches and other conferences.

On motion the secretary draw on the treasury for all expenses for having the minutes printed and distributed, also ten dollars for his services.

### RESOLUTIONS

Seeing the need of a better system of securing a statistical report of our Sunday schools throughout the entire conference, be it

Resolved 1. That the conference be re-districted in four Sunday school districts.

Resolved 2. That a Sunday school convention be annually held in each district during the month of October.

Resolved 3. That the moderator of this conference shall appoint a temporary president for each district whose duty it shall be to preside over the first meeting of each district when it will elect its own officers consisting of a president, vice-president, secretary and treasurer; also such committees as they may need to carry out the purpose of the convention.

Resolved 4. That at each meeting in each of said districts it shall be their purpose to arrange such program as they may think best to create and maintain a greater interest in the Sunday school work.

Resolved 5. That all schools shall be entitled to one delegate for each 50 members or fractional part thereof. Also all superintendents, choristers and ministers are entitled to membership.

Resolved 6. That all Sunday schools whose officers or a majority of them are Free Will Baptist and all Sunday schools supported by some Free Will Baptist church and use the Free Will Baptist literature and shall be able to furnish a report of this work, be entitled to membership in this convention.

Resolved 7. All schools that cannot conform to the requirements set forth in section six of this resolution may be admitted in the discretion of each convention to participate and take any active part in making the program interesting and beneficial to the great Sunday school work which shall be upon invitation by the president and program committee.

Resolved 8. That it shall be the duty of each Sunday school to forward to said convention annually with their report a sum not less than one or more than five cents per capita to defray any incidental expense that may occur from time to time.

Resolved 9. It shall be the purpose of this convention to see that a properly organized Sunday school is maintained in each church and at other places where the convention may think needful.

Resolved 10. That a special effort be made by each convention to see that a Sunday school is maintained in each church throughout the entire year.

Resolved 11. That in order that we may obtain each year an accurate report of each Sunday school we ask that a complete record be made each Sunday of its work, the same to be preserved in the Sunday school library or some place of safe keeping from year to year, and an annual report sent to each convention giving the following information, viz:

1st Name of school. 2nd Name of supreintendent. 3rd Name of delegate. 4th Members on roll. 5th Average attendance. 6th Members of Sunday school on church roll. 7th Number joining the church from the Sunday school. 8th Number of classes in school. 9th Are classes organized? 10th Number of teachers in school. 11th Amount of money paid for literature. 12th Amount paid for all other purposes.

Resolved 12. The Secretary of each district con-

vention shall annually forward to this conference a tabulated report of the Sunday schools in its district giving the information asked for in section eleven of this resolution the same to be placed in the minutes and recorded in the book of records of the conference.

Resolved 13. That the following division or groups be made, District 1: Prospect, Pleasant Grove, Rock Ridge, Union Spring. District 2: Corinth, Lee's Chapel, Oak Grove, Roberts Grove, Shady Grove, St. Paul.

District 3. Bethel, Johnston Union, Hopewell, Powhatan, St. Marys, Grove, Yelverton Grove.

District 4. Casey's Chapel, Daly's Chapel, Goldsboro, Riverside, St. John, LaGrange.

Resolved 14. That we as a church and as a denomination join hand to hand and heart to heart as one solid band of Christian workers in an effort to enlist into the work of the Sunday school the entire population of our respective communities and may we earnestly pray that in making this great effort in behalf of the Sunday school cause that the pronounced purpose shall be to make of them God-fearing and God-loving men and women, ever pointing them to the Lamb of God which taketh away the sin of the world.

In carrying out the foregoing resolution may we ever have the presence of the Giver of all good and perfect gifts to guide and direct us in all of our undertakings for him and for his cause and finally when our mission here is ended may we be permitted to hear Him say: "Thou hast been faithful over a few things, I will make thee ruler over many things, enter thou into the joy of thy Lord."

Resolved 15. That we join in with the State Sunday school work in helping to carry out the work that has been already started by the State Sunday School Board.
