

After being discussed by L. R. Ennis, J. W. Alford, D. C. Johnson, W. R. Coats, J. C. Griffin and A. E. Rouse, it was adopted by a vote of 37 to 4.

All ministers present pledged themselves to go back to their respective churches and make their best efforts to raise the quotos assigned to be raised by said churches.

Rev. R. E. Tripp preached to a spell-bound congregation. Text from Phillipians, "That I may know Him and the power of His resurrection and the fellowship of His suffering, being made comfortable to His death."

Meeting of the Executive Board of the North Carolina F. W. B. State Convention.

The Executive Board of the North Carolina State Convention met in the Free Will Baptist Church of Goldsboro, October 21, 1929, with the following members attending: J. W. Alford, S. H. Styron, W. C. Willis, E. T. Phillips by proxy, C. W. Johnson, and W. A. Jackson.

The meeting was opened with prayer by W. C. Willis, and L. R. Ennis was appointed secretary pro tem, following which the purpose of the meeting was stated by the chairman of the board, Rev. J. W. Alford.

A motion was made by S. H. Styron and seconded by C. M. Johnson that the original plan of the campaign for the liquidation of all outstanding indebtedness against Eureka College as adopted in the ministers' meeting on October 15, 1929, be adopted. Motion adopted.

The plan of the campaign is as follows:

1.-That the Executive Committee of the State Convention constitute the head and are hereby designated as having full direction of the campaign.

2.—To assist the Executive Committee in its work of directing the campaign the committee appointed in the 1929 session of the State Convention in the Cape Fear, Western, Eastern, and Central conferences shall serve in bringing success to the campaign in their respective conferences.

3.—That each church through its pastor be asked to donate a definite amount towards raising the sum of \$25,000.00 as required by the State Convention by April 1, 1930.

4.—That through the ladies of each church organization one-third of the amount determined as a pro rata of the church be raised.

5.—That a lady director be named whose duty it shall be to appoint one auxiliary director in each of the four conferences previously mentioned for the prosecution of the work.

6.—That all money raised through this campaign shall be immediately forwarded to the treasurer of the State Convention, Mr. W. C. Willis, Goldsboro, N. C., and that he shall keep separate account of same as campaign funds and make disbursements in payment of accounts approved by L. R. Ennis, treasurer of the college, and O. K.'d by the president of the State Convention.
