PROCEEDINGS

The one hundred fourteenth session of the Cape Fear Conference of the Original Free Will Baptist of North Carolina convened with the Bethel Church, Route 2, Four Oaks, on October 31 and November 1, 1968.

THURSDAY MORNING SESSION, OCTOBER 31, 1968

The Cape Fear Conference opened its 114th annual session Thursday morning, October 31, at 10 a. m., with the singing of the hymn, "There Shall Be Showers of Blessings."

The devotional was given by Rev. DeWayne Eakes, pastor of Casey's Chapel Church.

Rev. Edward Taylor, host pastor, graciously welcomed everyone to Bethel Church. Rev. W. O. Lassiter gave the response to the welcome.

The secretary of the conference, Ray G. Smith, declared the meeting opened for business.

The moderator recognized all visiting ministers. (See visiting ministers.) Enrollment of officers and standing boards were as follows:

A motion was made and carried to adopt the proposed program, granting the moderator the privilege to make any necessary changes.

The Children's Home report was given by Rev. Frances Garner. The motion carried to receive the report as information. (See report.)

Mrs. Almond Warrick gave the report of the Cape Fear Woman's Auxiliary. The report was adopted. (See report.)

The worship hour was opened with the congregation singing, "My Jesus I Love Thee." Prayer was offered by Rev. Henry Armstrong. A very inspiring message was brought to the conference by Rev. Eddie Edwards, pastor of th Johnston Union Church.

Following the morning message, the Ordaining Council held an ordination service for Brother John David Hill. The charge was given by Rev. Cedric D. Pierce Jr. Rev. Harry A. Jones presented the Bible on behalf of the Board of Education. Prayer was offered by Rev. C. Felton Godwin.

The conference adjourned for lunch.

THURSDAY AFTERNOON SESSION

The afternoon session began by singing the hymn, "When We All Get to Heaven." Devotions were conducted by Rev. M. E. Godwin.

A partial report of the Credentials Committee report was given by Rev. J. Walter Stanley. He reported 38 delegates, 25 ministers, 12 visiting ministers, 4 officers, and 23 visitors in attendance. A motion was made and carried to receive the report and to seat all delegates and ministers, with all visitors given the same privilege, except the power of voting.

The Executive Committee report was given by the conference secretary, Ray G. Smith. The report was adopted. (See report.)

A report of the North Carolina Ministerial Association of Original Free Will Baptists was given by Rev. James A. Evans. The report was received as information.

The report of the Board of Education was given by Rev. Rayford Lee. The report was adopted. (See report.)

A partial report of the Ordaining Council was given by Rev. C. D. Pierce Jr. The report was defeated by a vote of 28 opposed and 25 for. A supplement motion was made to adopt the report except the section which reads as follows: "That the Cape Fear Conference of Original Free Will Baptists authorize the Ordaining Council to require two years of college training—sixty-four semester hours, or its equivalent—through an acceptable institution for all candidates under thirty-five years of age that comes before it for ordination as a prerequisite for ordination." Also that this section be included in the report and the vote recorded against this section be included in the minutes. The motion carried. (See report.)

By motion, the conference adjourned until Friday morning at 9:30 a.m.

FRIDAY MORNING SESSION, NOVEMBER 1, 1968

The second day's session began with the congregation singing the hymn, "O Worship the King."

Devotions were conducted by Rev. John David Hill.

A report of the Cape Fear Missions Board was given by Rev. C. M. Coats. The report was adopted. (See report.)

Rev. W. O. Lassiter offered his resignation as a member of the Ordain-

ing Council because of his health. He expressed his appreciation for having had the opportunity to serve the conference in this capacity. A motion was made with regret to accept his resignation. The motion carried.

A report of the Cape Fear Sunday School Convention was given by Mr. John Adcox of the Fayetteville Church. The report was received as information. (See report.)

A report of the Cape Fear Ministers' Conference was given by Rev. Eddie Edwards. The report was received as information. (See reports.)

Rev. Joe Ingram gave a report of the North Carolina Free Will Baptist Board of Missions. The report was received as information. (See report.)

The moderator asked all to stand and join in the singing, "Stand Up, Stand Up for Jesus."

A report of Mount Olive College was given by Mr. Gary Barefoot, librarian for the college. The report was received as information. (See report.)

Mr. H. T. Hinson gave the treasurer's report. The report was adopted. (See report.)

The Temperance Committee report was given by Rev. Taylor Hill. The report was adopted. (See report.)

A motion was made that the Cape Fear Conference deposit its records, past and future, in the historical collection at Mount Olive College, and that these records be withdrawn only by an order of the conference. Also that the conference urge all our churches to adopt a similar policy regarding their historical records. The motion carried.

A five-minute recess was declared by the moderator.

The worship hour began with the congregation singing, "I Need Thee Every Hour." Rev. W. A. Martin brought the morning message.

Rev. Lloyd Vernon prayed the benediction and asked God's blessing on the noon meal.

The session recessed for lunch.

FRIDAY AFTERNOON SESSION

The afternoon session began by singing, "'Tis So Sweet to Trust in Jesus."

Rev. Joe Barrow spoke briefly to the conference concerning his plan to enter the mission field. He thanked the pople for their prayers and financial support.

A report of the Superannuation Board was given by Rev. Walter Reynolds. The report was received as information. (See report.)

Rev. David C. Hansley, general secretary of the State Convention of Original Free Will Baptists, brought greetings from the State Convention.

A final report of the Ordaining Council was given by Rev. Cedric D. Pierce Jr. The report was adopted. (See report.)

A complete report of the Credentials Committee was given by Rev. J. Walter Stanley. The report was adopted. (See report.)

A report of the Resolutions Committee was given by Cedric D. Pierce Jr. The report was adopted. (See report.)

The Nominating Committee report was given by Rev. Harry A. Jones. The report was adopted. (See report.)

A motion was made to give the secretary of the Ordaining Council, Rev. Cedric D. Pierce Jr., a gift of \$50 for his work with the Ordaining Council. The motion carried.

The Obituary Committee report was given by Rev. Walter Reynolds. The report was adopted. (See report.)

A motion was made that all unfinished business be left to the Executive Committee of the conference.

By motion the conference adjourned.

REPORT OF THE FREE WILL BAPTIST CHILDREN'S HOME

We sincerely hope all our people will always keep our children ever before them. It is most important that our efforts try to:

WE HOPE YOU WILL VISIT US AS OFTEN AS POSSIBLE: We always appreciate letters, cards, gifts, funds, and any way our children are remembered. However, it means much greater understanding and appreciation if you can visit us in person and know that you are a part of them.

Our New Cottage: The new cottage for our older girls is nearing completion. This cottage is urgently needed and will be most helpful when we can occupy it. This will do much to relieve our present crowded conditions and make it possible for us to admit those now on our "waiting list." Four

new girls are waiting to be admitted just as soon as this new cottage can be opened.

November—Children's Home Month: We sincerely hope our people will remember that "November is Children's Home Month." We urge all our churches, other organizations, and individuals to make their gifts and offerings just as generous as possible this November. Gifts received during November each year constitute a major part of our annual support and helps determine the things we undertake during the year. Gifts during the first two months of this fiscal year have been maintained at the same level as for the same period last year. It is imperative that gifts during November be as much as last year if we are to keep on schedule with our development program. Please try to give at least as much as you gave last year. Since we now have more children, a little increase will be most helpful.

THANKSGIVING SERVICE: We will again this year have a Thanksgiving service on Thanksgiving Day. The program will begin in Memorial Chapel at 10:30 a. m., and will conclude with the usual picnic lunch on campus at 12 noon. All our friends and supporters are invited to join us for this service of Thanksgiving.

The Children's Home will furnish barbecue and the things to go with it, as well as drinks, plates, napkins, etc. Others who can, are urged to bring a regular picnic lunch.

THANKS: We thank you for your continued valuable support of the Children's Home. The level of support by our people which was established three years ago, and maintained last year, is still being maintained. This continued support is enabling us to keep on schedule with our development program. It is a pleasure to number you among our partners in this ministry. We thank you for this support.

REPORT OF MOUNT OLIVE COLLEGE

ENROLLMENT SPOKED SAFELE

For the fall semester, 358 students are enrolled at Mount Olive College. Included in this number are 319 in the regular day program, 25 in night classes, seven who are auditing courses, and seven outside students who are taking private music. To provide educational opportunities for as many qualified students as possible, the College is administering a program of loan funds, scholarships, grants-in-aid, and part-time employment in excess of \$100,000 during 1968-69.

FACILITIES

The new library, named in memory of the late Rev. J. C. Moye and in honor of Mrs. Moye, is now in use. This facility which contains 17,000 volumes is a valuable asset to the educational program of the College.

With the opening of public community colleges in our area, the continued growth of Mount Olive College depends upon our having accommodations for more resident students. A new dormitory for men is urgently needed, and gifts in the amount of \$100,000 will enable the College to begin this project.

FINANCIAL SUPPORT

Mount Olive College is grateful to the Free Will Baptists of the Cape Fear Conference for their support in the amount \$10,231.60 last year.

PARTIAL REPORT OF THE ORDAINING COUNCIL

October 31, 1968

The Ordaining Council has held nine meetings and conducted four ordination services during the year.

On November 3, 1967, the following items were acted upon:

- 1. The Rev. C. M. Coats was elected to serve as chairman of the Ordaining Council for the 1967-68 conference years.
- 2. The Rev. Cedric D. Pierce Jr. was elected to serve as secretary of the Ordaining Council for the 1967-68 conference year.
- 3. The Rev. Harry A. Jones was elected to serve as vice-chairman and assistant secretary for the 1967-68 conference year.

On December 18, 1967, the following items were acted upon:

- North Carolina, was cleared to serve in the Cape Fear Conference.
- 2. A letter of transfer was received for the Rev. James E. Howard from the Eastern Conference.
- 3. A letter of transfer was received for the Rev. J. Stewart Humphrey from the Central Conference. in motion
- 4. The renewal of the ministerial license for Brother John David Hill by Bethel Free Will Baptist Church was approved.
- 5. The renewal of the ministerial license for Brother Harold Mac Wallace by Johnston Union Free Will Baptist Church was approved.
- 6. The Rev. Wiley Ferrell appeared after he had missed two consecutive sessions of the Cape Fear Conference and stated that he had joined the Western Conference. (Upon our inquiry the Western Conference Ordaining Council sent a letter confirming that he had made request for transfer of membership. Action was taken by this council in our regular meeting on June 24, 1968.)
- 7. The Rev. Wilson Parker appeared after he had missed two consecutive sessions of the Cape Fear Conference and was placed on probation through the 1968 annual session.
- 8. Plans were made for Brother Harold Mac Wallace's ordination service.
- 9. Brother Emmett W. Bartlett was cleared for ministerial license to be issued by the West Clinton Free Will Baptist Church as a continuation of his original license granted by Harrell's Chapel Free Will Baptist Church of the Central Conference. (Note: His church membership was transferred from Harrell's Chapel to West Clinton on November 19, 1967.)

On December 30, 1967, the following items were acted upon:

- 1. Upon the request of West Clinton Free Will Baptist Church, Brother Emmett W. Bartlett was examined for ordination. Having successfully passed the examination and meeting all requirements for ordination he was approved for ordination.
- 2. Brother Harold Mac Wallace and Brother Emmett W. Bartlett were ordained during the morning worship hour at the Cape Fear Union Meeting. Their names are to be added to the list of ordained ministers.

On March 25, 1968, the following items were acted upon:

- 1. The renewal of the ministerial license for the following men by their respective churches was approved:
 - A. William L. Littleton, Yelverton's Grove Church
 - B. W. J. Tyner Jr., Riverside Church
 - C. Charles Pittman, Tee's Chapel Church
 - D. Floyd Smith, Lanwood Chapel Church
- 2. Brother William L. Littleton was examined for ordination. Having successfully passed, he was approved for ordination and plans were made for his ordination service to be on June 29, 1968, at the union meeting convening with Bethel Free Will Baptist Church.
- 3. Brother W. J. Tyner Jr. was examined for ordination. Having successfully passed, he was approved for ordination and plans were made for his ordination service to be on June 29, 1968, at the union meeting convening with Bethel Free Will Baptist Church.
 - 4. Brother Charles Pittman commenced his examination for ordination.
- 5. The Rev. Gideon S. Stevens was placed in good standing with the Cape Fear Conference of Original Free Will Baptists by way of a personal letter dated February 21, 1968.

On June 24, 1968, the following items were acted upon:

- 1. Brother Charles Pittman of the Tee's Chapel Church continued his examination for ordination. He satisfactorily passed and was approved for ordination. His ordination service was planned for June 29, 1968, at the union meeting convening with Bethel Free Will Baptist Church.
- 2. Brother Elijah Floyd Smith of the Lanwood Chapel Church was examined for ordination. After satisfactorily completing his work, he was approved, and plans were made for his ordination to be at Bethel Church during the union meeting on June 29, 1968.
- 3. Brother Jessie Cleavon Wood of the Faith Free Will Baptist Church was examined for ministerial license. He was recommended by the council to Faith Church for license to preach the gospel in the Original Free Will Baptist Church for a period of one year.
- 4. The council appproved the renewing of the ministerial license of Brother Alton C. Bennett by Pleasant Grove Church.
 - 5. The Rev. Boyd L. Shook was granted a letter of transfer to the

Western Conference. His name is to be removed from the list of ordained ministers.

6. A letter of transfer to the Western Conference was granted for the Rev. Wiley Ferrell. This action confirms and completes council action on December 18, 1967. His name is to be removed from the list of ordained ministers.

On June 29, 1968, the following action was taken:

The men whose names follow were ordained at the union meeting convening with Bethel Free Will Baptist Church: William L. Littleton, Charles W. Pittman, Elijah Floyd Smith, and William Jasper Tyner Jr. Their names are to be added to the list of ordained ministers.

On July 23, 1968, a special call session of the ordination council was held to transact the following:

- 1. It was noted that on June 24, 1968, the Ordaining Council had approved Brother Jessie Cleavon Wood for ministerial license to be granted by Faith Free Will Baptist Church.
- 2. On July 8, 1968, the chairman of the Ordaining Council, the Rev. C. M. Coats, received information (concerning Brother Jessie Cleavon Wood's marital status) which led to the necessity of further examination of his qualifications to serve as a licensed minister.
- 3. After careful examination and consideration the following action was taken by the council: "By motion that we, the Cape Fear Conference Ordaining Council, annul the recommendation to the Faith Free Will Baptist Church to license Brother Wood on the scriptural grounds found in Matthew 5:31, 32; 1 Timothy 3:1-7; Titus 1:6-9; and 1 Corinthians 7:10, 11. We believe this action is taken under the leadership of God and in the best interest of the Cape Fear Conference of Original Free Will Baptists of North Carolina."
- 4. Therefore, the name of Brother Jessie Cleavon Wood is not to be added to the list of licensed ministers.

On September 23, 1968, the following items were acted upon:

- 1. Brother Larry Wilson Barbour of Wooten's Chapel Church commenced his examination for ministerial license which will be continued on December 16, 1968.
- 2. Brother James Dwight Gay of the First Church, Smithfield, began his examination for ministerial license. His examination will also be continued on December 16, 1968.
- 3. Brother Alton C. Bennett from the Pleasant Grove Church began his examination for ordination. This was to be continued on October 14, 1968.

On October 14, 1968, the following items were acted upon:

1. The Rev. Melvin Moore was cleared for work in the Cape Fear Conference.

- 2. The Rev. William E. Futch was cleared for work in the Cape Fear Conference.
- 3. Brother John David Hill's case was reviewed and it was noted that he has satisfactorily met all requirements for ordination. He was ordained at the 1968 annual session of the Cape Fear Conference during the morning service on October 31.
- 4. Brother Alton C. Bennett was granted permission to postpone continuing his ordination examination until December 16, 1968, the next regular meeting of the council, due to the illness of his wife.
- 5. Brother John J. Roberts of the Saint Mary's Grove Church began his examination for license to preach. He will continue his work on December 16, 1968.
- 6. The ordination service for John David Hill was planned.

On October 31, 1968, the following items were acted upon:

- 1. It was noted that the name of the Rev. James A. Evans was accidentally deleted from the roster of ordained ministers of the Cape Fear Conference in the minutes of the 1967 session. The council approved for the letter of apology to Brother Evans from Mr. Ray Smith, clerk, to be inserted in the permanent records of the Cape Fear Conference Ordaining Council. The letter, dated October 13, 1968, reads in part as follows: "... I would like to apologize for leaving your name off our list of ministers in the minutes of last year's session. This was certainly through error—thinking that you went with the other conference at the time you resigned from the Odraining Council. Please accept my apology."
 - 2. The report of the Ordaining Council to the conference was approved.
- 3. Whereas, Brother Jesse Caton failed to meet with the Ordaining Council on either November 2 or 3, 1967, at the Cape Fear Conference's annual session as requested; and, whereas, since that date his ministerial license, issued by the First Free Will Baptist Church, Fayetteville, North Carolina, has expired, his name is to be deleted from the list of licensed ministers.
- 4. The ministerial license of Brother C. H. Parrish expired on February 23, 1968. His name is to be removed from the list of licensed ministers.

RECOMMENDATIONS TO THE CONFERENCE

The Ordaining Council makes the following recommendations to the Cape Fear Conference of Original Free Will Baptists:

1. We recommend that each local church accept the responsibility to investigate thoroughly the moral character, marital status (whether divorced, remarried, etc.), and general reputation of each man to be recommended for license to preach or ordination to the gospel ministry; and we request that no church recommend a man for any phase of the ministry who does not meet the highest possible qualifications in the above areas. It is the opinion of the Ordaining Council that no man is truly qualified for the ministry who does not measure up to these standards and the council believes

that it is in the best interest of the Christian Church, the Free Will Baptist Denomination, and the Cape Fear Conference of Original Free Will Baptists, that such persons be denied license to preach or ordination credentials. Adoption of this recommendation will be considered as the conference's endorsement and acceptance of this policy.

2. Whereas, a resolution was adopted in the 1962 session of the North Carolina State Convention which reads in part, "Be it resolved that this convention firmly recommend that each ordaining council in the conferences making up the State Convention give more rigid and careful consideration to the examination leading to the ordaining of prospective candidates for the gospel ministry"; and,

Whereas, the Cape Fear Conference in 1962 adopted a statement in the Ordaining Council's report which reads, "The council recommends that the conference endorse the action of a planning committee meeting recently which recommended that all ordaining councils in the state work together toward a standard form for examining and ordaining candidates for the ministry"; and,

Whereas, the North Carolina State Convention in 1962 adopted the report of the Board of Christian Education as follows:

"Whereas, the educational level of our present society is ever increasing, and therefore the educational level of Free Will Baptists is also increasing; and,

"Whereas, the future of our denomination depends in a great measure upon the ability of its leadership, and its leadership hinges upon the availability of a God-called fully dedicated, prepared ministry;

"Therefore, the Board of Christian Education recommends:

"That the State Convention of the Original Free Will Baptists of North Carolina recommend to its members conferences and associations that two years of college (sixty-four semester hours or its equivalent) be required for all candidates under thirty-five years of age that come before them for ordination"; and,

Whereas, some of our sister conferences and associations have adopted the above recommendation; and,

Whereas, Mount Olive College is within the bounds of the Cape Fear Conference and provides ministerial scholarships, plus other financial and educational aids for ministers;

Therefore, the Ordaining Council recommends:

That the Cape Fear Conference of Original Free Will Baptists authorize the Ordaining Council to require two years of college training (sixty-four semester hours or its equivalent) through an acceptable institution for all

candidates under thirty-five years of age that come before it for ordination as a prerequisite for ordination.



CONSTITUTION

PREAMBLE

PREAMBLE

We, the Cape Fear Conference of the Original Free Will Baptist denomination of North Carolina, desiring to be in fellowship in a bond of union, do ordain this constitution.

This shall be the constitution of the Cape Fear Conference of the Original Free Will Baptist Churches of North Carolina.

PURPOSE

The object of the Cape Fear Conference shall be to promote Christ's kingdom among men by means in strict conformity to the Holy Scriptures.

ARTICLE I. COMPOSITION

This conference shall be composed of affiliated ordained ministers and churches within its bounds, who are in good standing, and of all general officers, and members of standing boards or committees of the conference. It shall operate under the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina. No church corporation whose articles or incorporation or constitution and bylaws conflict with the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina shall be permitted membership in the Cape Fear Conference.

ARTICLE II. REPRESENTATION

Each church shall represent with one delegate for each one hundred members or fraction thereof. The delegation from each church shall carry to the conference a letter certifying their appointment, and giving the statistics and financial condition of the church; together with a statement of all funds received and disbursed for denomination and benevolent purposes during the year. ARTICLE III. OFFICERS

The officers shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, who shall be elected for a term of two years, entering upon the duties of said office at the close of the session in which they are elected. Temporary officers, representatives or messengers, may be elected at the option of the conference for whatever purposes deemed essential.

ARTICLE IV. STANDING BOARDS AND COMMITTEES

It shall be the policy of this conference to elect as many boards and committees as may be necessary in carrying out its program. These shall keep records of their proceedings and make a report at each annual session of the conference.

A board of trustees, a board of Christian education, a board of missions and church extension, and a board of ordination consisting of five members each shall be elected. The term of office for members of these board shall be five years, but shall be so adjusted as to terminate the tenure of office of one member annually.

Section 1—Standing boards shall write their own bylaws and administer their respective programs of work, but each shall remain subject to their conference, of called all of or analytic as detail in the merical arounds

Section 2—The executive committee shall be composed of the moderator, assistant moderator, secretary, treasurer, and one member elected by the conference at the time of the official election of officers.

Section 3—Temporary committees shall be appointed at option of the conference for whatever purpose deemed necessary.

ARTICLE IX. MEETINGS

The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

SECTION 1—The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Cape Fear Conference; to appoint temporary committees, delegates, and representatives; to serve as ex officio member of all standing boards and committees; and in general, to perform the duties of the office of moderator.

Section 2—The duties of the assistant moderator shall be the duties

of the moderator when that officer is not present and he shall assist the moderator when called upon. In the event of the resignation or death of the moderator, the assistant moderator shall fill the vacancy until the next session of the conference.

Section 3—The secretary shall record the proceedings of all sessions of the Cape Fear Conference and preserve an accurate record of said proceedings in a book provided for this purpose. The secretary shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require the secretary's signature; and serve as a member of executive board.

Section 4—The duties of the assistant secretary shall be the duties of the secretary when that officer is not present, and he shall assist the secretary when called upon. In the event of the resignation or death of the secretary, the assistant secretary shall fill the vacancy until the next session of the conference.

Section 5—The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee, or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report to the conference.

Section 6—It shall be the duty of the executive committee to transact the business of the conference when the conference is not in session, and make report at annual conference. The executive committee shall plan the program for the annual session of the conference.

Section 7—The board of trustees shall hold in trust all conference and real property, gifts and bequests of the conference, and convey or expend said property or assets as the Cape Fear Conference may direct.

Section 8—It shall be the duty of the board of ordination to examine, ordain, and discipline ministers in keeping with the provisions of the Statement of Faith and Discipline for Original Free Will Baptist of North Carolina, along with whatever additional requirements may be made by the conference. The board of ordination shall examine ordained ministers seeking membership in this conference and make recommendations in keeping with their findings.

Section 9—It shall be the duty of the board of missions and church extension to cooperate with the churches of the conference to promote the establishment of churches within the bounds of the conference. The board of missions and church extension shall cooperate with the state board of missions to raise money, arrange itineraries, and keep the work of missions before our churches.

Section 10—It shall be the duty of the board of Christian education to keep our people informed as to our educational needs, and endeavor to promote the cause of and stimulate interest among our people in the

cause of Christian education. The board of Christian education shall cooperate with the educational institutions of our denomination and use all funds for best interest of Christian education.

Section 11—The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: credentials, nominating, resolutions, temperance, obituary, and letter digest.

Section 12—A board or committee will be recognized as having a quorum when there is a majority of the members present for a meeting, providing all the members of said board or committee have been duly notified concerning the said meeting.

Section 13—All reports, resolutions, and recommendations shall be considered properly presented to the conference in written form only.

Section 14—Each minister and delegate in good standing shall duly attend each day while the conference is in session or be subject to censure by the conference and reported to his local church.

Section 15—If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that session.

Section 16—No member shall be excused from any session of the conference without leave of the moderator.

Section 17—The conference shall adjourn by a majority vote.

Section 18—Each officer and member of standing committees and boards in good standing shall be entitled to a seat and vote in the conference.

Section 19—The conference shall open and close with suitable devotional services.

Section 20—This constitution and its bylaws may be altered or amended by a two-thirds favorable vote of the members present, provided that said amendment shall be presented on the first day of the annual session for action on the following day.

UNION MEETING

CAPE FEAR CONFERENCE OF ORIGINAL FREE WILL BAPTISTS

CONSTITUTION

ARTICLE I

NAME—This organization shall be known as the Union Meeting of the Cape Fear Conference of Original Free Will Baptists of North Carolina.

ARTICLE II

Purpose—The purpose of this union meeting is the creation of an effective agency through which the Cape Fear Conference may successfully promote its work. It shall thus be and remain subject to the authority and use of the conference—except in the election of its general officers—as a consistent medium devoted to the advancement of the conference program of evangelism, education, benevolence and church extension.

ARTICLE III

Composition—This union meeting shall be composed of churches affiliated with the Cape Fear Conference, the ordained and licensed ministers who are members of churches that belong to the conference, and all general officers and members of standing committees of both the conference and the union meeting.

ARTICLE IV

REPRESENTATION—The churches of the Cape Fear Conference shall represent in the quarterly sessions of the union meeting with one delegate for each one hundred members or fraction thereof. Sunday schools, leagues, and auxiliaries shall each represent with one delegate.

ARTICLE V

Finance—Each church shall send with its delegation to the quarterly sessions of this union meeting one percent of its annual budget exclusive of funds for building and equipment, or a total of four percent of the church budget for the full year of four union meeting sessions. Sunday schools, leagues, and auxiliaries shall represent with whatever amounts they may choose. All funds shall be allocated by the executive board of the conference, but said allocations shall be approved by the union meeting in regular session or by the conference.

ARTICLE VI

Officers—The general officers of this union meeting shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, each of whom shall be elected for a term of one year, at the last session of the union meeting before the annual session of the Cape Fear Conference.

ARTICLE VII

BOARDS AND COMMITTEES—All standing committees and boards created by the conference shall avail themselves of the advantage of promoting their work through the union meeting.

The general officers of the union meeting shall be added to the executive board of the conference and this composite committee shall constitute the executive committee of the union meeting. This committee shall have power to act for and on the behalf of the union meeting between its regular sessions. It shall also be the duty of the executive committee to prepare and supervise the programs of the union meeting and to allocate all undesignated funds.

ARTICLE VIII

MEETINGS—The union meeting shall hold its regular sessions Saturday before each fifth Sunday in the churches of the Cape Fear Conference. The host church shall be selected from time to time, according to the alphabetic succession of the initial letter of the name of each church. This method of selecting the place of meeting may be changed when deemed expedient or necessary, by an act of the union meeting in session or the executive committee.

ARTICLE IX

AMENDMENT—This constitution may be amended at any regular session of the Cape Fear Conference by a majority vote of the members present, provided that the proposed amendment be presented in writing by the union meeting.

BYLAWS GOVERNING THE BOARD OF EDUCATION

- 1. The board shall be composed of five members. Their terms of office shall be as provided for in the constitution of the conference.
- 2. The officers shall be chairman, assistant chairman, recording secretary, assistant recording secretary, and executive secretary, who shall have charge of the promotional work of the board. Provided; however, that any two officers may be combined at the option of the board, and provided further, that the executive secretary may, or may not be, a member of this board.
- 3. The treasurer of the conference shall, unless otherwise provided for, hold all funds of the board and disburse same on order of the board, or when duly signed by the chairman and secretary of the board. Annual reports of all receipts and disbursements shall be made to the conference in session and interim reports to the executive board when requested.
- 4. The board shall meet as often as necessary for the proper dispatch of the work assigned to it by conference direction, but must meet at least twice a year.
- 5. The board shall make, or cause to be made, adequate records of meetings of this board, detail records, reports, etc., of all activities of the board and its officers, and preserve same as permanent records.

- 6. This board shall be charged with the responsibility of cooperating with our state and national educational institutions in the promotion of general Christian education.
- 7. The organization, direction, and the training program of Free Will Baptist league shall be under the direction and supervision of this board.
- 8. The general supervision of the Sunday school promotional activities, organization of new Sunday schools, training program for workers, and any and all other Sunday school promotional programming shall be the responsibility of this board.
- 9. This board shall be charged with the responsibility of making, or cause to be made emphasis on the Christian family life.
- 10. This board shall be responsible for conducting area institutes, and conferences, on a conference scale, annually to instruct and help our people when necessary to have a better understanding of our conference, state, or national programs.
- 11. It shall be the responsibility of this board to direct and supervise all training programs of the conference.
- 12. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the responsibilities assigned to it, provided, however, that the same shall not be inconsistent with bylaws, nor the constitution of the conference.
- 13. The board shall be responsible for the promotion and administration of a Student's Loan Fund with which to aid worthy students in security and education.
- 14. The board shall lend money only upon the following terms and conditions:
- A. Students must be adjudged worthy as to character and ability, and must attend an institution of learning approved by this board.
- B. A promissory note must be made by the student, with one or more good endorsements, or other good security satisfactory to the board. The rate of interest shall be 1% while the student is in training. After completion of training, a new note shall be made bearing 6% interest with monthly, or quarterly payments to be made until obligations are fully discharged.
- 15. These bylaws may be amended or revised at any annual session of the conference, provided that such amendments, or revisions, as may be deemed necessary, shall lie on the table at least three hours before a vote is taken, during which time they shall be read twice, and provided further that such amendments or revisions shall require a two-thirds vote.

BYLAWS GOVERNING THE BOARD OF MISSIONS

1. The board shall be composed of five members. The first named shall be for a term of one year, the second for two years, the third for three years, the fourth for four years, the fifth for five years and thereafter for a term each of five years.

- 2. The officers shall be chairman, assistant chairman, recording secretary, and an executive secretary, who shall have general charge of the promotional work of the board. Provided, however, that any two officers may be combined at the option of the board, and provided, further, that the executive secretary may, or may not, be a member of the board.
- 3. The board shall meet as often as may be deemed necessary and attend to all matters pertaining to missions within the territory of the Cape Fear Conference, but must meet at least twice a year.
- 4. The treasurer of the conference shall hold all funds designated for Cape Fear missions and pay out same on order of the board, or when said order is duly signed by the chairman and the secretary of the board. Annual reports shall be rendered to the conference of all funds received and disbursed.
- 5. All persons doing work that merit compensation must first apply to the board on approved forms, and receive authorization to do work under regulations of the board before they can be compensated for same with mission funds.
- 6. Mission points, or stations, may be opened and maintained by the board for such a length of time as may be deemed best, employ evangelists, missionaries, and such field workers as may be deemed necessary for the proper promotion of the mission work.
- 7. The board shall not make any investment in property, nor promote any investment in property, without first giving due consideration to the safety of the investment, property titles, and other matters relative to the security of any investment.
- 8. No person shall be at liberty to enter upon any approved mission point without first consulting the board and receiving its approval as to place, plans, and purposes.
- 9. The board shall render annual reports to the conferences and interim reports to the executive board when requested.
- 10. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the mission program, provided that same shall not be inconsistent with these bylaws.
